No. 4052.—Whereas it appears to His Excellency the Governor in Council that the additional police entertained in the village of Yalwar in the Bagewadi taluka of the Bijapur district under the authority of Government Notification No. 689-A, dated the 21st January 1920, should be paid, from the date of their entertainment, the additional compensatory allowance of Rs. 2 per mensem, sanctioned for the regular police of the Bijapur district under Government Resolution in the Judicial Department, No. 10579, dated the 10th December 1919, the Governor in Council is pleased-

(a) to sanction the grant of the said rate of additional compensatory allowance, in addition to the other allowances previously sanctioned, from the said date, and

(b) to direct that the cost of the above, amounting to Rs. 10 per mensem, shall be defrayed by a rate assessed on all the communities of the village of Yalwar, except the Brahmanas, Carpenters, Mahrattas, Simpis and Korwars.

II.

No. 4053.—Whereas it appears to His Excellency the Governor in Council that the additional police entertained in the village of Bhadi in the Ankleshwar taluka of the Broach district under the authority of Government Notification No. 477, dated the 17th January 1913, and continued upto 29th February 1920, by Government Notification No. 5288, dated the 4th July 1919, should be paid, during the period from the 1st July 1919 upto the date of their distort the additional component of Base of the 1990 upto the date of their disbandment, the additional compensatory allowance of Rs. 3 per mensem, sanc-tioned for the regular police of the Broach district under Government Resolution in the Judicial Department, No. 10579, dated the 10th December 1919, the Governor in Council is pleased-

No. 4054.—Whereas it appears to His Excellency the Governor in Council that the additional police entertained in the villages of Udtara, Kalambe and Virmade in the Wai taluka and in the villages of Raigaon, Sarajapur and Anewadi in the Javli taluka of the Satara district, under the authority of Government Notification No. 5206, dated the 7th August 1918, as amended by Government Notifications No. 7934, dated the 7th December 1918, and No. 1452, dated the 21st February 1919, should be paid, during the period from the 1st July 1910 to the 21st December 1919, in the case of head constables and constables. the additional compensatory allowance of Rs. 2 per mensem sanctioned for the regular police of the Satara district under Government Resolution in the Judicial Department, No. 10579, dated the 10th December 1919, the Governor in Council is pleased—

(a) to sanction the grant of the said rate of additional compensatory allowance to the head constables and constables, in addition to the other allowances previously sanctioned, for the period stated above, and

 (δ) to direct that out of the cost of the above, amounting to Rs. 38 per mensem, one-third shall be recovered from the inhabitants of the village of Udtara, and that the balance should be recovered from the other villages in proportion to their male

IV.

No. 4055.—Whereas it appears to His Excellency the Governor in Council that the additional police entertained in the town of Nadiad in the Kaira district under the authority of Government Notification No. 6137, dated the 28th July 1919, should be paid, from the 1st July 1919 upto the date of their disbandment, *i.e.*, the 31st January 1920, the additional compensatory allowance of Rs. 3 per mensem each to the head constables and constables, sanctioned for the regular police of the Kaira district under Government Resolution in the Judicial Department, No. 10579, dated the 10th December 1919, the Governor in Council is pleased—

(a) to sanction the grant of the said rate of additional compensatory allowance, in addition to the other allowances previously sanctioned, for the period stated above,

(b) to direct that the cost of the above, amounting to Rs. 132 per mensem, shall be defrayed wholly by a rate assessed and charged by the Municipality of Nadiad upon the property of the Bania and Patidar residents of Nadiad town, and

(c) to exempt Government servants from liability to bear any portion of such cost.

V.

No. 4056.—Whereas it appears to His Excellency the Governor in Council that the additional police entertained in the Barejdi and Nandej villages in the South Daskroi taluka of the Ahmedabad district under the authority of Government Notification No. 6137, dated the 28th July 1919, as amended by Government Erratum in the Judicial Department, No. 7287, dated the 1st September 1919, should be paid, during the period from the rst July 1919 upto the date of their disbandment, *i.e.*, the 31st January 1920, the additional compensatory allowance of Rs. 3 per mensem each to the head constables and constables, sanctioned for the regular police of the Ahmedabad district, under Government Resolution in the Judicial Department, No. 10579, dated the 10th December 1919, the Governor in Council is pleased—

(a) to sanction the grant of the said rate of additional compensatory allowance, in addition to the other allowances previously sanctioned, for the period stated above, and

(b) to direct that the cost of the above, amounting to Rs. 54 per mensem, shall be defrayed wholly by a rate assessed by the District Magistrate upon the landowners of the Barejdi and Nandej villages.

(a) to sanction the grant of the said rate of additional compensatory allowance, in addition to the other allowances previously sanctioned, for the period stated above, and

(b) to direct that the cost of the above, amounting to Rs. 200 only for the month of July 1919, and thereafter at the rate of Rs. 90 per mensem, shall be defrayed by a rate assessed on the non-official income-tax payers of all the villages at the full amount of the income-tax, and that the balance shall be assessed in full on the Land Revenue payers.

" JUDICIAL.

No. 736, dated Simla, the 17th April 1920.

The following Order of His Majesty the King in Council regulating the practice in appeals to His Majesty in Council is published for general information :---

At the Court at Buckingham Palace, the 9th day of February 1920.

Present :

THE KING'S MOST EXCELLENT MAJESTY IN COUNCIL.

Whereas by an Act passed in the 4th year of the reign of His Majesty King William IV, entitled 'an Act for the better Administration of Justice in His Majesty's Privy Council' it is, amongst other things, enacted that it shall be lawful for

His Majesty in Council from time to time to make any such Rules and Orders as may be thought fit for regulating the mode, form and time of Appeal to be made from the decisions of any Courts of Judicature in India (from the decisions of which an Appeal lies to His Majesty in Council), and in like manner from time to time to make such other Regulations for the preventing delays in the making or hearing such Appeals and as to the expenses attending the said Appeals and as to the amount or value of property in respect of which any such Appeal may be made :

And whereas Her Majesty Queen Victoria did by Her Order in Council of the 10th day of April 1838, approve certain Bules and Orders for regulating the mode, form and time of Appeal from the decisions of the said Courts and also certain Regulations for the preventing delays in the making or hearing such Appeals and as to the expenses attending such Appeals and as to the amount or value of property in respect of which any such Appeal may be made :

And whereas the King's Most Excellent Majesty in Council hath deemed it expedient to rescind all the said Rules, Orders and Regulations and to substitute others in lieu thereof:

His Majesty is, therefore, pleased, by and with the advice of His Privy Council, to rescind all the said Rules, Orders and Regulations in the said Order in Council of the 10th day of April 1838, contained, and to approve of the several Rules, Orders and Regulations contained in the Schedule hereto, and to order as it is hereby ordered, that the same be respectively observed by all Courts of Judicature in India and by all persons whom it shall or may concern.

Whereof the Governor General of India in Council, and all other persons whom it may concern, are to take notice and govern themselves accordingly.

The Schedule above referred to.

1. Applications to the Court for leave to appeal to His Majesty in Council shall be made within 90 days of the decree or order to be appealed from, subject to the provisions of sections 4, 5 and 12 of the Indian Limitation Act, 1908.

2. The preparation of the Record shall be subject to the supervision of the Court, and the parties may submit any disputed question arising in connection therewith to the decision of the Court, and the Court shall give such directions thereon as the justice of the case may require.

3. The Registrar, as well as the parties and their legal Agents, shall endeavour to exclude from the Record all documents (more particularly such as are merely formal) that are not relevant to the subject-matter of the Appeal, and, generally, to reduce the bulk of the Record as far as praticable, taking special care to avoid the duplication of documents and the unnecessary repetition of headings and other merely formal parts of documents; but the documents omitted to be copied or printed shall be enumerated in a manuscript list to be transmitted with the Record.

4. Where in the course of the preparation of a Record one party objects to the inclusion of a document on the ground that it is unnecessary or irrelevant and the other party nevertheless insists upon its being included and the Court allows the document to be included, the Record, as printed (whether in India on in England), shall, with a view to the subsequent adjustment of the costs of and incidental to such document, indicate in the index of papers, or otherwise, the fact that, and the party by whom, the inclusion of the document was objected to.

5. Where the Record is printed in India, the Registrar shall, at the expense of the Appellant, transmit to the Registrar of the Privy Council 40 copies of such Record, one of which copies he shall certify to be correct by signing his name on, or initialling every eighth page thereof and by affixing thereto the seal, if any, of the Court.

6. Where the Record is to be printed in England, the Registrar shall, at the expense of the Appellant, transmit to the Registrar of the Privy Council one certified copy of such Record, together with an index of all the papers and exhibits in the case. No other certified copies of the Record shall be transmitted to the Agents in England by or on behalf of the parties to the Appeal.

7. Where there are two or more Appeals arising out of the same matter, and the Court is of opinion that it would be for the convenience of the Lords of the Judicial Committee and all parties concerned that the Appeals should be consolidated, the Court may direct the Appeals to be consolidated.

8. An Appellant who has obtained a certificate for the admission of an Appeal may at any time prior to the making of an Order admitting the Appeal withdraw the Appeal on such terms as to costs and otherwise as the Court may direct. 9. Where an Appellant, having obtained a certificate for the admission of an Appeal, fails to furnish the security or make the deposit required (or apply with due diligence to the Court for an Order admitting the Appeal), the Court may, on its own motion or on an application in that behalf made by the Respondent, cancel the certificate for the admission of the Appeal, and may give such directions as to the costs of the Appeal and the security entered into by the Appellant as the Court shall think fit, or make such further or other Order in the premises as, in the opinion of the Court, the justice of the case requires.

10. An Appellant whose Appeal has been admitted shall prosecute his Appeal in accordance with the Rules for the time being regulating the general practice and procedure in appeals to His Majesty in Council.

11. Where an Appellant, whose Appeal has been admitted, desires, prior to the dispatch of the Record to England, to withdraw his Appeal, the Court may, upon an application in that behalf made by the Appellant, grant him a certificate to the effect that the Appeal has been withdrawn, and the Appeal shall thereupon be deemed, as from the date of such certificate, to stand dismissed without express Order of His Majesty in Council, and the costs of the Appeal and the security entered into by the Appellant shall be dealt with in such manner as the Court may think fit to direct.

12. Where an Appellant, whose Appeal has been admitted, fails to show due diligence in taking all necessary steps in connection with the preparation of the Record, the Court may, either on its own motion or on the application of the Respondent, call upon the Appellant to show cause why a certificate should not be issued that the Appeal has not been effectually prosecuted by the Appellant, and if the Court sees fit to issue such a certificate, the Appeal shall be deemed, as from the date of such certificate, to stand dismissed for non-prosecution without express Order of His Majesty in Council, and the costs of the Appeal and the security entered into by the Appellant shall be dealt with in such manner as the Court may think fit to direct.

13. Where at any time between the admission of an Appeal and the dispatch of the Record to England the Record becomes defective by reason of the death, or change of status, of a party to the Appeal, the Court may notwithstanding the admission of the Appeal, on an application in that behalf made by any person interested, grant a certificate showing who, in the opinion of the Court, is the proper person to be substituted, or entered, on the Record, in place of, or in addition to, the party who has died, or undergone a change of status, and the name of such person shall thereupon be deemed to be so substituted or entered on the Record as aforesaid without express Order of His Majesty in Council. If, in the opinion of the Court, there has been undue delay in making this application, the Court may order the Appellant, or the party interested, to take all necessary steps to perfect the Record within such time as the Court may direct, and, if he fails to comply with such Order, the Court may call upon him to show cause why a certificate should not be issued that the Appeal has not been effectually prosecuted, and if the Court sees fit to issue such a certificate, the Appeal shall be deemed, as from the date of such certificate, to stand dismissed for non-prosecution without express Order of His Majesty in Council, and the costs of the Appeal and the security entered into by the Appellant shall be dealt with in such manner as the Court may think fit to direct.

14. Where the Record subsequently to its dispatch to England becomes defective by reason of the death, or change of status, of a party to the Appeal, the Court may, upon an application in that behalf made by any person interested, cause a certificate to be transmitted to the Registrar of the Privy Council showing who, in the opinion of the Court, is the proper person to be substituted, or entered, on the Record, in place of, or in addition to, the party who has died, or undergone a change of status. If, in the opinion of the Court, there has been undue delay in making this application, the Court may order the Appellant, or the party interested, to take all necessary steps to perfect the Record within such time as the Court may direct, and if he fails to comply with such Order, the Court shall report the matter to the Registrar of the Privy Council.

15. These Rules shall come into operation on the 1st day of January 1921, or on such other date as the Governor General of India in Council may determine.

GENERAL DEPARTMENT.

Bombay Castle, 10th May 1920.

No. 5321.—In exercise of the powers conferred by section 1 (4) (b) of the Bombay Prevention of Adulteration Act, 1899 (Bom. II of 1899), His Excellency the Governor in Council is pleased to direct that sections 2, 3 and 4 of the said Act, and sub-section (2) of section 142 of the Bombay District Municipal Act, III of 1901, shall come into force within the Municipal District of Mahábleshwar with effect from the 15th June 1920, and His Excellency the Governor in Council is pleased further to direct, under section 1 (5) (a) (ii) of the first-named Act, that the provisions of this Act shall, for the time being, not be applicable in the said Municipal District to any food other than milk, ghee and butter.

No. 5261.—In exercise of the powers-under section 2 of the Epidemic Diseases Act, 1897 (III of 1897), conferred by the Notification of the Government of India in the Department of Education (Sanitary) No. 566, dated 10th September 1919, the Governor in Council is pleased to prescribe in the Bombay Presidency, excluding the City of Bombay, the following temporary regulations to prevent the outbreak or spread of Influenza and Acute Pneumonia, namely :--

Influenza Draft Regulations.

1. Appointment of special officer.—In every local area which is threatened with an outbreak of Influenza or Acute Pneumonia the District Magistrate, subject to the general instructions of the Commissioner, may appoint either by name or by virtue of his office a special officer or officers to carry out all measures necessary to prevent the spread of these diseases.

2. Notification of outbreak.—(a) The District Magistrate shall cause to be published in every town or village in any area infected or threatened with Influenza or with Acute Pneumonia or with a disease suspected to be Influenza, a list of infected towns and villages in that area with the names of the special officers concerned: any area in the towns and villages of which such a list has been published shall be deemed to be an infected area.

(b) When any outbreak of Influenza or Acute Pneumonia or a disease suspected to be either occurs in his district, the District Magistrate shall forward to the District Magistrates of neighbouring districts a list of infected towns and villages for publication when deemed necessary. When the outbreak occurs or threatens in a pilgrim centre, he shall in addition send intimation to the District Magistrates of districts from which the pilgrims come.

3. Intimation of cases.—(a) In any town or village in an infected area every person shall, on such occurrence coming to his knowledge, give immediate information to the Municipal Secretary or to the Revenue Patel of (a) any human sickness or death, and (b) the arrival of any person from a place declared infected in any list published under regulation 2 (a).

(b) The Municipal Secretary or Revenue Patel shall, on receiving such information, send intimation thereof to the Mámlatdár or Mahálkari and to the Deputy Sanitary Commissioner of the district.

(c) In the case of any human sickness or death occurring on a railway in an infected area or on the arrival by rail in such area of a person from any place declared infected in any list published under rule $2(\alpha)$, the chief local Railway Officer in such area shall give intimation as prescribed in clause (b) of this regulation.

4. Segregation and disinfection.-The special officer may adopt such measures as he thinks necessary for-

- (a) isolating the patient, and
- (b) disinfecting clothes, vehicles or other property which have been exposed to infection.

5. Publication of remedies.—The special officer shall arrange for the publication, by beat of tom tom and by periodical distribution of leaflets in the local vernacular, of measures of protection against the disease.

6. Disinfection of buildings.—The special officer may require the occupier or owner of any building or enclosure in which a case of Influenza or Acute Pneumonia or a case suspected to be either has occurred, to carry out such measures as he considers necessary for the purpose of disinfecting or of improving the sanitary condition of such building or enclosure. He is also empowered to enter any building or enclosure and to order its disinfection, if he has reasonable cause to suspect that any portion of it has been recently occupied by a person suffering from either disease. 7. Bazaars. Markets, Fairs.—The District Magistrate may order, in the case of an infected town or village, that the bazaar, market or fair be held outside the inhabited area and at such distance therefrom as he may prescribe.

8. Requisition of Buildings.—The District Magistrate may take possession of and occupy any vacant ground or building for the purpose of a camp or hospital or dispensary. Such rent or compensation as may be agreed upon shall be paid to the owner or occupier or other person entitled thereto. In default of agreement, the amount payable shall be decided by arbiters, one appointed by the District Magistrate, one by the claimant and a third by the two arbiters so appointed : a majority decision of the arbiters shall be final and binding on both parties.

9. Destitute Patients.—The special officer, when he learns that any person suffering from Influenza or Acute Pneumonia is left uncared for, shall arrange to take him to the nearest Hospital.

10. Public Meetings.—If it appears to the District Magistrate that any public meeting, theatrical or cinema performance or any gathering of persons in any hall, theatre or public building is likely to sprgad either disease he may, after giving due notice to the convenors or management of such meeting, gathering or performance, prohibit the holding of the same for such time as he may consider necessary. He may also close schools.

11. Spitting in Public Places.—The District Magistrate may prohibit spitting in the streets or in any public place or building.

12. Public Conveyances, Waiting Rooms, etc.—In regulations 13, 14 and 15 the term "public conveyance" shall be deemed to include tramway and railway rolling stock and such of the provisions of these regulations as are applicable to public conveyances shall apply, as far as may be, to premises such as waiting rooms, offices, etc., used in connection therewith.

13. Conveyance of infected person prohibited.—No person owning or in charge of a public conveyance shall permit a person whom he has reason to believe to be suffering from Influenza or Acute Pneumonia to enter such conveyance.

14. Infected travellers.—If any person while using a public conveyance develops Influenza or Acute Pneumonia, the person in charge of such conveyance shall be responsible for—

- (a) removing the person so infected;
- (b) arranging for his accommodation and treatment at the nearest suitable place;
- (c) notifying the facts to the relatives of the patient and to the local civil authority prescribed in regulation 3 (a); and
- (d) properly disinfecting the conveyance used by the patient before it is again used.

15. Examination of travellers.—The special officer shall have power at any halting place or station to enter and examine any person using any public railway conveyance: but such examination shall not entail the detention of the conveyance for a longer time than is fixed for its detention at such place or station.

16. Overcrowding of railway carriages.—It shall be the duty of every railway servant to remove from a compartment the number of passengers in excess of the maximum fixed for such compartment by the railway administration and to insist on sufficient windows being kept open to ensure proper ventilation.

17. Co-operation of the Police.—All police officers shall afford a special officer all necessary assistance in carrying out the provisions of these regulations.

18. Compliance with regulations.—Every person to whom any order or requisition is directed under these regulations shall duly comply with the same, and no person shall obstruct any one in the performance of any duty imposed by or under these regulations.

19. Penalty.-Whoever shall disobey any of these regulations or any order made thereunder, shall be liable to be prosecuted under section 188, Indian Penal Code.

20. Short Title: Extent: Local modifications.—The foregoing regulations shall be called the Bombay Influenza Regulations and shall apply throughout the Bombay Presidency (excluding the City of Bombay) subject to the following modifications in the case of Cantonments and Hill Stations in charge of Superintendents :—

In the case of Cantonments substitute "General Officer Commanding" for "Commissioner" and "Cantonment Authority" for "District Magistrate".

In the case of Hill Stations in charge of Superintendents, substitute "Superintendent" for "District Magistrate".

EDUCATIONAL DEPARTMENT.

Bombay Castle, 26th April 1920.

No. 1842.—Under sections 21 and 22 of the Indian Universities Act, VIII of 1904, the Governor in Council is pleased to sanction the affiliation of the Rajaram College, Kolhápur, to the Bombay University with effect from the 20th June 1920 as a full grade College for the purpose of teaching the B.A. course subject to the conditions specified below :-

- (1) At present the affiliation should only be for the Pass Degree in the following subjects : English, Sanskrit, Persian, Optional English, Mathematics, History and Economics, Philosophy. The University will be prepared to consider the question of affiliation for Honours in certain subjects in 1922 after the first batch of graduates wholly trained in the College have passed out.
- (2) The financial arrangements between the College and the Arya Pratinidhi Sabha should be placed on a definite basis and the amount which the Sabha will devote to the use of the College each year should be communicated in writing to the University and approved by the Syndicate.
- (3) The financial arrangements made between the Arya Pratinidhi Sabha and the Maharaja of Kolhápur should also be communicated to the University, together with a statement of the time during which the subsidies promised by the Maharaja are definitely to continue, and these should be considered as satisfactory by the Syndicate.
- (4) The College should acquire the right of inspection of the various community hostels in which students of the College live in Kolhápur, and should also be allowed representation on the body which controls each of these hostels.
- (5) The affiliation should not become operative until the High School has been removed from the buildings at present occupied and all the buildings made over for College use.
- (6) The following should be the maximum number of students allowed in the various classes of the College :-

No. 4430.-The following Notification by the Government of India, Home Department, is republished :--

" POLICE.

No. 719, dated Simla, the 23rd April 1920.

The following regulations relating to appointments to the Indian (Imperial) Police Service in 1920 are published for general information.

2. The Secretary of State for India in Council proposes not to hold any competitive examination during the year 1920, for admission into the Indian (Imperial) Police Service, but to make a number of appointments of probationers by nomination as described below from among gentlemen who have rendered military service during the war.

3. Number of Appointments.—Appointments will be made in the United Kingdom by the Secretary of State for Iudia in Council and in India by the Government of India from among candidates who at the time of application were resident in India or adjacent countries, including Mesopotamia. The precise number of appointments to be made in the United Kingdom and in India will be announced hereafter.

4. Method of application for appointments made in the United Kingdom.— For the appointments to be made in the United Kingdom a qualifying examination will be held, for admission to which applications must be made to the Civil Service Commissioners, London, on the prescribed form, accompanied by a fee of 5s. The application form must reach the Civil Service Commissioners not later than the 29th May 1920.

5. Method of application for appointments made in India.*—Applications must be made on the annexed form (copies of which can be obtained on application to the nearest staff office) to the Adjutant General in India, Simla. Such applications will be accepted up to the 15th June 1920 from candidates in India and up to the 30th June 1920 from candidates overseas. Candidates will in due course receive from the Adjutant General in India, any further information or instructions that may be necessary.

[Warning.—Any attempt on the part of a candidate to enlist support for his application through officers of Government or other influential persons will disqualify him for appointment. The Selection Committee will disregard spontaneous recommendations from persons who are not personally acquainted with the candidate's work, whether at school, at the University, in the Forces or otherwise.]

6. Conditions of Eligibility.-

(a) Every candidate must have been born on or after 2nd June 1894 and on or before 1st August 1900.

(b) Every candidate must be a British subject and at the time of his birth his father must also have been a British subject.

(c) Every candidate must have served in His Majesty's Naval, Military, or Air Forces during the war.

(d) Every canditate must be of good character in civil and military life.

(e) Candidates for the appointments made in India by the Government of India must satisfy the latter, or the Selection Committee appointed by them on that behalf that they have received whole-time continuous and systematic education up to the age of 18, or until the date of entering His Majesty's Forces, whichever is the earlier, and must undergo a qualifying examination⁺ in English, Arithmetic, and General Knowledge. English will include essay writing, précis writing and other tests. General Knowledge will include matters historical, economic, social, political, geographical and scientific.

7. Those candidates who satisfy all the conditions referred to above and are considered suitable will be summoned to an interview before a Selection Committee who will prepare a list of candidates suitable for appointment, subject to medical examination and submit their recommendations for the orders of the Government of India.

Note.---A candidate who applied for appointment in 1919 but was not selected is not debarred from applying again for one of the appointments to be made in 1920.

8. Medical Examination.—Candidates who are recommended for appointment will be required to undergo an examination as to their physique and capacity for active outdoor work in the plains of India.

* Rules applicable to the case of Indian candidates were published in a Press Communiqué on the 21st November 1919.

+ The qualifying examination will begin on the 29th July 1920 at centres to be notified hereafter.

9. *Riding.*—Selected candidates will be required either to give satisfactory proof of their ability to ride or to undergo such riding tests as may be hereafter prescribed.

10. Allotment to Provinces.—Selected candidates will be allotted as probationers to the various provinces in India upon a consideration of all the circumstances, including their own wishes; but the requirements of the public service will rank before every other consideration. The allotments will also be subject to the right of the Government of India to make transfers if necessary.

11.—(a) Uniform.—It is an ordinary condition of appointment that a successful candidate shall provide himself, or be provided by his parents or guardians, with his uniform or the cost thereof. Government makes a contributory grant of £30 towards the cost of uniform.

(b) Horse and Saddlery.—A successful candidate must, when required to do so by Government, provide himself with a suitable horse and saddlery at his own expense. Local Governments in India are authorised to make to a newly appointed officer a grant of a sum not exceeding Rs. 600 towards the cost of such horse and saddlery.

12. Joining the Police Service.—Subject to what is stated in the next paragraph as regards the taking of leave before joining civil appointment, probationers will be required to join their appointments, if possible, within a short time of their final selection. Failure to do this will, in the absence of satisfactory explanation, lead to forfeiture of appointment.

13. Leave before joining civil appointment.—Each selected candidate will be granted leave at the rate of one month for each year of military service subsequent to his last departure from England, subject to a maximum of four months. He will receive, while on leave, the full pay of his new civil appointment. Every selected candidate who has earned the full period of leave admissible will be required to take it immediately after his release from military service and before joining his civil appointment. A selected candidate who has earned less than the maximum of four months will have the option of either taking the amount earned forthwith, or of joining his civil appointment with that amount to his credit and taking it later combined with civil leave earned in the meanwhile. In such a case combined leave on full pay will be limited to four months.

As the restriction of this concession to military service subsequent to a candidate's last departure from England might operate harshly in some cases, the Secretary of State has authorised the Government of India to relax this condition where it is considered necessary.

Any officer taking leave under these arrangements will receive a free passage from England to India on the expiry of his leave. In the event of his being discharged from the police service within three years of the date of his appointment on any ground, other than that of ill-health, he will be liable to refund to the Government the cost of any free passage granted him under these leave rules.

14. Rates of pay, and pay during probation.—The rates of pay are set out in Appendix I.

In the case of candidates selected under these Regulations the following modification of the normal scale has been approved. Those whose ages on the 1st August preceding their reporting themselves for duty were as stated below will receive pay in the time scale as follows, viz. :--

The pay of a probationer commences from the date on which he reports to the authorities for duty.

15. Period of probation.—Probationers will be required to qualify by passing the necessary departmental examinations (as well as the riding test, if required—see Regulation 9) within two years of their appointment.

16. Liability of probationers to removal.—Any probationer who may fail to pass the prescribed examinations within two years or be found unfit for police duties will be liable to removal from the service. Any probationer so removed from the service will be furnished with a free passage to England provided that he utilises such passage within three months from date of such removal.

It should be understood that the probation to be undergone by selected candidates will be of a real character.

17. Seniority.-Candidates appointed during 1919 and 1920 will all be graded inter se strictly according to age.

18. Promotion after probation.—No probationer will be eligible for promotion for acting or substantive posts until he has passed the prescribed departmental examinations, including the riding test.

19. Leave, Pension and Provident Fund.—Officers joining the Indian Police under these conditions will find a summary of information regarding leave, pension, and provident fund in Appendices II, III and IV. The Secretary of State for India in Council has decided that service in His Majesty's Naval, Military or Air Forces during the war, including sick leave, shall count, as stated below, for retiring and invalid pension:—

4. The time scale in paragraph 2 above will cover the appointments of Assistant Superintendent of Police and District Superintendent of Police.

5. The overseas allowances set out in columns 3 and 6 of the table in paragraph 2 above (which will reckon as pay for all purposes of the Civil Service Regulations) will be admissible only to officers of non-Indian domicile.

• These appointments are not set apart exclusively for members of the Police Department, and the Government reserves discretion to fill them by the selection of any officers who are considered best fitted for them, whether in the Department or outside it.

APPENDIX II. (See para. 19 of the Regulations.)

[Norg.—Appendices II and III are merely intended to show the principal leave and pension rules in the Civil Service Regulations at present applicable to the Indian (Imperial) Police Service without going into minute details, and do not profess to deal with every case that may arise. The rules are subject to alteration, and any disputed question must be decided with reference to the authorised text of the Civil Service Regulations for the time being.]

LEAVE.

1. The following is a summary of the principal regulations relating to the leave admissible to officers appointed to the Indian (Imperial) Police Service.

Long Leave.

- 2. Furlough with allowances (see para. 5) is admissible to an aggregate maximum amount of six years during an officer's service.

3. The amount of furlough "earned" is one-fourth of an officer's active service, and the amount "due" is that amount less any enjoyed.

4. Except as provided in Rule 7, furlough without medical certificate is limited to the amount "due" and may not exceed two years at a time. On medical certificate furlough may be extended to three years.

- 5. The allowances admissible during furlough are-
 - (1) During any period of furlough not exceeding two years half average salary, subject to certain maximum and (in the case of furlough with medical certificate) minimum limits.
 - (2) After the expiration of the first two years of any period of furlough, one quarter of average salary, subject to certain maximum and minimum limits.

6. Furlough on half average salary (see para. 5) may be commuted into leave on higher pay, subject to the following conditions :---

- (1) The leave on higher pay, or "commuted furlough," is fixed at one-half of the furlough commuted.
 - (2) The amount of furlough which may be commuted during an officer's total service is limited to two years.
- (3) The commuted furlough will carry an allowance at the rate of average salary, subject to a maximum of 2,400l. a year.
- (4) Subject to special consideration in exceptional circumstances, an officer must have six months' furlough at his credit at the end of the "commuted furlough," or any leave granted to him in continuation of it.
- (5) In any one period of leave not more than eight months may be spent on "commuted furlough" or on "commuted furlough" combined with privilege leave.
- (6) For the purpose of the rules governing the extent to which leave taken out of India may be allowed to count as service for pension, time spent out of India on "commuted furlough" will be reckoned according to its actual duration, and not according to the duration of the furlough in exchange for which it is granted.

7. In respect of urgent private affairs, an officer may be granted furlough in excess of the amount "due" for a period not exceeding six months at one time or 12 months in the whole of his service.

Short Leave.

8. Privilege Leave is a holiday which may be granted to the extent of one-eleventh part of the time that an officer has been on duty without interruption; and it may be accumulated up to four months.

Subject to certain conditions Privilege Leave may be combined with furlough or extraordinary leave without pay.

9. Joining time for a short period, usually with half average salary, is granted to an officer returning from leave out of India to enable him to rejoin his appointment.

10. Short Leave is also granted to enable officers to appear at examinations, etc.

11. Extraordinary Leave without allowances may be granted in case of necessity and, except in certain specified cases, only when no other kind of leave is by rule admissible. It may be granted in continuation of other leave.

[PART I

General.

12. Leave of absence, whether on furlough or on privilege leave, can never be claimed as of right, and is given or refused at the discretion of Government.

APPENDIX III. (See para. 19 of the Regulations.)

(See Note at commencement of Appendix II.)

PENSIONS.

1. The following is a summary of the pension rules applicable to officers of the Indian (Imperial) Police Service.

2. Subject to the absolute right of the Government of India to decline to permit any officer to retire before reaching the age for superannuation, should it be necessary in the public interest to retain his services, officers will be allowed to retire optionally after 25 or more years' service.

3. Retirement is ordinarily required at the age of 55 years, but for special reasons an officer is sometimes retained after attaining that age.

4. An officer becomes eligible for full retiring pension on completing 30 years' qualifying service.

5. If before completing this period of service an officer is permitted to retire voluntarily after completion of 25 or more years' qualifying service (para. 2), or is compelled to retire on attaining the age of 55 (para. 3), or through ill-health not occasioned by irregular or intemperate habits, he will be eligible for a reduced pension or, if invalided with less than 10 years' qualifying service, for a gratuity.

6. The amount of pension or gratuity is regulated as follows :--

7. Government may retire any officer after he has completed 25 years' service without giving reasons, and without admitting any claim to compensation in addition to pension, and in that event the pension admissible to him will ordinarily be regulated on a scale not exceeding that laid down above. Government also reserves the general power to reduce the pension ordinarily admissible in all cases where an officer's service has been unsatisfactory.

Additional Pensions.

8. The Government of India have classified certain high appointments into two grades, the lower comprising those posts which involve high but intermediate responsibility, the higher consisting of those which require a marked degree of independent administrative and professional capacity. Officers who have held appointments in the lower grade will be entitled to an additional pension at the rate of Rs. 300 per year of service in any appointment included in that grade, provided that no officer may draw an additional pension in excess of Rs. 1,500 in respect of service classed in the lower grade. Officers who have held appointments classed in the upper grade will be entitled to an additional pension at the rate of Rs. 500 for each year of service rendered in any appointment included in that grade, provided that no officer may draw an additional pension in excess of Rs. 2,500 in respect of service rendered in the lower grades combined or in the upper grade alone.

9. These additional pensions will be awarded only to officers who have given proof of special energy and efficiency, and will be subject to the condition that an officer must not retire voluntarily before the age of 55 with less than 28 years' service.

The upper grade includes :--

Inspectors-General of Police (except Inspector-General of Police, North-West Frontier Province, and Inspector-General, Railway Police, Rajputana).

Director of Central Intelligence.

Commissioners of Police, Calcutta and Bombay.

The lower grade includes :---

Inspector-General of Police, North-West Frontier Province, and

Inspector-General, Railway Police, Rajputana.

Deputy Inspectors-General of Police.

Commissioners of Police, Madras and Rangoon.

APPENDIX IV.

PROVIDENT FUND.

A general Provident Fund, to which contribution is compulsory, has also been established on the following basis :---

- (1) The contribution is compulsory up to 64 per cent. on salaries, with voluntary contributions of not more than a further 93 per cent. Subscriptions on leave of any kind are optional.
- (2) Compound interest on such payments is annually credited by Government to each officer subscribing.
- (3) The sum which thus accumulates to the credit of an officer is his absolute property, subject to the rules of the Fund, and is handed over to him, unconditionally, on quitting the service; or, in the event of his death before retirement, to his legal representatives or such other person or persons as, under and subject to the rules of the fund for the time being in force, may be entitled thereto.

No. E.-10320 .- The following Regulations by the Government of India, Public Works Department, are republished :--

"INDIAN PUBLIC WORKS DEPARTMENT AND INDIAN STATE RAILWAYS.

REGULATIONS AS TO APPOINTMENT OF ASSISTANT EXECUTIVE ENGINEERS IN 1920.

[The Secretary of State is unable to give any undertaking that the Regulations will remain unaltered in the future.]

1. Until further notice the Secretary of State for India in Council will, during each year, make a number of appointments of Assistant Executive Engineers in the Public Works and State Railway Departments of the Government of India.

In making these appointments he will act with the advice of a Selection Committee, including at least one eminent representative of the Engineering profession.

In 1920 it is intended that 17 appointments of Europeans and 2 of Indians should be made.

The Selection Committee will probably sit in July.

2. Applications must be made on a printed form, which may be obtained from the Secretary, Public Works Department, India Office, Whitehall, S. W. 1, or, in the case of officers in India and Mesopotamia, from the Secretary to the Government of India, Public Works Department, Simla. Applications must be received at the India Office not later than 30th June.

3. An Indian candidate must have attained the age of 21 and not attained the age of 24 years on the first day of July of the year in which he offers himself for appointment.

Every European candidate must have been born on or after the 2nd August 1893 and on or before the 1st August 1898.

[N.B.—Indians must obtain a certificate of age and nationality in the form explained in Appendix II. As the production of this certificate is a necessary condition of appointment intending candidates are advised to procure it without delay. The certificate should be forwarded to the India Office together with the candidate's form of application or at the earliest subsequent opportunity.]

4. Every European candidate in 1920, subject to the exception stated below, must have. served in His Majesty's Naval, Military or Air Forces during the war for at least one year, or if his service be less than one year, have been discharged on account of wounds or sickness resulting from such service.

In the case of Europeans who have been prevented on adequate grounds from joining His Majesty's Forces, applications to be exceptionally admitted as candidates may be made to the India Office for consideration.

5. Every European candidate must be a British subject and, except as provided in Regula-tion 6, if he or his father or his mother was not born within His Majesty's Dominions and allegiance, the father must at the time of the candidate's birth have been a British subject and allegiance, the lather must at the time of the candidate birth have been a British subject and still be (or have continued to be until his death) a British subject. The decision of the Secretary of State in Council whether a candidate satisfies these conditions shall be final. A candidate must also be of good moral character and sound bodily health and, in the opinion of the Secretary of State for India in Council, in all respects suitable to hold an appointment in the Indian Public Works Department or State Railway Department.

6. Indians are eligible for the appointments open to them provided that they are British subjects or that the Governor-General in Council has made a declaration under section 96a of the Government of India Act, 1915, as amended by section 3 of the Government of India (Amendment) Act, 1916, that they are to be considered eligible.

7. Applications from European candidates in India and Mesopotamia should be forwarded direct to the Secretary, Public Works Department, India Office, Whitehall, London, S. W. I. These applications will be examined by the Selection Committee at the India Office, and any candidate who may be considered fit for appointment will be required to appear in person before a Local Advisory Committee in India.

8. Indian candidates must produce evidence that they have either (1) obtained one of the University degrees mentioned in Appendix I; or (2) passed sections A and B of the A.M.I.C.E. examination; or (3) obtained such other diploma or distinction in Engineering as the Secretary of State may decide to accept in any particular case. It is preferred that candidates should have taken a college course and obtained one of the degrees mentioned in Appendix I. It is advisable that in addition they should have had at least one full year's practical experience of Civil Engineering under a qualified civil engineer at the time when they appear before the Selection Committee. Those whose qualifying diploma has been obtained without a college course should have had a full three years of such practical experience. three years of such practical experience.

9. European applicants eligible under Rule 4 who can produce evidence of the above qualifications will be admitted as candidates; others not holding one of the recognised degrees or diplomas must produce evidence-

- (a) of having received a general education high enough to fit them to receive proper professional training and to become members of the Engineering profession ;
- (b) of having received some technical education (University or otherwise) in Engineering ; and
- (c) of having had some practical training and experience in Engineering as civilians and in military or quasi-military service.

An applicant who has served or is serving at the time of his application, must produce, if possible, a report by his Commanding Officer on his character, administrative capacity and powers of organisation, and aptitude, natural bent, and Engineering experience.

10. In the event of any candidate being selected who has not, in the opinion of the Selection Committee, had sufficient practical experience, he may be required to undergo, after arrival in India, such period of probation in charge of works as may be decided upon, and his final appointment will be made dependent upon the result of such probation.

11. Candidates must be prepared, if called upon, to attend at the India Office, at their own expense, for a personal interview with the Selection Committee. Applicants in India (see Rule 7 above) must be prepared to attend before the Local Advisory Committee authorised by the Government of India to investigate their candidature.

12. Candidates will further be required, before final appointment by the Secretary of State in Council, to appear, at their own expense, before the Medical Board at the India Office for examination as to their physical "tness for service in India, or in case of applicants selected with-out attendance at the India Office, before such Medical Board as the Government of India may appoint.

The Regulations governing the physical examination of candidates for the Public Works and State Railway Departments of the Government of India are given in Appendix III.

*13. Selected candidates will also be required to satisfy the Secretary of State of their ability to ride.

14. They will on appointment be provided with a free first-class passage to India and they will be expected to proceed thither about the end of September or later in the year in which they are appointed.

Their pay will begin from the date of their landing in India, and if they so desire, they will be able to obtain an advance of two months' pay recoverable by month'v instalments of one-third of salary. Of this advance a portion not exceeding one-half may be drawn in England. The pay of candidates appointed in India will begin from the date of reporting for duty as they may be directed.

15. If less than 24 years of age on 1st August 1920, European candidates will enter the service as Assistant Executive Engineers on a salary of Rs. 6,300 a year. If above 24 years, they will be credited with service as though they had been appointed in their 24th year. The years of service so credited will subsequently count for purposes of pay and promotion, but not for leave.

Service in His Majesty's Forces will count for active and total service for pension (includ-16. ing invalid pension) as follows:—Candidates who have attained the age of 25 and are under 27 on Ist August preceding arrival in India, will be allowed to count a period not exceeding one year, provided such period was spent on active war service, including sick leave. Candidates of 27 years and over will similarly be allowed to count a period not exceeding two years subject to the same proviso.

The instruments required by Assistant Executive Engineers are supplied to them in India. 17.

Particulars as to pay, pension, etc., are contained in Appendices IV and V. 18.

* Selected candidates will be examined by the Civil Service Commissioners as to their ability to ride, and will be required to obtain either-

(a) a certificate from the Civil Service Commissioners that they are sufficiently at home in the saddle for the efficient performance of all the duties of the Indian Public Works and State Railway Departments ; or

(b) a certificate from the Civil Service Commissioners of minimum proficiency in riding. In the latter case they will be subjected, on their arrival in India, to such further tests in riding as may be prescribed by their Government.

Oandidates are warned that the certificate of minimum proficiency in riding, without which they will not be allowed to proceed to India, is only granted to those who can qualify in a series of tests, which includes jumping.

The chief tests will be saddling and bridling ; mounting and dismounting ; trotting and cantering ; riding at a trot without stirrups ; riding at a trot without reins ; jumping a hedge hurdle about 3 feet in height.

Although the examination will, in the main, be confined to these points, the examiner will not be debarred from applying any other tests which may appear desirable.

Knowledge of the principles of road-making, waterworks, sanitary and railway engineering. (Important.)

The Selection Committee were further of opinion that all candidates should have had some workshop training.

The degrees shown in Lists A and B are accepted without reservation in the case of candidates who matriculated on or before 30th June 1914. The special conditions applicable to candidates who matriculated on or after 1st July 1914 are stated in the Notes appended to the two lists.

Candidates who rely on a degree in 'Mechanical' or 'Electrical' Engineering or in 'Naval Architecture ' should have had at least one year's practical experience in Civil Engineering.

APPENDIX II.

PARTICULARS REGARDING THE CERTIFICATE OF AGE AND NATIONALITY TO BE OBTAINED BY CANDIDATES WHO ARE NATIVES OF INDIA.

A.—Rules for Candidates born within His Majesty's Dominions.

1. A candidate who is resident in British India must obtain a certificate signed either (a) by the Secretary to Government (or his lawful deputy) of the province in which his family resides, or (b) by the Commissioner (or his lawful deputy) of the District in which his family resides.

A candidate who is resident in a Native State must obtain a certificate signed by the highest Political Officer (or his lawful deputy) accredited to the State in which his family resides.

3. The certificate required must be in the following form :-

and the nature of the evidence produced must be such as to satisfy the officer who issues the certificate.

The documentary evidence which a candidate may be expected to produce in order to 4 obtain such certificate comprises :-

- (a) The horoscope.
- (b) Family books.
- (c) Tradesmen's account books showing entries relating to the birth.
- (d) The record of admission in the registers of the school in which the candidate was educated, and the record of the candidate's age at various periodical school examinations.
- (e) If the candidate is matriculated, a certified copy of his application to the Registrar in Form A.

Oral testimony from persons able to give relevant evidence may also be taken.

5. If a candidate has proceeded to England without obtaining a certificate, the certificate may be granted to his father or guardian on production of the requisite evidence.

B .- Rules for Candidates not born within His Majesty's Dominions.

6. The rules are the same as the foregoing except that a candidate not born within His Majesty's dominions must also prove that he is the son or grandson of a person born in those dominions, and in his case the form of certificate must be not as in paragraph 3 above but as follows :-

APPENDIX III.

REGULATIONS AS TO THE PHYSICAL EXAMINATION OF CANDIDATES FOR APPOINTMENT TO THE PUBLIC WORKS DEPARTMENT OF THE GOVERNMENT OF INDIA.

Note.—These regulations are published for the convenience of candidates and in order to enable them to ascertain the probabi-bity of their coming up to the required physical standard. But it must be clearly understood that the Scoretary of State reserves to himself an absolute discretion to reject as unfit any candidate whom he may consider, after hearing the opinion of his medical advisers, to be physically disqualified for the public service ; and that his discretion is in no respect limited by these Regulations.

It is not the practice to communicate to candidates who may be reported as physically unfit for service in India the reasons for the Medical Board's opinion.

General Physical Requirements.

1. A candidate must be in good mental and bodily health, and free from any physical defect likely to interfere with efficient performance of duty.

2. In the examination of candidates the Medical Board will apply the following table of correlation of age, height and chest girth :--

3. Measurement of Height.—The candidate will be placed against the standard with his feet together, and the weight thrown on the heels, and not on the toes or outside of the feet. He will stand erect without rigidity, and with the heels, calves, buttocks and shoulders touching the standard; the chin will be depressed to bring the vertex of the head level under the horizontal bar, and the height will be noted in parts of an inch to eighths. In the Indian Police Force a minimum height of 5 feet 4 inches is required, but in other Departments no fixed limit of height is imposed.

4. Measurement of Chest.—The candidate will be made to stand erect with his feet together, and to raise his hands above his head. The tape will be carefully adjusted round the chest, with its posterior upper edge touching the inferior angles of the shoulder blades, and its anterior lower edge the upper part of the nipples. The arms will then be lowered to hang loosely by the side, and care will be taken that the shoulders are not thrown upwards or backwards so as to displace the tape. The candidate will then be directed to empty his chest of air as much as is possible. This is best done by continuous whistling with the lips as long as sound can be produced. The tape is carefully gathered in during the process, and when the minimum measurement is reached it is recorded. The candidate will then be directed to inflate his chest to its utmost capacity. This maximum measurement will likewise be noted. The girth with the chest fully expanded and the range of expansion between the minimum and the maximum will then be recorded.

5. The hearing must be good.

6. The speech without impediment.

7. The teeth in good order, *i. e.*, decayed or broken teeth must be properly stopped or crowned and deficient teeth replaced by artificial teeth where necessary for effective mastication.

8. The chest must be well formed, the lungs and heart sound.

9. Rupture, hydrocele, varicocele, varicose veins in a severe degree, or other condition likely to cause inefficiency will disqualify a candidate, unless such condition is cured by operation.

10. The limbs, feet, and toes must be well formed and developed, with free and perfect motion of all the joints.

11. A candidate must have no congenital malformation or defect likely to interfere with efficiency.

12. A candidate must not be the subject of chronic skin disease.

13. Evidence of previous acute or chronic disease pointing to an impaired constitution will disqualify.

14. The regulations as to the standard of vision required are shown separately for each department. In all cases of 'colour blindness' a note of the same will be made on the candidate's papers.

Candidates may, if they wish it, undergo a preliminary examination by the Medical Board which meets at the India Office every Tuesday, under the following conditions :---

(α) Applications must be addressed to the Under Secretary of State, India Office, Whitehall, London, accompanied by a fee of two guineas, and a statement as to the particular appointment which the candidate desires to obtain.

(b) Candidates must pay their travelling expenses.

(c) Candidates considered to be unfit by the Medical Board at this preliminary examination are not bound to accept its opinion, but may, at their own risk continue their studies, with the knowledge that they will have to submit themselves for a final medical examination by the Medical Board, prior to the examination, or to their appointment.

(d) On the other hand, it must be distinctly understood that the preliminary examination by the Medical Board is held solely for the candidate's information, and that, if after that

examination he is reported to be apparently fit, he has not on that account any claim to be accepted as physically fit when he presents himself for the final Medical Examination, upon which alone his acceptance or rejection will depend. Candidates may be considered fit for the service at the preliminary examination, but may be found at the final examination to be unfit, either on account of some physical defect which did not exist or passed undetected at the preliminary examination, or for other reasons.

REGULATIONS AS TO THE STANDARD OF VISION.

1. If myopia in one or both eyes exists, a candidate may be passed provided the ametropia does not exceed 3.5 D, and if, with correcting glasses not exceeding 3.5 D, the acuteness of vision in one eye equals $\frac{6}{9}$, and in the other $\frac{6}{8}$, there being normal range of accommodation with the glasses.

2. Myopic astigmatism does not disqualify a candidate, provided the lens, or the combined spherical and cylindrical lenses, required to correct the error of refraction, does not exceed 3 5 D; the acuteness of vision in one eye, when corrected, being equal to §, and in the other §, together with normal range of accommodation with the correcting glasses, there being no evidence of progressive disease in the choroid or retina.

A candidate having total hypermetropia not exceeding 4 D is not disqualified, provided the sight in one eye (when under the influence of atropine) equals §, and in the other eye equals §, with + 4 D glasses, or any lower power.

4. Hypermetropic astigmatism does not disqualify, provided the lens or combined lenses required to cover the error of refraction do not exceed 4 D, and that the sight of one eye, equals \$, and the other 6, with or without such lens or lenses.

5. A candidate having a defect of vision arising from nebula of the cornea is disqualified if the sight of one eye be less than f_{2}^{i} . In such a case the better eye must be emmetropic. Defects of vision arising from pathological or other changes in the deeper structures of either eye, which are not referred to in these rules, may exclude a candidate.

6. Squint or any morbid condition, subject to the risk of aggravation or recurrence, in either eye, may cause the rejection of a candidate. Any imperfection of the colour sense is a disqualification for appointment to the engineering branch of the Railway Department. In other cases the existence of imperfection of colour sense will be noted on the candidate's papers.

Superintending Engineers.-Rs. 1,750, rising by annual increments of Rs. 100 a month to Rs. 2,150 a month.

Chief Engineers.—Rs. 2,750, rising by annual increments of Rs. 125 a month to Rs. 3,000 a month.

The increments will be given for approved service only, and in accordance with the rules of the Department.

Exchange compensation allowauce will not be granted to future entrants.

Pay on the junior scale will be drawn by officers holding charges of less importance than a Divisional charge, but no such officer will be allowed to draw more than the pay of the eighth year of service on the junior scale unless he is reported to be fully qualified for the charge of a Division.

Pay on the senior scale will be drawn by officers holding charges of not less importance than the charge of a Division.

Promotions above the grade of Executive Engineer are dependent on the occurrence of vacancies in the sanctioned establishment, and are made wholly by selection; mere seniority is considered to confer no claim to promotion.

APPENDIX V. (See para. 18 of the Regulations.)

Noge.—This Appendix is merely intended to show the principal leave and pension rules in the Civil Service Regulations at present applicable to Engineers appointed to the Indian Service of Engineers from the United Kingdom without going into minute details, and does not profess to deal with every case that may arise. The rules are subject to alteration, and any disputed question must be decided with reference to the authorised text of the Civil Service Regulations for the time being.

PART I]

Leave.

1. The following is a summary of the principal regulations relating to the leave admissible to Engineers appointed to the Indian Service of Engineers by the Secretary of State from the United Kingdom.

Long Leave.

2. Furlough with allowances (see paragraph 5) is admissible to an aggregate maximum amount of six years during an officer's service.

3. The amount of furlough 'earned' is one-fourth of an officer's active service, and the amount 'due' is that amount less any enjoyed.

4. Except as provided in Rule 7 furlough without medical certificate is limited to the amount 'due' and may not exceed two years at a time. On medical certificate furlough may be extended to three years.

5. The allowances admissible during furlough are :--

- (1) During any period of furlough not exceeding two years half average salary, subject to certain maximum and (in the case of furlough with medical certificate) minimum limits.
- (2) After the expiration of the first two years of any period of furlough one-quarter of average salary, subject to certain maximum and minimum limits.

6. Furlough on half average salary (see paragraph 5) may be commuted into leave on higher pay subject to the following conditions :---

- (1) The leave on higher pay, or ' commuted furlough,' is fixed at one-half of the furlough commuted.
- (2) The amount of furlough which may be commuted during an officer's total service is limited to two years.
- (3) The commuted furlough will carry an allowance at the rate of average salary, subject to a maximum of 2,400*l*. a year.
- (4) Subject to special consideration in exceptional circumstances, an officer must have six months' furlough at his credit at the end of the 'commuted furlough,' or any leave granted to him in continuation of it.
- (5) In any one period of leave not more than eight months may be spent on 'commuted furlough' or on 'commuted furlough' combined with privilege leave.
- (6) For the purpose of the rules governing the extent to which leave taken out of India may be allowed to count as service for pension, time spent out of India on 'commuted furlough' will be reckoned according to its actual duration, and not according to the duration of the furlough in exchange for which it is granted.

7. In respect of urgent private affairs, an officer may be granted furlough in excess of the amount 'due' for a period not exceeding six months at one time or 12 months in the whole of his service.

Short Leave.

8. Privilege leave is a holiday which may be granted to the extent of one-eleventh part of the time that an officer has been on duty without interruption; and it may be accumulated up to four months. It may be combined with leave of other kinds.

9. Joining time for a short period, usually with half average salary, is granted to an officer returning from leave out of India to enable him to rejoin his appointment.

10. Short leave is also granted to enable officers to appear at examinations, etc.

11. Extraordinary leave without allowances may be granted in case of necessity, and, subject to exception in special cases, only when no other kind of leave is by rule admissible. It may be granted in continuation of other leave.

General.

12. Leave of absence, whether on furlough or on privilege leave, cannot be claimed as of right, and is given or refused at the discretion of Government.

PENSIONS.

13. The following is a summary of the pension rules applicable to Engineers appointed to the Indian Service of Engineers by the Secretary of State from the United Kingdom.

Ordinary Pensions.

14. Subject to the absolute right of the Government of India to decline to permit any officer to retire before reaching the age for superannuation should it be necessary in the public interest to retain his services, officers will be allowed to retire optionally after 20 or more years' service.

15. Retirement is ordinarily required at the age of 55 years, but for special reasons an officer is sometimes retained after attaining that age.

16. An officer becomes eligible for full retiring pension on completing 30 years' qualifying service.

17. If before completing this period of service an officer is permitted to retire voluntarily after completion of 20 or more years' qualifying service (paragraph 14), or is compelled to retire on attaining the age of 55 (paragraph 15), or through ill-health not occasioned by irregular or intemperate habits, he will be eligible for a reduced pension or, if invalided with less than 10 years' qualifying service, for a gratuity.

18. The amount of pension or gratuity is regulated as follows :---

- (a) After a service of less than 10 years.—A gratuity not exceeding one month's emoluments for each completed year of service.
- (b) After a service of not less than 10 years.—A pension not exceeding the following amounts :—

19. Government may retire any officer after he has completed 25 years' service without giving reasons, and without any claim for compensation in addition to pension, and in that event the pension admissible to him will ordinarily be regulated on a scale not exceeding that laid down above. Government also reserves the general power to reduce the pension ordinarily admissible in all cases where an officer's service has been unsatisfactory.

Additional Pensions.

20. The Government of India have classified certain high appointments into two grades, the lower comprising those posts which involve high but intermediate responsibility, the higher consisting of those which require a marked degree of independent administrative and professional capacity. Officers who have held appointments listed in the lower grade will be entitled to an additional pension at the rate of Rs. 300 per year for each completed year of effective service in any appointment included in that grade, provided that no officer may draw an additional pension in excess of Rs. 1,500 in respect of service classed in the lower grade. Officers who have held appointments listed in the upper grade will be entitled to an additional pension at the rate of Rs. 500 for each completed year of effective service rendered in any appointment included in that grade, provided that no officer may draw an additional pension at the rate of Rs. 500 for each completed year of effective service rendered in any appointment included in that grade, provided that no officer may draw an additional pension in excess of Rs. 2,500 in respect of service rendered in any appointment included in that grade, provided that no officer may draw an additional penson in excess of Rs. 2,500 in respect of service rendered in the upper grade alone.

21. These additional pensions will be awarded only to officers who have given proof of special energy and efficiency, and will be subject to the condition that an officer must not retire voluntarily before the age of 55 with less than 28 years' service.

The upper grade includes the Secretary to the Government of India, Public Works Department, the Inspector-General of Irrigation, and Chief Engineers of the Indian Service of Engineers.

The lower grade includes Superintending Engineers, Indian Service of Engineers, and Deputy Secretary to the Government of India, Public Works Department.

PROVIDENT FUND.

22. A General Provident Fund, to which contribution is compulsory, has also been established on the following basis:---

(1) The contribution is compulsory up to 64 per cent. on salaries, with voluntary contributions of not more than a further 98 per cent. Subscriptions on leave of any kind are optional.

PART I]

- (2) Compound interest on such payments is annually credited by Government to each officer subscribing.
- (3) The sum which thus accumulates to the credit of an officer is his absolute property, subject to the rules of the fund, and is handed over to him, unconditionally, on quitting the service; or, in the event of his death before retirement, to his legal representatives or such other person or persons as, under and subject to the rules of the Fund for the time being in force, may be entitled thereto.

No. D.-158.—The following regulations for the appointment, in India, of probationers for the Imperial Forest Service in 1920 are published for general information :—

Applications are invited from natives* of India and Burma for about 15 probationerships for the Imperial Forest Service in India and about 3 in Burma. Candidates of European or Anglo-Indian descent must be unmarried and, if appointed as probationers, must remain unmarried until completion of the prescribed course of training and their return to India.

2. Applicants, who should not be more than 23, nor less than 20 years of age on 1st January 1920, must possess the *Honours* B.Sc. degree of a British or Indian University, or have passed in divisions I or II of the B.Sc. degree of the Allahabad University.

3. Any attempt on the part of a candidate to enlist support for his application through persons of influence will disqualify him for appointment. Testimonials or other recommendations should not be attached to the applications.

4. Applications, which should be addressed to the Secretary to the Government of India, Department of Revenue and Agriculture, Simla, through the Chief Secretary to the Government of Bombay, must be in the form prescribed and must reach the Chief Secretary not later than June 1st to enable Government to select suitable candidates for an interview at Poona on June 3th. Applicants must be prepared to produce, in case they are called for an interview, documentary evidence, if possible, of their age, birth place, and nationality, and the various school and University distinctions and degrees and of the birth-place and nationality of father and mother. Copies of the regulations and of the forms of application may be obtained from the Secretary to the Government of India, Revenue and Agriculture Department, the Revenue Secretaries to the Governments of the Punjab, the United Provinces, Bengal, Bombay, Madras, Burma, Bihár and Orissa; the Chief Commissioners of Assam, the Central Provinces, Coorg, Ajmere, Delhi; the Chief Commissioner and Agent to the Governor General, North-West Frontier Province; the Agent to the Governor General, Baluchistan and Political Officers of Indian States.

5. Applications from officers already in the public service, whether as probationers or on a permanent establishment, will not be entertained.

6. Candidates, who, from their papers and from the remarks made by local Governments, or Political Officers or Agents, in forwarding their applications, appear prima facie to be suitable will be summoned by the Government of India to undergo a written qualifying examination in English (the test will be by precis writing as well as by an essay: deductions of marks will be made for faults of writing and spelling) and Mathematics (Arithmetic; Algebra up to and including the Binomial theorem; Plane Trigonometry up to and including the solution of triangles and the theory and use of Logarithms). These examinations will be held on July 9th and 10th at local centres, namely, Rangoon, Calcutta, Allahabad, Lahore, Bombay and Madras. Candidates must state in their applications the centre at which they wish to appear if called up for examination. This choice once made may not be varied.

7. Candidates who have satisfactorily undergone the test referred to in paragraph 6 will be summoned by the Government of India to appear at Dehra Dun on or about August 15th, where they will first be required to undergo a physical test, which will consist of an excursion extending over about 15 to 16 miles and of such a nature as to test candidates' activity and power of endurance. Those completing this test satisfactorily will next be subjected to a strict medical examination, in which particular stress will be laid on good vision and hearing; when, if passed as fit for the work of the Forest Department, they will be interviewed by a Selection Board appointed by the Government of India.

8. Candidates will not be entitled to any travelling allowance for journeys to appear before local Governments, or for journeys to and from the local centres referred to in paragraph 6; but those summoned to appear at Dehra Dun for the physical test, medical examination and interview will be reimbursed, by the President, Forest Research Institute and College, Dehra Dun, before the candidates leave Dehra Dun to return to their homes, the cost of a second class ticket [by rail or (and) by sea] to and from Dehra Dun from the nearest railway stations or ports to their homes. Candidates

must make their own arrangements for board and lodging at Dehra Dun, but the President, Forest Research Institute and College, will endeavour to assist those who communicate with him on this subject.

9. Those finally selected as a result of the examinations, tests and interview prescribed in paragraphs 6 and 7 will be appointed as probationers for the Indian Forest Service; they will be required to leave for England early in September and, subject to their undergoing satisfactorily, as described below, a course in Forestry and allied subjects in England, will be appointed finally as Assistant Conservators of Forests. Candidates selected for training will be provided with first class passages to England.

10. Period of Probation.-Before appointment to the Imperial Forest Service a probationer will be required :-

- to have undergone and qualified in, to an extent to be prescribed by His Majesty's Secretary of State for India, the course of Forestry at such University as the Secretary of State may prescribe;
- (2) to have undergone a special course of instruction in Forestry under the direction and supervision of the Director of Indian Forest Studies;
- (3) to have passed an examination in Forest Engineering and, if required, in certain other special subjects, namely, Systematic Botany of Indian trees, Indian Geology, Forest Law and Indian Working Plans;
- (4) to have undergone a final competitive examination in Forestry;
- (5) to have satisfied the Secretary of State, in such manner as may be determined, of his ability to ride.

The period of probation is, in ordinary cases, two years. The Director of Indian Forest Studies instructs probationers in each case as to the order and manner in which they should fulfil these various requirements.

11. Charges.—Probationers will be required to defray all expenses of lodging, board, tuition, and excursions to forest centres in the United Kingdom while at the University, and on practical instruction.

12. Allowances.—The Secretary of State for India in Council makes payment to each probationer at the rate of $\pounds 200^*$ per annum, not exceeding a total of $\pounds 400$. These payments are ordinarily made on the following dates in each year :—

The cases of probationers whose probation does not extend over the full period of two years will be specially considered.

For tours made on the Continent under the instructions of the Director of Forest Studies, subsistence and travelling allowance will be paid by the Secretary of State for India in Council at such rates as he may from time to time fix. The fees of the local forest officials at the centres visited will also be paid by the Secretary of State.

The grant of allowances is subject to the following conditions :-

- (a) that the progress of the probationer in his studies is satisfactory;
- (b) that the probationer gives security⁺ to refund the payments in the event of his failing to qualify for an appointment in the Indian Forest Service, or not signing the articles of agreement as specified in paragraph 15 or failing to join the Indian Forest Service at the end of the period of probation.

13. Conduct.—Every probationer is required to conduct himself during the period of probation in a manner satisfactory to the Secretary of State, and to give evidence of satisfactory progress in his studies in such a manner as may be required, failing which, or in the event of serious misconduct, he is liable to have his name removed from the list of probationers.

14. Appointment and Seniority.—Probationers who comply with the requirements of paragraph 10 within the sanctioned period of time, and also satisfy such other tests as may be prescribed, are appointed Assistant Conservators in the Indian Forest Department, provided they are of sound constitution and free from physical defects which would render them unsuitable for employment in the Indian Forest Service. No probationer will be confirmed as a member of the Imperial Forest Service who fails to profit by the course of training, or who appears, in the light of the experience acquired as to his capacity and qualifications during the probationary period, to be unsuited for the work of a forest officer.

• This allowance is unlikely to be sufficient to meet all the needs of a probationer, who should be in a position to provide himself with at least another £150 per annum from other sources.

† Probationers will be required to give security to the local Government or Political Officer through whom they submitted their applications. If this condition is not satisfied they will not be permitted to leave for England. The position of the Assistant Conservators in the Provincial Forest Lists is determined by the Secretary of State for India in Council on the report of the Director of Indian Forest Studies. It is possible that officers promoted from the Provincial to the Imperial Service will take rank according to their pay in the latter service. In this case probationers recruited under these regulations must be prepared to find their names placed below those of officers promoted from the Provincial Service.

Probationers are allowed at the end of the period of probation to state their preference in respect to the province to which they desire to be allotted; but the distribution is made to the several provinces according to the needs of the public service, at the discretion of the Secretary of State for India in Council and no guarantee can be given that probationers will, on appointment, be posted to their own provinces. Indians will not, however, be required to serve in Burma and Burmans will not be required to serve in India.

Officers are at all times liable to be transferred from one province to another at the pleasure of the Government of India.

15. Articles of Agreement.—A probationer is required, on qualifying for appointment as Assistant Conservator, to sign articles of agreement setting forth the terms and conditions of his appointment; he must embark for India when required to do so by the Secretary of State. Failure to embark at the stated time will, in the absence of satisfactory explanation, lead to forfeiture of appointment.

16. Passage to India.—Each probationer on appointment to the Indian Forest Service is provided with a free first-class passage to India.

17. Salary.—The scale of pay and allowances in force for officers of Indian domicile is given in Appendix II to these regulations.

18. Promotion, Leave, and Pension.—Promotion, leave, and pension are governed by the Regulations laid down by the Government of India, and applicable to Forest officers, such regulations being subject to any modifications or alterations which may be made in them from time to time by the Government of India, and their interpretation in case of any doubt arising being left to that Government.

Certain information regarding appointments in the upper controlling staff of the Indian Forest Service will be found in Appendix II, and a summary of information regarding Leave and Pensions is contained in Appendix III.

APPENDICES.

APPENDIX I.

FINAL EXAMINATION.

1. With a view to the allocation of the annual Currie Scholarship for Indian Forest Students (value about £35), and to facilitate the allotment of probationers to the several provinces in accordance with paragraph 14 of the Regulations as to appointments in the Indian Forest Service, probationers who have completed their prescribed course of training are required to undergo a competitive final examination in Forestry.

2. A list of the probationers in order of merit is prepared by adding together (a) the marks obtained at the final examination, and (b) the marks obtained during the course of practical training in forestry under the control of the Director of Indian Forest Studies. The maximum of marks obtainable under (a) is the same as under (b).

3. The final examination consists of an oral examination and three or more papers, as follows :---

- (i) One or more papers in Silviculture, Forest Protection (including Forest Botany and Forest Entomology), and Forest Utilisation (including Forest Engineering).
- (ii) One or more papers in Forest Management, Forest Mensuration, Forest Valuation, and Forest Administration.
- (iii) A paper in General Forestry (Practical) dealing with the work done and with the forests visited during the course of practical training.
- 4. Probationers are not required to pay any fee for the examination.

Probationers trained in the United Kingdom will, on appointment to the Indian Forest Service as Assistant Conservators, enter the time scale at the second year, irrespective of the duration of the probationary period spent under training in the United Kingdom. Pay will be drawn from the date on which they report their arrival in India. This concession as regards pay will affect pay only and not service for pension or leave.

APPENDIX III,-LEAVE AND PENSION.

[Note.—The following is a brief summary of the general principles at present governing the grant of leave of ordinary kinds and pension to officers appointed to the Indian Forest Service by the Secretary of State. The rules are .subject to alternation from time to time, and are to be found in full in the authorised text for the time being of the Civil Service Regulations.]

Leave.

1. Leave of absence can never be claimed as of right, and is given or refused at the discretion of Government.

2. Subject to this qualification, an officer is entitled to one month's privilege leave after every eleven months of continuous duty. Privilege leave may be accumulated up to four months and may be combined with average pay furlough, half average pay furlough, special leave, or extraordinary leave without allowances. An officer on privilege leave is entitled to the full pay which he drew when last on duty.

3. Furlough may be taken after eight years' service reckoned from the date on which an officer first joined his appointment in India and thereafter after intervals of not less than three years' service.

Pension.

4. The following is the scale of pensions admissible to officers of the Imperial Forest Service, subject to the absolute right of Government to decline to permit any

Additional pensions of Rs. 300 a year for each completed year of effective service as a Conservator subject to a limit of Rs. 1,500 and of Rs. 500 for each completed year of effective service as Chief Conservator or Inspector General of Forests, provided that no officer may draw an additional pension of more than Rs. 2,500. Additional pensions will only be awarded to officers who have given proof of special energy and efficiency, and will not be granted to officers retiring of their own option before the age of 55 with less than 28 years' service.

The rates and conditions of invalid pensions are now under consideration.
