No. 22.—The following Notice to Mariners is published for general information :—

"Alterations to Jafrabad Light, Káthiáwár Coast, from Fixed to Flashing.

The old fixed light till recently exhibited on the promontory at the entrance to the Port of Jafrabad, Káthiáwár Coast, has been discontinued and replaced by a 'New Dioptric 4th Order Revolving Light,' giving single flashes every twenty seconds and a complete revolution of the apparatus every two minutes. The new light was exhibited on the 1st instant, and is visible all round the compass. Height from sea-level to centre of light is 85 feet. Range of visibility 16 miles in clear weather."

No. 23.—The following Notice to Mariners is published for general information :—

"GULF OF ADEN-NORTH SHORE.

ADEN HARBOUR.

Directions for obtaining Pilots for entering the Port of Aden.

No. 1634.—Under Section 137 of the Sea Customs Act, 1878, and in supersession of this Office Notification No. 5991 of 14th November 1891, published at *Bombay Government Gazette*, Part I, 1891, page 937, the Chief Customs Authority hereby directs that the following goods may (subject to the conditions, if any, hereinafter expressed in the case of each class of those goods respectively) be shipped at the Port of Bombay from any wharf from which they may legally be shipped, without a shipping bill of such goods being delivered to the Customs Collector, namely :—

- (1) Her Majesty's mail;
- (2) Stone ballast;
- (3) Coals for ships' use;
- (4) Ice;
- (5) Fresh fruit and vegetables;
- (6) Live-stock, the property of passengers ;
- (7) Parcels of samples of no value;
- (8) Packages for conveyance by P. and O. Company's Parcels Post: (provided that written application, giving the number of packages

to be shipped for each port be made to the Customs Collector before shipment of such packages, and that shipping bills, with all such particulars of the goods as are required by Section 29 of the Act, be delivered to the Customs Collector within 24 hours after the departure of the vessel by which the packages have been shipped);

- (9) Wines, spirits, stores, &c., taken afloat for picnics or water parties: (provided that unless the person requiring to take any such articles for such purposes furnish the Preventive Officer at the Bandar with a detailed list of all articles so taken, specifying marks, brands, descriptions, &c.; the said articles or any portion of them, when re-landed at the same or any other wharf, will not be passed back without payment of import duty, if dutiable;
- (10) Fire-arms, taken for shooting expeditions across the harbour (provided that the owner obtain a pass containing the following particulars, namely,—

Owner of arms; Marks, name, and number on arms; Description of arms;)

from the Preventive Officer on duty at one of the undermentioned places, namely,---

> Apollo Bandar; Town Bandar; Carnac Bandar; Prince's Dock;

or that he obtain a general pass, covering the arms, for a year or lesser period from the Customs Collector at the Town Customs House, and that when the arms are re-landed, the pass so obtained be shown to the Customs Officer at the bandar.
