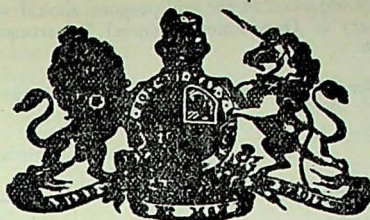

Proclamation.

No. 1543.—Under the provisions of Section 10 of the Bombay District Municipal Act Amendment Act, 1884, the Governor in Council is pleased, with reference to Government Notification, Military Department, No. 78, dated 13th February 1889, published at pages 127 and 128 of Part I of the *Bombay Government Gazette* dated 14th idem, notifying the revised limits of the Ahmednagar Cantonment, to announce that it is proposed to alter the limits of the municipal district of Bhingár in the district of Ahmednagar, so as to include within the said limits a piece of ground situated to the north of Cantonment boundary pillars Nos. 29 and 30 and required for the purposes of a school-house. When this piece is added, the boundary of the municipal district of Bhingár will be as follows:—

North.	East.	South.	West.
Northern bank of the Bhingár river, town wall, and Survey Nos. 254, 253 and 252.	Book Nos. 117 and 118 of the lands of the alienated village of Nagardevala.	Cantonment Pillars Nos. 28, 29, 30, 31 and 32.	Road leading to Commissariat cattle lines.

All persons who entertain any objection to the said proposal should submit the same, with the reasons therefor, in writing to the Secretary to Government, General Department, Bombay, within two months from the date of this proclamation.
