EDUCATIONAL DEPARTMENT.

Bombay Castle, 16th January 1895.

No. 107.—The following rules for regulating admission into the lower grades of the Public Service are framed in supersession of all rules at present in force in this behalf, and indicate the intentions of Government so long as the rules are not modified :—

Rules for regulating the admission of Candidates into the Lower Grades of the Public Service.

1. Except as hereinafter mentioned, these rules apply to all appointments in the Revenue and Judicial brauches of the Public Service or Departments subordinate thereto, as well as any other branches of the service above those of a menial character to which His Excellency the Governor in Council may from time to time declare them to be applicable by a Notification in the Bombay Government Gazette. They do not apply to persons already in the service, nor to Graduates and others who have passed any special prescribed tests, nor to persons seeking employment in the Executive Police either on first appointment or on transfer to any post in the Police Department.

2. Hereafter no one will be eligible for employment in any appointment to which these rules apply, except—

(a) students who have passed an examination of the first or highest grade; that is to say, students who have passed the Bombay University School Final Examination in the subjects named in Rule 3, and students who have passed the Government of India Final Examination for European schools with the language named in Rule 4,

(b) holders of the second and third grade certificates of qualification which are mentioned in Rule 6,

(c) students who have passed any of the lower examinations of the Bombay University (Matriculation, the Previous Examination, or the First Examination for a degree) before September 1889.

(d) holders of first and second class certificates issued by the Educational Department under the old rules, or in Sind passed pupils of the Agricultural School, Hyderabad,

(e) holders of Training College certificates which, however, will qualify for Educational service only.

3. Students who pass the University School Final Examination will be eligible according to the class in which they pass for admission to the Public Service, on the following conditions, viz.:—

(1) they must have taken Maráthi, Gujaráti, Kánarese, or Siudhi as their second* compulsory subject ; and

(2) amongst their optional subjects, they must have passed in two of the following, viz., Natural Philosophy, Biology, Agriculture and Drawing: Provided that a student who has passed the second grade examination of the Jamsetji Jijibhoy School of Art will be eligible if he passed in Natural Philosophy, Biology or Agriculture; that a student who has passed the Final Examination of the High School Agricultural Class will be eligible, if he passed in Natural Philosophy, Biology or Drawing; and that a student who has obtained the certificate for Mauual Training according to Schedule J of the Grant-in-aid Code will be eligible if he has passed in Natural Philosophy, Biology, Agriculture or Drawing.

4. Students who pass the Government of India Final Examination for European schools will be eligible for admission to the Public Service, provided

• Urdu may be offered by candidates who desire employment in offices where Urdu is recognized as a vernacular. they have passed the examination with Maráthi, Gujaráti, Kánarese or Sindhi as their second* language, or have offered one of these languages as an optional* subject and passed in it.

5. Students who have passed a first grade examination according to Rules 3 or 4 will be eligible for admission into English or vernacular offices, according to the languages in which they have passed.

6. Certificates of qualification under Rule 2 (b) will be given to students who pass an examination according to Schedule A. (second grade) or B. (third grade) :--

The second grade certificate will qualify its holder for admission into an English or vernacular office, according to the language or languages in which the holder has passed.

The third grade certificate will qualify its holder for admission into an English, Maráthi, Gujaráti, Kánarcse or Sindhi office according to the language in which the holder of the certificate has passed.

7. Excepting the Bombay University School Final Examination, the examinations for first, second and third grade certificates will be held by the Educational Department, and will, until further orders, be regulated by the following orders, viz :—

(1) Examinations will be held every year at convenient centres in
 September, or as soon after as may be. The examinations will be held on dates (which will be the same for all the districts in a Division) to be fixed by the Educational Inspector and notified by the Collector three months before the examination.

(2) The Educational Inspector of the Division will superintend the examinations and will appoint the Examining Committees, which will consist of a President and two or more members to be selected from officers of the Educational or other Public Departments, or such representatives of non-Government schools as may be willing to serve.

(3) Applications for admission to an examination must be forwarded to the Educational Inspector or his Deputy on or before the 1st of August in each year. Each application must contain the name of the candidate in full and the name of the school (if any) from which the candidate is presented; and each application must specify the examination at which the candidate desires to appear, and the second language and the optional subjects (if any) to be taken up by the candidate. The Inspector will instruct a candidate to appear at a particular centre, in the event of there being any difficulty in examining him in the language he has selected at the centre he has chosen.

(4) Every male candidate must, before he is admitted to the examination, satisfy the Committee that he has completed his 17th year and has not completed his 25th year. In the case of female candidates, there is no restriction as regards age.

(5) The Educational Inspector will grant certificates to candidates who pass the examinations. Each first and second grade certificate must bear the holder's signature in English characters, and each third grade certificate must bear the holder's signature in the characters of his vernacular.

(6) The Director of Public Instruction will publish annually in the *Government Gazette* a list of candidates who pass for certificates of each grade. The names will be arranged for the divisions or districts in order of merit, and the total number of marks obtained will be shown opposite each name.

(7) No candidate who has once passed the examination and received a certificate will, under any circumstances, be allowed to re-appear for examination for a certificate of the same grade: provided that, with the sanction of the Director of Public Instruction, holders of certificates may

• Urdu may be offered by candidates who desire employment in offices where Urdu is recognized as a vernacular. be permitted to appear for examination in optional subjects added to the examination since the date of their passing.

(8) Every candidate must pay a fee of Rs. 5 if a candidate for a first or second grade certificate, and of Rs. 2 if a candidate for a third grade certificate, before the examination commences. Duplicate certificates may be issued by the Educational Inspector on his being satisfied that the original certificate is lost or destroyed and on payment of a double fee.

(9) Detailed regulations, consistent with these rules, will from time to time be issued by the Director of Public Instruction to secure uniformity in the conduct of the examinations in the several Educational Divisions.

8. Holders of certificates will not be admitted to the Public Service until they have completed their 18th year.

9. Every person appointed to the Public Service in virtue of his eligibility thereto under these rules, will enter it, subject to the condition of passing any special examination required in the Department to which he is appointed.

Theoretical Mensuration may be taken up as an optional subject; and candidates who have passed in it, or who can produce a certificate of having passed in Drawing, Agriculture, Levelling and Surveying, Physiology, Botany, or Manual Training will have a preferential claim to appointments.

N.B.-1. Subject (3) of Scheme 1 will be compulsory on a candidate for an office in which a vernacular is required, but Urdu may be offered by a candidate for an office in which Urdu is recognized as a vernacular. The standard in Urdu will be the same as that proscribed for Maráthi, and the book to be taken up will be notified annually by the Educational Inspector.

A candidate for an office in which English only is required may, in place of subject (3) of Scheme 1, offer any portion of Science treated in a popular way, equal in amount and difficulty to one of Macmillan's " Science Primers.'

3. A candidate for an office, in which Urdu is recognized as a vernacular, may offer Urdu in place of Maráthi under subjects (2) and (3) of Scheme 2.

SCHEDULE B.

Third Grade Certificates.

An alternative examination is offered, and certificates of the third grade will be given to candidates who pass in all the subjects of one or other of the schemes given below :-

No. 108.—The following Schedule J. to the Grant-in-aid Code is published for general information :—

SCHEDULE J.

Provisional rules for an optional course of Manual Training in secondary schools.

- 1. The course of instruction in Manual Training in secondary schools is as under :---
- Drawing.—(a) Free-hand, model, and practical geometry as required for the First Grade Examination of the Sir J. J. School of Art.
 - (b) Use of drawing board, T square, set squares, compasses, and scales.
 - (c) Orthographic projection—construction of plan, section and elevation of a simple piece of wood work, such as joints in carpentry, a box, a door, a window, or book shelves; the drawings to be to scale from sketches or data supplied.

·Carpentry.-First year-

- (a) Use of jack-plane and hand plane, try square, marking gauge, flat chisels, mortise chisels, tenon saw, mallet, compasses.
- (b) Plane a piece of timber true, square and to size; construct a halved joint, open mortise and tenon joint, closed mortise and tenon joint, double mortise and tenon joint.
- (c) Construct drawings to scale of the above joints, before beginning and after completing each; a variety of scales to be used.

Second year-

- (a) Use of shooting board, ornamental planes and turning lathe.
- (b) Construction of open dovetail joint, secret dovetail joint; feather and groove; turning.
- (c) Construction of a simple piece of work, e.g. book shelves, table, picture frame, box, drawers, model roof truss; all the work being planned and drawn to scale beforehand.
- 2. The class for drawing should meet at least twice a week for one hour each time; and students should have attended this class for at least a year before beginning the course in carpentry. The class for carpentry should meet three times a week for one and a half hours each time.
- 3. The examination in Drawing will be the First Grade Examination of the Sir J. J. School of A1t.
- 4. The Practical Examination will be held at convenient centres; the time required being five or six hours.

The examination would consist in drawing neatly and to scale a prescribed joint from sketches or data, and then constructing it (the joint) in teak wood.

- 5. Rough pieces of timber of proper sizes would have to be sent beforehand to the Superintendent of the examination; students would bring their own tools and drawing instruments.
- The finished pieces would be marked with the students' names and sent on to the Examiner.
- 6. Certificates may be given to students who satisfy the Examiner in the second year test. The Examiner who will sign such certificates will be an officer of the College of Science.
