To-The Secretary of State for Foreign Affairs.

I have the honour to state that at a meeting of the Quarantine Beard which took place on the 2nd instant, the Austrian Delegate proposed that a night service should be established in the port of Alexandria.

Until recently vessels were unable to enter the harbour at night, but since the new pass has been lighted, a few vessels have entered after sunset. They have, however, been unable to obtain pratique until the following morning. In the case of cargo vessels this causes no inconvenience as they cannot begin to load or discharge until the following morning. In the case of passenger steamers, however, some hardship is entailed by the inability to obtain pratique at night.

No complaints had been made to me by any of the English steam-ship agents on this subject, and I understand that only one English vessel carrying passengers has arrived at night since the opening of the new pass. The Peninsular and Oriental steamers arrive here about day-break, when they are able to obtain pratique.

The Austrian Delegate brought forward his proposal in view of the fact that the Austrian Lloyd steamers from Brindisi now arrive regularly at about 8 o'clock P.M., carrying a large number of passengers.

The President made a proposal, of which I have the honour to inclose a copy, that as a provisional measure pratique should be given at night to any mail or passenger steamers which should have cleared the pass by 10 o'clock P.M., pratique in any case not to be given after 11 o'clock P.M. The President observed that at the present time provision had not been made for a regular night staff by the Quarantine Board or the Custom House, and that the proposed temporary measure would, he thought, satisfy all. He added that the Director General of Customs had informed him that he would be able to keep the Baggage Office open until 11 P.M. The proposal of the President was agreed to unanimously.

On the question of the amount of the extra charge to be made for giving pratique at night, there was some discussion as to whether Piastres Tariff one hundred should be charged as at Suez or Piastres Tariff forty as at Port Said.

On this question being put to the vote, there was a majority in favour of the charge of Piastres Tariff one hundred. I voted with the minority in favour of Piastres Tariff forty on the ground that at Suez the Medical Officer has to go out some distance to the roads, while at Alexandria there are no greater difficulties than at Port Said.

I have the honour to observe that, although the above decision of the Board will probably satisfy the requirements of shipping during the winter months, an all-night service (as required by Articles 28 and 29 of the Reglement General in Annex 3 of the Venice Convention) will become necessary at no distant period, and that provision should be made for this contingency in the budgets of the Quarantine Board and the Customs Administration for next year.

No. 24.—The following translation of the special Regulations of the Ottoman Board of Health applicable to the Mecca Pilgrimage of 1894-95, received through Her Majesty's Secretary of State for India, is published for general information:—

SPECIAL REGULATIONS APPLICABLE TO THE MECCA PILGRIMAGE OF 1894-95.

### Year of the Hegira 1312.

Article 1.—From the beginning of the month of Rajab until the end of the month of Zilhijja (that is to say, from the 28th December 1894 to end of June 1895), the lazaretto of Camaran will be open to receive arrivals by sea subject to quarantine.

Article 2.—During the period of the six months mentioned above (Rajab, Shaban, Ramazan, Shawwal, Tilkaada, Zilhijja), pilgrim vessels coming from beyond the Straits of Babelmandeb, whatever the tenor of their Bills of Health, must proceed direct to the Island of Camaran without calling at any other port on the littoral of the Red Sea.

Article 3.—Pilgrim vessels are vessels which are chartered to carry pilgrims proceeding to the Hedjaz.

Article 4.—Vessels bound for the Red Sea having on board not more than one pilgrim for every 100 tons of registered tonnage, are not included in the definition of pilgrim vessels. Such vessels will be dealt with, according to the tenor of their Bills of Health, conformably to the General Regulation of 1867 applicable to arrivals from cholera-infected places.

Article 5.—Vessels carrying not more than five pilgrims for every 100 tons of registered tonnage can proceed to Abu-Saad where they will discharge their pilgrims and merchandise subject to quarantine destined for the Hedjaz.

Quarantine will also be performed at Abu-Saad by the 'Sambouks' and other coasters subject to quarantine proceeding from one port to another of the Red Sea littoral.

Article 6.—For this purpose a lazaretto is established at Abu-Saad, as a branch of the Camaran lazaretto, which will be open throughout the year to arrivals specified in Articles 4 and 5 of this Regulation.

Article 7.—Vessels upon which cases of cholera or suspicious cases have occurred, either in the port of embarkation or during the voyage, will undergo (both vessels and pilgrims) quarantine for 15 days at Camaran. This quarantine will be renewed each time a cholera case occurs among crew or passengers after their arrival at the lazaretto and will date from the last case of sickness. In such cases the provisions of the Cholera Regulation of 1867 will be strictly applied.

Article 8.—When a batch of pilgrims has suffered from cholera during their stay at Camaran, they will not be admitted to free pratique at Jeddah until they have undergone a supplementary quarantine for five days and vigorous disinfection at the lazaretto at Abu-Saad.

Vessels carrying such pilgrims may, however, clear in quarantine in conformity with Article 16 of the principal Regulation after landing at Abu-Saad the pilgrims and their baggage and merchandise destined for Jeddah.

Article 9.—Indian or Malay pilgrims who take the indirect route viâ Suez to the Hedjaz will be subjected to quarantine, unless they can prove on their arrival at Jeddah, by their passports or other official documents, that they have come from beyond the Suez canal or that they have spent at least ten days in Egypt in free pratique and in good health.

Vessels embarking at Suez Indian or Malay pilgrims who do not fulfil these conditions will be treated as infected, and will have to proceed to Camaran, at any rate in certain cases, to undergo quarantine there according to the country of origin of the pilgrims in question.

Article 10.—Merchandise destined for Yemen not susceptible of infection can be landed at Hodeida under the supervision of the sanitary authority.

Article 11.—Vessels coming from beyond the Suez canal and Egypt with unclean Bills of Health must proceed to Camaran for quarantine.

Article 12.—Pilgrim vessels which arrive from ports where cholera exists, but have had no cholera case during the voyage or after arrival, will undergo (vessels and pilgrims) a quarantine for ten days. Merchandise coming from a cholera-infected port will remain on board, if there have been no cholera cases during the voyage or after arrival, and will be exempt from disinfection and from sanitary fees, except in the case of old personal effects and stuffs already used, unwashed wool, old cottons, horse hair and feathers, raw hides and other raw animal products, as well

as rags of all kinds, which will be subject to the provisions of the Cholera Regulation of 1867.

Article 13.—No pilgrim vessel, even when admitted to free partique, will be allowed to leave Camaran without re-shipping, after the performance of their quarantine, all the pilgrims brought by her.

Article 14.—Vessels coming from the Persian Gulf and Zanzibar with pilgrims on board bound for the Hedjaz will also proceed to Camaran where they will be detained 24 hours for the disinfection of the effects and wearing apparel of the pilgrims and crew. These vessels will, however, be treated according to the tenor of their Bills of Health in the manner provided by the Cholera Regulation of 1867.

Article 15.—Sambouks coming from beyond the Straits of Babelmandeb with pilgrims will be subject to the same rules as vessels specially chartered for pilgrims. They must proceed direct to the anchorage of Camaran, and will be excluded from all other Arabian ports on the Red Sea.

Article 16.—The embarkation on board a pilgrim vessel of live animals, as well as hides, animal products, rags of all kinds, coal, petroleum, and all other inflammable or explosive material, except such coal and animals as are necessary for the service and provisioning of the vessel during the voyage, is strictly prohibited.

Article 17.—All vessels embarking more than 100 pilgrims must be provided with a medical man licensed by authority in the country of departure, as well as with medicines, disinfectants and articles necessary for the care of the sick. A special place must be arranged on the deck as a hospital. Attendance and medicine will be given gratuitously.

Article 18.—On the arrival of a pilgrim vessel at Camaran or at Abu-Saad, as the case may be, all pilgrims will be disembarked and undergo the usual medical examination. If the condition of the vessel is good, and no suspicious case has occurred during the voyage, the vessel and the pilgrims will undergo five full days' quarantine and their clothing and effects will be disinfected, but the cargo will be subject to the provisions of the Cholera Regulation of 1867.

Article 19.—The sanitary authority will not allow the departure of a pilgrim vessel from any port in the Empire without assuring himself that it satisfies the following conditions: viz.,—that the vessel is fit to undertake the voyage without danger; that she is well equipped, well-regulated, well ventilated, provided with a sufficient number of boats; and that she contains nothing on board that is or may become injurious to health or prejudicial to the safety of the passengers; that there are on board suitably stored, besides the provisions of the crew, food, drinking water of good quality and fuel, in sufficient quantity for all the pilgrims and for the entire declared duration of the voyage. This last provision, however, in so far as it concerns food, is strictly applicable only to vessels passing the Straits of Babelmandeb. For all other vessels the Captain is bound to have food only in the proportion necessary for the wants of the pilgrims who may have contracted to be fed on board during the entire voyage. The sanitary authority will refer to the authority to which the vessels are sub-

ject for the application of those of the above provisions which do not concern him directly.

Article 20.—Every pilgrim vessel which does not conform to the provisions of the present Regulation will be held to have contravened sanitary rules and be liable to extreme measures regarding quarantine.

A ticle 21.—Vessels carrying pilgrims are suretly subject to the following instructions concerning the measuring of pilgrim vessels.

Read and adopted in meeting of the Superior Council of Health, the 10th and 22nd December 1891, and amended the 23rd and 25th December 1893, and 27th and 29th October 1894.

### Instructions regarding the measurement of pilgrimships referred to above in Article 21.

- 1. Only steamers and ships propelled partly by steam and partly by sail are authorised to carry pilgrims on voyages beyond the Straits of Babelmandeb or beyond the Suez Canal.
- 2. The space to be given to each pilgrim irrespective of age or sex shall be at least 9 superficial feet and 54 cubic feet, between decks. No passenger shall be accommodated in the ship's hold; and the deck, free of all goods, shall be reserved for the use of the crew and the passengers travelling between decks.
- 3. Any ship which can produce an official certificate furnished by the authority on which it is dependant, proving its capacity with regard to the number of passengers that can be embarked, shall not be liable to a second measurement, except in the event of the size, capacity and arrangements of the ship being found by the sanitary authority not to be in accord with the number of passengers shown in the certificate.
- 4. Any ship sailing under the Turkish flag which is unable to produce an official certificate of measurement, shall be measured by a competent officer of the Imperial Marine to be named by the local authority, with the assistance of the sanitary authority of the port where the ship happens to be; the service rendered by the sanitary authority in such a case is gratuitous.

As regards ships belonging to a foreign marine and not possessing official certificates of measurement, the sanitary authority shall give them the opportunity of producing the documents required in communication with their respective Consuls. The Consul can, if he so desires, cause the measurement in question to be made by the competent local authority in accordance with the requirements of Article 2 above.

5. The Sanitary authority shall refuse to give a Bill of Health to any ship which has embarked pilgrims without the necessary certificate.

Definition of the term 'Machinery' for the purposes of the Indian Tariff Act, 1894.
No. 324 S. R., dated Calcutta, the 18th January 1895.

RESOLUTION-By the Government of India, Finance and Commerce Department.

In the Resolution of the 3rd November 1894, read in the preamble, the Local Governments concerned were requested to furnish the Government of India with an expression of their opinion on the definition of the term 'Machinery,' which was given therein, for the purposes of the Indian Tariff Act, VIII of 1894.

2. The replies received were duly considered by the Select Committee on the Tariff Amendment Bill, and the grounds of their decision are enunciated in the speeches of the Honourable Sir James Westland contained in the Abstract of the Proceedings of the Legislative Council read above. Accordingly the definition of the term 'Machinery' and its component parts finally adopted by the Legislature (vide entry No. 14 of Schedule IV of the Indian Tariff Act Amendment Act, XVI of 1894) allows of the free import of—

Machinery, namely, prime-movers, and component parts thereof, including boilers and component parts thereof; also including locomotive and portable engines, steam-rollers, fire-engines and other machines in which the prime-mover is not separable from the operative parts.

Machinery (and component parts thereof), meaning machines or sets of machines to be worked by electric, steam, water, fire, or other power not being manual or animal labour, or which before being brought into use require to be fixed with reference to other moving parts; and which are intended for—

- (a) the preparing, ginning, pressing, spinning, weaving, sowing, knitting, bleaching, and dyeing of cotton, jute, hemp, silk, wool, or other fibres and any other process intervening between the raw material and the finished product as packed ready for the market;
- (b) the smelting and milling of iron and other metallic ores and the manufacture of iron, steel, and other metals;
- (c) the manufacture of leather, sugar, indigo, silk, paper, soap, gas, oil, flour, cordage, rope, and twine;
- (d) the milling of rice;
- (e) the drying and rolling of tea;
- (f) the pulping of coffee;
- (g) printing presses;
- (h) foundries and workshops of iron and other metals;
- (i) railway workshops;
- (j) the refining of petroleum, and the manufacture of vegetable oils;
- (k) the crushing of bones and bricks;
- (1) the manufacture of lac;
- (m) potteries;
- (n) saw mills;
- (a) mining, navigation, agriculture, and pumping;
- (p) such other manufactures and industries as the Governor General in Council may from time to time specify.

Provided that the term does not include tools and implements to be worked by manual or animal labour, and provided also that only such articles shall be admitted as component parts of machinery as are indispensable for the working of the machinery and are, owing to their shape or to other special quality, not adapted for any other purpose.

Note.—Machinery and component parts thereof made of substances other than metal are included in this entry;

while under entry No. 13 of the same schedule the only machines, tools, and implements to be worked by manual or animal labour, which can be admitted free, are—

water-lifts, sugar-mills, oil-presses, and parts thereof, and any other machines and parts of machines ordinarily used in processes of husbandry, or for the preparation for use or for sale of the products of husbandry which the Governor General in Council may, by notification in the Gazette of India, exempt.

- 3. As regards the question as to what are and what are not component parts of machinery, the attention of all Collectors of Customs should be invited to the express provisions of the law and to the remarks in elucidation of this point contained in the Honourable Sir J. Westland's speech of the 27th December 1894. No hard-and-fast lines other than those contained in the Act itself can be prescribed, but if the general principles laid down in the above-mentioned speech are borne in mind, Collectors of Customs should have but little difficulty in giving effect to the intentions of the Legislature. They should bring to notice any points arising in ordinary practice in which they think that the words of the law oblige them to impose a duty, where they have reason to believe that the intention of the law was to exempt.
- 4. In the letter to the Government of Madras of the 31st December 1894, the Government of India undertook to adopt the suggestion of the Madras Chamber of Commerce regarding the publication in the Gazettes and the communication to Mercantile and Trade representative bodies of all Government decisions on questions raised and adjudicated upon under the Tariff Act. The Governor

General in Council is of opinion that the best way of giving effect to this suggestion is to publish such decisions in the Supplement to the Gazette of India, and to communicate them without delay to Chambers of Commerce and the Press, and further to collect the decisions and notifications and rules issued under the Act periodically into volumes of 'Selections from the Records of the Government of India,' which will be for sale to the public. This course will be followed in future, and this Resolution, together with the Resolution of the 3rd November 1894, cited in the preamble, and extracts from the speeches referred to in paragraph 2 are accordingly published for general information.

ORDER.—Ordered, that copy be forwarded to the Governments of Madras, Bombay, Bengal, and the North-Western Provinces and Oudh, to the Chief Commissioner of Burma; also to the Chambers of Commerce, Madras, Bombay, Bengal, Karachi, and Rangoon, and to the Upper India Chamber of Commerce.

Ordered also, that this Resolution and the papers mentioned in the last paragraph be published for general information in the Supplement to the Gazette of India.

#### Read-

Resolution in the Finance and Commerce Department No. 873, dated 31st May 1881. Resolution in the Finance and Commerce Department No. 3172, dated 25th June 1894. Letter from the Government of Bombay No. 5964, dated 13th July 1894.

In the letter from the Government of Bombay read in the preamble, the orders of the Government of India are requested on proposals made by the Collector of Customs, Bombay, for the adoption of some general principle for the guidance of Customs officers in differentiating between machines and machinery for the purpose of the levy of duty under the Indian Tariff Act.

- 2. The question has more than once engaged the attention of Government in connection with the working of former Tariff Acts. It was considered very fully in 1880 in view to the removal of the great diversity of practice which prevailed in the Custom Houses at that time in the classification of articles as machines (hardware) and machinery. On the suggestion then made that Government should either issue a general definition as to articles which should be deemed machinery, or frame an authoritative list of articles to be passed free as machinery, the decision arrived at, as stated in the Resolution of the 31st May 1881 read above, was as follow:—
  - These reasons have led the Government of India to the conclusion that neither a definition of machinery, nor a list of articles which should be exempted under that head, can be issued which would not be open to objection as including or excluding much which the law and the Government of India do not intend to include or exclude, as the case may be. The only feasible course to adopt is that local officers should exercise their discretion in determining what articles should be passed free as 'machinery,' bearing in mind the distinction between 'machinery' and machines' or articles so named, doubtful points being referred, as hitherto, to the Government of India.
- 3. The Government of India are still of opinion that it is practically impossible to frame in genera terms a definition of machinery which would not be open to the objections expressed in 1881 and still leave much opening for doubt and discussion. It may be possible, however, by supplementing a general definition by particular limitations, to lessen to a material extent the occasions for doubt; and in view of the difficulties experienced by Customs officers and the complaints by importers it is expedient that the question should again be fully considered.
- 4. It appears to the Government of India that the principle of imposing indirect taxation in the from of import duties for revenue purposes having been accepted, no reasonable claim can be urged for the exemption from duty of articles of common domestic use merely because they are called machines, articles, for instance, like coffee-grinding machines, which are found in every household, or sodawater machines. But a fair claim can be made for the exemption of machinery which represents fixed capital directly employed in the productive industries of the country. Any definition which failed to bring out this distinction clearly would obviously be defective.
- 5. The following definition has been suggested to the Government of India as substantially meeting the necessary conditions. It is both general and specific, and while the specification has been so framed as to include all important industries now existing in India, it also contains a proviso enabling Government to add to the list—

Machinery, meaning machines or sets of machines which are worked by electric, steam, water, or other power not being manual or animal labour, or which before being brought into use require to be fixed with reference to other moving parts; and the term includes all such machines or sets of machines intended for-

(a) the pressing, spinning, and weaving of cotton, jute, silk, wool or other fibres;

(b) the smelting of iron-ore and manufacture of iron;

(c) the manufacture of leather, paper, sugar, indigo, soap, gas, and flour;

(d) the milling of rice;

(e) the drying and rolling of tea;
(f) the pulping of coffee;

(g) printing presses;
(h) foundries and workshops of iron and other metals;

(i) the refining of petroleum; (i) mining, navigation, and agriculture;

(k) any other manufacturing or other industry that may be specified from time to time by the Governor General in Council;

Provided that the term does not include tools or implements.

6. On the suitability of this definition, which will require legislation to give it effect, the Governor General in Council desires to be favoured with an expression of the opinion of

Extract from the Speeches of the Honourable Sir James Westland, K.C.S.I., contained in the Abstract of the Proceeding of the Legislative Council dated 17th and 27th December 1894.

The second cause of the difficulties to which I am alluding is the indefiniteness of the lines which The second cause of the difficulties to which I am alluding is the indefiniteness of the lines which divide machinery which is free, articles made of iron which are taxed at one per cent., and hardware and cutlery, including ironmongery, which pays the five per cent. rate of duty. The exemption of machinery was based on the principle that it was undesirable to burden with a five per cent. duty capital employed in the productive industries of the country; but, even while the old Tariff was in force, difficulties were found in restricting the application of the exemption within its intended limits. 'Machinery' is a somewhat wide term, and it gives rise to claims for exemption of 'machines,' which is a still more indefinite and extensive term. We have met this difficulty by giving a somewhat precise definition of machinery, which will, we hope, have the effect of opening the door freely to such articles as represent what may be called the fixed capital employed in productive industries, but will at the same time prevent claims arising for exemption of articles which, though they may bear, in common parlance, the name of machines, have no right to expect entry into India without the same payment of duty the name of machines, have no right to expect entry into India without the same payment of duty which we levy upon nearly all other imported articles. The proposed definition of machinery was circulated to Chambers of Commerce, and other authorities, a short time ago, and has been slightly expanded in consequence of suggestions received.

The second point which the Select Committee took up was the question of the definition of machinery.

We have carefully considered this question, and I may mention to the Council the point of view from which, in the Bill as now framed, we have dealt with the subject, especially as it involves certain considerations which relate generally to the question of customs taxation.

The principle of the Bill, as has been so often said, is that of levying a general import duty of five per cent. If the rate were not only general but universal, the working of the Tariff would be easy, and, as a matter of fact, the difficulties which arise in applying a Tariff arise almost entirely out of the exemptions. The exemptions are the peculiarites which we have carefully to hedge round, so as to prevent their being extended beyond the grounds upon which they are based.

Now the question may fairly be asked, if we exempt the large and costly machinery of wealthy companies, is it not inconsistent to continue to tax the small machines used by workers in their own trades? But the principle on which the exemption of machinery is justified is this: looking to the fact that there is a certain amount of capital which is seeking investment in some productive line of business, we want to attract that capital to those lines of business in which India is interested, or, at any rate, to prevent it being discouraged by the weight of any initial taxation. We therefore proclaim this exemption in their favour, and we consider ourselves compensated by the fact that they will add to the production of the country, which eventually pays its dues to us in some shape or other.

Now this ground of exemption, whether it be a good one or a bad one, does not apply to the small producers of the country; there is in their case no new capital to attract in the same sense. They may or may not invest their savings in labour-saving machines, but at least they do not require the enticement of an exemption from taxation to determine the precise line in which they shall invest their money if they invest it at all.

The operation may look at first sight like taxing the poorer and exempting the richer. But this is a question that unfortunately arises in every individual case touched by the customs duty. In each case, taken by itself, it may be urged that it is hard that the burden of tax should be imposed. In is hard lines that the village carpenter should be unable to get his tools unweighted by a tax: it is hard lines that an old woman should not be able to get a warm garment without having a duty added on to its price. There is no answer to these arguments except to say that the money is absolutely required for the purposes of the administration, and that we cannot admit exemptions which are based upon the mere ground that the people who pay the tax would have somewhat fuller pockets if they did not pay it. You cannot work an Import Tariff on eleemosynary principles, and your exemptions must be based on some other ground than the mere hardship of having to pay the tax.

The exemption of machinery I base upon the economic ground I have stated, and I would rather reconsider the question of its exemption than admit a corresponding claim in the case of the innumerable other interests which might argue that they have as much claim to consideration as wealthy mill-owners and industrial companies. The comparative estimation of claims to consideration must to my mind be based upon economic grounds, and not on questions of comparative ability to meet the tax-collector's demands.

These remarks will explain the general scheme of our definition of machinery; and I have only further to remark with reference to it that what we sought was not a scientific definition of machinery, as such, but a definition which would as accurately as possible include the kind of articles which on the grounds I have stated we proposed to exempt, and could not be stretched so as to include others to which those grounds do not apply. We want a working definition for our Custom Houses, and not merely one that will pass a dialectic scrutiny.

We had some discussion over the question of component parts, with reference to which more than one suggestion was made to us; and objection has been taken especially to the limitation expressed in the words 'which are not adapted for any other purpose.'

Now, I admit there is a certain difficulty in defining exactly what is a component part of machinery and what is not. It is easy to see that what are ordinarily classed as 'renewals' and 'spares'—duplicates of those parts of a machine which wear out most rapidly—are component parts. It is easy also, I take it, to see that nuts and bolts are not component parts except when they are actually in their place in the machine, or at least are not separately imported. But at intermediate stages between these there may be some difficulty. A cog-wheel, for example, may be imported for the particular purpose of being fitted into a particular part of a machine ready for it, or it may be imported without reference to any particular purpose, and simply as hardware. I cannot help thinking that the circumstances of importation are in such cases a guide to the Customs Collector; and I do not know any better way of indicating the test than that of its being, owing to the special shape, adapted for the particular purposes and not for general use for miscellaneous purposes. Again, there are articles which may be described as parts of machinery, which are perpetually being used up in its working and requiring continual replacement. Take, for example, asbestos packing; there is no more reason why that should be exempt merely because it is used for machinery than for the exemption of lubricating oil. The principles on which we base the exemption of machinery do not apply to what may be called the stores used up in its working.

It is not possible to work a Tariff upon the principle that the same article may be taxed, or may be exempt, according to the purpose which the particular importer has in view. Wire gauze, for example, is used for a hundred different purposes. We cannot allow a paper manufacturer to claim an exemption for his importation on the ground that he requires it for the working of his paper machines, and tell all other importers that because they are not paper manufacturers they must pay duty. It is not therefore the mere fact that an article is to be used with, or fitted into, a place in a machine that gives it its claim to exemption, but the fact that in ordinary practice that and no other is the purpose for which the article is imported and used; and that the article is such and of such special character that on its importation it may be at once presumed that use as part of an exempted piece of machinery is the purpose for which it is required.

We have considered all the suggestions that have been made to us in respect of these definitions, and we have adopted several of them, but some of them we considered to go too far, and to be framed on such a principle that, though they were good so far as they went, they did not sufficiently bear in mind the necessity of restricting the exemption to those things alone which ought, on our principles, to go untaxed—a necessity which, from the point of view of the Government, is just as important as that of declaring the exemption itself."

### BY THE COMMISSIONER OF CUSTOMS, SALT, OPIUM AND A'BKA'RI.

#### NOTIFICATION.

No. 134—In exercise of the powers conferred by Sections 24 and 75 of the Sea Customs Act, VIII of 1878, and in supersession of all previous rules, the Commissioner of Customs is pleased to make the following rules for passing free of Import duty baggage in actual use and for the landing of passengers' baggage and passing the same through the Custom House at Bombay:—

#### FREE BAGGAGE.

1. Baggage includes all packages imported by a passenger for his or her own use which are not part of the cargo and are not manifested.

Baggage is not exempt from duty except under the circumstances mentioned below:

2. Baggage is exempt from duty only when it consists of articles free from duty or of bond fide wearing apparel and other articles of personal use, the property of the person whose baggage is being passed such as are in actual use at time of importation or have been actually in use previously. It is in the discretion of the proper officer of Customs to determine, subject to the above rules, whether any goods shall be treated as baggage exempt from duty or as goods liable to duty.

LANDING AND PASSING OF BAGGAGE THROUGH THE CUSTOM HOUSE.

### I .- Troopships.

- 1. Returns in the appended Form A will be supplied to the Commanding Officer on board, who should see that they are filled in as regards columns 1 to 3, and countersign them himself before the arrival of the transport in the harbour.
- 2. Immediately on the arrival of the transport she will be boarded by a Customs Officer, who will receive all the returns along with a list of all the officers on board.
- 3. The said Customs Officer will fill up columns 4, 5 and 6 in each return and recover the amount of duty payable from the person in whose name the goods are entered, and give a receipt in the appended form.
- 4. If the said Customs Officer is furnished with a list of all the officers on board and with complete returns duly filled in as aforesaid, all passengers' baggage on board may be landed free from Customs control.
- 5. The foregoing rules will not, however, preclude the Customs House authorities from examining or detaining any goods as to which any doubt may arise.

### II.—Steamers (other than troopships) and square-rigged vessels from Foreign Ports.

1. Immediately after the vessel has anchored, a Customs Officer will examine and pass on board all free cabin baggage not contained in soldered or nailed down cases, which the passenger may offer for examination including (1) uniform, and accountrements appertaining thereto, belonging to a public servant for his personal use; (2) arms forming part of the equipment of an officer entitled to wear diplomatic, Military, Naval or Police uniform on his making the following declaration on the baggage form:—

"I hereby declare I am a Officer\* serving in India."

- 2. All baggage passed as above may be landed at any Bandar and removed without further Customs control.
- 3. All other baggage may be landed either at the Docks, at Carnac Bandar or at the Town Bandar under cover of boat-notes if discharged in the stream. After landing it may be cleared at any time between 10 A.M. and 5 P.M. on the owner or his agent producing the keys of all locked packages and presenting a signed declaration in Form B, and paying the duty and landing charges, if any, at the Docks Custom House, or Town Custom House.
- 4. No fire-arms belonging to any one passenger in excess of two guns or two rifles and a revolver or a pair of pistols will be passed without the permission of the Collector of Customs.

### III .- Native Craft from Foreign Ports.

Passengers will be required to go with all their baggage to the Customs Officer in charge of the Dutiable Anchorage, who will examine it and pass all free articles contained in cases that he has the means of opening. The Customs Officer will send all dutiable articles and all cases which he cannot open to the Custom House, there to be cleared by the owner on payment of duty.

### IV .- Steamers from Customs Ports.

- 1. All personal baggage arriving by steamers from Customs Ports will be passed free by Customs Officer on board the steamer on the passenger making a declaration in the above Form B, and certifying that the baggage was actually shipped at the Customs Port from which the passenger has arrived and not transhipped at such a port from a vessel from a Foreign Port without payment of duty.
- 2. In the event, however, of the baggage having been transhipped at a Customs Port from a vessel from a Foreign Port, the baggage will be dealt with in the same way as the baggage coming direct from Foreign Ports.

<sup>\*</sup> In the case of a Military Officer it should be stated whether in Military or Civil employment.

### V .- Transhipment.

In the case of baggage to be transhipped direct to another steamer along with the passenger to either a Customs or Foreign Port, transhipment will be allowed under supervision of a Preventive Officer and under cover of a written transhipment order obtained from him on a boat note form. Duty on the dutiable portion of such baggage if for a Customs Port must be paid at the Port of destination and all such baggage shall be included in the list of transhipment goods for Customs Ports put in by the Master of the oncarrying-steamer when applying for Port clearance.

- 3. An article, on which duty has previously been paid on its importation into India, is exempt, if not more than three years have elapsed since it was taken out of India, and it remains the property of the original importer, or a member of his family. All such articles should be entered in the Schedule, and the grounds of exemption stated in the last column, and the receipts referred to in paragraph 7 below produced, without which no claim for exemption under this paragraph will be admitted, except in the case of articles on which duty was paid on first importation before the 14th November 1891, the date on which this rule was introduced. No claim for exemption from duty on fire-arms, made on the grounds that the arms are re-imported and duty has been paid on them on their first importation, will be allowed in respect of arms exported after six months from the 15th December 1894 unless:—
  - (1) in the case of arms exported as baggage, particulars of the arms as to description, and the name of maker and number on the arms have been forwarded to the Customs House at the port of embarkation for registration and a pass obtained before shipment, and the pass is produced at the time of re-importation for the purpose of checking the arms with the pass; and
  - (2) in the case of arms exported as cargo, particulars of the arms as above have been given in the shipping bill and information as to date and vessel by which exported is furnished at the time of re-importation, to allow of the information being checked by a reference to the shipping bill; or if the port of re-importation is not the original port of exportation, a certificate is produced from the Customs authorities at the port of exportation certifying to the correctness of such information.
- 4. Military officers in Military employment are allowed to pass free a sword and either a revolver or a pair of pistols as part of their equipment. Military officers in Civil employment are not entitled to free entry except for arms forming part of their uniform, that is, for a sword alone.
- 5. This Return, duly countersigned, together with a nominal roll of all officers embarked, should be handed over by the Officer Commanding the Troops on board, immediately on arrival in Bombay, to the officer superintending the disembarkation, for delivery to the Custom House Officer when he comes on board
- 6. Columns 4, 5 and 6 will be filled in at once by the Custom House Officer who comes on board, and the duties will be received by him.
- 7. On paying duty, the officer will receive a printed receipt, which must be shown on demand to any Customs Officer on board the ship at Sassoon Dock or at any Bandar. In the case of arms, if they are sudmitted for examination, the Custom House Officer will note in the receipt, for future identification, the description of the arms and the name of the maker and the numbers on them. Without these particulars no receipt will be admitted in support of any claim for exemption under paragraph 3 above.
- 8. It is to be clearly understood that any omission or false declaration in this Return will subject the articles, if liable to duty, to seizure and confiscation, under Section 167, Clause 40 of Act VIII of 1878. Every such case will be reported in writing by the Custom House Officer to the Superintending Staff Officer for the information of the Brigadier-General.
- 9. Officers are informed that the Custom House authorites are empowered to examine and detain all packages which they suspect or regarding which doubts may arise. All such cases will be reported by the Custom House Officer on board or at the Custom House, Sassoon Dock or any other Bandar, to the officer superintending the disembarkation, who will thereupon, under the orders of the Brigatier-General, direct the Officer Commanding the Troops to deliver packages to the Custom House Officer, who thenceforward becomes responsible for the same.

The receipt granted under paragraph 3 above must be produced or no claim for exemption under this paragraph will be admitted, except in the case of articles on which duty was paid before the 14th November 1891, the date on which this rule was introduced. No claim for exemption from duty on fire-arms, made on the grounds that the arms are re-imported and duty has been paid on them on their first importation will be allowed in respect of arms exported after six months from the 15th December 1894 unless-
  - (1) in the case of arms exported as baggage, particulars of the arms as to description, and the name of maker and number on the arms have been forwarded to the Customs House at the port of embarkation for registration and a pass obtained before shipment, and the pass is produced at the time of re-importation for the purpose of checking the arms with the pass; and
  - (2) in the case of arms exported as cargo, particulars of the arms as above have been given in the shipping bill and information as to date and vessel by which exported is furnished at the time of re-importation, to allow of the information being checked by a reference to the shipping bill; or if the port of re-importation is not the original port of exportation, a certificate is produced from the Customs authorities at the port of exportation certifying to the correctness of such informa-
- 5. Military officers in Military employment are allowed to pass free a sword and either a revolver or a pair of pistols as part of their equipment. Military officers in Civil employment are entitled to exemption from duty only on the sword which forms part of their uniform.
- 6. A fee of one and a half annas per package is charged on baggage landed at the Town Bandar from Mail Steamers.
- 7. Any person making a false declaration or attempting to pass dutiable goods without payment of duty is liable to a fine of Rs. 500 and confiscation of the property.
