No. 3500.—The following Notice issued by Her Britannic Majesty's Consul, Bassoral, regarding the procedure to be observed by British Indian sailing vessels visiting the Shat-el-Arab, is published for general information:—

" Notice.

British Indian sailing vessels visiting the Shatel-Arab (Bassorah river) should observe the following procedure:

 That they should fly their flag night and day from the time of entering the river till they have left it.

- II.—That they should provide themselves with bills of health granted by the competent authorities of the port whence they come, indicating the vessel's destination.
 - III.—That the vessels bound for Muhammerah are not subject to Ottoman Sanitary Service and Customs Regulations, and that therefore they need not stop at Fao.
- IV.—That the Quarantine Office at Fao when recovering quarantine tax from vessels bound for Bassorah will accept one rupee for six piastres (Kurush).
- V.—That Nákhodas have not to pay any money to Turkish officials for which they do not get receipts, and that they should at once report to the British Consul at Muhammerah or Bassorah any irregularity or ill-treatment they may have experienced at the hands of Turkish officials.
- VI.—Vessels bound for Bassorah or other Turkish ports on the river will stop at Fao and do quarantine, if required, before proceeding onward."

New Light at Gogha Bundar, Gulf of Cambay.

Information has been received from the Commissioner of Customs, Salt, Opium and A'bkári, dated 7th instant, that on 1st April 1895 a light was exhibited from an iron structure recently erected at Gogha Bandar.

Gogha Light is a 6th order dioptric fixed white light elevated 25 feet above high water spring tides and is visible from seaward between the bearings of N.W. through west and south to S.S.E. from a distance of ten miles in clear weather.

General Rules of 1895 for working Railways open for traffic.

Read-

Section 47 of the Indian Railways Act, 1890.

Government of India, Public Works Department, Notification No. 118, dated the 21st March 1895, publishing—in the Gazette of India of the 23rd March 1895—the Government of India circular No. 6 Railway, dated the 12th March 1895, and the General Rules for all open lines of railway in British India administered by the Government, therewith promulgated.

Letter from the Government of Bombay, Public Works Department, Railway Branch, No. 1214, dated the 1st June 1895, forwarding letter from the Manager and Engineer-in-Chief, Bhavnagar-Gondal-Junagarh-Porbandar Railway Company, No. 2151, dated the 16th May 1895.

OBSERVATIONS.—The Manager and Engineer-in-Chief, Bhavnagar-Gondal-Junagarh-Porbandar Railway Company, has applied that the General Rules for working open lines of railway in British India administered by the Government, which have been published in the Gazette of India of the 23rd March 1895, under the Government of India, Public Works Department, Notification No. 118, dated the 21st March 1895, may be made applicable to the Bhavnagar-Gondal-Junagarh-Porbandar Railway.

RESOLUTION.—The Governor General in Council is pleased to sanction, with effect from the 1st

January 1896, the application to such portion or portions of the Bhavnagar-Gondal-Junagarh-Porbandar railway as are situate in British territory, of the General Rules for open lines of railway in British India administered by the Government which are cited in the foregoing observations, in supersession of the rules now in force.
