No. 324.—The following Despatch from Her Majesty's Secretary of State for India, No. 3, Judicial, dated the 18th July 1895, with its accompaniments, is published for general information:—

"No. 3, Judicial INDIA OFFICE, London, 18th July 1895.

To His Excellency the Right Honourable the Governor in Council, Bombay.

My Lord,

I forward a copy of a letter* (with enclosures) from the Right Honourable Lord

* 19th June 1895.

Herschell with reference to the newly constituted Society of
Comparative Legislation of which he is the President.

2. I request that Your Excellency in Council will take the matter into your consideration and adopt such means as you may think best fitted to further the objects of the Society.

House of Lords, S. W., the 19th of June 1895.

Sir,—As President of the Society of Comparative Legislation and at the request of the Council of that Association, I have the honour to invite your co-operation in furthering the objects of the Society, and your assistance in bringing those objects to the notice of the Indian Governments.

The Society, as you are aware, took its inception from a valuable paper read by Sir Courtenay Ilbert, K.C.S.I., before the Fellows of the Imperial Institute on the * * * * * * * * 1894, and definitely took shape at a large and important inaugural conference held at the Imperial Institute on the 19th of December 1894 over which I had the honour to preside.

The Society has since obtained more definite organization; the Council and the Executive Committee have been formed, and a formal constitution and prospectus, or scheme of the objects of the Society have been drawn up. Of these documents, I have now the honour to enclose copies, in the hope that you will be good enough to have them placed on record in your Department, and that you will also forward copies to the Governor General of India and the Governors of Madras and Bombay for their consideration accompanied with an invitation that they will severally take such action as may appear best calculated to advance the objects which this Society has in view and to promote the study of comparative law.

Those objects are both practical and scientific. The Society is intended to be of service to legislative bodies both here and elsewhere, to practising lawyers and to jurists, and students of sociology. If the Authorities in India will help us, we believe that we shall be able to repay any assistance they may render, by communicating to each the results of the work to which all will have contributed, after that work has been arranged, assimilated and supplemented by ourselves.

I do not enlarge further upon the objects of the Society, for these are fully detailed in the documents which I enclose, but it may be well that I should briefly indicate the nature of the assistance which those who are so disposed can afford us. It is hoped that many persons in India will help in the useful work to be done by the Society so far as to become subscribing members of it, and it would be useful, if, in each province having a Legislature, persons of position would consent to act as Local Agents, for the purposes of procuring subscriptions to the Society and otherwise assisting its objects. I should be glad to think that branch Societies will eventually be formed, from whom the Central Society may receive valuable suggestions and co-operation. But at present I can do no more than ask that suitable persons may be found to accept the position of corresponding members to whom our communications may be addressed and from whom we may obtain information. I trust that we shall be so fortunate as to secure as our correspondents either the Chief Justices or some other Judges or the Advocate General or some other barristers who will carry sufficient weight to enable them to organise branches of the Society.

I have ventured to ask you to become on this occasion the medium of communication with the Indian Governments, as it has appeared desirable that the first communication from the Society should reach India in the most influential manner; but I have no wish to trespass further upon your kindness, and any replies that this letter may produce, will, I trust, be sent direct to me at the Imperial Institute, and the Secretaries will then know to whom future letters from the Society should be addressed.

It would not be becoming in me to make suggestions to the Authorities in India as to the mode in which the subject dealt with in this letter should be treated, but I venture to think that the Society will be more successful if it is remembered that work of the character required comes better as the fruit of individual effort, than as the result of directions emanating from a Government Institution.

THE SOCIETY OF COMPARATIVE LEGISLATION.

A conference, presided over by the LORD CHANCELLOR, was held at the Imperial Institute, on the 19th December 1894, to consider the best means of furthering the study of Comparative Legislation, as suggested in a paper lately read at the Institute by Sir Courtenay Ilbert, K.C.S.I. The following Resolutions were passed :-

Moved by the LORD CHANCELLOR, seconded by SIR ROBERT HERBERT, G.C B. :-

(1) "That it is expedient to establish a Society of Comparative Legislation, with the object of promoting knowledge of the course of legislation in different countries, more particularly in the several parts of Her Majesty's Dominions, and in the United States."

Moved by LORD HOBHOUSE, K.C.S.I., seconded by SIR RAYMOND WEST, K.C.I.E. :-

(2) "That, for this purpose, a Council be formed, with instructions to nominate an Executive Committee, charged with the duty of preparing a Constitution for the Society, and of indicating the best mode of carrying out its objects."

Moved by the Lord Chief Justice of England, seconded by Mr. Thomas RALEIGH :-

(3) "That the Lord Chancellor be the first President of the Society."

These resolutions were the origin of the Society. Some further explanation of its objects, however, may be needed.

They are both practical and scientific. The Society is intended to be of service to legislative bodies, practising lawyers, jurists and students of sociology.

To jurisprudence the Society will apply the comparative method of investigation, which has already proved fruitful. It will gather together, epitomise, and arrange materials now scattered through many periodicals, or to be found only in official documents of which few libraries contain copies, and it will otherwise endeavour to promote the study of comparative law. Chief among its aims will be the collecting of information as to the statute law and the forms and methods of legislation in the British Empire and the United States.

In France, Germany, and America, similar associations exist; and it has long been matter of surprise that no such society has been formed in the British Empire, with its great variety of legal systems. In India, where English, Hindu, and Mahomedan law coexist, and have affected each other, and where ancient customs of interest to the legal historian are still observed, and in our colonies, dependencies, and possessions, in which French, Roman-Dutch, and Spanish law subsist, will be found a vast field for the work of a Society of Comparative Legislation. In extent and variety, the jurisdiction of the Judicial Committee of the Privy Council, as a Court of Appeal, is unequalled. In a single year, it may be called upon to consider questions of constitutional law of moment to all civilised countries, cases dependent on Hindu or Mahomedan law, on texts of the Digest, on the Ordonnances of Louis XIV., on the Coutume de Paris or other portions of the old customary law of France before the Revolution, or on the ancient customs of Normandy. It is somewhat remarkable that there should not have long ago been founded a society for the scientific study and comparison of the very diverse laws brought before the Appellate Court of the colonies and possessions of the British Empire.

Benefits, direct and indirect, from the labours of the Society may be counted upon.

In the British Empire are some 60 Legislatures; in the United States are nearly 50. Each of them is occupied with much the same problems. The same questions as to criminal law and the administration of justice, capital and labour, marriage and divorce, patents and literary property, the regulation of the sale of intoxicating liquors, education, railways, companies, bankruptcy, merchant

shipping and mercantile law generally, come from time to time before the British and Colonial Parliaments, and the Legislatures of the States of the American Union. Experiments as to similar subjects are being made by more

than a hundred legislatures in English speaking countries.

It is not uncommon, on the introduction of measures into Parliament, to refer to the laws of other countries. At present the results of foreign experiments are only imperfectly and casually brought to the notice of those who might profit by them; and enactments may be proposed and adopted in one English speaking community in ignorance of the fact that similar measures have after trial been abandoned or modified in another. Much, it is conceived, might be learned with advantage both as to the substance and as to the form of legislation, and many mistakes might be avoided, if precedents derived from the experience of other countries were collected and studied. In the future changes in criminal law, for example, it would be advantageous to have some acquaintance with the provisions of the Criminal Codes passed after careful discussion in Germany, Holland, Italy and Hungary. Impressed by the advantage of ascertaining systematically the course of foreign legislation, M. Dufaure established, in connection with the French Ministry of Justice, the Comité de Législation Etrangère, the duty of which was to collect and arrange information as to foreign laws. M. Dufaure's action has, it is believed, been justified by the results. It is hoped that the Society of Comparative Legislation may render services of a similar kind, and may be the means of enabling Governments and Legislatures to profit by useful precedents.

English speaking races shew a tendency towards unity in law. Our colonies borrow the principle and form of many statutes from England. The United Kingdom also borrows from the colonies. Among the colonies themselves, there is a like movement, and the same interchange goes on between the United Kingdom and her colonies and the United States. No fewer than 36 States of the American Union, it is alleged, have adopted the Australian Ballot system. The Torrens system of land transfer, which had its origin in South Australia, and the provisions of which were to some extent founded on the register of British ships, has been adopted in many of our colonies. One law as to bills of exchange may be said to exist throughout the Colonial Empire. A similar statute is in force in India. Several of our colonies have adopted a bankruptcy law

borrowed from the English statutes of 1861, 1869, and 1883.

The open and avowed adoption of statutes gives no complete idea of the extent of assimilation. Underneath differences of phraseology will be found a tendency to approximation even in colonies and possessions where the English common law never prevailed. The Roman-Dutch law, for example, in both South Africa and Ceylon, has been modified by the introduction of elements

borrowed from English statute and common law.

Very often the local differences are unimportant and accidental. In the United States are some 47 different systems for conducting civil litigation. But for the most part they are based on the New York Code, the English Common Law Procedure Acts, and the Judicature Acts. "While nearly every one of these divers systems is founded upon one or the other of two models, and conforms to its model in all substantial particulars, probably no two of them are alike in every respect." In some colonial statutes relating to procedure, it is stated that, "unless it is otherwise provided," the procedure shall be regulated

by the practice in the Superior Courts in England.

English Mercantile Law is already to a large extent the law of all English speaking countries. On this subject the same rules are acted upon, the same decisions and text books are cited with respect, in all courts of the British Empire and in the United States. The statutory modifications of the Lex mercatoria here and elsewhere are similar. The Indian Contract Act, embracing sale of goods, indemnity and guarantee, bailment, agency and partnership, is framed apon English decisions and statutes. Our colonies and several States of the American Union have passed similar statutes altering the common law to meet the necessities of modern commerce. The Factors and the Companies Acts are cases in point; they are reproduced, generally with slight modifications, in colonial legislation. In the Cape Colony, where Roman-Dutch law is the basis, the

Legislature has, by a single Act, incorporated a large part of the commercial law of England (Act 8, 1879). There is still, however, much diversity in the law relating to bankruptcy. In some parts of the British Empire no bankruptcy law proper exists. In the interest of commerce few legal reforms could be more beneficial than the adjustment and determination of rights in bankruptcy and the administration of bankrupt estates throughout the Empire according to the same principles.

There was a time when it seemed that Roman law might become the law of the world. In the early part of this century, the tendency in countries engaged in codifying their law was to take the Code Civil of France as a model. This is no longer the case. In recent times the tendency, especially as to commercial legislation, is to approximate to English Law. It has spread almost as widely as the English language or literature.

In accordance with a plan which has proved successful in the case of the American Bar Association and the Institut de Droit International, standing committees, entrusted with separate parts of the work of the society, will be formed. The number and nature of the committees will depend on the assistance which the society receives. But the intention is to begin with only a few important subjects.

One of the first committees to be formed will be a Statute Law Committee. In furtherance of its work, communications will be addressed to the Governments of British colonies and dependencies, with a view to obtain information as to the existing condition of statute law, and in particular as to the following points:-

The form of statute and written law. II. Modes of preparing and passing bills. III. Revision and amendment of statutes.

Form and manner of publication and numbering of statutes. Measures taken to secure uniformity of language. IV.

V.

VI. Consolidation and Codification.

VII. Indexing of statute law.

One result of the labours of the Society may be, it is hoped, to bring about uniformity in regard to the form, numbering and publication of statutes; as to which there is now great diversity. Efforts will be made to procure the preparation, on some uniform plan, of a satisfactory index of the statutes of each legisature; and perhaps it is not too much to hope that we may one day have a general index of the legislation of the British Empire. Mr. Stimson, in his Digest of the Laws of the States of the American Union, and the University of New York, in its Library "Bulletin," have shown what may be done within a moderate compass. Prepared not solely for the use of the lawyer, such an index as is here suggested might be of use to the statesman and student of sociology.

It may be expedient in the first instance to deal chiefly with statute law. This will not, however, be the sole work of the Society. As the Lord Chief Justice pointed out at the recent conference, the statute law of a country cannot be understood without reference to the common law on which it is based, and which it was intended to correct.

The services of those who are interested in different parts of comparative jurisprudence will be made use of. In India alone, which is at once, to cite Sir Henry Maine's language, "the great repository of verifiable phenomena of ancient usage and ancient juridical thought," and the scene of some of the most interesting modern experiments in legislation, is a limitless field for work such as the Society seeks to promote. There are interesting modern Codes goaying as the Society seeks to promote. There ancient and modern Codes coexist. In customs and usages, still observed, are legal conceptions of which in the Western world are only obscure traces; and the meeting of several diverse systems of law has given rise to problems akin to those which in the decline of the Roman Empire arose from the contact of its law with the customs and laws of other States.

Here it may be pointed out that in no modern book is there an adequate treatment of the systems of law in force in the British Empire. The first and only edition of Burge's "Commentaries on Colonial and Foreign Laws" is dated 1838.

Little can be done without co-operation in all parts of the Empire. It is intended to establish branches in the different colonies and possessions. From these branches valuable suggestions may be expected. With them, in great measure, must rest the success of the undertaking. It is desired to enlist the aid in particular of the Governors, Chief-Justices and Judges of our colonies, of Chambers of Commerce throughout the Empire, of the Inns of Court and Incorporated Law Societies, of the Universities, of the Diplomatic and Consular Services, and of the Bar Associations and Statute Revision Commissions in the United States.

Probably the work of the Society would be advanced by holding from time to time conferences. In Germany, Italy, Austria, and Switzerland, representative meetings of lawyers and jurists annually take place. At these meetings are discussed questions of interest to the legal profession and the public. It is no disrespect to existing associations to say that hitherto no meetings, with the objects here indicated, have taken place in England, or in any part of the British Empire; and it is believed that the utility of the new Society would be recognised, its objects would be shewn to be not merely academic but practical, if conferences were periodically held for discussion of legal matters affecting the whole Empire.

The information collected by the Society will be edited, and published in a concise and intelligible form, for the use of members.

Provided that no person shall be charged with the commission of any offence punishable under this rule except on the complaint of the person importuned, or of a member of the police force employed in the cantonment above the rank of constable, or of a member of the military police force employed in the cantonment and specially authorised in this behalf by the Commanding Officer of the cantonment, or of an officer as defined in the said Act.

- 3. (1) No person shall, except in the following cases, be arrested without a warrant on a charge of having committed a breach of Rule 1:
 - (a) Where such person is arrested at the request of the person importuned, or of a member of the military police force employed in the cantonment and specially authorised as aforesaid, or of an officer as defined in the said Act, in whose presence the said breach was committed.
 - (b) Where the member of the police force arresting such person is of a rank superior to that of constable and the said breach was committed in his presence.
- (2) In either of the cases mentioned in the last foregoing clause of this rule, any member of the police force employed in the cantonment may arrest, without a warrant, any person committing or charged with having committed a breach of Rule 1:

Provided as follows:

- No person shall be so arrested whose name and address are known either to the complainant or the arcsting officer.
- (ii) No person shall be so arrested who consents to give his name and address unless there is reasonable ground for doubting the accuracy of the name or address so given, the burden of proof of which shall be on the arresting officer.
- (iii) No person so arrested shall be detained after his name and address have been ascertained.

(3) No person arrested under this rule shall, except under the order of a Magistrate, be detained longer than may be necessary for bringing him before a Magistrate.

NOTICE.

ORDER TO THE PUBLIC.

Whereas in former years, on the occasion of festival processions in the streets of the town of Belgaum, disturbances of the public peace have occurred in consequence of assumption by certain of the processionists of masks or disguises offensive to the feelings of persons of other castes; I issue the following orders (under Section 42 of the District Police Act IV of 1890) in view to prevent any such disturbance taking place at the approaching festival of the Daspra:—

- (1) *On the occasion of the procession to be held on various days on or about the 19th Septem-
- *In the public streets of the town and cantonment of Belgaum.

 ber to 28th September 1895, both days inclusive, in connection with the Dasara festival, no mum-

mer or person disguised in any way will be permitted to take part in or accompany any such procession unless he shall have obtained a written pass from the District Superintendent of Police granting him permission so to do.

- (2) Again, on the aforesaid dates no such mummer or disguised person shall, without special permission from the District Superintendent of Police, perambulate or appear in the aforesaid streets, unless he takes part in or accompanies a procession, directions for the conduct of which have been issued by the District Superintendent of Police, except indeed he be on his way to or from any such procession.
- (3) Further, no one shall, without permission from the Superintendent of Police, take part in or accompany such procession who is armed with a stick or stone or anything whatever that may be used as a weapon of offence.
