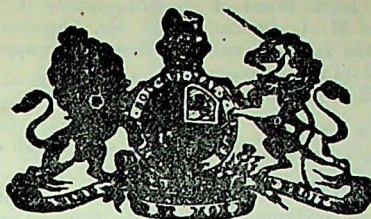

Notifications under the Bombay Local Boards and District Municipal Acts.

GENERAL DEPARTMENT.

Bombay Castle, 1st October 1895.

No. 4048.—In exercise of the power conferred by Section 27 of the Bombay Local Boards Act of 1884, His Excellency the Governor in Council is pleased to approve of the appointment by election of Ráo Sáheb Annaji Vásudev Mulgund to be Vice-President of the Táluka Local Board of Kalghatgi in the Dhárwár District.

No. 4049.—In exercise of the power conferred by Section 27 of the Bombay Local Boards Act of 1884, His Excellency the Governor in Council is pleased to appoint Mr. R. A. Lamb, I. C. S., to be President of the District Local Board of Kolába vice Mr. H. W. J. Bagnell, I. C. S., resigned.

Proclamation.

No. 4050.—Under the provisions of Section 10 of the Bombay District Municipal Act Amendment Act II of 1884, the Governor in Council is pleased to announce that it is proposed to alter the limits of the municipal district of Dhulia in the Dhulia Táluka of the Khándesh Collectorate so that the boundaries of the said municipal district will be as under—

North.—Susi Nála.

South.—Along the road from the Jamnagiri Temple to the cross roads near burial ground in front of the New Civil Hospital; thence along the front of the military lines to the junction of the Chálisgaon and Málegaon roads; thence along the eastern berme of the Málegaon road to the southern boundary to the north of Hagra Nála of Survey No. 460;

thence along the north bank of Hagra Nála to the western boundary of Survey No. 453; thence along the east of the eastern berme of the Chálisgaon road as far as the bridge over Vinchurkar's Nála on the Chálisgaon road.

East.—Along the right or east bank of the said Vinchurkar's Nála from the Chálisgaon road as far as the western boundary of Survey No. (revised) 444; thence along the eastern boundary of Survey Nos. (revised) 393, 375, 400, 401, 334, 332, 331, 295, 278, 63 to the junction of the northern boundary of Survey No. (revised) 63 with the eastern boundary of Survey No. (revised) 64; thence along the east bank of the said Vinchurkar's Nála to its junction with the Pánjhra river.

West.—Along the west or left bank of Moti-Nála from the Jamnagiri Temple to the Pánjhra river in a continuous line adjoining the Survey Nos. 10, 39, 84 and including a portion of No. 14 belonging to the village of Mahindale and thence eastward along the bank of the Pánjhra river until it reaches the Moti Nála.

All persons who entertain any objections to the said proposal are hereby required to submit the same, with the reasons therefor in writing, to the Secretary to Government, General Department, Bombay, within two months from the date of this Proclamation.
