NOTIFICATIONS.

GENERAL DEPARTMENT.

Bombay Castle, 9th December 1895.

No. 5360.—The following draft of rules which it is proposed to make under Section 35 of the Bombay Boiler Inspection Act, 1891—

- (1) for settling under clause (a) thereof the duties and emoluments of Examiners appointed under the said Act,
- (2) for regulating under clause (c) of the said section the conduct of the examinations to be held under Section 19 of the said Act,
- (3) for prescribing, under clause (d) of the Section 35 aforesaid, the qualifications to be required of candidates at the said examinations, the fees to be paid by them, the forms of certificates to be granted to them, and the

capacity of boiler of which each such certificate shall qualify the holder to be in charge, and

- (4) under clause (f) of the Section 35 aforesaid generally for giving effect to the provisions of the said Act in every part of the Presidency of Bombay in which that Act is in force, including Aden;

is published for the information of persons likely to be affected thereby. It is proposed that the rules in this draft should supersede all rules heretofore in force under the said Act with the exception of those published under Government Notifications

I.—Preliminary.

1. These rules may be cited as "The Bombay Short Title. Engineers' Examination Rules, 1895."
2. In these rules unless there be something repugnant in the subject or context—
 - (a) "the Act" means the Bombay Boiler Inspection Act, 1891;
 - (b) "section" means a section of the said Act;
 - (c) "the Collector" (i) means in the City of Bombay the Collector of Bombay, (ii) in Aden includes the First Assistant Resident, and (iii) means elsewhere the chief local officer in charge of the revenue administration of a district;
 - (d) the words defined in Section 3 shall be deemed to have respectively the same meaning as is given to them by the Act;
 - (e) words in the singular include the plural and *vice versa*.

II.—Board of Examiners.

3. The Collector shall be *ex-officio* President of the Board of Examiners.
4. The Examiners from time to time nominated under Section 20 shall

7. The Examiners shall endorse on the printed application of each candidate the result of his examination for a certificate of competency, and return to the Collector the application so endorsed.

III.—Examinations.

8. (i) Examinations shall ordinarily be held

9. Every examination shall be attended by one or more clerks from the Collector's office, who shall do such clerical work as may be necessary and shall act as interpreter when required to do so by the Board of Examiners.

10. The examinations will be of three kinds,

IV.—Admission of Candidates to the Examinations for Certificates of Competency.

A.—General.

11. Candidates at examinations for certificates

Unsuccessful candidates will not be entitled to a return of any portion of the fees paid by them; but, if applied for, the fee paid by any applicant who is not admitted to examination will be returned to him in full:

Provided that in the event of a candidate being unavoidably absent from any examination for which he has paid fees, it shall be in the discretion of the Collector to allow him to appear at any examination held within six months of the first without a second payment of fees.

12. Every applicant for examination must

| Application. | make an application in the form of Appendix A. He shall duly fill in all the parts of the said form which are to be filled in by a candidate, and sign the same in the presence of the Collector, an Assistant Collector or a Magistrate, who shall append his signature in token of attestation. The applicant shall then lodge his application at the office of the Collector not later than fifteen days |

before the date fixed for the examination, together with—

- (a) all testimonials of good character, sobriety, experience and ability, together with copies of the same;
- (b) any other papers required by these rules or the printed form of application; and
- (c) a receipt from a Government treasury for the amount of the fee prescribed in Rule 11 for the examination at which he wishes to appear;
- (d) a letter declaring in what language he desires to be examined;
- (e) all previous certificates issued to the applicant under the Act.

13. Candidates for certificates of competency

Candidates to be able to read. who are natives of India must prove to the satisfaction of the Examiners that they can read their vernacular sufficiently well to perform the duties required of them.

B.—Testimonials.

14. No applicant will be admitted to examination

Testimonials. whose testimonials as to sobriety, experience and ability do not relate to a period of at least 12 months immediately preceding the date of application to be examined, and are not in the opinion of the Board trustworthy and satisfactory.

15. The testimonial for any period during which the candidate acted as a chief engineer must be signed by the manager, owner or secretary by or under whom the candidate was employed, and, for such period as he acted as a second or lower grade engineer, must be signed by the chief engineer, to whom the candidate was subordinate; but if for any sufficient reason the chief engineer's signature is not obtainable, it may be signed by the manager, owner or secretary, but the testimonial must declare that the facts stated therein are either in accordance with the reports of the chief engineer, or, if no such reports are available, are within the personal knowledge of the person signing the same.

16. Testimonials relating to service beyond the limits of British India must be countersigned either by the Consul, or by some other recognised official authority of the country in which the service was performed; or, in the case of a Native State, by the Political Agent:

or must be authenticated by the testimony of some credible person on the spot having personal knowledge of the facts required to be established.

17. If the Board has reason to doubt the truth of any fact stated in any application or testimonial, it may make through the Collector such inquiries as it shall think fit.

18. The applications and copies of the testimonials referred to in Rule 12 shall be filed in the office of the Steam Boiler Department, and the original testimonials shall, at the close of each examination, be returned to the candidates who presented them, if they apply for the same, and copies of them shall be obtainable free of cost on application to the Collector.

C.—Age and Training of Candidates.

19. A candidate for a third class certificate of competency will not be admitted to examination, unless he (a) is qualified within the meaning of the rules next following as a candidate for a second class engineer's certificate of competency, or unless he (b) proves to the satisfaction of the Board that previous to his application he has been three years employed as a fireman on engines and boilers, or (c) produces from the Principal of the College of Science at Poona, or from the Principal of the Victoria Jubilee Technical Institute at Bombay, a certificate stating that he has completed a three years' course in the workshops of that College or Institute and during that period has been constantly instructed in the management of engines and boilers.

20. A candidate for a second class engineer's certificate of competency must be 21 years of age. Age and training of second class candidates. No candidate for a certificate of this class will be admitted to the examination, unless he (1) proves to the satisfaction of the Board that, previous to his application,—

(a) he has served an apprenticeship for not less than three years to an engineer, and that during that time he has been employed on the making or repairing of engines; or

(b) he has been employed for not less than three years as a journey-man mechanic in some factory or workshop on the making or repairing of engines; or

(c) he has for not less than two years fulfilled the requirements either of clause (a) or of clause (b) as to service or employment, and has, for not less than one year in addition thereto, served as engineer in charge or assistant engineer in some mill or factory with boilers under steam; or unless he

(2) produces from the Principal of the College of Science at Poona or under the signature of the Director of Public Instruction, as the full Technological Certificate of the Victoria Jubilee Technical Institute at Bombay, a certificate stating that he has completed in the workshops of such College or Institute a three years' course, and during that period has been constantly instructed in the management of boilers and engines.

21. A candidate for a first class engineer's certificate of competency must be 22 years of age. Age and training of first class candidates. No candidate for a certificate of this class will be admitted to the examination unless he proves to the satisfaction of the Board that, previous to his application,—

(1) he has received such training as is required by Rule 20 in the case of a candidate for a second class engineer's certificate of competency; and also proves that—

(2) either

(a) he possesses or is entitled to a first class engineer's certificate of service; or,

if he neither possesses nor is entitled to a first class certificate of service,

(b) that he has served—

- (i) for at least one year with boilers under steam as engineer with a second class engineer's certificate of competency, or
- (ii) for at least two years with boilers under steam as engineer with a second class engineer's certificate of service, or
- (iii) for at least one year with boilers under steam as second engineer with a second class engineer's certificate of service, and, in addition, for at least six months as chief engineer with boilers under steam which are by law required to be in the charge of an engineer holding a certificate :

Provided that if an applicant who is able to satisfy the Collector as to the character of his services, has in consequence of service abroad been unable to obtain a second class certificate of competency or of service, he may be allowed, if the Collector see fit, to be examined for a first class certificate of competency or of service although he has not obtained a certificate of the lower grade.

22. Any person qualified under the rules hereinbefore contained to appear for examination as a candidate for a certificate of any class other than the third class, may be permitted to appear for examination as a candidate for a certificate of any class inferior to that for which he is so qualified to appear as a candidate.

D.—General Rules regarding Service.

23. Every candidate who qualifies for admission to the examination by engine-room service, must show by his testimonials that he has been regularly employed in the engine-room as a fireman or as an engineer of a certain grade.

24. Service with boilers not continuously under steam shall count as service of half the same length with boilers continuously under steam, unless the candidate proves that more than half of such service was actually under steam; and the candidate must show by his testimonials whether the boilers with which he has worked were or were not continuously under steam.

25. Service as an engineer means service in those capacities only which afford opportunities of obtaining practical experience as an engineer on engines, boilers and their appurtenances; it does not include service as a fireman, stoker, donkeyman, greaser, winchman, labourer, or engineer's steward.

26. Service performed in places where the Act is not in force may be accepted as qualifying service subject to the same rules as those which apply to service performed in places where the Act is in force.

V.—Subjects of Examination for Certificates of Competency.

27. To be entitled to a third class certificate of competency a candidate must satisfy the Examiners that—

- (a) he fully understands the working and management of boilers, the use of the best

means of firing for the prevention of smoke, and the separate use of gauge glass-cocks, blow-off cocks, scum-cocks and other appliances;

- (b) he is able to some extent to explain the actual working of engines, and the separate uses of feed-pumps, slide-valves, pistons and other appliances;
- (c) he is able to show how he would act in case of the break-down of any portion of the machinery, &c.

28. To be entitled to a second class certificate of competency a candidate—

- (a) must give a description of boilers, and the methods of staying them, together with the use and management of the different valves, cocks, pipes and connections;
- (b) must understand how to correct defects from accident, decay and other causes, and know the means of repairing such defects;
- (c) must understand the use of the barometer, thermometer and salinometer, and the principles on which they are constructed;
- (d) must know the causes, effects and usual remedies for incrustation and corrosion;
- (e) must state how a temporary or permanent repair could be effected in case of derangement of a part of the machinery, or of total break-down;
- (f) must write a legible hand, and understand the first five rules of arithmetic, and decimals, and their application to questions about consumption of stores, full capacities of tanks, the duty of pumps, and the direct strains in engines and boilers;
- (g) must pass a creditable examination as to the various constructions of engines in general use and as to the details of the different working parts, external and internal, and the use of each part;
- (h) must possess a creditable knowledge of the prominent facts relating to combustion, heat and steam.

29. To be entitled to a first class certificate of competency a candidate must be able to—

- (a) make an intelligible hand-sketch or a working drawing of some one or more of the principal parts of a steam-engine; and to mark in, without a copy, all the necessary dimensions in figures, so that the sketch or drawing could be worked from;*
- (b) take off and calculate indicator diagrams;
- (c) calculate safety-valve pressures, and the strength of the boiler shell, stays and riveting;
- (d) state the general proportions borne by the principal parts of the machinery to each other, and calculate the direct stress, the torsional stress and the bending stress, in round bars, and the direct stress and the bending stress in rectangular bars with given loads;

- (e) explain the method of testing and altering the setting of the slide-valves, and sketch about what difference any alteration in the slide-valve will make in the indicator diagram, and also explain the method of testing the fairness of shafts, and of adjusting them ;
- (f) explain surface condensation, super-heating, and the working of steam expansively ;
- (g) work calculations including the mensuration of superficies and solids and the extraction of the square root, and the application of these rules to questions relating to the power, duty and economy of engines and boilers, and to the stresses in rods, shafts and levers of the engine.

VI.—Mode of Examination.

30. Every examination shall be of such a nature as to test the practical knowledge of the candidates and to ascertain their competency to manage boilers and prime-movers.

31. The examination for third class certificates will be conducted *vivâ voce*, and in the City of Bombay will be held in Her Majesty's Indian Marine Dockyard, and elsewhere, if possible, in a foundry where the candidate's knowledge can be practically tested in the use of the steam, vacuum and water-gauges.

32. (1) Each first and second class candidate will in the first place be called upon to give written answers within a prescribed time to ten of the "Elementary Questions" issued by Government and referred to in Appendix D. If the candidate's answers are not satisfactory, his examination will cease, and he shall be declared to have failed.

(2) If his answers to the ten questions are satisfactory, the candidate will be called upon—

(a) if a first class candidate—

(i) to answer, within a prescribed time, a paper of ten questions in arithmetic as specified in clause (g) of Rule 29 ;

(ii) to make, within a prescribed time, a rough drawing of some part of a boiler or engine ;

(iii) to answer *vivâ voce* questions on the subjects specified in clauses (b) to (f), both inclusive, of Rule 29, and on the papers which may have been set to him ;

(b) if a second class candidate—

(i) to answer, within a prescribed time, a paper of ten questions in arithmetic as specified in clause (f) of Rule 28 ;

(ii) to answer *vivâ voce* questions on the subjects specified in clauses (a) to (g), both inclusive, of Rule 28 and on the papers which may have been set to him ;

(3) Answers to written questions must be worked out in the presence of at least one of the Examiners.

(4) Each candidate's answers to written questions must be given up on the expiry of the

time prescribed, whether his answers are then complete or not.

(5) If, at the expiry of the time prescribed—

(a) the answers given by the candidate satisfy the Examiners of his capability to take charge, in the case of—

(i) a first class candidate, of boilers, whatever their nominal horse-power, and in the case of

(ii) a second class candidate, of boilers of ninety nominal horse-power,

(b) the candidate has failed to work out the whole of the questions set to him, but the result of the *vivâ voce* examination, taken in connection with the answers to such of the questions as he has worked out, satisfies the Examiners that the candidate is competent to take charge, in the case of—

(i) a first class candidate, of boilers, whatever their nominal horse-power and in the case of

(ii) a second class candidate, of boilers of ninety nominal horse-power.

he shall be declared to have passed, otherwise the candidate shall be declared to have failed.

33. When a candidate for a first or second class certificate fails either in the elementary questions or in the subsequent portion of the examination, the Board of Examiners shall fix a period after the expiry of which he may again appear for examination, and shall inform him thereof; and the candidate shall not be at liberty to appear again for examination at any place at which an examination is held under the Act until after the expiry of the period so fixed.

VII.—Rules for the Examination Room.

34. Candidates will be allowed, in the time allotted, to cancel any part of their work, and, when required, additional paper will be supplied by the Examiner, but they will not be allowed to work out the problems on a slate or on waste paper. The additional sheets must be attached to and form part of the examination papers to be given in by the candidate.

35. The examination in rough working drawing which candidates for first class certificates have to pass under Rule 29 (a), may at the candidate's option be applied either to hand-sketches clearly dimensioned and complete in the necessary *views* and *sections* or to drawings to a scale. Candidates will have to bring with them any drawing instruments they may require.

36. A candidate discovered (a) to have taken into the examination room any book, paper, document or memoranda of any description, or (b) copying from or affording, giving or receiving any assistance or any information to or from, or communicating in any way with another, during the time of examination, shall be regarded as having failed in his examination, and will be turned back for four months, in the same manner as if he had failed in the practical part of the examination; and no part of the fees he may have paid for examination will be returned to him.

37. If a candidate leaves the room before answering any question which has been given to him, he cannot afterwards be permitted to answer it, but the Examiner may substitute other data, or another question.

VIII.—Grant of Lower Grade Certificates in certain cases.

38. If a candidate allowed under the proviso to Rule 21, to be examined for a first class certificate though he has not obtained a certificate for a lower grade, or if a candidate already in possession of a certificate of service, fail to pass the examination for the higher grade, but pass the examination for the lower grade, he may receive a certificate for the grade passed, but no part of the fee paid by him will be returned.

39. A candidate who has been permitted to be examined for a first class certificate of competency under the proviso to Rule 21 without first obtaining a second class certificate of competency or a first class certificate of service, and who fails in his examination in practical knowledge, shall not be re-examined for a certificate of the higher grade until he has served 12 months as second engineer with a second class engineer's certificate of competency as required by the rules.

40. If the candidate fails in the examination for the lower as well as for the higher grade of certificate, he may be re-examined for a second class certificate only, subject to the provisions of Rule 33.

IX.—Postponement of Grant of Certificate in certain cases.

41. (1) If, after a candidate has passed his examination, it is discovered that his services are insufficient to entitle him to a certificate of the grade for which he has passed, such certificate will not be granted to him; but if the Collector is satisfied that the error in the calculation of his services did not occur through any fault or wilful misrepresentation on the candidate's part, the Collector may direct the certificate to be issued, or may allow the candidate to appear for re-examination without payment of further fee, when he has performed the deficient service.

(2) If, in such a case, the applicant's services are sufficient to entitle him to receive a certificate of a lower grade, provided as aforesaid he has not wilfully misrepresented the amount of his services, a certificate of such lower grade may be granted to him, and the difference between the fee paid by him for the superior certificate and the fee payable for the inferior certificate may be refunded.

(3) In such a case, when the applicant has by further service made up the time in which he was found to be short, he may be required, before he can receive the higher certificate, to be re-examined in all the subjects.

X.—Surrender of Lower Grade Certificates.

42. No certificate of the first or second class shall be granted to the holder of a certificate of a lower grade unless and until the holder has surrendered to the Collector the certificate of the lower grade.

43. Every certificate of competency granted under Section 22 to a person in possession of a certificate entitling him thereto under the said section shall be in the form in this behalf provided in Appendix B, and shall be endorsed on the certificate of competency by virtue of which such person is so entitled as aforesaid.

XI.—Certificates of Service.

44. In order (1) to ascertain that a candidate for a certificate under Section 23 of the Act is possessed of competent skill for the charge and management of a boiler, and (2) to determine what class of certificate he is qualified to hold, the Board of Examiners shall subject him to such practical examination as they in each case think fit.

45. Applicants for certificates of service will be charged fees at the following rates:—

XII.—Form of Certificates.

46. Certificates of competency and of service shall be in the forms given in Appendix B, respectively, or to the like effect.

47. Applications under Section 22 for certificates of competency corresponding to foreign certificates in the possession of the applicants, shall be in the form of Appendix 1. Each applicant shall duly fill in the form, and, together with copies of the original foreign certificates in his possession, shall lodge the form with the Collector at least ten days before any meeting of the Board of Examiners.

48. Holders of certificates of the first class will be deemed to be capable, as first class engineers, of having charge of boilers of any horse-power.

Holders of certificates of the second class will be deemed to be capable, as second class engineers, of having charge of boilers not exceeding ninety horse-power nominal.

Holders of certificates of the third class will be deemed to be capable, as third class engineers, of having charge of boilers not exceeding thirty horse-power nominal.

49. Applications for duplicates under Section 26 shall be lodged with the Collector, together with a sworn declaration describing the lost certificate and other documents relied upon by the applicant.

50. Duplicates of all certificates granted under the Act shall be recorded in the Steam Boiler Office.

(E)—*Declaration to be made by Applicant.*

APPENDIX C.

Examination in Rough Working Drawing for a First-Class Engineer's Certificate of Competency.

1. The regulations in regard to the qualifications of a candidate for a First Class Engineer's Certificate of Competency specify that—

“He must be able to make rough working drawings of the different parts of the engines and boilers ;

“He must be able to state the general proportions borne by the principal parts of the machinery to each other.”

2. In accordance with these clauses a candidate for a first-class certificate is required to make a rough working drawing of the parts specified on the other side of this leaf. A mechanic who has been some years in charge of engines and boilers ought by this time to have familiarly in his mind the general construction of at least one set of engines and boilers, say that set he was last with. Fine drawing is not expected, and in the proportions of the parts a wide margin will be allowed ; absurd dimensions will be failure in practical knowledge.

3. The drawing must, however, be practically a working drawing, giving a sufficient number of views to show the parts fully—sections, plans, or elevations, just as the candidate would require to be supplied to him if he had to make the parts to the design of another person.

4. A clear hand sketch showing the construction completely, and fully dimensioned will be accepted if the candidate prefers this alternative.

5. A portion only of the parts specified may be accepted in place of the whole, if that portion is sufficient to show that the candidate has a good practical idea of the construction of the parts, and a fair notion of their general proportions or dimensions.

6. Candidates are hereby cautioned not to put on paper what they have not fully considered, and deliberately intend to be understood, as their statement of what they know about the construction of any part required.

7. The statements given in by a candidate may be in themselves, apparently, of little importance, but, as sample material from which the state of the candidate's knowledge of engines and boilers is to be inferred, every detail which is glaringly inconsistent with a sound knowledge of the use of the part, or in which an essential consideration has evidently been overlooked, is an important element in the description which the candidate is giving of his own qualifications.

8. The candidate is advised not to begin more than he can clearly finish in the time allowed. An important object in this part of the examination is to ascertain whether the candidate can be trusted to mark all necessary dimensions upon a sketch or a drawing. The test of this is, practically, the making of the part from the sketch without having to supply additional dimensions, and without measuring the drawing. To prove this ability the candidate must fully dimension

the parts shown in his sketch or drawing notwithstanding that the parts may be correctly drawn to scale. A drawing is fully dimensioned when no part of it is left to the option of the party who is to work to the drawing.

9. To prevent misunderstanding, however, when the candidate has been led into showing more of the details than he has time fully to finish, he should name, in the statement on the other side, the particular parts which he has fully dimensioned.

10. All dimensions should have lines and darts to indicate distinctly the points between which the dimensions are given.

11. Beware of writing cross dimensions upon centre lines or upon longitudinal dimension lines. This is not an order but a recommendation.

12. The candidate is not expected to design anything: he has merely to sketch or draw something with which he is expected to be already familiar.

13. Pencil in nothing after 3 o'clock: all the dimensions, the figures, and the darts must be inked in; employ the remaining time in examining the drawing and in inking in any figures which may have been before overlooked, and in checking the dimensions.

14. Make sure that you will have sufficient room on the sheet to show all the necessary views. You can have another sheet of paper if necessary. All the paper used must be forwarded with the drawing.

No. 5410.—In pursuance of Government Notification No. 3861, dated 17th September 1895, published at pages 960 and 961 of the *Bombay Government Gazette*, dated 19th idem, Part I, the Governor in Council is pleased, in exercise of the powers conferred by clause (g) of Sub-section (1) of Section 18 of the Indian Factories Act, 1881, as amended by the Indian Factories Act, 1891, to make the following rule, and to direct that it be added as Rule No. 21 to the body of rules made under the said Act and published in the Notification specified in the margin:

“ 21.

- (1) Every occupier of factories shall keep a register consisting of a bound book, each page of which shall be numbered in consecutive order, and shall contain a foil, a duplicate foil and a counterfoil in the following form, viz.:

- (2) Every certificate granted under Section 5 of the Act to any person employed or desirous of being employed in a factory shall be prepared by filling up in the consecutive order of the pages the foil and duplicate foil of the register kept by the occupier of that factory under this rule. Such foil and duplicate foil, when filled up, shall be signed by the certifying surgeon when satisfied as to the correctness of the entries therein, and the foil shall be detached and given to the person entitled to the certificate.
- (3) The counterfoil shall also be filled up with entries corresponding with those on the foils belonging to it, and the certifying surgeon, when satisfied that the entries in counterfoil and foils do so correspond, shall initial the counterfoil, which shall be retained in the register.
- (4) The occupier of the factory shall, from time to time, as circumstances require, enter and sign, or cause to be entered and signed, in the last column of the counterfoil, a description of the employment of the person to whom the certificate refers, with the date on which such employment, in each case, commenced; and shall, on such person ceasing to be employed in the factory, forthwith write and sign, or cause to be written and signed, across the counterfoil referring to such person, the words 'no longer employed in factory.'
- (5) The occupier of a factory employing therein any person on production of a certificate purporting to have been granted to such person in respect of his or her employment in any other factory, shall forthwith obtain from the occupier of such other factory, who shall send it at once on demand, the duplicate foil of the certificate so produced, and shall forthwith, after the certificate and duplicate foil have been compared and ascertained to correspond in every particular, enter or cause to be entered in the register of his own factory, and sign or cause to be signed, a copy of such duplicate foil on a duplicate foil of the next form of such register to be filled in, making or causing to be made corresponding entries (also to be signed) on the counterfoil of such form, and with the words 'copy for _____ factory' (also to be signed) written across both duplicate foil and counterfoil, and shall retain both in his register.
- (6) Except as in this rule provided, no entries shall be made on the foils, duplicate foils or counterfoils in any register."

"Fort William, the 5th December 1895.

No. 3846-I.—In exercise of the powers conferred by Sections 26 and 27 of the Cantonments Act (XIII of 1889) as applied to the cantonment of Bhuj by the Notification of the Government of India in the Foreign Department No. 2840-I., dated the 9th July 1891, and in supersession of the Notification of the Government of India in the Foreign Department No. 2841-I., dated the 9th July, 1891, the Governor-General in Council is pleased to declare that the rules made under the said Act for all cantonments in British India and published by the Notification of the Government of India in the Military Department No. 460, dated the 3rd May 1895, shall be in force in the cantonment of Bhuj, subject to the omission from Rule 1 of the words 'within or without the limits of the cantonment as the cantonment authority with the concurrence of the District Magistrate may determine.'

No. 3847-I.—In exercise of the powers conferred by Sections 4 and 5 of the Foreign Jurisdiction and Extradition Act (XXI of 1879) and of all other

powers enabling him in this behalf, the Governor-General in Council is pleased, in continuation of the Notification of the Government of India in the Foreign Department No. 2840-I., dated the 9th July 1891, applying the Cantonments Act (XIII of 1889) to the cantonment of Bhuj, to apply the provisions of the Cantonments Act Amendment Act (V of 1895) to the said cantonment.

No. 7680.—The following Notification by the Government of India in the Foreign Department is republished for general information:—

"No. 3573-I.

Simla, the 29th October 1895.

Whereas the Rulers or Administrators of the States mentioned in the second column of the schedule hereto annexed have ceded to the British Government full jurisdiction within the lands which lie within their respective territories, and are occupied, or may be hereafter occupied, by the railways mentioned opposite their names, respectively, in the first column of the said schedule (including the lands occupied by stations and out-buildings and for other railway purposes): In exercise of this jurisdiction and of the powers conferred by Sections 4 and 5 of the Foreign Jurisdiction and

Extradition Act (XXI of 1879), and of all other powers enabling him in this behalf, the Governor-General in Council is pleased to direct that the following rules shall be in force on the said lands :

I.—In these rules ‘arms,’ ‘ammunition,’ and ‘military stores’ have respectively the meanings assigned to them in the Indian Arms Act, 1878, except that ‘ammunition’ includes also saltpetre and that ‘military stores’ includes also sulphur when in quantities exceeding ten seers in weight.

‘Export’ means transmission by rail from any station in any of the said lands to any station beyond the said lands.

‘Import’ means transmission by rail from any station beyond the said lands to any station within the said lands.

‘Transport’ means transmission by rail from one station in the said lands to another station in the said lands.

Explanation.—Arms, ammunition, and military stores taken from one station to another in the said lands across intervening territory which is not within the said lands are transported within the meaning of these rules.

II.—(a) The export, without the special permission of the Political Agent, of arms, ammunition, or military stores is forbidden.

(b) Station Masters to whom arms, ammunition, or military stores, unaccompanied by evidence of such special permission are tendered for despatch, shall detain them and report the matter through the Superintendent of Railway Police for the orders of the Political Agent.

III.—When any arms, ammunition, or military stores are imported they shall not be delivered to any importer or consignee, unless—

- (a) the importer or consignee produces the original license issued by the Secretary to the Government of India, Foreign Department, or other competent authority, authorising the export of such arms, ammunition, or military stores from British India and their import to some station within the lands above referred to, and
- (b) the senior police-officer at the station at which the arms, ammunition, or military stores have been received has compared the consignment with the license and authorised the Station Master to make delivery.

For the purpose of making the comparison required by clause (b), the police-officer shall have power to open any package which he thinks suspicious.

IV.—Every Station Master shall give information to the officer mentioned in clause (b) of the preceding rule of the arrival at his station of any consignment of imported arms, ammunition, or military stores.

V.—A Station Master at whose station a consignment of imported arms, ammunition, or military stores is received may, after obtaining the

sanction of the Superintendent of Railway Police, but not otherwise, forward the consignment, should the owner or consignee desire him to do so, to any other station within or beyond the lands above referred to.

VI.—No license shall be necessary in respect of arms or ammunition, but when any arms, ammunition, or military stores are transported, immediate information regarding such transport shall be given to the senior police-officer at the stations of despatch and receipt by the Station Masters concerned.

VII.—Arms shall not in ordinary cases be taken from passengers; but, if a Carrying of arms by Station Master has reasonable ground for apprehending a disturbance from the possession of arms by a passenger, he may at any time before such passenger has taken his place in the train, but not afterwards, refuse to carry him unless he delivers up his arms. If the passenger gives up his arms, they shall be labelled with the name and description of the owner, entered in the roadway bill, and delivered free of charge to the owner at his journey's end.

Provided that no person who has been duly exempted from the operation of sections 13—16 of the Indian Arms Act (XI of 1878), or has a license to carry arms granted by competent authority, shall, except in the case of evident and undoubted necessity, be asked to give up his personal arms under this rule.

VIII.—Every person employed upon the Railway shall, in the absence of reasonable excuse, the burden of proving which shall be upon him, be bound to give information to the nearest police-officer regarding any box, packet, or bale in transit which he may have reason to suspect contains arms, ammunition, or military stores in respect of which an offence against these rules has been, or is being, committed.

IX.—(i) Whoever commits any of the following offences (namely) :

- (a) exports any arms, ammunition, or military stores without obtaining the special permission of the Political Agent as required by rule II,
- (b) imports any arms, ammunition, or military stores without a license of the nature referred to in rule III,

shall be punished with imprisonment for a term which may extend to three years, or with fine, or with both.

(ii) Whoever commits any of the following offences (namely) :

- (a) imports any arms, ammunition, or military stores in excess of the quantities entered in the license referred to in rule III,
- (b) imports after the expiration of the period for which such license has been granted,
- (c) omits to give information as required by rule VIII,

shall be punished with imprisonment for a term which may extend to six months, or with fine which may extend to five hundred rupees, or with both.

X.—When any person is convicted of an offence under the last preceding rule, it shall be in the discretion of the convicting magistrate further to direct that the whole or any portion of the arms, ammunition, or military stores in respect of which the conviction is obtained, and any box, package, or bale in which the same may have been concealed, together with the other contents of such box, package, or bale shall be confiscated.

XI.—(1) Whenever any magistrate has reason to believe that arms, ammunition and military stores have been imported contrary to these rules, such magistrate, having first recorded the grounds of his belief, may seize and detain the same in safe custody for such time as he may think necessary.

(2) In such cases notice calling upon the importer or consignee to appear and to produce the license referred to in Rule III shall be published for three months at the railway station at which the arms, ammunition, or military stores have been seized, and at such other places as the magistrate may think necessary.

(3) If the importer or consignee does not appear and produce such license within three years from the date of such notice, such arms, ammunition, or military stores shall be confiscated.

XII.—The orders of the Political Agent shall be taken regarding the disposal of articles confiscated under these rules, and such orders shall be final.

XIII.—(1) A magistrate may award up to one-half the amount of any fine inflicted under these rules, and up to one-half the sale price of any confiscated articles sold in pursuance of orders issued under these rules, to any person, whether in the employ of a railway company or not, who has given information leading to a conviction.

(2) Cases in which no fine is inflicted, or in which it appears desirable to give a reward larger than is provided for above, shall be submitted for the orders of the Political Agent.

XIV.—Nothing in the foregoing rules shall apply to the import of any arms, ammunition, or military stores when the same are covered by a certificate granted by the officer in charge of an arsenal in British India stating that they are assigned to the ruler of a state mentioned in the second column of the schedule hereto annexed.

Orders of Her Majesty in Council dated, respectively, the 30th July 1868, the 19th March 1883, and the 3rd October 1895, exempting from re-measurement for tonnage certain ships belonging to the United States of America.

At the Court at Osborne House, Isle of Wight, the 30th day of July 1868.

PRESENT :

THE QUEEN'S MOST EXCELLENT MAJESTY IN COUNCIL.

Whereas it is enacted by the Merchant Shipping Act Amendment Act, 1862, that 'when-ever it is made to appear to Her Majesty that the rules concerning the measurement of tonnage of merchant ships for the time being in force under the principal Act have been adopted by the Government of any foreign country and are in force in that country, it shall be lawful for Her Majesty, by Order in Council, to direct that the ships of such foreign country shall be deemed to be of the tonnage denoted in their certificates of registry or other national papers, and thereupon it shall no longer be necessary for such ships to be remeasured in any port or place in Her Majesty's dominions, but such ships shall be deemed to be of the tonnage denoted in their certificates of registry or other papers in the same manner, to the same extent, and for the same purpose in, to, and for which the tonnage denoted in the certificates of registry of British ships is deemed to be the tonnage of such ships.'

And whereas it has been made to appear to Her Majesty that the rules concerning the measurement of tonnage of merchant ships now in force under 'the Merchant Shipping Act, 1854,' have been adopted by the Government of the United States of America, with the exception that no deduction from the gross tonnage of such ships specified in the registers or other national papers thereof, is

made for crew space in sailing vessels, and for crew space and engine room in steam vessels, and such rules are now in force in that country having come into operation on the 1st January 1865.

Her Majesty (in pursuance and exercise of the powers hereinbefore mentioned) is hereby pleased, by and with the advice of Her Privy Council, to direct that the merchant ships of the said United States of America the measurement whereof shall, after the said 1st of January 1865, have been ascertained and denoted in the registers and other national papers of such ships testified by the dates thereof, shall be deemed to be of the tonnage denoted in such registers or other national papers in the same manner, and to the same extent, and for the same purpose in, to, and for which the tonnage denoted in the certificates of registry of British ships is deemed to be the tonnage of such ships, after making therefrom the same deductions in respect of crew space and engine room as would, if such ships were British, be made from their gross tonnage under the laws relating to British ships.

At the Court at Windsor, the 19th day of March, 1883.

THE QUEEN'S MOST EXCELLENT MAJESTY IN COUNCIL.

Whereas by the "Merchant Shipping Act Amendment Act, 1862," it is enacted that, whenever it is made to appear to Her Majesty that the rules concerning the measurement of tonnage of merchant ships, for the time being in force under the principal Act, have been adopted by the Government of any foreign country, and are in force in that country, it shall be lawful for Her Majesty, by Order in Council, to direct that the ships of such foreign country shall be deemed to be of the tonnage denoted in their certificates of registry, or other national papers; and, thereupon, it shall no longer be necessary for such ships to be remeasured in any port or place in Her Majesty's dominions, but such ships shall be deemed to be of the tonnage denoted in their certificates of registry, or other papers, in the same manner, to the same extent, and for the same purposes, in, to, and for which the tonnage denoted in the certificates of registry of British ships is to be deemed the tonnage of such ships.

And whereas it was made to appear to Her Majesty that the rules concerning the measurement of tonnage of merchant ships, for the time being in force under the principal Act had been, with certain exceptions, adopted by the Government of the United States of America, and Her Majesty by Order in Council, dated the 30th day of July 1868, was pleased to direct that the merchant ships of the said United States of America the measurement whereof should, after the 1st of January 1865, have been ascertained and denoted on the registers, and other national papers of such ships, testified by the dates thereof, should be deemed to be of the tonnage denoted in such registers or other national papers, in the same manner, and to the same extent, and for the same purpose, in, to, and for which the tonnage denoted in the certificates of registry of British ships is deemed to be the tonnage of such ships, after making therefrom

the same deductions in respect of crew space and engine room as would, if such ships were British, be made from their gross tonnage under the laws relating to British ships.

And whereas the Government of the said United States of America have provided that on and after the 5th day of August 1882, a deduction from the gross tonnage of every vessel of the United States shall, on measurement or remeasurement thereof, be made for crew space in sailing ships, and for crew and engine space in steam ships.

And whereas it has been made to appear to Her Majesty that, in consequence of such last recited provision, the rules concerning the measurement of tonnage of merchant ships now in force under 'The Merchant Shipping Act, 1854,' have been adopted by the Government of the United States of America, with the exception of a difference in the mode, in certain steamers, of estimating the allowance for engine room, and such rules are now in force in that country, having come into operation on the 5th day of August 1882, and that it is desirable that the ships of the said United States, measured or remeasured as aforesaid, on or after the said 5th day of August 1882, shall instead of requiring remeasurement in the United Kingdom for crew space in sailing ships, or for crew and engine space in steam ships, be deemed to be of the tonnage denoted in their certificates of registry, or other national papers.

Now, therefore, Her Majesty is hereby pleased, by and with the advice of Her Privy Council, to direct as follows:—

1. As regards sailing ships: that merchant sailing ships of the said United States of America, the measurement whereof after the said 5th day of August 1882, has been ascertained and denoted in the registers and other national papers of such sailing ships, testified by the date thereof, shall be deemed to be of the tonnage denoted in such registers, and other national papers, in the same manner, and to the same extent, and for the same purpose in, to, and for which the tonnage denoted in the certificate of registry of British sailing ships is deemed to be the tonnage of such ships.
2. As regards steam ships: that merchant ships belonging to the said United States of America which are propelled by steam or any other power requiring engine room, the measurement thereof shall, after the said 5th day of August 1882, have been ascertained and denoted in the registers and other national papers of such steam ships, testified by the dates thereof, shall be deemed to be of the tonnage denoted in such registers or other national papers in the same manner, and to the same extent, and for the same purpose in, to, and for which the tonnage denoted in the certificates of registry of British ships is deemed to be the tonnage of such ships. Provided nevertheless, that if the owner or master of any such American steam ship desires the deduction for engine room in his ships to be estimated under the rules for engine room measurement and deduction applicable to British ships, instead of under the American rules, the engine room shall be measured, and the deduction calculated, according to the British rules.

Whereas by an Order in Council, dated the 30th July 1868, made by Her Majesty in exercise of the powers conferred upon Her by the Merchant Shipping Act Amendment Act, 1862, Her Majesty was pleased to direct that the Merchant Ships of the United States of America the measurement whereof should, after the 1st January 1865, have been ascertained and denoted on the registers and other national papers of such ships, testified by the dates thereof, should be deemed to be of the tonnage denoted in such registers or other national papers, in the same manner, to the same extent, and for the same purpose, in, to, and for which the tonnage denoted in the certificate of registry of British ships is deemed to be the tonnage of such ships, after making therefrom the same deductions, in respect of crew space and engine room, as would, if such ships were British, be made from their gross tonnage under the laws relating to British ships.

And whereas by another Order in Council, dated the 19th March 1883, made in exercise of the aforesaid powers Her Majesty was pleased to direct as follows :—

1. As regards sailing ships : that merchant sailing ships of the United States of America the measurement whereof after the 5th August 1882, has been ascertained and denoted in the registers and other national papers of such sailing ships, testified by the date thereof, shall be deemed to be of the tonnage denoted in such registers and other national papers, in the same manner, to the same extent, and for the same purpose in, to, and for which the tonnage denoted in the certificate of registry of British sailing ships is deemed to be the tonnage of such ships.
2. As regards steam ships : that merchant ships belonging to the United States of America which are propelled by steam or any other power requiring engine room, the measurement whereof shall, after the said 5th day of August 1882, have been ascertained and denoted in the registers and other national papers of such steam ships, testified by the dates thereof, shall be deemed to be of the tonnage denoted in such registers or other national papers in the same manner, to the same extent, and for the same purpose in, to, and for which the tonnage denoted in the certificate of registry of British ships is deemed to be the tonnage of such ships. Provided, nevertheless, that if the owner or master of any such American steam ship desires the deduction for engine room in his ship to be estimated under the rules for engine room measurement and deduction applicable to British ships instead of under the American Rule, the engine room shall be measured and the deduction calculated according to the British Rules.

And whereas by Section 84 of the Merchant Shipping Act, 1894, it is enacted that, whenever it appears to Her Majesty the Queen in Council

that the tonnage regulations of that Act have been adopted by any foreign country, and are in force there, Her Majesty in Council may order that the ships of that country shall, without being remeasured in Her Majesty's dominions, be deemed to be of the tonnage denoted in their certificates of registry or other national papers, in the same manner, to the same extent, and for the same purposes as the tonnage denoted in the certificate of registry of a British ship is deemed to be the tonnage of that ship.

And whereas it has been made to appear to Her Majesty in Council that the tonnage regulations of the Merchant Shipping Act, 1894, have been adopted by the United States of America, and such regulations are now in force there, having come into operation on the 1st day of April 1895.

And whereas there still are or may be ships belonging to the United States of America to which the hereinbefore recited orders of the 30th July 1868, and the 19th March 1883, may respectively apply, and it is expedient not to revoke the same, but to let the said recited orders remain in force so long as there are any ships to which the same may so respectively apply.

And whereas the provisions of Section 1 of the Rules Publication Act, 1893, have been complied with.

Now, therefore, Her Majesty, in pursuance and exercise of the powers hereinbefore mentioned, is hereby pleased, by and with the advice of Her Privy Council, to direct that the merchant ships of the United States of America the measurement whereof shall, after the 1st day of April 1895, have been ascertained and denoted in the registers and other national papers of such ships, shall be deemed to be of the tonnage denoted in their certificates of registry or other national papers in the same manner, to the same extent, and for the same purposes as the tonnage denoted in the certificate of registry of a British ship is deemed to be the tonnage of that ship.

Note I.—With the sanction of the Court any party may pay the cost of proceeding by railway or any public conveyance where such is available, and in such case the process-server shall be bound to proceed by such railway or public conveyance.

Note II.—For processes applied for and ordered to be executed as emergent, the fee will be the ordinary fee and half as much again.

Note III.—Where one individual is to be served in more than one capacity, *e.g.*, personally and also as guardian of a minor or minors, only one fee is to be levied.

Note IV.—When a process issued by a Civil Court other than a Mámlatdár's Court is returned unserved, and has to be re-issued for service, a half fee only shall be charged on the occasion of each re-issue.

This rule applies whatever may be the reason which prevented service (*e.g.*, whether the failure to serve was due to the fault of the party on whose behalf it was issued or not), and whether the identical paper is re-issued or a fresh paper.

Note V.—When the service is set aside in an enquiry under Section 32, Civil Procedure Code, or when witnesses, &c., have to be summoned a second time in consequence of the court not sitting, or not taking up, or not completing the hearing of the case on the day on which they were first summoned, no further fee is to be levied upon re-issue.

Note VI.—If a warrant has already been issued to arrest a judgment-debtor who has failed to pay the decretal amount, and who has been ordered to be imprisoned in a civil jail and such warrant of arrest is in force, no further fee is leviable on the order of committal to jail.

Note VII.—No fee is to be charged for any process issued by a court of its own motion.

Note VIII.—No process fee shall be charged on proclamations under Section 10 of Regulation VIII of 1827.

Note IX.—The fees levied for all processes in suits to which Chapter 2 of the Dekkan Agriculturists' Relief Act (XVII of 1879) applies, except suits of the description mentioned in Section 3, clauses (w) and (x), to which an agriculturist is not a party, shall be one-half the fees which would be leviable in similar suits to which the said Act does not apply.

Note X.—No fee shall be levied for the service of any notice or other process issued in proceedings taken under Chapter 4 of the Dekkan Agriculturists' Relief Act, XVII of 1879.

Note XI.—Nothing contained in these rules (or in any rules heretofore made by the High Court under Section 20 of the Court Fees Act (VII of 1870)) shall apply to process issued by a Village Munsiff under Chapter 5 of the said Act (XVII of 1879).

Note XII.—(a) When the services of one or more bailiffs or peons are required for a longer period than three days, the party on whose application the process was issued shall, in addition to the fee leviable under the above rules, be required to pay the whole salary of such bailiffs or peons for the whole period in excess of three days.

(b) The time occupied in going to, and returning from, the place at which service of process is to be made, shall not be reckoned as a portion of the above period.

(c) If the amount payable on account of salary under the above rule shall involve a fractional part of an anna, such part shall be remitted.

Note XIII.—For the purposes of these rules the Courts of the Agents for Sirdárs shall be treated as District Courts, and all other civil courts not specifically mentioned, as Subordinate Judges' Courts.

The rest of the Rules framed by the Honourable the Chief Justice and Judges under Sections 20 and 22 of the Court Fees Act, VII of 1870, published in the *Bombay Government Gazette* dated 19th July 1888 at page 598 *et seq.*, and given in High Court Civil Circulars No. 109 *et seq.*, to stand as at present."

WHEREAS a sum of money was subscribed in Bombay to be applied to purposes intended to commemorate the services of Lord Mayo as Viceroy and Governor General of India and was credited to the "Mayo Memorial Fund" in the names of Messrs. James Gibbs, G. W. Terry and Sir Mungaldas Nathooobhoy who formed the Mayo Memorial Fund Committee.

AND WHEREAS in the year 1879 The Mayo Memorial Fund Committee handed over Rs. 10,000 in Government of India Promissory Notes out of the funds in their hands to found a Scholarship or Scholarships in the Sir Jamsetjee Jeejeebhoy School of Art as the Director of Public Instruction might arrange to be called The Mayo Scholarships AND WHEREAS the investments now representing the said Fund consist of Government of India Promissory Notes of the nominal value of Rs. 11,800 bearing interest at the rate of $3\frac{1}{2}$ per cent. per annum AND WHEREAS the Principal of the said School of Art has for some time past administered the income of the securities under the direction of the Government of Bombay.

AND WHEREAS by order dated the thirtieth day of November 1895 duly notified in the *Bombay Government Gazette* the said Government of India Promissory Notes for Rs. 11,800 have been under Section 4 of the Charitable Endowments Act, 1890, vested in the Treasurer of Charitable Endowments for the Bombay Presidency AND WHEREAS Mr. James Monteath, Financial Secretary to Government, Mr. Kyrle Mitford Chatfield, Director of Public Instruction, and Mr. Edwin Greenwood, Principal, Jamsetjee Jeejeebhoy School of Art, Bombay, have applied to the Government of Bombay to settle a scheme for the administration of the said property and the following scheme has with their concurrence and the concurrence of the Director of Public Instruction been settled by the Governor of Bombay in Council Now under Section 5 of the Charitable Endowments Act, 1890, it is hereby declared that the following scheme shall come into operation from the date that the securities so as aforesaid became vested in the Treasurer of Charitable Endowments for the Bombay Presidency:—

Scheme.

The income of the property so as aforesaid vested in the Treasurer of Charitable Endowments for the Bombay Presidency shall be administered by the Principal for the time being of the Sir Jamsetjee Jeejeebhoy School of Art, Bombay.

In awarding the Scholarships the Principal of the said School of Art shall be guided by the following rules or such other rules as he and the Director of Public Instruction and the Governor of Bombay in Council may from time to time agree upon regard being always had to the purposes hereinbefore set out for which the Fund was raised.

Rules.

Three Scholarships to be called "The Mayo Scholarships" each of the value of Rs. 10 per mensem tenable for 3 years shall be awarded triennially at the examination of the School of Art in April. Two Scholarships shall be attached to the Painting Atelier and one to the Sculpture.

Three Silver Medals to be called "The Mayo Medals" shall be given annually to the most successful Students in

- (a) Architecture,
- (b) Painting,
- (c) Modelling.

Only one Medal shall be awarded to any one Student and if he be successful in more than one subject either in the same or following years he shall receive the equivalent in books, &c. The Principal of the said School of Art or officer administering the income of the Funds shall submit and furnish to the Government of Bombay through The Director of Public Instruction a yearly account at the close of each financial year showing full particulars of all receipts and expenditure and in what manner the income has been administered.
