improve the arrangement of the subjects, and we have, in section seven, defined the matters in which rights may be acquired in Government waters, for which compensation shall be awarded when the supply of water is stopped or diminished; the matters in which no rights shall be deemed to have accrued, and for which no compensation shall be given on account of loss or diminution of the supply of water; the neasure of compensation to be awarded when the market-value of the property is not ascertainable, and the conditions under which such rights can be in future acquired.

Part III. of the Bill has been re-arranged and simplified; but its provisions are, in the main, unaltered. In section twenty-eight, we have provided more distinctly than was done in the original Bill, that compensation for land occupied for private water-courses may be awarded either in the manner prescribed by Act X. of 1870, by a permanent alienation, or by a rent charge payable by the occupier, at the option of the person to be compensated. Sections thirty-one and thirty-two, regarding conditions of the supply of water, have been so framed as to leave the Government freedom as to the disposal of the water of a canal, and to prevent the growth of prescriptive rights to any particular measure of water which might hereafter prevent the expansion and extension of irrigation.

We have re-arranged and modified Chapter IV. of the original Bill, regarding charges for the use of canal water, and have omitted the provisions originally made for punitive stoppages of water-supply.

In sections thirty-seven to forty-three of the Bill, as amended, we have defined "the owner's rate -the conditions under which it may be imposed, the limit of the rate, and the persons liable to pay itmore fully than in the original Bill.

of India for the purpose of making Laws and Regulations, to which the Bill to regulate the construction and maintenance of public works for irrigation, navigation, and drainage was referred, have the honour to report that we have considered the Bill, and the papers noted in the margin.

We have made the Bill applicable to the Panjab only instead of to the North Western Provinces, the Panjab, Oudh, and the Central Provinces. This change has been made on account of the difficulty of adapting the provisions of the Bill to the cir-cumstances of the whole of the territory to which it was first proposed to extend it in such a way as to keep what was suitable for each Province.

We have omitted from the preamble of the Bill the words "subject, in certain cases, to rights acquired by usage or grant," and have detailed the rights which may be so acquired in another part of the Bill. We have altered Part II. of the Bill considerably, with a view to simplify it and

We have so modified the provisions of the original Bill regarding the rates on land irrigable, but not irrigated, as to avoid the possibility of their being needlessly or oppressively enforced.

Sections fifty-four to sixty-seven of the Bill, as amended, are substantially the same as in the Bill as introduced.

Sections sixty-eight to seventy-one contain the provisions which relate to the mode in which labour may be obtained for repairing canals on emergencies and for effecting necessary annual silt clearances. The system of statute labour does already exist in the Panjáb, and we have prescribed the conditions under which it may be exacted, and have empowered the local Government to make rules regarding the payment of labourers, and for regulating the exercise of the power of calling out such labour.

In Part VII., we have empowered divisional canal officers to decide summarily disputes regarding the use, construction, or maintenance of water courses, or to refer them to the Deputy Commissioner; and we have made such summary decisions final for the time which is required for ripening any crop which is on the ground, by restraining the Civil Courts from decreeing specific performance.

In Part VIII. of the Bill, as amended, we have defined the offences regarding canals, which we consider should be made punishable, and the penalties which may be inflicted. These are mainly the same as in the Bill introduced.

In section seventy-nine, we have given the Local Government general power to frame rules, with the previous sanction of the Governor General in Council, and have thus obviated the necessity of constant reference to the powers in the several sections of the Bill.

We recommend that the Bill, as thus amended, be passed.

I cannot subscribe the recommendation "that this Bill be passed," because I dissent from some of its most important provisions on the following considerations:

- 1st.—That it is highly inexpedient to curtail, in the manner proposed, the local extent of the enactment, of which the essential provisions in regard to the acquisition of water-courses, the construction and maintenance of irrigation and drainage works, and the general administration of the whole system of canal irrigation, are no less, if not more, urgently needed in the North-Western Provinces than in the Panjáb.
- 2nd.—That the impressment of manual labour, except under emergent circumstances where danger to life and property is reasonably to be apprehended, is unjustifiable.
- 3rd.—That to tax any particular classes, as is contemplated by the provisions in regard to the levy of a special rate on lands not irrigated, for assumed benefits of which they may have, for good and substantial reasons, elected not to avail themselves, is wholly inequitable.

- (c) diminution of natural products;
- (d) stoppage of navigation, of the means of drifting timber, of watering cattle, or stoppage of fisheries;
- (e) displacement of labour or deprivation of any accessory advantage or opportunity of profit other than those referred to in the first three clauses of this section.

In determining the amount of such compensation, regard shall be had to the diminution in the market-value of the property in question occasioned by the application in respect of which compensation is demanded; and where the market-value of such property is not ascertainable, the amount of compensation to be awarded shall be reckoned at twelve times the amount of the diminution of the annual met profits of such property occasioned by such application.

No right to any such supply of water as is referred to in clauses one, two or three of this section in respect of a work or channel not in use at the passing of this Act shall hereafter be acquired as against the Government except by grant or prescription.

9. No claim for compensation for any such diminution or stoppage shall be entertained, unless it be made within one year next after such stoppage or diminution has commenced.

10. The Deputy Commissioner shall proceed to inquire into any such claim, and to determine the amount of compensation,

if any, which should be given; and sections nine to twelve, fourteen and fifteen, eighteen to twenty-three, twenty-six to forty, fifty-one, fifty-seven, fifty-eight and fifty-nine of Act No. X. of 1870 shall apply to such inquiries:

conveyed through some existing water-course, he shall give notice to the person or persons responsible for the maintenance of such water-course to show cause, on a day not less-than fourteen days from the date of such notice, why the said supply should not be so conveyed; and, after making inquiry on such day, the Divisional Canal officer shall determine whether and on what conditions the said supply shall be conveyed through such water-course.

When such officer determines that a supply of canal-water may be conveyed through any watercourse as aforesaid, his decision shall, when confirmed or modified by the Superintending Canal officer,

be binding on the applicant and also on the persons responsible for the maintenance of the said watercourse.

Such applicant shall not be entitled to use such water-course until he has pa d the expense of any alteration of such water course necessary in order to his being supplied through it, and also such share of the first cost of such water-course as the Divisional or Superintending Canal officer shall determine.

Such applicant shall also be liable for his share of the cost of maintenance of such water-course so long as he uses it.

the shall call upon the applicant to make such deposit as he considers necessary to defray the cost of the preliminary proceedings, and the amount of any compensation that may become due under the provisions of section twenty-eight in respect of such transfer;

and, upon such deposit being made, he shall publish a notice of the application in every village through which the said water-course passes, and

shall send a copy of the notice to the Deputy Commissioner of every district through which such

water-course passes.

Third.—The proposed water-course shall be completed to the satisfaction of the Divisional Canal officer within one year after occupation of the land is given to the applicant.

In cases in which land is occupied or a watercourse is transferred on the terms of a rent charge,

Fourth.—the applicant or his representative in interest shall, so long as he occupies such land or water-course, pay rent for the same at such rate and on such days as shall be determined by the Deputy Commissioner when occupation is given.

Fifth.—If the right to occupy the land shall cease owing to a breach of any of these rules, the liability to pay the said rent shall continue until the applicant or his representative in interest has restored the land to its original condition, or until he has paid by way of compensation for any injury done to the said land such amount and to such persons as the Deputy Commissioner shall determine.

Sixth.—The Deputy Commissioner may, on the application of the person entitled to receive such rent or compensation, determine the amount of rent due or assess the amount of such compensation, and if any such be not paid by the applicant or his representative in interest, the Deputy Commissioner may recover the amount, with interest thereon at the rate of six per centum per aunum from the date on which it became due, as if it were an arrear of land-revenue, and shall pay the same, when recovered, to the persons to whom it is due.

If any of the rules or conditions prescribed by this section is not complied with, or

if any water-course constructed or transferred under this Act is disused for three years continuously, the right of the applicant, or of his representa-tive in interest to occupy such land or watercourse, shall cease absolutely.

or alteration of a water-course, and for the deposit of soil from water-course clearances.

yond the control of the Government, or of any repairs, alterations or additions to the canal, or of measures taken for regulating the proper flow of water therein, or for maintaining the established course of irrigation which the Divisional Canal officer considers necessary; but the person who suffers such loss may claim such remission of the ordinary charges payable for the use of the water as shall be authorized by the Local Government.

Liability to Charges.

33. If water supplied through a water-course be used in an unauthoriz-Liability when person ed manner, and if the person, by whose act or causing waste cannot be identified. neglect such use has occurred, cannot be identified,

the person on whose land such water has flowed, if such land has derived benefit therefrom,

and if he cannot be identified, or if such land has not derived benefit therefrom, all the persons chargeable in respect of the water supplied through such water-course shall be jointly liable to the charges made for such use.

All charges for the unauthorized use or for waste of water may be recovered in addition to any penalties incurred on account of such use or waste.

All questions under this section, shall be decided by the Divisional Canal officer, and his decision shall be final unless the Local Government shall otherwise direct.

If water supplied through a water-course be suffered to run to waste, Liability when water and if, after inquiry officer, the person through whose act or neglect runs to waste. such water was suffered to run to waste, cannot be discovered, all the persons chargeable in respect of the water supplied through such water-course shall be jointly liable for the charges made in respect of the water so wasted.

35. Where a water-rate is charged on land held

by several joint owners, it Water-rate chargeable shall be payable by the manager or other person on owner of land of which profits divisible. who receives the rents or

profits of such land, and may be deducted by him from such rents or profits before division, or may be recovered by him from the persons liable to such rate in the manner customary in the recovery of other charges on such rents or profits.

or shall have tendered an advance of money sufficient to provide for the construction of the said works; such advance to be re-payable in conformity with the rules for recovering advances made under the Act for the time being in force as to advances for improvements in land.

If any question shall arise whether the said conditions are complied with or not in respect of any land, it shall be determined in the same manner as suits relating to rent under the law for the time being in force.

The owner of any vessel causing damage to a canal, or removed or detained under this section, shall be liable to pay to the Government such sum as the Divisional Canal officer shall, with the approval of the Superintending Canal officer, determine to be necessary to defray the expenses of repairing such damage, or of such removal or detention, as the case may be.

Recovery of such charges on failure of payment.

Seizure, as is described in the two last preceding sections, the said Canal officer shall give notice to the owner or person in charge of the property seized that it or such portion of it as may be necessary, will, on a day to be named in the notice, but not sooner than fifteen days from the date of the notice, be sold in satisfaction of the claim on account of which such property was seized unless the claim be discharged before the day so named.

And if such claim be not so discharged, the said Canal officer may, on such day, sell the property seized, or such part thereof as may be necessary to yield the amount due, together with the expenses of such seizure and sale:

Provided that no greater part of the furniture of any vessel or of any cargo or goods shall be so sold than shall, as near as may be, suffice to cover the amount due in respect of such vessel, cargo or goods.

The residue of such furniture, cargo or goods, and of the proceeds of the sale, shall be made over to the owner or person in charge of the same.

59. If any vessel be found abandoned in a canal,

Vessels found abandoned may be taken possession of and sold. or any cargo or goods carried in a Government vessel on a canal or stored on or in canal lands or

on or in canal lands or warehouses be left unclaimed for a period of two months, the Divisional Canal officer may take possession of the same. A Divisional officer so taking possession may publish a notice that, if such vessel and its contents, or such cargo or goods, are not claimed previously to a day to be named in the notice, not sooner than thirty days from the date of such notice, he will sell the same; and, if such vessel or cargo are not so claimed, he may at any time after the day named in the notice, proceed to sell the same.

And thereupon, so much of the said river, stream, or drainage-channel as shall be comprised within such limits, shall be held to be a drainage-work as defined in this Act.

After prohibition, obstructions may be removed.
cation of such notification, issue an order to the person causing or having control over any such obstruction to remove or alter the same.

If, within a time to be fixed in the order, such person shall not remove or alter such obstruction, the said Canal officer may himself remove or alter it; and if the person to whom the order was issued shall not, when called upon, pay the expenses involved in such removal or alteration, such expenses shall be recoverable from him or his representative as an arrear of land-revenue.

Local Government may cause schemes and estimates for necessary drainage-works to be prepared. vernment that any drainage works are necessary for the improvement of any lands, or for the proper cultivation or irrigation thereof,

or that protection from floods or other accumulations of water, or from erosion by a river is required for any lands,

such Local Government may cause a scheme for such drainage works to be drawn up and published, together with an estimate of its cost and a statement of the proportion of such cost which the Government proposes to defray, and a schedule of the lands which it is proposed to make chargeable in respect of the scheme.

Powers of persons employed on such scheme.

Deputy Commissioner to ascertain the proprietors, sub-proprietors or farmers, or any of them whose villages or estates are or will be, in the judgment of the Deputy Commissioner, benefited by such work, and to set down in a list, having due regard to the circumstances of the district, and of the several proprietors, sub-proprietors or farmers, the number of labourers which shall be furnished by any of the said persons jointly or severally, from any such village or estate, for employment on any such work when required as hereinafter provided.

The Deputy Commissioner may from time to time add to or alter such list or any part thereof.

70. When it appears to a Divisional Canal

Properly authorized Canal officer may make requisitions on proprietors or others to supply labourers in case of anticipated serious injury to canals or drainage-works.

and that the labourers necessary for the proper execution thereof cannot be obtained in the ordinary manner within the time that can be allowed for the execution of such work so as to avoid such consequences,

the said officer may require any person named in such list to furnish so many labourers (not exceeding the number which, according to the said list, he is liable to supply) as to the said officer shall seem necessary for the immediate execution of such work.

Every requisition so made shall be in writing, and shall state the nature and locality of the work to be done, the number of labourers to be supplied by the person upon whom the requisition is made, the approximate time for which and the day on which the labourers will be required; and a copy thereof shall be immediately sent to the Superintending Canal officer for the information of the Local Government.

The rates to be paid to any such labourers in excess of the highest rates paid in the neighbourhood for similar work, shall be fixed by the Local

Government, and the payment shall extend to the whole period during which any such labourer is absent from his ordinary home.

The Local Government may direct that the provisions of this chapter shall be applicable to any district or part of a district for the purpose of effecting necessary annual silt clearances.

71. When any requisition has been made on

liable to supply, and to continue to supply his labour, for the purposes aforesaid.

aforesaid, such certificate and all other proceedings thereon shall be void, and no person shall proceed to solemnize the said marriage until new notice has been given and a certificate thereof issued in the manner aforesaid.

PART III.

REGISTRATION OF MARRIAGES.

Marriages, with certain exceptions, to be registered as herein prescribed.

26. All marriages solemnized in India from and after the commencement of this Act, between persons both or one of whom shall profess the

Christian Religion, except marriages solemnized under Parts IV. and V. of this Act, shall be registered in the manner hereinafter prescribed: Provided that no omission or defect in such registration shall invalidate any marriage not otherwise invalid.

27. Every marriage solemnized by a Clergyman of the Church of Registration of mar-riages solemn zed by Clergyman of the Church England shall be registered by the Clergyman of England. solemnizing the same in

the register of marriages of the station or district in which such marriage shall be solemnized, according to the form contained in the third schedule to this Act annexed.

28. Every Clergyman of the Church of England shall send four times Quarterly returns in every year returns in duplicate, authenticated Archdeaconry. by the signature of such Clergyman, of the entries in the register of marriages solemnized at or in any station or district at which such Clergyman shall have any spiritual charge, to the Registrar of the Archdeaconry to which he shall be subject, or within the limits of which such station or district shall be situated.

Such quarterly returns shall contain all the entries of marriages contained in the said register from the first day of January to the thirty-first day of March, from the first day of April to the thirtieth day of June, from the first day of July to the thirtieth day of September, and from the first day of October to the thirty-first day of December, of each year respectively, and shall be transmitted by such Clergyman within two weeks from the expiration of each of the quarters above specified. The said Registrar upon receiving the same shall transmit one copy to the Secretary to the Local Government.

29. Every marriage solemnized by a Clergyman of the Church of Registration and returns Rome shall be registered

of marriages solemnized by Clergymen of the Church by the person and ac-cording to the form directof Rome. ed in that behalf by the

Roman Catholic Bishop of the Diocese or Vicariate in which such marriage shall be solemnized, and such person shall forward quarterly to the Secre-

tary to the Local Government, returns of the entries of all marriages registered by him during the three months next preceding.

30. Every marriage solemnized by a Clergyman of the

Registration and returns of marriages solemnized by Clergymen of the Church of Scotland.

Church of Scotland shall be registered by the Clergyman solemnizing the same in a register of marriages to

be kept by him for the station or district in which the marriage shall be solemnized in the form prescribed in section twenty-seven for marriages solemnized by Clergymen of the Church of England, and such Clergyman shall forward quarterly to the Secretary to Government, through the Senior Chaplain of the Church of Scotland in the territory subject to the Local Government, returns similar to those prescribed in section twenty-eight for Clergymen of the Church of England, of all marriages solemnized by him.

What marriages to be entered in register book and certificate prescribed in Schedule IV.

31. After the solemnization of any marriage under this Act by any person who has received episcopal ordination, but who is not a Clergyman of the Church of England,

nor of the Church of Rome, or by any Minister of Religion licensed under this Act to solemnize marriages, the person solemnizing the same shall forthwith register such marriage in duplicate, that is to say, in a marriage register book to be kept by him for that purpose, according to the form contained in the fourth schedule to this Act annexed, and also in a certificate attached to the marriage register book as a counterfoil.

32. The entry of such marriage in both the certificate and marriage Such entries to be register book shall be signed and attested. signed by the person by whom the said marriage has been solemnized, and also by the persons married, and shall be attested by two credible witnesses who were present at the solemnization of the marriage, and every such entry shall be made in order from the beginning to the end of the book, and the number of the certificate shall correspond with that of the entry in the marriage register book.

Such certificate to be forwarded to Marriage Registrar, copied, and transmitted to Govern-

33. The person solemnizing the said marriage Such certificate to be shall forthwith separate the certificate from the marriage register book and transmit it within one month from the time

of the solemnization of such marriage to the Marriage Registrar of the district in which the marriage was solemnized, or, if there be more Marriage Registrats than one, to the Senior Marriage Registrar, who shall cause such certificate to be copied into a book to be kept by him for that purpose, and shall transmit all the certificates which he shall have received during the month, with such number and signature or initials added thereto as are hereinafter required, to the Secretary to the Local Government.

34. Such copies shall be entered in order from

Copies of such certificates to be entered and

the beginning to the end of the said book, and shall bear both the number of the certificate as copied,

and also a number to be entered by the Marriage Registrar, indicating the number of the entry of the said copy in the said book, according to the order in which each certificate was received by the said Marriage Registrar.

35. The Marriage Registrar shall also add such last-mentioned number of the entry of the copy in Registrar to add number of entry to certificate, and send to Government. the book to the certificate,

with his signature or initials, and shall, at the end of every month, transmit the same to the Secretary to the Local Go-

vernment. 36. The person solemnizing any marriage

Custody and disposal of register book of marriages between Native Christians.

ral marriage register book and proceeding in the manner contemplated by sections twenty-seven to thirty-three, both inclusive, register such marriages in a separate register book, and shall keep safely the said register book until the same shall be filled, or, if he shall leave the district in which he solemnized the marriage before the said book is filled, shall make over the same to the person who shall succeed to his duties in the said district, who shall keep safely the same, and shall make therein the entries by this Act required to be made in respect of any such marriage solemnized by him within the said district.

And the person having the control of the book at the time when it shall be filled, shall send the same to the Marriage Registrar of the district, or, if there be more Marriage Registrars than one, to the Senior Marriage Registrar, who shall send it to the Secretary to the Local Government to be kept by him with the records of his office.

PART IV.

MARRIAGES SOLEMNIZED BY, OR IN THE PRESENCE OF, A MARRIAGE REGISTRAR.

37. When a marriage is intended to be solemnized by, or in the pre-One of the parties to sence of, a Marriage Registrar, one of the

shall give notice in writing, in the form of the first schedule to this Act annexed, or to the like effect, to any Marriage Registrar of the district within which the parties shall have dwelt for not less than five days then

next preceding, or, if the parties dwell in different districts, shall give the like notice to a Marriage Registrar of each district, and shall state therein the name and surname, and the profession or condition of each of the parties intending marriage, the dwelling place of each of them, and the time, not being less than five days, during which each has dwelt therein, and the church, chapel, or other building in which the marriage is to be solemnized:

Provided that, if either party shall have dwelt in the place stated in the notice during more than one calendar month, it may be stated therein that he or she hath dwelt there one month and upwards.

Notice to be filed and copy entered in the Mar-riage Notice Book.

38. The Marriage Registrar shall file all such notices, and keep them with the records of his office, and shall forthwith enter a true copy of all such notices in a book to be for that purpose furnished to him by the Government, to be called the "Marriage Notice Book," and the Marriage Notice Book shall be open at all reasonable times without fee, to all persons desirous of inspecting the same.

39. The Marriage Registrars or Registrar of

Notice how to be published in ordinary cases, and how in the case of minors.

all districts in the British territories in India shall respectively publish all such notices of marriage given in their respective

districts, by causing a copy of such notices to be affixed in some conspicuous place in their respective offices, or, where such Registrars are Ministers of the Christian Religion ordained or otherwise set apart to the ministry of the Christian Religion, such notices shall be affixed in some conspicuous place in the church or chapel or place of worship in which such Ministers respectively officiate.

When one of the parties intending marriage (not being a widow or widower) is under twenty-one years of age, every Marriage Registrar shall within twenty-four hours after the receipt by him of the notice of such marriage, send, or cause to be sent, by the post or otherwise, a copy of such notice to all the other Marriage Registrars (if any) in the same district, who shall likewise affix the same in some conspicuous place in their own offices or chapels as aforesaid.

40. The Marriage Registrar, upon being re-

quested so to do by or on behalf of the party by whom the notice was given, and one of the

given, and one of the parties intending marriage having made oath or declaration as hereinafter required, shall issue under his hand a certificate of such notice having been given and of such oath or declaration having been made: Provided no lawful impediment according to the law of England be shown to the satisfaction of the Marriage Registrar why such certificate should not issue, and the issue of such certificate has not been sooner forbidden, in manner hereinafter mentioned, by any person or persons by this Act authorized in that behalf:

Provided always that, where, by such oath or declaration, it appears that one of the parties intending marriage (not being a widow or widower) is under twenty-one years of age, the Marriage Registrar shall not issue his certificate until the expiration of fourteen days after the entry of such notice of Marriage.

41. When one of the parties intending marriage (not being a widow or If minor be resident widower) is under twentyin Presidency town, the High Court on application one years of age, and both may order certificate in parties intending marriage less than fourteen days. are at the time resident in any of the towns of Calcutta, Madras, or Bombay, and are desirous of being married in less than fourteen days after the entry of such notice as aforesaid, it shall be competent for both parties intending marriage to apply by petition to the High Court of such town, or any Judge thereof, for an order upon the Marriage Registrar to whom the notice of marriage has been given, directing him to issue his certificate before the expiration of the said fourteen days required by section forty of this Act. And it shall be competent to the said High Court, or any Judge thereof, on sufficient cause being shown in its or his discretion, to make an order upon such Marriage Registrar, directing him to issue his certificate at any time to be mentioned in the said order, before the expiration of the said fourteen days required by section forty; and the said Marriage Registrar, on receipt of the said order, shall proceed to issue his certificate in accordance therewith.

42. Any person whose consent would be re-

Issue of certificate may be forbidden in specified manner. quired by section eighteen in respect of a marriage to be solemnized under Part II. may enter a pro-

test against the issue of the Marriage Registrar's certificate, by writing, at any time before the issue of such certificate, the word "forbidden" opposite to the entry of the notice of such intended marriage in the Marriage Notice Book, and by subscribing thereto his or her name and place of abode, and his or her character, in respect of either of the parties, by reason of which he or she is so authorized; and when such protest has been entered, no certificate shall issue until the Marriage Registrar shall have examined into the matter of the protest, and is satisfied that it ought not to obstruct the issue of the certificate for the said marriage, or until the protest be withdrawn by the party who entered the same.

43. In all cases where a Marriage Registrar,

If the Registrar doubt the legal authority of the person forbidding, he may refer to the High Court, the Zilla Judge, or the Governor General in Council.

do, the said Marriage Registrar shall apply by petition, where the district of such Registrar is within any of the towns of Calcutta, Madras, and Bombay, to the High Court of Judicatare in the Presidency or place within which such district is comprised, or, if such district be not within any of the said towns, then to the Judge of the zilla or district within which the same is comprised;

and the said petition shall state all the circumstances of the case, and pray for the order and direction of the Court concerning the same, and the said High Court, or any Judge thereof, or such Judge of the zilla or district, shall be empowered to examine into the allegations of the petition and the circumstances of the case, and, if, upon such examination, it shall appear that the person forbidding the issue of such certificate is not authorized by law so to do, such High Court or any Judge thereof, or such Judge of the zilla or district, shall declare that the person forbidding the issue of such certificate is not authorized as aforesaid, and then, and in such case, such certificate shall be issued, and the like proceedings may be had in relation to such marriage as if the issue of such certificate had not been forbidden by such person.

And in all cases where a Marriage Registrar appointed to act within the territories of any Native Prince or State in alliance with Her Majesty under section eight, shall not be satisfied that the person forbidding the issue of the certi-

ficate is not authorized by law so to do, the said Marriage Registrar shall transmit a statement of all the circumstances of the case, together with all documents and papers relating thereto, to the Governor General of India in Council; and, if it shall appear to the Governor General of India in Council that the person forbidding the issue of such certificate is not authorized by law so to do, the Governor General of India in Council shall declare that the party forbidding the issue of such certificate is not authorized as aforesaid, and then, and in such case, such certificate shall be issued, and the like proceedings may be had in relation to such marriage as if the issue of such certificate had not been forbidden by such person.

Oath or declaration to be made before issue of certificate.

Oath or declaration to be made before issue of certificate.

Marriage Registrar, one of the parties intending marriage shall appear per-

sonally before such Marriage Registrar, and shall make oath (or shall make his or her solemn declaration instead of an oath) that he or she believes that there is not any impediment of kindred or affinity, or other lawful hindrance, to the said marriage, and that both the parties to the intended marriage have, or (where the parties have dwelt in the districts of different Marriage Registrars) that the party making such oath or declaration bath, for the period mentioned in section thirty-seven, had their, his or her usual place of abode within the district of such Marriage Registrar, and where either or each of the parties, not being a widower or widow, is under the age of twenty-one years, that the consent of the person or persons whose consent to such marriage is required by law has been obtained thereto, or that there is no person resident in India having authority to give such consent, as the case may be:

Provided always that, where under the foregoing provision, the said High Court or Judge thereof, or such Judge of the zilla or like district, or such other person as aforesaid, declares the marriage to be proper, it shall not be necessary to make oath or declare that such consent has been obtained to such marriage.

Certificate to be as that prescribed in Schedule II. second schedule to this Act annexed, or to the like effect, and the Government of each Presidency or place shall furnish to every Marriage Registrar a sufficient number of forms of certificate.

When any Native Christian about to be If either party be a Native Christian, the Registrar shall ascertain that the notice and certificate married applies for or tenders a notice of marriage, or applies for a certificate from a Marriage Regisare understood. trar, such Marriage Registrar shall ascertain whether the said Native Christian understands the English language, and, if he does not, the said Marriage Registrar shall translate such notice or certificate, or both of them, as the case may be, or shall cause the same to be translated to such Native Christian in the language of such Native Christian, or the said Marriage Registrar shall otherwise ascertain whether such Native Christian is cognizant of the purport and effect of the said notice and certificate.

47. In all cases whatsoever where a Marriage

If Registrar in allied Native State refuses certificate, petition may be made to Governor General in Council. Registrar resident in the territories of any Native Prince or State in alliance with Her Majesty has refused to issue his certificate, it shall be

lawful for either of the parties intending marriage to apply by petition to the Governor General of India in Council, who shall decide thereon; such decision shall be final, and the Marriage Registrar to whom the application was originally made, shall proceed in accordance therewith.

48. After the issue of the certificate of the Marriage Registrar, or,

After issue of certificate marriage may be solemnized in presence of Marriage Registrar and two witnesses. Marriage Registrar, or, where notice is required to be given under this Act to the Marriage Registrars for different districts, after the issue of the

certificates of the Marriage Registrars for such districts, marriage may, if there be no lawful impediment to the marriage of such parties, be solemnized between and by the parties described in such certificate or certificates according to such form and ceremony as they may see fit to adopt; but every such marriage shall be solemnized between the hours of six in the morning and seven in the evening, in the presence of some Marriage Registrar (to whom shall be delivered such certificate or certificates as aforesaid), and of two or more witnesses, and in some part of the ceremony each of the parties shall declare—

"I do solemnly declare that I know not of any lawful impediment why I, A. B., may not be joined in matrimony to C. D.," or shall declare to the like effect.

And each of the parties shall say to the other—"I call upon these persons here present to witness that I, A. B., do take thee, C. D., to be my lawful wedded wife [or husband]," or words to the like effect.

When marriage is not had within three calendar months after notice, a new notice required.

When marriage is not had within three calendar months after the notice shall have been entered by the Marriage Registrar, as required by section thirty-eight,

the notice and the certificate which may have been issued thereupon, and all other proceedings thereupon shall be utterly void; and no person shall proceed to solemnize the marriage, nor shall any Marriage Registrar enter the same, until new notice shall have been given, and entry made, and certificate thereof given, at the time and in the manner aforesaid.

Native Christians to be made to understand the declarations at marriage.

Whether such Native Christian understands the English language, and, if he does not, the party solemnizing the said marriage shall, at the time of the solemnization thereof, translate, or cause to be translated, to such Native Christian, the declarations made at such marriage in accordance with the provisions of this Act.

51. After the solemnization of any marriage under this Part, the Mar-Marriages to be reriage Registrar present at the solemnization thereof shall forthwith register such marriage in duplicate, that is to say, in a Marriage Register Book, according to the form of the second schedule to this Act annexed, and also in a certificate attached to the Marriage Register Book as a counterfoil; and the entry of such marriage in both the certificate and the Marriage Register Book shall be signed by the person by or before whom the marriage has been solemnized, if there be any such person, and by the"Marriage Registrar present at such marriage, whether or not the marriage is solemnized-by him, and also by the parties married, and attested by two witnesses; and every such entry shall be made in order from the beginning to the end of the book, and the number of the certificate shall correspond with that of the entry in the Marriage Register Book.

PART V.

MARRIAGE OF NATIVE CHRISTIANS.

- 54. Every marriage between Native Christians applying for a certificate, shall be certified under this Part of this Act, if the following conditions be fulfilled, and not otherwise:—
- (1.) The age of the man intending to be married shall exceed sixteen years, and the age of the woman intending to be married shall exceed thirteen years:
- (2.) The man and the woman shall not stand to each other within the prohibited degrees of consanguinity or affinity:
- (3.) Neither of the persons intending to be married shall have a wife or husband-still living:
- (4.) In the presence of the person so licensed, and of at least two credible witnesses, each of the parties shall say to the other—
- "I call upon these persons here present to witness that I, A. B., in the presence of Almighty VI.—51 g

God, and in the name of our Lord Jesus Christ, do take thee, C. D., to be my lawful wedded wife [or husband]," or words to the like effect:

(5.) Such declaration shall be made between the hours of six in the morning and seven in the evening:

"Provided that no marriage shall be certified under this Part when either of the parties intending to be married has not completed his or her eighteenth year, unless such consent as is mentioned in section eighteen has been given to the intended marriage, or unless the party who has not completed his or her eighteenth year is proved to the satisfaction of the person licensed to grant certificates under section nine, to have resided apart from, and to have been independent of, the control of his or her parents or guardians.

55. When, in respect to any marriage falling under this Part of this

On marriage (the conditions having been fulfilled) licensed person to grant a certificate thereof.

Act, the conditions prescribed in the last preceding section shall have been fulfilled, it shall be

the duty of the person licensed as aforesaid in whose presence the said declaration shall have been made, to grant a certificate of such marriage, on the application of either of the parties to such marriage, on the payment of a fee of four annas. Such certificate shall be signed by such licensed person, and shall be received in any suit touching the validity of such marriage as conclusive evidence of the same marriage having been performed, and no evidence to the contrary shall-be received in any such suit.

56. A register book of all marriages of which certificates are granted under section fifty-five, shall be kept by the person granting such certificates in his own vernacular language.

Such register book shall be kept according to such form as the Local Government or Chief Commissioner shall from time to time prescribe, and the said book or true extracts therefrom, duly authenticated, shall be deposited at such places and at such times as the Local Government or Chief Commissioner shall direct.

PART VI.

PENALTIES.

or, without an order of a competent Court authorizing him to do so, solemnizes any marriage when one of the persons intending marriage (not being a widow or widower) is a minor before the expiration of fourteen days after the receipt of such notice, or without sending, or causing to be sent, by the post or otherwise, a copy of such notice of mamiage to the Senior Marriage Registrar of the district (if there be more Marriage Registrars of the district than one), and, if he himself be not the Senior Marriage Registrar, or issues any certificate,. the issue of which shall have been prohibited asin this Act provided by any person authorized to prohibit the issue thereof, shall be punished with imprisonment for a term which may extend to fiveyears, and shall also be liable to fine.

knowingly and wilfully issues any certificate for marriage under this Act, or solemnizes any marriage between such persons as aforesaid, without publishing, or causing to be affixed, the notice of such marriage as directed in Part II. of this Act, or after the expiration of two months after the certificate shall have been issued by him:

respect of the dwelling of the persons married, or of the consent of any person whose consent to such marriage is required by law, or of the notice of marriage, or of the certificate, or the translation thereof respectively, or in respect of the hours between which the same may have been solemnized, nor shall any evidence be given to prove the contrary in any suit touching the validity of such marriage.

71. Every person charged with the duty of registering any marriage, Corrections of errors. who shall discover any error to have been committed in the form or substance of any such entry, may, within one month next after the discovery of such error, in the presence of the persons married, or, in case of their death or absence, in the presence of two other credible witnesses, who shall respectively attest the same, correct the erroneous entry according to the truth of the case, by entry in the margin without any alteration of the original entry, and shall sign the marginal entry, and add thereunto the day of the month and year when such correction shall be made, and such person shall make the like mar-ginal entry, attested in the like manner, in the certificate thereof.

Every certified copy purporting to be signed by the person entrusted under this Act with the custody of any marriage register, or certificate, or duplicate cer-

tificate, required to be kept or delivered under this Act, of any entry of a marriage in such register, or of any such certificate or duplicate certificate, shall be received as evidence of the marriage purporting to be so entered, or of the facts purporting to be so certified therein, without further proof of such register or certificate, or duplicatecopy, or of any entry therein respectively, or of such copy.

Transmission of certificates of certain marriages to Secretary of State for

India.

74. The Secretary to the Local Government shall, at the end of every quarter in each year, select from the certificates of marriages forwarded to him during such quarter,

the certificates of the marriages of which the Governor General of India in Council may desire that evidence shall be transmitted to England, and forward the same certificates signed by him to the Secretary of State for India, for the purpose of being delivered to the Registrar General of Births, Deaths, and Marriages.

75. The Local Government shall determine what fees shall be chargeable under this Act for the receipt and publication of notices of marriages, the issue of certificates of marriage and the registration of marriages by Marriage Registrars,

and for the entry of protests with, or prohibitions of, the issue of marriage certificates by the said Registrars,

for searching register books, or certificates, or duplicates, or copies thereof,

and for the issue of copies of entries in the same under sections fifty-seven and seventy-two,

and may from time to time vary or remit such fees either generally or in special cases as to it may seem fit.

STATEMENT OF OBJECTS AND REASONS.

The law relating to the solemnization in India of marriages of persons professing the Christian religion is at present distributed over two English Acts of Parliament and three Acts of the Indian Legislature.

The object of this Bill is to reduce into a smaller compass and simplify the existing law on this subject by the consolidation of the different enactments referred to, and at the same time to amend the law in those matters in which it has been shown to be defective.

For example, by Act V. of 1865 it is provided that marriages between Native Christians shall be valid where the ages of the contracting parties are not less than sixteen and thirteen years, respectively, and where they do not stand in relation to each other within the prohibited degrees of consanguinity or affinity.

It has been very forcibly represented by the President and several Members of the Bengal Christian Association that this provision of the law works injuriously by freeing the children of Native Christian parents from the control which all other parents can legally exercise over their sons and daughters ere the latter have attained their majority.

The Bill requires the consent of the parents or guardians of Native Christians to a marriage between them, where the age of either of the parties about to contract such marriage is less than eighteen years, except in cases in which the minors have been altogether separated from their parents or natural guardians, and by reason of such separation are not properly subject to their control.

There is also some ambiguity in regard to the provisions of the law respecting the submission of returns, and the disposal of the records of the registration of marriages solemnized between Native Christians.

The Bill lays down distinctly how such marriages are to be recorded in all cases, and provides for the disposal of the record. It also substitutes for the fixed rates of fees in respect of marriages solemnized by or before Marriage Registrars, a power to the Local Government to regulate such fees and their remission; and, lastly, extends the Marriage Law to all places within the territories of Native Princes in alliance with Her Majesty, in respect of marriages between British subjects professing the Christian religion.
