LEGISLATIVE DEPARTMENT

The following Bill was introduced into the Council of the Governor General of India for the purpose of making Laws and Regulations on the 2nd January 1872, and was referred to a Select Committee with instructions to make their report thereon in a month;—

Bill No. 1 of 1872.

A Bill to consolidate and amend the Law relating to the Courts in British Burma,

Whereas it is expedient to consolidate and amend the law relating to the Courts in British Burma; It is hereby enacted as follows:—

CHAPTER I.

PRELIMINARY.

- This Act may be called "The Burma Courts Short title. Act, 1872."
- It extends to all the territories subject to the Chief Commissioner of British Burma;

Commencement. and shall come into force on the date of the passing thereof.

Pending suits to be disposed of by Courts in which instituted.

Recorders of Rangoon and Maulmain, shall be heard and disposed of by the Courts in which they were instituted.

3. All suits, appeals, applications or proceedings pending in the Court of the Chief Commissioner and Recorder.

Transfer of suits pending in the Court of the Chief Commissioner, shall be transferred to the Court of the Judicial Commissioner, those

pending in the Court of the Recorder of Rangoon shall be transferred to the Court of the Judge of Rangoon; and those pending in the Court of the Recorder of Maulmain shall be transferred to the Court of the Judge of the Town of Maulmain, or, v1,—55 c

if the subject-matter thereof be beyond ais jurisdiction, to the Court which has jurisdiction under this Act.

pealed, except as to the suits, appeals, applications and proceedings mentioned in section two, but not so as to affect the operation of any Act extended to British Burma by any of the said Acts.

CHAPTER II.

LAWS TO BE ADMINISTERED.

5. Where, in any suit or proceeding, it is necessary for any Court under this Act to decide Certain decisions to be according to Native law. any question regarding succession, inheritance. marriage or caste, or any religious usage or institution, the Buddhist law, where the parties are Buddhists, the Muhammadan law in cases where the parties are Muhammadans, and the Hindú law in cases where the parties are Hindús, shall form the rule of decision, except in so far as such law has by legislative enactment been altered or abolished, or is opposed to any custom having the force of law prevailing in British Burma.

In cases not provided for by the former part of this section or by any other law for the time being in force, the Court shall act according to justice, equity and good conscience.

The ministerial officers of all other Courts subordinate to the Judicial Commissioner shall be appointed by the presiding officers thereof; provided that the appointment of a ministerial officer whose monthly salary exceeds fifty rupees shall be subject to the sanction of the Judicial Commissioner.

When in the trial of any civil appeal the Appellate Court entertains Reference to Judicial a doubt in regard to a Commissioner. having the force of law, or as to the construction of a document, or as to the admissibility of any evidence affecting the merits of the case, such Court may draw up a statement of the point as to

which it is in doubt, and refer it with the Court's own opinion, for the decision of the Judicial Commissioner.

30. The Judicial Commissioner shall, after considering the point so Procedure on such rereferred, send a ruling thereon to the Court by which the reference was made, and such Court shall, on the receipt of such ruling, proceed to dispose of the case in conformity with such ruling.

- 38. The Court of the Judge of Rangoon shall have civil jurisdiction in the adjudication of suits of every description, and of whatever value arising within his local jurisdiction, except those which are cognizable by a Court of Small Causes.

Rangoon agrees with the finding of the Court from whose decision the appeal has been made, the finding of that Court shall be upheld.

- (2). If the difference arise in a civil appeal, and be on a point of law or usage having the force of law, or the construction of a document, the ruling of the Court from whose decision the appeal has been made shall be upheld, unless either the Judicial Commissioner or the Judge of Rangoon be of opinion that the point should be referred to the High Court of Judicature at Fort William in Bengal, in which case they shall state the point as to which they differ, and forward the statement with their respective opinions thereon to such High Court.
- (3). In all other cases, the point shall be referred to the High Court with a similar statement of opinions.

66. Where the reference is in a civil suit, the Decree may be passed contingent on opinion of High Court, but execution

STATEMENT OF OBJECTS AND REASONS.

It having been determined to appoint a Judicial Commissioner for Burma, the object of this Bill is to provide for the constitution of that Officer's Court, and to carry out certain modifications of the existing legal machinery of the Province which experience has shown to be desirable. Provision is made for a special Court, consisting of the Judicial Commissioner and another officer, which will cial Commissioner and another officer, which will in certain cases sit as the final Court of Appeal, and will dispose of capital cases against European British Subjects.
