BILLS OF THE COVERNMENT OF INDIA.

LEGISLATIVE DEPARTMENT.

The following Report of a Select Committee, together with the Bill as re-settled by them, was presented to the Council of the Governor General of India for the purpose of making Laws and Regulations on the 20th June 1872:

We, the undersigned, the members of the Select Committee, to which the Bill to consolidate and amend the law relating to the solemnization in India of marriages of persons professing the Christian Religion was recommitted, have the honour to present this final report.

We have considered the papers noted in the From Officiating Chief Sceretary to Government of Fort St. George, No. 48, dated 5th April 1872, and enclosures. margin, received after the presentation of the first report.

The Bill, as formerly settled and as published in the Gazette of India, applied (so far as regards Native States) to Christian British subjects of Her Majesty. As there are many Native Christian subjects of Her Majesty in Native States, for whom it is desirable to provide, we have struck out the word 'British' in section one, and in section nine we have authorised the Governor General in Council to license persons to grant certificates of marriage to such Native Christians. Power to do this is conferred on the Governor General in Council by Statute 32 & 33 Vic., c. 98, s. 1.

We have provided (section two) that the repeals to be effected by the proposed Act shall not invalidate any marriage confirmed by a repealed enactment (e. g. 14 & 15 Vic., c. 40, s. 24), and that appointments made and licenses granted under any repealed Act shall be deemed to be respectively made and granted under the proposed Act.

Section eleven forbids a marriage to be solemnized in any place other than a church, where there is a church within five miles of such place. We have provided that this distance shall be measured, not as the crow flies, but by the shortest road.

Sections seventeen and forty-one provide that ministers and marriage-registrars shall not issue certificates if any lawful impediment, according to the law of England, be shown to their satisfaction. We have struck out the words in italics.

In sections twenty-five and fifty-one we have provided that the two witnesses there mentioned shall be exclusive of the person solemnizing the marriage.

Section sixty contains a clause declaring that, in the case of marriage between Native Christians, the parties shall not stand to each other within the prohibited degrees of affinity. In the case of Natives there is no rule as to these degrees applicable throughout India. We have therefore struck out this clause and replaced it by a general provision that nothing in the Act shall validate any marriage forbidden by the personal law to which either of the parties is subject.

We have extended section sixty-six (as to forbidding the issue of a certificate by falsely representing oneself to be a person whose consent to the marriage is required by law) to cases where the person making the representation believes it to be false, or has not reason to believe it to be true.

Sections seventy-six and seventy-seven are intended to prevent monogamists from acquiring a right to practise polygamy by changing their religion. But we are of opinion that a Bill regulating the solemnization of Christian marriages is not the proper place for such provisions, which affect persons other than Christians, and which relate to the essence of the contract of marriage, whereas the Act is intended only to govern its ceremonial and the mode of contracting it. And as we have reason to think that under the existing law a second marriage effected during the existence of a prior one contracted under the law of monogamy would be invalid, it seems to us more prudent to postpone the matter for further consideration and to make it the subject of a separate Act.

In section seventy-eight we have provided that a marriage, otherwise duly solemnized, shall not be void merely on account of irregularity in respect of the place of its solemnization.

We have empowered the Local Government to declare who shall in any place be deemed to be the District Judge, and we have authorised the Governor General in Council to delegate to any officer the powers conferred by the Act in respect of Christians in Native States.

Lastly, we have saved marriages duly performed by ministers, consuls, and consular agents of foreign States.

We have found it necessary or expedient to amend the drafting of most of the sections, and we recommend that the Bill thus altered be passed.

A Bill to consolidate and amend the law relating to the solemnization in India of the marriages of Christians.

[As re-amended by the Select Committee.]

Whereas it is expedient to consolidate and amend the law relating to the solemnization in India of the marriages of the persons professing the Christian religion; It is hereby enacted as follows:—

PRELIMINARY.

Short title.

1. This Act may be called "The Indian Christian Marriage Act, 1872."

It extends to the whole of British India, and,
so far only as regards
Christian subjects of Her
Majesty, to the territories of Native Princes and
States in alliance with Her Majesty;

and it shall come into force on the passing Commencement. thereof.

2. The enactments specified in the fifth schedule hereto annexed are repealed, but not so as to invalidate any marriage confirmed by, or solemnized under, any such enactment.

And all appointments made, licenses granted, consents given, certificates issued, and other things duly done under any such enactment shall be deemed to be respectively made, granted, given, issued, and done under this Act.

For clause xxiv. of section nineteen of the Court Fees Act, 1870, the following shall be substituted:—

'XXIV. Petitions under the Indian Christian Marriage Act, 1872, sections forty-five and fortyeight.'

- 3. In this Act, unless there is something repugnant in the subject or context,—
- "Church of England" and "Anglican" mean and apply to the Church of England as by law established;
- "Church of Scotland."
 "Church of Scotland."
 "means the Church of Scotland as by law established;
- "Church of Rome" and "Roman Catholic" mean and apply to the Church which regards the Pope of Rome as its spiritual head;
- "Church" includes any chapel or other building generally used for public Christian worship;

- "Minor" means a person who has not completed
 the age of twenty-one
 years and who is not a
 widower or a widow.
- "Native State" means the territories of any Native Prince or State in alliance with her Majesty;

The expression "Christians" means persons professing the Christian religion;

And the expression "Native Christians" includes
"Native Christians." the Christian descendants
of Natives of India converted to Christianity, as well as such converts.

PART I.

THE PERSONS BY WHOM MARRIAGES MAY BE SOLEMNIZED.

4. Every marriage between persons one or both of whom is a Christian or Christians shall be solemized accordance with the provisions of the next following section; and any such marriage solemnized otherwise than in accordance with such provisions shall be void.

Persons by whom marriages may be solemnized.

5. Marriages may be solemnized in India—

- (1) by any person who has received episcopal ordination, provided that the marriage be solemnized according to the rules, riter, ceremonies, and customs of the Church of which he is a Minister;
- (2) by any Clergyman of the Church of Scotland, provided that such marriage be solemnized according to the rules, rites, ceremonies, and customs of the Church of Scotland;
- (3) by any Minister of religion licensed under this Act to solemnize marriages;
- (4) by, or in the presence of, a Marriage Registrar appointed under this Act;
- (5) by any person licensed under this Act to grant certificates of marriage between Native Christians.
- 6. The Local Government may grant licenses to Ministers of Religion to solemnize marriages within the territories under its administration, and may revoke such licenses.
- 7. The Local Government may appoint one or Marriage Registrars. more Christians, either by name or as holding any office for the time being, to be the Marriage Registrar or Marriage Registrars, for any district subject to its administration.

Where there are more Marriage Registrars than one in any district, the Local Government shall appoint one of them to be the Senior Marriage Registrar.

When there is only one Marriage Registrar in a district, and such Registrar is absent from Magistrate when to be Marriage Registrar. such district, or ill, or when his office is temporarily vacant, the Magistrate of the district shall

act as, and be, Marriage Registrar thereof during such absence, illness, or temporary vacancy.

Marriage Registrars in Native States.

8. The Governor General in Council may, by notification in the Gazette of India, appoint any Christian to be a Marriage Registrar in respect

of any district or place within the territories of any Native Prince or State in alliance with Her Majesty.

The Governor General in Council may, by like notification, revoke any such appointment.

Licensing of persons to grant certificates of mar-riage between Native Native Christians.

9. The Local Government or (so far as regards any Native State) the Governor General Council, may grant a license to any Christian, either by name or as hold-

ing any office for the time being, authorizing him to grant certificates of marriage between Native Christians.

Any such license may be revoked by the Authority by which it was granted, and every such grant or revocation shall be notified in the official Gazette.

and such consent is hereby required for the same marriage, unless no person authorized to give such consent be resident in India.

38. When a marriage is intended to be solemnized by, or in the pre-sence of, a Marriage Notice of intended mar-riage before Marriage Re-Registrar, one of the parties to such marriage gistrar.

shall give notice in writing, in the form contained in the first schedule hereto annexed, or to the like effect, to any Marriage Registrar of the district within which the parties have dwelt,

or, if the parties dwell in different districts, shall give the like notice to a Marriage Registrar of each district,

and shall state therein the name and surname, and the profession or condition, of each of the parties intending marriage, the dwelling-place of each of them, the time during which each has dwelt therein, and the place at which the marriage is to be solemnized:

Provided that, if either party has dwelt in the place stated in the notice for more than one month, it may be stated therein that he or she has dwelt there one month and upwards.

39. Every Marriage Registrar shall, on re-Publication of Notice. ceiving any such notice, cause a copy thereof to be affixed in some conspicuous place in his office.

When one of the parties intending marriage is a minor, every Marriage Registrar shall, within twenty-four hours after the receipt by him of the notice of such marriage, send, by post or otherwise, a copy of such notice to each of the other Marriage Registrars (if any) in the same district, who shall likewise affix the copy in some conspicuous place in his own office.

Notice to be filed and copy entered in Marriage Notice Book.

40. The Marriage Registrar shall file all such notices and keep them with the records of his office,

and shall also forthwith enter a true copy of all such notices in a book to be furnished to him for that purpose by the Local Government, and to be called the " Marriage Notice Book;"

and the Marriage Notice Book shall be open at all reasonable times, without fee, to all persons desirous of inspecting the same.

41. If the party by whom the notice was given requests the Marriage Re-Certificate of r notice gistrar to issue the certificate next hereinafter mentioned, and if one of the parties intending marriage has made oath as hereinafter required, the Marriage Registrar shall issue under his hand a certificate of such notice having been given and of such oath having been made:

Proviso. Provided-

that no lawful impediment be shown to his satisfaction why such certificate should not issue;

that the issue of such certificate has not been forbidden, in manner hereinaster mentioned, by any person authorized in that behalf by this Act;

that four days after the receipt of the notice have expired and further,

that where, by such oath, it appears that one of the parties intending marriage is a minor, fourteen days after the entry of such notice have expired.

And each of the parties shall say to the other as follows, or to the like effect—" I call upon these persons here present to witness that I, A. B., do take thee, C. D., to be my lawful wedded wife [or husband]."

(3.) In the presence of the person licensed under section nine, and of at least two credible witnesses other than such person, each of the parties shall say to the other—

"I call upon these persons here present to witness that I, A. B., in the presence of Almighty God, and in the name of our Lord Jesus Christ, do take thee, C. D., to be my lawful wedded wife [or husband]," or words to the like effect:

Provided that no marriage shall be certified under this Part when either of the parties intending to be married has not completed his or her eighteenth year, unless such consent as is mentioned in section nineteen has been given to the intended marriage, or unless it appears that there is no person living authorized to give such consent.

A Bill to legalize the repayment of money deposited in District Savings Banks in the names of Minors.

Whereas it is expedient to legalize the repayment
Preamble. of moneys deposited in
District Savings Banks in
the names of minors; It is hereby enacted as
follows:—

Short title.

1. This Act may be called "The Minors' Deposits Act, 1872:"

Local extent.

It extends to the whole of British India;

Commencement.

And it shall come into force on the passing thereof.

2. Any deposit of money heretofore or hereafter made in any District Savings Bank by, or on behalf of, any person, who has not completed the age of eighteen years, may be repaid to him or to his guardian, together with the interest accrued thereon; and the receipt of himself or his guardian shall be a sufficient discharge.

All repayments under this Act shall be made by the Secretary to the Bank, subject to such rules as the Government of India in the Financial Department may, from time to time, prescribe.

STATEMENT OF OBJECTS AND REASONS.

The object of this Bill, which is founded on Statute 26 & 27 Vic., c. 87, s. 30, is to legalize the repayment of moneys deposited in District Savings Banks by or on behalf of minors, i.e., in the words of the Indian Succession Act, persons who have not completed the age of eighteen years.

Such deposits are often made by fathers on behalf of their minor children, and hardship is sometimes caused by the impossibility (as the law stands) of providing thereout for the maintenance, clothing, and education of these minors.

Bill for imposing a duty on certain spirits manufactured in British Burma.

For the purpose of imposing a duty on spirits

Preamble. manufactured at distilleries in British Burma,
worked according to the English method; It is hereby enacted as follows:—

Short title. 1. This Act may be called "The Burma Spirit Duty Act, 1872:"

Local extent. It extends only to British Burma;

And it shall be deemed to have come into force on the first day of April 1872.

2. A duty shall be levied on spirits manufactured in Burma.

Duty on English spirits manufactured in Burma.

method, at such rate per imperial gallon, of the strength of London proof, as the Local Government with the previous sanction of the Governor General in Council, from time to time directs.

Such duty shall be augmented or reduced in proportion to the strength of the spirits.

3. This Act shall be taken as part of the Act to be read as part of the Excise Act, 1871, and the provisions of the second and thirdelauses of section twenty-one of that Act shall apply to the said spirits, as if for the words "aforesaid duty," the words "duty leviable under the Burma Spirit Duty Act, 1872," were substituted.

STATEMENT OF OBJECTS AND REASONS.

The Excise Act, 1871, section twenty-one, imposes a duty of three rupees per imperial gallon on spirits manufactured according to the English process. This duty was not considered adapted to British Burma, where a heavy fee was charged for licensing distilleries in which spirits were so manufactured. That Province was, therefore, expressly excluded from the operation of section twenty-one. It is now thought advisable to alter the local practice as to charging a license-fee, and to impose a duty on such spirits at a rate to be determined, from time to time, by the Chief Commissioner with the previous sanction of the Government of India. The Bill substantially consists of a clause conferring this power upon him retrospectively from the 1st April 1872, when the Excise Act came into force in British Burma.
