A Bill to consolidate and define the law relating to the settlement and collection of Landrevenue in Oudh.

Whereas the Government of India is by law entitled to a proportion Preemble of the produce of the land

of Oudh to be, from time to time, fixed by itself, and whereas it is expedient to consolidate and define the law relating to the settlement and collection of such proportion, and to the duties of Revenue Officers in Oudh ; It is hereby enacted as follows :-

### PRELIMINARY.

### CHAPTER I.

### REVENUE OFFICERS.

2. There shall be in Grades of Revenue Offi-Oudh the following grades of Revenue Officers :-

- The Chief Commissioner, who shall be (1)the chief controlling revenue authority in Oudh.
- Commissioners, each of whom shall, subject to the control of the Chief (2)Commissioner, be the chief controlling revenue authority within a division.
- Deputy Commissioners, each of whom (3)shall, subject to the control of the Commissioner, be the chief executive revenue authority in a district.
- Assistant Commissioners and Extra As-(4)sistant Commissioners, each of whom shall, subject to the control of the Deputy Commissioner, exercise such powers as the Chief Commissioner may, from time to time, direct.
- (5)Tahsíldárs, each of whom shall, subject to the control of the Deputy Commissioner, be the chief executive revenue authority in a tahsil or sub-district.

The Deputy Commissioner may distribute amongst the Assistant Commissioners, Extra Assistant Commissioners, and other supordinate officers of his district, as he thinks proper, such revenue duties as, under this or any other Act in force for the time being, they are authorized to perform.

The Chief Commissioner shall make rules

as to the appointment, Rules as to Village Offiduties, payment, and recers. moval of Lambardars or

Village Headmen, Patwaris or Village Accountants, Kanungos or Superintendents of Village Accountants, such regard as the Chief Commissioner thinks fit being had to custom or descent.

Where by any such rule the appointment of Patwaris is directed to be made by the landowners of a village, or the landowners are made primarily responsible for enforcing the due submission of such returns as may be prescribed to be kept by Patwaris, the neglect or refusal of such landowners to make such appointment or to enforce the submission of such returns shall be punishable with such fine as the Chief Commissioner directs; and such fine shall be recoverable as an arrear of land-revenue.

a representative for the payment of revenue due in respect of any land, they are said to be settled with, or a settlement is said to be made with them, in respect of that land.

charge of a settlement, stating the principle on which the revenue in such settlement is to be assessed.

No Court of Justice shall be entitled, under any circumstances, to require the production, or shall permit evidence to be given of the contents, of such instructions.

> (1) a summary settlement, that is to say, a provisional settlement, made pending a first regular settlement : the declaration of the Local Government that a settlement was summary shall be conclusive proof that it was so;

(2) a first regular settlement, that is to say a settlement in which the revenue is assessed and a settlement-record is for the first time formed ;

(3) a re-settlement, that is to say, a settlement subsequent to a first regular settlement, in which the revenue is re-assessed.

11. Whenever a district or other local area is to be put under settlement, Notification of settlethe Chief Commissioner ment.

shall, with the previous sanction of the Governor General in Council, issue a notification of settlement.

Such notification shall-

- (1) define the local area which is to be put under settlement;
- (2) mention such of the officers by whom it is to be made as to the Chief Commissioner seems fit ;
- (3) declare whether surveys and plans are to be made, and whether the boundaries of villages and estates are to be adjusted.

The officers mentioned in such notification shall be called Settlement Officers, and the principal officer so mentioned shall be the officer in charge of the settlement.

Nor shall it at such subsequent settlement be revised otherwise than by making new maps, surveys, or measurement, when the Chief Commissioner so directs, and by amending such of the documents of the settlement-record as depend thereon so as to accord with such new maps, surveys, or measurement; but not so as to alter any statement as to the share or holding or status of any person, except in the manner provided in Chapter IV.

as to any right of which he is in possession, by any entry not based on a judi-

cial decision made in a settlement record, may, after such settlement-record has been sanctioned, but subject to such rule in regard to suits of this nature as may be prescribed by any law of limitation in force for the time being, bring a suit in a Civil Court for a declaration that such entry is incorrect, and that a different entry ought to have 'been made.

Every person interested in such entry shall be made a defendant in such suit.

A decree obtained in such suit shall be of the same effect as if the entry Effect of decree.

which it declares to be . correct had been made originally in the settlement record.

21. Any Revenue Officer, and, in a district Erection and repair of boundary-marks.

under settlement, any Settlement Officer, may by a notice in writing, require

the person liable for the revenue of any village, estate, or field to erect or repair boundary-marks sufficient for defining the limits of such village, estate, or field;

and if such boundary-marks are not so constructed or repaired within a period to be specified in the notice, such Revenue or Settlement Officer may cause boundary-marks to be so erected or repaired;

and the cost of such erection or repair shall be recoverable from the persons liable for the revenue of such village, estate, or field, as if it were an arrear of land-revenue due in respect of such village, estate, or field.

The provisions contained in the former part of this section are also applicable to such villages or local areas as are or may be held revenue free.

22. Settlement Officers may issue commissions

Power to issue commis-sions to take evidence, or for local investigation, and to refer to arbitration.

to take evidence, or for local investigations according to the provisions of the Code of Civil Procedure, and may, if empower-

ed by the Local Government, refer any matter in dispute to arbitrators whether with or without the consent of parties.

The arbitrators to be appointed under this section shall exercise such powers, proceed in such manner, and their finding shall be liable to such appeal as the Local Government directs.

23. Settlement Officers shall have the same power to compel the at-Power to compel attendtendance of all persons ance of witnesses. whom they believe to be able to give them information as to the matters into which they are empowered to inquire under sections eleven and fourteen, as the Judges of Civil Courts have to procure the attendance of witnesses under the Code of Civil Procedure ;

and all persons who appear before such officers are bound to state the truth upon all such matters, and to produce such documents and other things as may be required of them.

24. Settlement Officers and the servants and workmen employed by Power to enter lands, them shall have the powers to make surveys, &c. specified in the Land

Acquisition Act (X. of 1870), section four, for the purpose of making such plans and surveys as are directed by the notification prescribed by section eleven, and of collecting such information as to the quality and produce of the land as may be necessary to enable them to assess the revenue to be paid thereon.

25. Unless it is otherwise expressly provided

What to be deemed to belong to owners of estates.

in the settlement-record, all forests, unclaimed, unoccupied, deserted, or

waste lands, quarries, spontaneous produce and other accessory interests in land shall be deemed to belong to the owners of the estate within the boundaries of which they are at such settlement included.

26. Mines of metal or coal and gold-washings Mines to be deemed to belong to Government. Shall, until the contrary is proved, be deemed to be the property of the Go-

vernment. But if the Government works, or causes to be worked, any such mine, and thereby damages the surface of the soil, compensation for such damage shall be made to the owner of such surface in cases where the Government is not itself such owner.

Such compensation may be claimed, and shall be ascertained and awarded, as if the surface were acquired in accordance with the provisions of the Land Acquisition Act, 1870.

### CHAPTER III.

ENGAGEMENTS FOR PAYMENT OF LAND-REVENUE.

27. When the land in respect of which a set-

With whom settlement is to be made. tlement is to be made is owned by one person, the settlement shall be offered to that person.

When such land is owned by several persons, the settlement shall be offered to such persons through their representatives.

When there are two classes of owners, superior and inferior, the settlement must be first offered to the superior; if he refuses the offer of the settlement, it shall be offered to the inferior.

28. When the officer in charge of the settle-

Settlement Officer to report amount of assessment, and how computed. ment has satisfied himself as to the amount at which an estate or a number of estates within a certain

specified area should be assessed, he shall submit to the Commissioner a report of such amount and of the grounds on which it is computed and the Commissioner shall forward such report, together with his own opinion thereon, to the Chief Commissioner.

29. The Chief Commissioner shall give such

instructions as he thinks fit to the officer in charge of the settlement, as to the terms on which the

person with whom the settlement is to be made shall be permitted to offer to engage for the revenue,

and such officer shall inform such persons that they may make an offer on such terms, subject to the final sanction of the Governor General in Council.

32. All the owners of land in an estate shall

be jointly and severally liable for the payment of the whole amount of re-

venue assessed upon it, and to all the processes hereinafter prescribed for the collection of arrears of revenue.

33. If the persons, with whom the settlement Effect of refusal to offer. is to be made, neglect or

as is mentioned in section thirty, the officer in charge of the settlement may exclude such persons from their estate, and may make a settlement of such estate with any other persons, or may take the estate under direct management.

The period of such exclusion shall, in no case exceed the term of the settlement.

All persons so excluded shall be entitled to an allowance from Government, the amount of which shall be fixed by the Chief Commissioner but which shall not be less than five per cent., nor more than ten per cent., on the nett amount realized by Government from the land from which such persons are excluded.

34. If the term for which any settlement has

been made expires before a new settlement is made, all persons who continue to occupy the land after

the expiration of such term shall hold it upon the conditions of the expired settlement until a new one is made.

#### CHAPTER IV.

MAINTENANCE OF THE SETTLEMENT-RECORD.

35. When a settlement-record has been handed

Recording of facts affecting settlement record. over to the Deputy Commissioner under the provisions of section seventeen, he shall, from time to time, record, or cause to be recorded, all facts affecting any matter stated in the settlement-record, which occur subsequent to the handing over to him of the settlement-record.

36. The Chief Commissioner shall make rules Rulesforsuch recording. as to the facts to be so recorded,

the manner in which, the person by whom, and the occasions on which, such facts are to be recorded,

and as to the fees which are to be paid in respect of recording them.

37. The Chief Commissioner shall, from time Rules for settlement of lands of which revenue is resumed, &c. to time, make rules as to the procedure to be followed in making or modifying settlements of

lands of which the revenue has been assigned and is resumed by Government,

lands affected by alluvion, diluvion, or other river action,

and other isolated portions of land.

Such rules may provide for any matters which may be provided for in a notification of settlement under section eleven, and the officers empowered by such rules to act as Settlement Officers shall have all the powers hereinbefore given to Settlement Officers.

### CHAPTER V.

#### COLLECTION OF LAND-REVENUE.

Chief Commissioner may make rules as to payment

of revenue.

38. The Chief Commissioner may, from time to time, make rules as to the instalments by which, and the places and times which, the revenue at

payable in respect of any land shall be paid, and as to the mode in which notice as to such instalments, places, and times shall be given to the persons concerned :

until the Chief Commissioner otherwise directs, the practice as to these matters now observed shall continue.

Every person who has engaged to pay any por-

tion of land-revenue shall Revenue to be paid at pay the same at the place, place and on day appointed. and before sunset on the day, appointed by the Local Government in that behalf.

Any sum not so paid becomes thereupon an arrear of land-revenue,

Effect of non-payment. and the person who owes such arrear becomes a defaulter.

39. When an arrear of land-revenue has ac-

crued, the Deputy Com-Procedure for recovery of arrears. Warrant. missioner may issue a warrant ordering the defaulter to pay the amount within a time therein stated, and empowering an officer named in the warrant, in default of the arrear being so paid, to

bring the defaulter to the tahsil at a date to be named in the warrant. If the arrear be not paid, and if, on the day

named in the warrant, the defaulter does not show satisfactory cause for extending the time for

payment of the arrear, the Deputy Commissioner may direct him to be conveyed to his head quarters and there kept under personal restraint for ten days.

The Deputy Commissioner may empower any Tahsildar of his district to exercise the powers conferred by the first and second clauses of this section.

If the arrear be not paid within ten days, and

no good reason for the Imprisonment in civil non-payment is shown, the Deputy Commissioner

may issue an order to the jailor of the civil jail of the district, directing him to confine the defaulter therein as a civil prisoner until the arrear is paid, or until the expiration of such period, not exceeding one year from the date of the order, as the Deputy Commissioner thinks fit; and such person shall be confined according to the terms of such order;

respect of an arrear, the defaulter on account of whose arrear such process has been enforced shall, if he has been imprisoned under this section, be forthwith discharged.

40. No proceeding had, or process enforced, under section thirty-nine, When civil court may shall be liable to be coninterfere. tested in any civil court, unless the person aggrieved thereby denies that the amount of revenue claimed was due, and tenders security for any arrear in respect of which the process was issued, or which is due, or is likely to be become due, before the termination of the suit, and for any costs arising out of the proceedings in the civil court.

In such case the court shall issue a precept to the Deputy Commissioner to discharge the prisoner from custody, but the court shall in no case interfere with any such attachment and sale of moveable property as aforesaid.

41. If any such process as is mentioned in section thirty-nine Party proceeded against taken against any person, may pay under protest and sue for recovery. he may pay the amount claimed under protest, and upon such payment, the process shall be withdrawn, and the party against whom it was issued may sue the Government in any civil court for the amount so paid.

42. When an arrear of land-revenue has ac-Land may be attached crued, the Deputy Comand taken missioner may in addition under direct management. to, or instead of, the processes hereinbefore specified, cause the land in respect of which the arrear has become due to be attached and taken under the direct management, of any agent whom he appoints for that purpose.

The agent so appointed shall stand for all purposes in the position of Powers and obligations of the person on account of agent. whose default the land

was attached, and shall be bound by all the liabilities of such person to any subordinate proprietors or tenants with rights of occupancy,

and shall be entitled to manage the land attached, and to receive all rents and profits accruing on such land, to the exclusion of the person on account of whose default the land was attached,

until the arrears of land-revenue due therefrom -have been satisfied, or until the Deputy Commissioner directs him to restore the person, whose interest has been attached, to the management thereof.

All surplus profits of the land attached, after defraying thereout the Application of surplus cost of such attachment and direct management, profits. shall be applied on discharging the arrear, and any instalment of land-revenue that may become due during such management.

And no such management shall continue after

If such tender be made, or if the Deputy Commissioner considers such offer satisfactory, the Deputy Commissioner may transfer the share of the defaulting member to such community or member, on such terms as he considers equitable, either permanently or until such arrear is paid.

If more such members than one make such tender or offer, the one who is most nearly related to the defaulter, or who, in case of sale, would have a right of pre-emption, shall be preferred.

- where land is sold for an arrear of revenue due in respect thereof,
- (5) that the land sold does not belong to the defaulter.

56. The proceeds of any sale under sectiond fifty-two shall be applieas follows :-

- to the payment of the arrear due ; (1)
- to the payment of any other arrear of (2)land-revenue due by the same person ;

### STATEMENT OF OBJECTS AND REASONS.

The object of this Bill is to consolidate and define the law regulating the settlement and collection of land-revenue in Oudh, which in most respects, have hitherto been conducted in conformity with the system followed in the Panjáb.

The Bill (which has been prepared by the Officiating Chief Commissioner) follows, for the most part, the Panjáb Revenue Act XXXIII. of 1871; but, besides making several desirable amendments in drafting, it has been found necessary to deviate substantially from that Act in certain respects. These are mentioned in the following extract from the letter covering the draft Bill :-

"A clause has been added to section two of the Panjáb Act to include those grades of revenue officers whose appointment and duties are mentioned in the immediately following sections ; and the wording of section four of the Panjáb Act has been altered so as to bring it into accord with section six, Act XXXII. of 1871 (the Oudh Civil-Courts Act).

"The second clause of section six of the Panjáb Act (section six of the Oudh Bill) is not sufficient in Oudh. In the Panjáb the Patwárí, once appointed, is responsible to the Deputy Commissioner for the performance of his duty. In Oudh Patwárís are the private servants of the land owners, and it is necessary to hold the landowners primarily responsible for the punctual submission of such returns as the Government requires.

"In section seven of the Bill occurs one of the main alterations of the Panjáb Land Revenue Act. These I may here shortly describe. They are (1) the substitution throughout the Bill of the expression 'settlement-record' for 'record of rights', (2) the restriction of revision of settlements to cases in which there is a revision of assessment; (3) the dispensing, in future revisions, of settlement with the statement of village customs; and (4) a modification of the sections which contain the provisions relating to sequestration of profits.

"As regards the substitution of the term ' settlement record' for ' record of rights, which first occurs in section ten of the Bill now submitted, I am to explain that, in ordinary official language, the term record of rights has heretofore been almost entirely confined to the administration paper. It has on some occasions been applied to the document known as Statement No. III .-- a statement defining the extent of the right and interest of the several shareholders of an estate. But it has never been used in the enlarged sense given to it in the Panjáb Revenue Act, where it stands for the settlement, misl. or record. Section fourteen of the Panjáb Revenue Act details the documents of which ' records of rights' are to consist. Amongst these are the village field map, the village field book, and the tender of engagement on be-half of the persons settled with. The Officiating Chief Commissioner submits that not one of these documents can, without straining the ordinary meaning of the words, be termed a record of rights. They all necessarily form a part of the settlement, scheme, or record, and it appears, therefore, to Sir George Couper that the term 'settlement-record' more appropriately describes the documents referred to, than the expression ' record of rights.'

"Passing to the second main modification, I am to observe that section ten of the Panjáb Act defining the several kinds of settlement, declares that a re-settlement is a settlement subsequent to a first regular settlement, in which either the revenue is re-assessed, or the record of rights is revised, or in which both these processes are conducted. The Officiating Chief Commissioner would submit that there should be no revision of records unaccompanied by a revision of assessment. The law provides for the preparation of a very detailed record of all rights and customs connected with the land." Provision is also made for the maintenance of these records in accord with existing facts (Chapter IV.); and Sir George Couper would deprecate any provision in the Bill which might be held to contemplate the neglect of a portion of the law and the possible necessity of employing an especial staff of officers to do what the law declares shall be done as occasion arises. The Government of India is well aware that the evils attendant on a general revision of records are very great. Hopes are aroused or revived that long dormant claims will be listened to, that a new policy will be introduced, and that rights barred by limitation will, in some way or another be, resuscitated. Animosities are fostered, a sense of uncertainty and disquiet generally prevails, and the result is an amount of disappointment and heart-burning, prejudical to the satisfactory administration of the province.

"In fact, the Officiating Chief Commissioner would deprecate a revision of records at any time subsequent to their preparation other than in the manner contemplated in Chapter IV, viz., the mutations required from time to time to render the records accurate registers of existing facts; and he is of opinion that any such course, even when the assessments are being revised, extending beyond what is absolutely necessary for a revision of the assessment, had better be avoided. The modifications made in Chapter II. will be found to be based on this principle.

"I am to add that, should it at any time be necessary or desirable to give settlement officers judicial powers, the Chief Commissioner has authority to invest them with these under section twenty-six, Act XXXII. of 1871.

" In the notification mentioned in section eleven, it is unnecessary, in Oudh, to specify whether a future settlement is a summary settlement, a first regular settlement, or a re-settlement in the words of the Panjáb Act. The summary settlement of the entire province was completed in 1858-59; the first regular settlement is also now very nearly finished. Clause 3 of section eleven, Panjáb Act, and the part of clause four, and in the case of a first regular settlement, have, therefore, been omitted from the draft.

"The third alteration of importance is in section fourteen, where it is proposed that in future settlements no administration paper shall be prepared. The Officiating Chief Commissioner appeals with confidence to the experience of all officers engaged in the administration of the country in confirmation of his opinion, that these documents seldom accurately describe the prevailing customs. If customs really prevail, the fact of their existence can be substantiated whenever occasion may require. If any doubt exists as to the prevalence of a custom, the record of its existence in a document of this kind may do more harm than good. It would be far preferable in Sir George Couper's opinion to employ a staff to look through the judicial decisions of a particular district, and ascertain the customs judicially determined to exist, than to throw away money on the preparation of documents which are notoriously inaccurate, and which carry with them no judicial sanction.

"In lieu of this clause, one has been entered requiring statement of the responsibilities of subordinate holders, where these exist. In the present settlement this record has been prepared throughout the province, and is as necessary in Oudh as the general statement of shares of the different persons directly settled with. The last part of clause two of this section has been omitted, as the khusrah, the record to which the clause refers, does not give information as to the terms on which the fields are occupied, nor is it intended that it should do so. "In section sixteen the first sentence of the Panjáb Act has been omitted. Provision to that effect has been made by section twenty-six of the Oudh Civil Courts Act, which also covers the omission in section seventeen made in the present Act.

"In section nineteen provision has been made for the continuous maintenance of the settlement record, so far as it is a record of rights, and for limiting a settlement to the proper duty of the resurvey and re-assessment of the land.

"In section twenty it has not been considered necessary to make Government a party to every suit brought by a person aggrieved by an entry in the settlement-record. If the Government is properly the defendant, the plaintiff will make it defendant. The proviso to this section does not apply in Oudh. Nor does section twenty-one of the Panjáb Act.

"In section twenty-one of the Oudh Bill, which corresponds to section twenty-two of the Panjáb Act, it has been considered advisable to add a clause, extending to revenue-free villages the provisions as to crection and repair of boundary marks, which, under the original section, are apparently applicable in revenue-paying villages only.

"Sections twenty-seven and twenty-eight of the Panjáb Act have been omitted. The separation and disposal of the Oudh forests and wastes has been completed.

"In section thirty of the Panjáb Act, it is directed that settlement may be made at the option of the Financial Commissioner, either with the superior or the inferior holder, when a double tenure exists. According to the rules in force in Oudh, this option is not given, and the section has been amended in the draft accordingly. (Section twenty-seven.)

"In section thirty-one of the Panjáb Act, as adopted in the draft, a clause has been inserted to permit of the proposed assessments being reported for an entire pargana at a time.

"The last clause of section thirty-two of the Panjáb Act has been amended in the draft, the sanction of the Supreme Government being required to the settlements in Oudh.

"The last clause of section thirty-three and the whole of section thirty-four of the Panjáb Act have been omitted from the draft. The preliminary instructions of the Chief Commissioner, and the proviso requiring the sanction of the Government of India appear to the Officiating Chief Commissioner to be checks on the propriety of the offer of engagement, which are amply sufficient. With the assistance given by section thirty-seven of the Act, section thirty-four seems superfluous. The reference to section thirty-three (in section thirtyseven of the Panjáb Act) is omitted in the corresponding section of the draft sections thirty-five and thirty-six of the Panjáb Act, numbered as sections thirty-two and thirty-one of the Oudh Bill, respectively, have been transposed, the order proposed in the Oudh Bill appearing the more natural. "In section thirty-nine of the Bill, the words of section forty-three of the Panjáb Act have been departed from only to include standing crops in the property excepted from attachment. This has been done on the advice of one of the most experienced officers of the Commission. The attachment of standing crops is a constant source of disputes, which are difficult of decision by an authority at a distance; and in the delay and doubt the value of the measure, as an incentive to the prompt payment of revenue, is, to a large extent, lost.

" With reference to the sections dealing with the process commonly known as sequestration of profits (sections fifty-one to fifty-three of the Panjab Ast both inclusive), the Officiating Chief Commissioner submits that the wording of these sections as they stand in the Panjáb Act is somewhat vague. The word 'estate' bears a certain definition under the Act, but the word ' land' has not been particularly defined. Yet the two words are so intermingled in these three sections, that their purport is rendered vague and indefinite. The Officiating Chief Commissioner has endeavoured to modify the wording of these sections so as to render them more precise, and, at the same time, to suit their provisions to the requirements of this province. In lieu of the word 'contracts' it is proposed to insert the words ' lines, beneficial leases, or other incumbrances,'-an expression imported from the Oudh Rent Act. It is proposed that such liens shall be liable to cancelment, whether protected by a decree of Court or not. The fact is, that, in the eastern districts of Oudh, a peculiar kind of mortgage is very prevalent, under which the mortgagor, on receipt of a consideration, makes over to his mortgagee certain lands at a quit-rent, such rent being, in many instances, less than the amount of revenue due to Government on account of the said lands. These mortgagees have frequently protected themselves by decree of Court ; but it is manifest that the Government is not bound to recognize any transaction which imperils its re-venue. The Officiating Chief Commissioner has, therefore, endeavoured to word these sections so as to protect the Government revenues, and at the same time secure the mortgagees in the enjoyment of such rights as do not militate against the State's interests.

"In section fifty-two of the Panjáb Act (section forty-eight of the Bill) a clause has been inserted in accordance with the old regulation, directing that no farm under the section shall be made for a longer period then fifteen years. The proviso to this section has been materially altered. Its phraseology has been slightly changed to render the meaning clearer. But, further, the proviso, as it stands in the Act, does not state at what rate of rent the lease of the lands in his cultivating occupancy shall be offered to the defaulter, and it closes with a declaration that he is in respect of these lands a mere tenant-at-will. The result-of this is, that, unless carefully protected by the terms of the lease granted to him by the Deputy Commissioner, the defaulting owner may, after one year's occupation, be wholly ejected by the farmer to whom the estate may have been let under the first clause of the section. This seems to the Officiating Chief Commissioner a terrible punishment for the imprudence which ordinarily leads to default, even of the more serious sort; and he has proposed an amendment, which is in accordance with the present practice, and which not only leaves the defaulter a right of occupancy in the lands of his home farm, but gives him it at a rent slightly easier than that of a tenant-at-will. In a case of determined contumacy (and such cases must be very rare when affairs have arrived at the point of a cancelment of settlement), the Deputy Commissioner has still the power, under the amended section, of arranging that the defaulter shall be for the future a tenantat-will. In the last clause the date of the annexation has been entered in room of the vague date given in the Panjáb Act.

"In section fifty of the Bill, the words 'and several,' which occur in the last line of section fifty-four of the Panjáb Act, have been struck out. It has been pointed out that we relieve the farmer only from his joint responsibility, not from respon-sibility for the individual share which he holds.

" As no arrears of land-revenue accrue to Government in Oudh from houses, the Officiating Chief Commissioner thinks section fifty-six of the Panjáb Act may be more correctly expressed in the form in which it appears in the draft.

"As regards section fifty-seven of the Panjáb Act, the Officiating Chief Commissioner is not of opinion that any property, except that in respect of which the arrear has accrued, should pass in sale free of all incumbrances, and has so far amended the section in his draft ; and he has added a proviso securing to the proprietor, whose lands have been sold, the privilege which has been given by the Bill in cases of cancelment of settlement, that of holding the lands of his home farm on the terms of a tenant with a right of occupancy.

"Section two hundred and fifty-seven of the Civil Procedure Code declares final the decision in appeal on an objection to the regularity of a sale by order of Court, and there seems no reason for giving a special appeal under this Act. Section fifty-eight of the Panjab Act has been amended accordingly in the corresponding Section (fiftyfour) of the present Bill.

"The Partition Act, XIX. of 1863, debars from the cognizance of the Civil Courts suits connected with partition, and clause two, section sixty-five of the Panjáb Act, has been omitted from the Oudh Bill. Further, the fees provided for in the last sentence of that section, are provided for, when necessary, by the Court Fees Act, that sentence has also been omitted."

It is hoped that this Bill may become law simultaneously with a Bill to declare what laws are in force in Oudh. The written laws of that Province, which are now in a state of great obscurity and confusion, will then have been simplified as much as can reasonably be desired.

Whereas it is expedient to provide for the appointment of Municipal Preamble. Committees in towns in the Panjáb, and for police, conservancy, local improvements, and education in such towns, and

for the levying of rates and taxes therein; It is hereby enacted as follows :-

### I.-Preliminary.

This Act may be called "The Panjáb 1. Municipal Act, 1872": Short title.

### II .- Appointment, Duties and Powers of Committees.

6. In every town to which this Act is extended, the Local Government

Appointment of mem-bers of Committee. shall appoint, or cause to be appointed, a Committee

consisting of not less then five members.

Such members may be appointed as the Local Government from time to time directs, either ex-officio, or by nomination, or by election, or some by one and some by any other of such methods :

Provided that (except with the approval of the Governor General in Council) not less than two-fifths of the members of a Committee shall be persons other than salaried officers of Government.

The Local Government may-

(a) from time to time, remove any of the members of any Committee, add to their number, and fill up vacancies occurring among them ;

(b) determine the time and manner of the election of those members whom it may direct to be appointed by election, and the persons by whom they shall be elected, and generally make such rules as it thinks fit for regulating such election.

appoint the President and Vice-President, or either of them, of any Committee, or authorise any Committee to appoint by election from their number such President or Vice-President or both.

No appointment under this section, other than the appointment by election of a Vice-President, shall be valid unless and until it is notified in the Panjáb Gazette.

7. Subject to any general rules or special Power to levy rates or make assessments. this behalf,

orders which the Governor General in Council may from time to time make in

every Committee intending to impose taxes for the purposes of this Act shall, from time to time, give public notice of such intention, and shall in such notice define the persons or property within the town to be taxed for the purposes of this Act, and the amount or rate of the taxes to be imposed hereunder.

No tax shall be collected under this Act, until the assessment thereof has been confirmed by the persons and in manner for the time being prescribed by such rules.

10. All sums received by the Committee of any Municipal Fund. town to which this Act ex-

tends, and all fines levied under this Act, shall constitute a fund, which shall be called the Municipal Fund of such town, and shall, together with all property which may become vested in such Committee, be under their control, and shall be applied by them as trustees for the purposes of this Act.

11. Every Committee, so far as the Municipal Fund at their disposal per-

Duties and powers of Committees. Truth at then disposal permits, shall, after providing out of such Fund for

a police establishment in manner hereinafter mentioned,

keep the public streets, roads, drains, tanks, and water-courses of the town for which they are appointed clean and repaired;

and generally may do all acts and things necessary for the construction, repair and maintenance of local public works of general utility;

and may also make provision, by the establishment of new schools or the aiding of already existing schools or otherwise, for the promotion of education;

and may also make provision for promoting the public health, safety, comfort and convenience.

12. Every Committee shall set apart out of Provision for Police. the Municipal Fund, such

ance of the police establishment in the town for which the Committee is appointed.

Power to make rules as to Committees. 13. Every Committee may make rules for regulating—

the time and place of their meeting;

the conduct of their business;

the division of duties among the members of the Committee ;

the dutics, salaries, appointment, suspension and removal of the officers and servants of the Committee;

and other similar matters.

Power to make bye-laws.

14. Any Committee may make bye-laws-

(a) for defining, prohibiting and abating nuisances which are not public or common nuisances under the Indian Penal Code, or under Act No. V. of 1861 (for the regulation of Police):

(b) for defining the cases, manner and times in and at which the officers of the Committee may enter upon private property for the detection and abatement of nuisances :

(c) for securing a proper registration of births and deaths;

(d) and for carrying out all or any of the purposes of this Act.

The Committee may, from time to time, repeal, alter or add to any bye-laws made under this section.

15. No bye-law, and no alteration or repeal of

Bye-laws to be confirmed and published. or addition to a bye-law, shall have effect until it has been confirmed by the Local Government.

All bye-laws made under this Act, and all rules made under section thirteen, and all alterations and repeals of and additions to such bye-laws and rules, shall, before coming into force, be published for such length of time and in such manner as the Local Government from time to time directs.

16. The officers of the Committee shall have

III.—Suits by and against Committees.

ing twenty rupees, in amount or value, shall be in writing, and shall be signed by the President or Vice-President (if any) and at least two other members of the Committee.

No contract unless so executed shall be binding on the Committee on whose behalf it is made.

No member of a Committee shall be personally

Committee : but the funds from time to time in the hands of the Committee shall be liable for, and chargeable with, contracts duly made as aforesaid.

Every member of a Committee shall be liable for any misapplication of money entrusted to the Committee to which he has been a party, or which happens through, or is facilitated by, his neglect of his duty; 19. No suit shall be brought against a Com-

mittee or any of their officers, or any person acting under their direction, for any thing done, or pur-

porting to be done under this Act, until the expiration of one month next after notice in writing has been delivered or left at the office of the Committee, or at the place of abode of such person, stating the cause of suit and the name and place of abode of the intended plaintiff.

Unless such notice be proved, the Court shall find for the defendant.

Every such suit shall be commenced within three months next after the accrual of the right to sue, and not afterwards.

And if any person to whom any such notice of suit is given shall, before suit brought, tender sufficient amends to the plaintiff, such plaintiff shall not recover.

### IV .-- Penalties.

20. No member or servant of a Committee

Penalty on member or servant of Committee being interested in contracts made with Committee.

shall be interested directly or indirectly in any contract made with the Committee, and if any such person be so interested,

he shall thereby become incapable of continuing in office or in employment as such member or servant, and shall be liable to a fine of five hundred rupces: Provided that no person by being a shareholder in, or member of, any incorporated or registered Company, shall be disqualified from acting as a member or servant of a Committee by reason of any contract entered into between such Company and the Committee.

Nevertheless it shall not be lawful for such shareholder or member to act as a member of the Committee in any matter relating to any contract entered into between the Committee and such Company.

21. Whoever infringes any bye-law made and Penalty for infringement of bye-laws or nonpayment of fines. a fine not exceeding fifty

rupees, and, in the case of a continuing infringement, to a fine not exceeding five rupees for every day after notice from the Committee of such infringement.

In default of payment of any fine imposed under this section, the defaulter shall be liable to simple imprisonment for a term not exceeding eight days.

22. Prosecutions under this Act for infringements of bye-laws may be
