ACTS PASSED BY THE GOVERNMENT OF INDIA.

LEGISLATIVE DEPARTMENT.

The following Act of the Governor General of India in Council received the assent of His Excellency the Governor General on the 17th December 1896, and is hereby promulgated for general information :—

Act No. XXI of 1896.

An Act to amend the Indian Paper Currency Act, 1882.

WHEREAS it is expedient to authorise an increase of the amount which may be invested in securities of the Government of India out of the coin and bullion received for currency notes under the law relating to the Government paper currency; It is hereby enacted as follows :—

1. (1) This Act may be called the Indian Paper Short title and commencement. Currency Act Amendment Act, 1896; and (2) It shall come into force at once.

2. Section 19 of the Indian Paper Currency XX of 1882. Amendment of section 19, Act XX, 1882. Paper Currenc, Act, 1882, as amended by Act No. XV of 1890 (an Act to amend the Indian Paper Currenc, Act, 1882), shall be read as if for the words "eighty millions" the words "one hundred millions " were substituted.

3. Act No. XV of 1890 (an Act to amend the Repeal of Act XV, 1890). Indian Paper Currency Act, 1882) is repealed, but not so as to affect the validity of anything heretofore done in pursuance of the provisions of that enactment.
