PROCEEDINGS OF THE LEGISLATIVE DEPARTMENT, BOMBAY.

The following Report of the Select Committee of the Council of His Excellency the Governor of Bombay on the Bill to prohibit the practice of Inoculation and to make the Vaccination of Children in certain portions of the Bombay Presidency compulsory, and the Bill as amended by the Select Committee are, in accordance with Rule 25 of the Rules for the conduct of Business at Meetings of the Council, published for general information :---

Report of the Select Committee appointed to consider the Bill (No. 3 of 1891) to prohibit the practice of Inoculation and to make the Vaccination of Children in certain portions of the Bombay Presidency compulsory.

We, the Members of the Select Committee appointed to consider Bill No. 3 of 1891 (to prohibit the practice of inoculation and to make the vaccination of children in certain portions of the Bombay Presidency compulsory), have the honour to present the following Report.

2. The Bill was published in English on 5th November 1891, in Gujaráti, Maráthi and Kánarese on the 19th December 1891 in the *Bombay Government Gazette*, and in Sindhi on the 3rd December 1891 in the *Sind Official Gazette*.

3. The Committee sat on three occasions to consider the Bill. Certain suggestions of amendment received from the Honourable Mr. J. R. Naylor, and others contained in a letter from a Society styling itself the Indian Progress Society were also considered by us.

4. Certain verbal alterations have been effected by us in section 2, sub-section (2), clauses (a) and (b); in section 3; in section 4, clauses (i), (j) and (k); in sections 5, 6, 7 and 8; in section 9, sub-sections (1), (2) and (3); in section 14, sub-section (2); in sections 16, 18, 19, 21 and 23, clause (2); and in sections 20, 30, 31 and 32.

5. Apart from these we have amended section 2, clause (b), by adding thereto clause (4) in the following terms :--

"(4). Except when an epidemic of small-pox exists or is apprehended, notice of the intention of Government to introduce the Act as aforesaid on a date specified shall be given in the *Bombay Government Gazette* at least one month before such notification is issued, and Government shall receive and consider such objections as may be submitted to Government by persons interested not later than a week before the date specified as aforesaid."

We have also amended sub-section (3), clause (a), so as to read "by name, if such area is a territorial sub-division or area with a specific name and defined limits, or".

6. From section 4 we have omitted clauses (g) and (h), as being unnecessary when the alteration in sub-section (3) of section 2 noted above is introduced.

We have further amended section 4 by the insertion of a clause below clause (j) of the original Bill defining "Sanitary Commissioner", an amendment which renders possible the omission of explanatory sentences from subsequent sections of the Bill.

We have further added a clause below clause (k) of the same section of the original Bill, defining "register" and "registration" as referring to registration in pursuance of any law, bye-law, or rule, adverted to in clause (k).

7. Section 9, sub-section (2), clause (b), sub-clauses (i) and (ii), have been amended as shown below, in order to carry out the intention of always allowing twelve months from the date of a child's birth as the period within which its vaccination is to be effected, thus:

(i) "If the child is less than *nine* months old, within twelve months after its birth";

(*ii*) "If the child is nine months, or more than nine months but less than fourteen years old, within three months of its being brought within the said limits," and "such" in line 37 has been amended into "the said."

S. We have made several amendments in section 14. One of us, the Honourable Mr. Javerilal Umiashankar Yajnik, objects to the introduction of arm to arm vaccination. The other members of the Committee do not share his objections. They consider that the Bill ought to contain provisions authorizing in case of necessity arm to arm vaccination. In order, however, to allow the greatest possible freedom of action to those who are willing to conform substantially to the requirements of the Act, we have amended the proviso below clause (2) (a) of the section, in the terms following :—

"(3). The operation of any such notification shall be subject to the following provisos, viz.—

(a) that if the period prescribed by section 9 for the vaccination of an unprotected child will expire while such notification is in force, the parent or guardian of such child may give written notice to a public vaccinator before the expiry of the said period of his desire to arrange privately for the effectual vaccination of the child in conformity with the provisions of this Act, and thereupon the public vaccinator shall for the said purpose allow an extension of the said period for such time not exceeding one month as he deems reasonable.

"(b) Provided further, that lymph shall not be taken from any child who does not appear to be in good health and free from taint of a disease transmissible by vaccination."

9. Clause (2) (b) of section 14 which authorizes a public vaccinator to take lymph from a child brought to him under section 10 for inspection, has been amended by the addition of the condition that he shall do so "in such manner as shall not be injurious to such child."

10. We have amended section 17, in order to render its terms more explicit, and its application more general.

11. We have deemed it expedient to amend section 28 in a way that will permit of a prosecution under the present Bill, when it becomes law, being instituted by order of, or under authority from, "a Magistrate of a district or of a sub-division of a district, or of a Superintendent of Vaccination", instead of only by order of, or under authority from, Government or a Superintendent of Vaccination, as in the original Bill.

12. The above, together with a slight amendment in the form of Schedule D, constitute all the amendments which we have made in the Bill as it stood at the First Reading.

Dissent.

I regret I cannot endorse the view the Select Committee have taken of that part of Section 14 of the Bill which legalizes compulsion in respect of arm to arm vaccination under certain circumstances and with certain safeguards. It seems to me that if compulsory vaccination is to be made acceptable to the bulk of the people in the districts of this Presidency, legislation should proceed on the only safe lines on which the Act in the City of Bombay upon which the Bill is modelled has worked so smoothly during the last fifteen years, namely, by restricting compulsion to those cases in which the vaccine lymph is taken from the animal direct.

Such a course, I am persuaded, is not only in accordance with the best medical opinion of the day as rendering impossible even an accidental inoculation of syphilis and other diseases, but will go far to deprive compulsion of its sting in respect of the deep-seated religious and other prejudices of the people against lymph from a child of a different religion or a lower caste being used for purposes of vaccination. I reserve a fuller statement of my reasons.

Preliminary.

1. This Act may be cited as the Bombay District Vaccination Act, 1892.

2. (1) Section 33 extends to the whole of the presidency of

(i) the city of Bombay,

(ii) the town of Karáchi,

- (d) "medical practitioner" means any person duly qualified by a diploma, degree or license to practise in medicine or surgery or specially licensed by the Governor in Council to practise vaccination and grant certificates under the provisions of this Act;
- (e) "unprotected child" means a child who has not been protected from smallpox by having been successfully vaccinated, or who has not been certified under section 12 to have already had small-pox or to be insusceptible of vaccination;
- (f) "animal lymph" means vaccine, taken from the calf of a cow or buffalo;
- (g) "district" means-a-territorial-division constituting-a-district-for-the-purposes-of the Code-of Criminal Procedure, 1882; Act X of-

 - to register births and-deaths,-but nothing in this Act respecting registrars shall be deemed to apply to any registrar appointed--under-the Births,- Deaths and Marriages Registration Act, 1886, as such registrar.

(k) "register" and "registration" refer to registration in pursuance of any such law, bye-law or rule as aforesaid.

Establishment.

5. (1) Subject to such rules and orders vaccination circles. as may from time to
