A Bill to amend the Bombay Salt Act, 1890.

Whereas it is expedient to amend the Bo. II of 1890. Bombay Salt Act, 1890, in manner herein-after appearing; It is enacted as follows:

Proviso added to section 11 of Bombay Act II of 1890.

1. To section eleven of the said Act the following proviso shall be added, viz.:

“Provided that no such license shall be necessary for any process of manufacture of salt on which duty has been paid.”
