PART V.

PROCEEDINGS OF THE LEGISLATIVE DEPARTMENT, BOMBAY.

The following Bill, together with the Statement of Objects and Reasons accompanying it, is published in accordance with Rule 15 of the Rules for the Conduct of Business at Meetings of the Council of His Excellency the Governor of Bombay for making Laws and Regulations:-

Bill No. 2 of 1876.

A Bill to consolidate and amend the Law relating to the powers and procedure of Mámlatdárs' Courts.

WHEREAS it is expedient to consolidate and amend the law Preamble. relating to the powers and procedure of Mámlatdárs' Courts; It is hereby enacted as follows :-

- 1. This Act may be called "The Mámlatdárs' Courts Act, Short Title. 1876."
- Clause 2, Section I. of Act XVI. of 1838 and (Bombay) Act V. of 1864 are Repeal of Acts. repealed. All references made in any Act passed by the Governor of Bombay in Council or in any Act of the Governor General in Council passed prior to the coming into operation of the Indian Councils Act 1861, to the said portion of Act XVI. of 1838, or to (Bombay) Act of 1864, shall be read as if made to the corresponding portion of this Act.
- 3. In this Act, unless there be something repugnantinthe Interpretation Clause. subject or context,-"Mámlatdár" shall

The word

- include any Revenue " Mámlatdár." Officer ordinarily exercising the powers of a Mamlatdar and any other person who may be specially authorized by the Governor in Council to exercise the powers of a Mámlatdár under this Act, or who at the time of the passing of this Act is duly authorized to exercise the powers of a Mamlatdar under Bombay Act V. of 1864.
- The words "Plaintiff" and "De-(2.)fendant" shall include " De-"Plaintiff," a pleader duly appointfendant." ed to act on their behalf, and the recognized Agents of a plaintiff or defendant as defined in Section 17 of the Code of Civil Procedure (Act VIII. of 1859).

4. It shall be lawful for Mámlatdárs'

Mámlatdárs' Courts may give immediate possession of lands, &c., and maintain existing possession. Courts within the territories in their revenue charge to give immediate possession of all lands, premises, trees, crops, fisheries,

as well as of the use of water from wells, tanks, canals, or water-courses, or of the profits thereof to any party entitled to such possession by reason of the determination of any tenancy or who shall have been dispossessed of the same otherwise than by due course of law, and also in cases in which a disturbance of the possession of any lands, premises, trees, crops, or fisheries, or of the use of water from any well, tank, canal, or water-course, or of the use of roads or customary ways to fields is attempted by any party, to issue an injunction to such party to refrain from such dis-

Provided that application be made within six months after dispossession or attempted disturbance.

turbance: Provided that application be made to them by the party aggrieved within six months from the date of the deter-

mination of such tenancy or of such dispossession, or of such attempted disturbance.

Illustration I.

A lets B his field to cultivate for a specific period of one or more years. B refuses to resign possession after the expiration of that period. A can sue for possession in the Mámlatdár's Court at any time within six months from the date of the expiration of the said period.

Illustration II.

B is a yearly tenant of A, who gives him notice to vacate six months before the commencement of the next cultivating season (Bombay Act I. of 1865, Section 43, Clause 2). At the expiration of that period B refuses to vacate. A can sue B in the Mamlatdar's Court at any time within six months from the expiration of such notice.

Illustration III.

A lets B the use of water from his well, or from his water-course for a specific period, at the expiration of which B continues to take water from the well or water-course. A may sue B in the Mámlatdár's Court at any time within six months from the expination of the said period to obtain an injunction to stop B from taking the water.

Illustration IV.

A and B hold lands adjacent to a qiz, or stat, or similar artificial water-course which has hitherto been exclusively used by B. A draws water therefrom. B may sue in the Mamlatdár's Court at any time within six months from the date on which A commences to take the water, for an injunction to prevent A from so doing

5. All suits under this Act shall be commenced by a Snits to be commenced by a plaint. Particulars to be given in plaint.

Court by the plaintiff, and which shall contain the following particulars:

- (1). The name, caste, profession, and place of abode of the plaintiff.
- (2). The name, caste, profession, and place of abode of the defendant.
- (3). The nature and situation of the property of which, or of the profits of which, possession or use is sought, or the nature of the injunction to be granted, as the case may be.
- (4). The date on which the dispossession or unlawful possession or use commenced or was attempted.
- (5). The means by which the defendant obtained or attempted to disturb possession.
- (6). A list of the plaintiff's documents, if any, or of his witnesses, and what evidence is required from each witness, and whether such witnesses are to be summoned to attend, or whether the plaintiff will produce them on the day and at the place to be appointed according to Section 11 of this Act.
- 6. When the plaint is presented, the Mamlatdar shall red and verified.

 Mamlatdar shall require the plaintiff to subscribe and verify the plaint in his presence, in open Court, in the manner following, or to the like effect:—
- "I, A. B., the plaintiff, do declare that what is stated in this plaint is true, to the best of my information and belief."

7. The Mamlatdar shall endorse the plaint to the effect that it was duly subsective in case plaintiff scribed and verified.

cannot write.

In case the plaintiff cannot write, the

verification may be written for him in open Court, and the Mamlatdar shall, in such case, state that the verification was made in his presence, at the request of the plaintiff, who affixed his mark to his name in token of the authenticity of the verification.

8. If the plaint do not contain the

Mámlatdár may allow plaint to be amended, if it do not contain the required particulars, &c. several particulars hereinbefore required to be specified therein, or if it contain particulars other than

those specified, whether relevant to the plaint or not, or if the statement of particulars be unnecessarily prolix, the Mamlatdar may order the plaint to be amended within three days from the date of such order.

9. If the plaintiff decline to subscribe

The Mamlatdar may reject plaint, if plaintiff refuse to verify or subscribe the plaint, or if the claim appear to be barred. or verify the plaint as hereinbefore required, or to amend the same as directed by the Mamlatdar, or if it appear upon the face

of the plaint, or after questioning the plaintiff, that the plaintiff was dispossessed or that the disturbance of possession or use was attempted more than six months before the plaint was presented, the Mamlatdar shall reject the plaint.

10. If it appear to the Mamlatdar that

The plaintiff shall be required to appear with his documents and witnesses on the day and at the place appointed, of which ten days' notice in the form of Schedule A shall be issued at the plaintiff's expense to the defendant.

The date to be fixed for the trial shall not be earlier, except by consent of both parties, than 10 days, nor, except for unavoidable reasons, later than 15 days, from the day on which the notice is issued.

Attendance of witnesses.

Attendance of witnesses to be summoned to appear on the day and at the place appointed, the Mamlatdar shall issue summonses for that purpose. The payment of the cost incurred in thus procuring the attendance of witnesses shall be regulated in accordance with the rules that may from time to time be made by the High Court in regard to the payment of witnesses.

13. If the plaintiff fails to attend with his proofs, or omits to adopt measures to procure the attendance of his wit-

nesses on the day and at the place appointed, the Mámlatdár shall reject the plaint with costs.

If the defendant fails to attend, and If the defendant does not appear, the case to be heard ex-parte. Satisfied from the evidence before him that the notice has been duly served on the defendant, and in sufficient time to enable the defendant to appear and answer on the day fixed in the notice, he shall proceed to hear the plaint ex-parte:

Provided that if either party satisfy the
But a case may be re-heard on sufficient cause being shown,

Mamlatdar at any time within 15 days from the date of the plaint being thus re-

jected, or of such ex-parte decision, that he was prevented by some unavoidable circumstance from being present, or from procuring the attendance of his witnesses, it shall be lawful for the Mamlatdar to re-hear the case, a notice in the form of Schedule B being issued, at the applicant's expense, to the opposite party.

When proceedings and at the place appointed, the Mamlatdar may, if he consider there is sufficient reason after taking the evidence of those that are present, adjourn the hearing of the suit from time to time till the attendance of the witnesses can be enforced.

The provisions of Section 13 shall apply on any date to which the proceedings may be adjourned under this Section, as if such date were the day originally fixed for the hearing.

- 15. On the day appointed the Mám-Points to be decided by the Mámlatdár at the hearing. dence that is then and there before him, and to try the following issues, viz.:—
- (a). If the plaintiff avers that he has been dispossessed:
 - (1). Whether the plaintiff or any person on his behalf was in possession or enjoyment of the property or use claimed up to any time within six months before the suit was filed.

- (2). Whether the defendant is in possession at the time of the suit, and if so whether he obtained possession otherwise than by due course of law.
- If the plaintiff avers that he is still in possession, but that the defendant has attempted to disturb him in his possession:
 - Whether the plaintiff or any person in his behalf is actually in possession or enjoyment of the property or use claimed.
 - Whether the defendant has, at any time within six months before the suit was filed, attempted to dispossess or oust the plaintiff otherwise than by due course of law.

If the Mamlatdar's finding upon these issues be in favour of

the plaintiff, he shall award him immediate possession or grant the injunction prayed for, as the case may be.

Mámlatdár's The award if in defendant's favour.

If his finding be in favour of the defendant, he shall reject the plaint.

Costs to be awarded.

In either case the costs of the suit, including the costs of execution, shall follow the decree.

Every order of the Mamlatdar whether for rejecting Mámlatdár's order to or returning a plaint, be endorsed on the or whether for allowplaint. ing or disallowing the claim, shall be endorsed by the Mamlatdar, on the plaint, who shall also place on record his reasons for the same,

17. If the Mámlatdár's decision be for awarding possession Mámlatdár's award or restoring a use, he how to be executed. shall issue an order to the Village Officers to give effect thereto.

If it be for granting an injunction, he shall cause the same to be prepared in the form of Schedule C, and shall deliver or tender the same then and there to the defendant, if he be present, and if he be not present, shall send it to the Village Officers to be served upon him.

When the Mamlatdar awards costs, such costs, together with the costs of execution, shall be recovered from the party in person, and in the event of non-payment, by the attachment and sale of his property.

Provided that nothing in this section shall prevent the party against whom the Mámlatdár's decision is passed from re-covering by a suit in the Civil Court mesne profits for the time he may be kept out of possession.

Provided further that in any subsequent suit or other proceeding in the ordinary Civil Courts between the same parties, or other persons claiming under them, the Mámlatdár's decision respecting the possession of any property shall not be held to be final.

- 19. There shall be no appeal from any order passed by No appeal to lie from a Mámlatdár under Mámlatdár's orders. this Act.
- If any plaint verified under this Act shall contain any Punishment for false statement which the verification of plaint. or believe to be false, or shall not know or believe to be true, such plaintiff shall be subject to punishment according to the provision of any law for the time being in force for the punishment of persons intentionally giving or fabricating false evidence.
- Any suit instituted by any person bound by an order respecting the pos-Limitation of Suits. session of property made under this Act, or by any one claiming under such person to recover the property comprised in such order, shall be dismissed although limitation has not been set up as a defence, unless it has been instituted within three years from the date of the final order in the case.

STATEMENT OF OBJECTS AND REASONS.

His Excellency the Viceroy and Governor General having withheld his assent to Bill No. 5 of 1875, which was read a third time and passed by the Governor in Council on the 23rd March 1876, the same Bill is now re-introduced with the modification necessary to remove the objections entertained to it by His Excellency the Viceroy.

The latter part of Section 2 has been altered so as to confine its operation to Acts of the Governor in Council of Bombay and to Acts of the Governor General in Council which were passed prior to the Indian Councils Act coming into operation, and a new section (Section 21) has been added at the end of the Bill to make the same Rule of limitation applicable in the case of orders passed under this Bill as is now applicable, according to Article No. 46, Schedule 2, Act IX. of 1871, when orders have been passed under the enactments which Section 2 repeals.

The last three sections of the Bill, as passed on the 23rd March 1876, have been entirely omitted. They were found to be at variance with the Rules prescribed in Chapter XXXV. of the Criminal Procedure Code for Civil Courts generally, and were objected to by His Excellency the Viceroy for this reason.

The opportunity has been taken of making a slight addition to the definition of the word "Mamlatdar" in Section 3, Clause 1, in order that the powers of persons already authorized to hold inquiries under Bombay Act V. of 1864 may be continued under the proposed new Act without further orders. And Clause 3 of Section 18, which was struck out of the Bill in Committee on the 7th January 1876, has been re-inserted in a modified form in order that the question, whether decisions under the Act should be accepted by the ordinary Civil Courts as final, may be more fully considered before the Act becomes law.
