Government Notifications, Appointments, &c., NOTIFICATIONS.

POLITICAL DEPARTMENT.

Bombay Castle, 26th November 1886,

No. 6951.—HIS EXCELLENCY THE RIGHT HONOURABLE THE EARL OF DUFFERIN, K.P., G.M.S.I., G.C.B., G.C.M.G., Viceroy and Governor General of India, arrived in Bombay on Saturday, the 13th instant, at 4-45 p.m., in the I. G. S. "Clive" and was received with all the Naval and Military honours due to his high position.

At 4-30 r.m.•a Deputation consisting of the Chief Secretary to Government, the Director of Indian Marine and the Military Secretary to His Excellency the Governor proceeded on board the "Clive" under arrangements made by the Director of Indian Marine.

The Earl of Dufferin left the "Clive" at 4-45 P.M., and landed at the Apollo Bandar under arrangements made by the Senior Naval Officer. The yards of Her Majesty's

Ships in harbour were manned and a salute of 31 guns was fired from the ships as His Excellency left the "Clive."

On His Excellency's arrival at the steps of the Bandar a Salute of 31 guns was fired from the Saluting Battery. A Guard of Honour of British Infantry with Band and Colours was drawn up, and His Excellency was received by His Excellency the Commander-in-Chief and Staff, the Chief Justice, the Lord Bishop, the Members of Council, the Judges of the High Court, His Highness the Rája of Kolhápur, His Highness the Mahárája Holkar, His Highness the Rája of Rutlam, His Highness the Naváb of Cambay, the Naváb of Janjira, the Thákore Sáhebs of Limbdi and Wadhwán, and other Chiefs of the Bombay Presidency, the Additional Members of the Council of His Excellency the Governor for making Laws and Regulations only, the Secretaries and Under Secretaries to Government, the Brigadier-General Commanding the Bombay District, the Private Secretary and Staff of His Excellency the Governor, the Chairman of the Municipal Corporation, the Municipal Commissioner, the Sheriff of Bombay, the Heads of Departments, Civil and Military, and such other official and non-official gentlemen as were able to be present. The Foreign Consuls were also present.

The road from the Apollo Bandar to the Statue of the Queen Empress was lined by the troops of the garrison and the Bombay Volunteers.

An address of welcome was presented to His Excellency by the Municipal Corporation, to which His Excellency made a suitable reply.

His Excellency, escorted by a Detachment of the Governor's Body Guard, proceeded direct to Malabar Point, where His Excellency was received by His Excellency the Governor on the steps of the great entrance of Government House, a Guard of Honour of Bombay Infantry with Band being in attendance.

Owing to indisposition His Excellency was unable to attend the Levée and the Drawing Room which were notified to be held at the New Secretariat at 9-30 P.M. In His Excellency's absence the Levée was held by His Excellency the Governor of Bombay, and the Drawing Room by Her Excellency the Countess of Dufferin.

On Tuesday morning, the 16th instant, His Excellency received the visits of His Highness the Raja of Kolhapur, His Highness the Rao of Cutch, His Highness the Navab of Cambay, the Raja of Dharampor, the Navab of Janjira, the Thakore Sahebs of Limbdi and Wadhwan, the Chief of Bhor, and the Rana of Porebandar at Government House, Malabar Point, and in the afternoon of the same day His Excellency paid return visits to His Highness the Raja of Kolhapur, His Highness the Rao of Cutch and His Highness the Navab of Cambay at their private residences.

On Wednesday, the 17th instant, at 1 P.M. and 1-20 P.M., His Excellency received the visits of His Highness the Maharaja Holkar and His Highness the Raja of Rutlam, and paid them return visits at 3-20 and 3-40 P.M., respectively. At 5 P.M. His Excellency presided at the prize distribution to the students of the Sir Jamsetji Jijibhoy School of Art.

On Thursday the 19th instant in the afternoon His Excellency received and replied to an address presented by the deputation from the Municipality of Surat, and paid a visit to the Elephanta Caves.

On Friday, the 19th instant, at 9 A.M., His Excellency left Bombay for Poona by a Special Train from the Bori Bandar Station. His Excellency's departure was private and all arrangements connected therewith were made from Government House.

On arrival at the Poona Station at 2-15 p.m., His Excellency was received by the Civil and Military authorities present in Poona. A Guard of Honour of Bombay Infantry was in attendance and a Salute of 31 guns was fired. From the Station His Excellency proceeded to the Council Hall, where he received and replied to the addresses presented by the Poona City Municipality, the Poona Sárvajanik Sabha and the Deccan Education Society. His Excellency then passed through the City and at 9 p.m. took his departure for Nándgaon by a Special Train.

"County of York," to conduct an investigation into the circumstances connected with the stranding on the 18th November 1886 of the steamer "Oorun" on the coast near Powas, distant about five miles from Ratnágiri.

2. The investigation will be held at the Fort Police Court on Monday the 29th instant, at 12 o'clock (noon).

"County of York," to conduct an investigation into the circumstances connected with the wreck of the S.S. "Washisti" on the 19th November 1886, at Burmana Point, near Viziadurg Harbor.

No. 102.—The following Notification by the Government of India, Department of Finance and Commerce, No. 4255, dated 23rd November 1886, "Statistics and Commerce," is republished for general information and guidance, with reference to Notification No. 54, dated 30th June 1886:—

"No. 4255.—In exercise of the powers conferred by Sections 58 and 67 of the Indian Merchant Shipping Act, 1880, the Governor-General in Council is pleased to make the following rules regarding the relief of distressed seamen or apprentices in Madras, Bombay and Burma:—

Relief of distressed seamen.

In these rules the term 'distressed seamen' includes—

(a) all seamen and apprentices being native Indian subjects of Her Majesty who have been shipwrecked, discharged, or left behind at any place in British India, whether from any British ship employed in the merchant service, or from any of Her Majesty's ships, or who have been engaged by any person acting either as principal or agent to serve in any ship belonging to any foreign power, or to the subject of any foreign State, and who are in distress in any such place;

- (b) all scamen and apprentices not being native Indian subjects who have been shipwrecked, discharged, or left behind at any place in British India from any British ship registered in British India, and who are in distress in any such place.
- 2. In taking charge of distressed seamen, the local authority will provide them with subsistence and clothing, as their necessities may require, but upon the most reasonable terms possible, and no more expensive clothing should be supplied to an officer than to a common seaman. Beds and bedding should not be supplied except under special circumstances, and the value of clothing should not exceed Rs. 10 for each person. In any case of unusual expense, when the local authority considers it absolutely necessary to deviate from the foregoing rules, or to provide relief for a longer period than one month, a statement of the exceptional circumstances which necessitated the further outlay is to accompany his accounts when transmitted for audit. Money payments to the seamen themselves for purposes of relief must be avoided as far as practicable.
- 3. In all cases to which Section 62 of the Act applies, a report should be submitted by the local authority to the Government, in order to admit of the seaman's wages (if any are due) and the expenses incurred in his behalf being recovered from the master or owner or other person liable under Section 63 of the Act.

Conveyance home of distressed scamen,

- 4. Distressed seamen who are in receipt of relief are to be sent home by the earliest available opportunity, and British vessels requiring men to make up their complement should be preferred in order to admit of the seamen earning wages while being so sent; but if no such vessel can be found, and if there is no immediate prospect of any such vessel requiring men, they should be sent as supernumeraries on board the British vessels (whether registered in British India or not) that may be in the port at the time, and bound to their homes, or to ports near their homes, as the case may be; provided, however, that no ship be required to convey more than one supernumerary to every fifty tons of her registered tonnage. Distressed seamen who refuse to work, if able, for their passage home, cease to be entitled to further relief under these rules.
- 5. The local authority will endorse upon the agreement of the British ship, on board which distressed seamen are sent under Section 56 or Section 57 of the Act, the name of each man sent on board, and the day on which he was sent on board. He will also, in the case of a distressed seaman sent on board under Section 57, fill up, sign, and deliver to the master an order with certificate in Form A for the seaman's conveyance.
- 6. Whenever there are no British merchant vessels to which distressed seamen can be allotted, and the local authority thinks it desirable, in order to avoid expense, to engage a passage for them in foreign merchant vessels, he may do so on the best terms he can obtain. He should avoid, if practicable, making any payment beforehand for such passage, but should report the terms to the Government, and direct the master to apply for payment to the shipping master at the port to which the vessel is bound,

The acknowledgments of Government are also due to His Excellency for the able assistance rendered as a Member of Council.

Pending the arrival of His Royal Highness the Duke of Connaught, the command of the army will devolve upon Major-General Carnegy, the next Senior Officer on the Divisional Staff, as Provincial Commander-in-Chief from the date His Excellency Lieutenant-General Sir Charles George Arbuthnot, K.C.B., relinquishes the command.
