No. 434.—In exercise of the powers conferred by Section 56 of the Indian Stamp Act, 1879, the Governor-General in Council is pleased to make the following rule, in supersession of rule 7 * Republished at pages of the rules promulgated 195 to 197 of the Bombay by Financial Notifica-Government Gazette of the .-tion* No. 1288, dated 3rd 16th March 18>2, Part I. March 1882 :—

(7) The duty payable on any instrument chargeable with a duty of one anna may be denoted by a coloured impression marked on a skeleton form of such instrument by the Superintendent of Stamps at Calcutta, Bombay, Madras, Rangoon, or Lahore, and by the Commissioner of Stamps at Allahabad.'

No. 453.—Whereas a doubt has been expressed as to the proper stamp duty chargeable under the Indian Stamp Act, 1879, on a charter-party containing a penalty clause, and it is desirable that the doubt should be removed, the Governor-General in Council, in exercise of the powers enabling him in that behalf, is pleased to direct that the stamp duty chargeable on a charterparty shall, notwithstanding anything contained in the instrument as to the payment of compensation in case of breach of the contract evidenced thereby, be limited to the amount chargeable under the Indian Stamp Act, 1879, Schedule I, Article 18.

No. 200.—His Excellency the Governor in Council is pleased to direct that the following rule should be substituted for rule 4 of the Rules for the preparation and submission of petitions to Government, published under Government Notification No. 316, dated 27th January 1885, at pages 126-7 of Part I. of the Bombay Government Gazette of the 29th idem :—

- "All petitions to Government should be written as concisely as the nature of the case admits of. If they are found to be unnecessarily prolix, or to be couched in unintelligible, exaggerated or disrespectful terms, they will be returned for amendment to the parties submitting them.
- "Petitions of appeal preferred by parties to civil and political suits should invariably be submitted in English. Petitions on other matters may be either in English or in any of the vernacular languages of this Presidency.

Those written in any of the vernacular languages, when not accompanied by English translations, will be rendered into the latter language by the Oriental Translator to Government before being placed before His Excellency the Governor in Council; but manuscript petitions in the vernacular in which the words are not properly separated and the sentences punctuated wherever

Full stop necessary by means of the marks shown in the margin will

be returned to the senders to be redrafted."

- 6. In any case in which a conveyance is called from a stand to any place to take up a fare, onehalf the full fare of such conveyance may be demanded by the driver in addition to the regulated fare of the conveyance as laid down.

MARINE DEPARTMENT.

Bombay Castle, 26th January 1886.

No. 3.—Under the provisions of Sections 73 and 74 of the Bombay Port Trust Act, 1879, No. 22 of the Bye-laws for the Regulation and Management of the Wet Docks has been revoked by the Trustees, and the following bye-laws have been passed by them :—

22. No cargo shall be discharged from a vessel except under the superintendence on board of such vessel of the master of such vessel, or of a licensed stevedore or mukádam. Such master, stevedore or mukádam shall see to and be personally responsible for the proper slinging of cargo on board of such vessel when discharging.

22E.--No cargo shall be discharged from or loaded into any vessel except under the personal superintendence on shore of a contractor permitted by the Trustees to work cargo on shore, or of an experienced foreman employed by such contractor, or of a servant of the Trustees authorised to work cargo on shore. Such contractor shall be personally responsible for the proper slinging of cargo on shore.

22F.— No stevedore, mukádam, or contractor, or foreman of such stevedore, mukádam or contractor, permitted as aforesaid to superintend the working of cargo, or servant of the Trustees authorised to work cargo on shore, shall allow any goods, whether in bags, bales, boxes, or

otherwise, to be slung without himself seeing that the following precautions for safety are first adopted :---

- (1). That the sling is first laid down flat without turns or kinks preparatory to receiving the goods.
- (2). After the sling has been made up and with the first strain on heaving up that the running loop is well beaten home with a wooden bar so as to make the grip secure.

These bye-laws are published as required by Section 74 of the Bombay Port Trust Act prior to the approval of Government being given thereto.

No. 5.—Under the provisions of Section 43 of the Bombay Port Trust Act, 1879, the following item is added to the Table of Rates to be charged at the Prince's Dock :—

No. 50A.—Bran per ton on import twelve annas and per ton on export twelve annas; the removal and delivery rate when unclaimed is fixed at eight annas per ton and the rent per week when stored in unclaimed warehouse six annas per ton.

No. 6.—Under the provisions of Section 7 of Act XII. of 1875 (The Indian Ports Act) the following addition is made to No. 19 (Section X.) of the Bombay Port Rules:—

The master or other person in charge of any vessel when at anchor or moored in the harbour shall not allow such a number of cargo boats to be made fast to the vessel either alongside or astern as shall cause the vessel to drag its anchor or moorings.

ECCLESIASTICAL DEPARTMENT.

No. 4.—In supersession of Government Notification dated 3rd August 1870, and with reference to Note (3) under Rule XIX. of the rules published under Notification No. 27, dated 1st July

1.-26

1885, the following revised rules for the erection and repair of monuments of stone, with or without iron railings, in cemeteries are published for general information :---

- (a.) A drawing of the proposed monument, with a copy of the inscription to be engraved upon it, shall be submitted to the Archdeacon, with a statement as to the kind of stone which is to be used and an estimate of the cost.
- (b.) This drawing, &c., if approved of by the Archdeacon, shall be transmitted by him to the Executive Engineer of the district, who shall furnish to the Archdeacon an estimate of the average annual sum which will be required to keep it in repair. As the annual sum has to be realized by interest on stock notes at 4 per cent, it should be stated in multiples of 8 annas, and not in smaller fractions.
- (c).—The endowment is intended to cover the cost of ordinary annual maintenance and repairs, and not the risk of accidents due to floods or other natural causes, and the sum should be estimated accordingly. In the event of accident, the friends should be communicated with and the procedure laid down in the Government of India Rules (Rule XIX., Government Notification, Ecclesiastical Department, No. 27, dated 1st July 1885) followed.
- The repair of fragile or costly work liable to be broken cannot be undertaken by Government and should be excluded in estimating the endowment required.
- (d.).—The Archdeacon shall grant permission for the erection of the monument as soon as he shall be informed by the Chaplain (or other officer) in charge of the cemetery that the capital sufficient to provide this average annual sum has been paid to him in Government stock notes, which, it may be noted, are issued for the following amounts:—

(The Church Trustees of the district are to be informed by the Archdeacon that this permission has been granted, and are to see that the monument is erected in a workmanlike manner and upon a sound foundation.) The Executive Engineer of the district shall be informed in writing by the Chaplain (or other officer) in charge of the cemetery of the completion of the monument and requested to bring it upon his list as for repair by the Public Works Department from funds to be supplied as laid down in rule (f).

(e).—The Government stock notes received under the preceding rule shall be sent to the Accountant General for safe custody, and the interest accruing from these and any other investments shall be paid into the

Government Savings Bank in the names of the Chaplain and Collector (or chief Civil or Military officer). All monies deposited for repairs to monuments in any one station, or for any one cemetery, shall be treated as belonging to one single account. The interest accruing on such monies shall form a common fund, to be used exclusively for the repair of those monuments for which deposits have been made. Chaplains (or other officers in charge) should be very careful to keep a correct record of all deposits made for the repair of tombs. In order that Government may know that the tombs are kept in proper repair an annual report should be forwarded for each cemetery to the Accountant General, "ho will consolidate the returns so received and render a general return to Government. The return should contain remarks both by the Chaplain and Executive Engineer as to the state of the tombs for which endowments have been made.

(f).—Joint estimates shall be framed annually by the Executive Engineer and the Chaplains of the cost of repairs of tombs as required by

Works Code), and the aggregate of the sums so estimated as required for *endowed* tombs shall be placed to the credit of the Executive Engineer, Public Works Department, at the treasury by the Chaplain, or other officer, in whose name jointly with that of the Collector (or chief Civil or Military officer) the monies are in deposit at the Government Savings Banks.

(g).—It should be understood that the Chaplain, or other officer, who is in charge of the cemetery in accordance with the rules for the care and use of Government cemeteries will be held responsible for seeing that such monuments are kept in proper repair so far as funds are available.

In order to facilitate the registration of the export trade direct from the shipping bills, it is hereby directed that in the case of goods shut out of one vessel and intended for shipment on board another, if the shippers ask for the transfer before the first vessel's export general manifest is checked and completed, a fresh triplicate shipping bill shall be put in, and endorsed with the word "Transferred."

If the application for transfer be made after the export general manifest of the first vessel has been checked and completed, a fresh triplicate shall be put in by the shippers, but no endorsement shall be made thereon, the transaction being treated as a new one.

With a view to enable the Reporter General's Department to distinguish, in the case of goods arriving by Native craft from Customs ports, between those originally manifested for transhipment at Bombay to some other port and those so manifested after the vessel's arrival in Bombay, Daláls and Pass-note Writers are required in future to make on both the import and export general manifests of Country craft, as also on the tranship permits, the following remarks, *i.e.*, if the goods are shown in the documents from the port of export as shipped for transhipment at Bombay to some other port,-

"Originally manifested at the port of (name of port) for transhipment at Bombay to (name of port);"

if the destination of the goods is changed after arrival at Bombay,

"Subsequently manifested at Bombay for transhipment to (name of port)".

In the event of the goods being transhipped to a square-rigged vessel, all particulars required for statistical purposes should be given on the tranship permits in the case of goods subsequently manifested for transhipment, and all such tranship permits should be forwarded by the Export Department to the Reporter General in the same way as shipping bills are now forwarded.

When application is made to allow goods carried by country craft from Customs ports and originally manifested for importation to be transhipped, a fee of rupee one will invariably be charged in respect of each item to be amended, if the application be not made within 24 hours after entry inwards of the vessel.

When goods are subsequently manifested for transhipment, Daláls and Pass-note Writers will be in a position to make the required endorsement, on the import general manifest only when the destination of the goods may have been changed before entry inwards of the vessel. In other cases it must be made either by a General Manifest Clerk, Prince's Dock, or by the Ove-seer, Import Department, should application for amendment be made after the manifest is forwarded to the Reporter General's Department, when the amendment fee will be levied by the Assistant Collector of Customs in charge of the Import Department.

It is directed that a note shall be printed in red ink on the right upper side of every shipping bill to the following effect :---

"The attention of shippers is called to Section 140 of the Sea Customs Act, requiring them to give notice to the Custom House within five days after the vessel's departure, when goods mentioned in the shipping bills are not shipped or are re-landed. The corresponding penal clause 57 of Section 167 of the Sea Customs Act will henceforward be enforced, unless such notice be given, or the goods transferred to another vessel within the five days prescribed."

It is further notified that shipping bills not bearing the above note in red ink will not be admitted for Custom House purposes on and after the 16th proximo (March 1885)."
