PROCEEDINGS OF THE LEGISLATIVE DEPARTMENT, BOMBAY.

The following report of the Select Committee of the Council of His Excellency the Governor of Bombay on the "Bill to consolidate the lands and other property vesting in the Trustees of the Port of Bombay and certain other lands and property on, or connected with, the foreshore of the Island of Bombay into one estate, and to vest the control and management of the same in one Public Trust; and for other purposes," and the Bill as amended by the Committee are, in accordance with Rule 25 of the Rules for the conduct of business at Meetings of the Council, published for general information :---

and the papers noted in the margin. We have also received and considered the representations of deputations from the Trustees of the Port of Bombay and the Bombay Chamber of Commerce, and with reference to sections 36-38 of the Bill, have heard the statements of the Muni-

cipal Commissioner of Bombay, and have the honour to present this report.

The subject of the constitution of the Board has received our careful attention. 2. We find that there is a general concurrence of opinion in favour of the Trustees being partly elected by the Chamber of Commerce and partly nominated by Government, as proposed in the Bill, and we are of opinion that, with the modifications as to the minimum

number of Netive Trustees and as to the manner of their appointment which we have introduced into section 5 of the Bill, a Board thus constituted will be as fairly representative of all the interests most concerned in the due administration of the Port Trust as it is possible for any Board to be.

3. The holders of the new properties which it is intended to vest in the Board will not consent to any arrangement under which, in consideration of their making over those properties to be managed by the Board, they should be guaranteed a certain minimum amount of interest on the valuations of their respective properties, and should be entitled, over and above such minimum amount of interest on their capital, to a share in any profit which by careful administration the Board might from time to time he in a position to distribute in the shape of a dividend. The difficulties connected with an equitable valua-tion of the different properties to be vested in the Board, and the uncertainty of the realization of any profit, disincline the holders of the new properties to assent to part with them upon any terms other than actual sale. We have therefore come to the conclusion that the Bill should provide for the purchase of these properties, and we approve of sections 29 and 30 of the Bill, which make provisions to this effect. We think also that in the general interests of both shippers and merchants and of all others concerned in the trade of the Port it is desirable that there should be no attempt to render the administration. of the Trust a source of profit, even should a maximum be fixed to the amount of profit to be distributed annually. The true interests of all parties will, in our opinion, be best consulted by requiring the Board to levy such rates only as may be necessary to enable them to meet known fixed liabilities and to pay their working expenses.

4. This being our view as to the best mode of acquiring the new properties and vesting them in the Board, we do not consider it desirable that the holders of those properties should have any representation on the Board. When once they have parted with their properties they will be, with respect to them, in the ordinary position of vendors having no longer any claim over, or concern in, the properties sold. As security-holders their sole concern will be to see that they are paid punctually the interest on their paper, and such payment is effectually guaranteed to them by section 35 of the Bill. Moreover, as it is proposed (section 30), that the securities shall be transferable by endorsement, it is probable that in the course of a few years a large proportion of them will have changed hands: many, perhaps, will be found in the possession of persons having any knowledge of, or care for, the concerns of the Port. There would also be considerable trouble and expense involved in keeping up a register of the security-holders and making provision for periodical elections by them of Trustees. The proposals contained in the Bill as to the nomination of Trustees, of which we approve, have the advantage of great simplicity, and we do not think that any adequate reason exists for the creation of a complex machinery for securing the representation of the one class of security-holders.

The existence in the Bounbay Chamber of Commerce of a recognized Association of the leading mercantile gentlemen of the city greatly facilitates the introduction, to a certain extent, of the electoral system of representation on the Board, and we have re-tained in the Bill the proposal that five of the Trustees should be elected by that body. But there would be great difficulties in the way of providing for the election of members of the Board by Native Merchants. No Native Association exists similar to the European Chamber of Commerce, and to enact that there shall be public elections of Native Members would entail a complicated system of account-keeping and registration in order to ascertain what persons should be entitled to vote. Upon the whole, therefore, we think that the principle of selection is more suited to circumstances in the case of the Trustees who should represent Native interests on the Board, but we have ascertained that the feeling of the Natives themselves is that it would be preferable that their representatives should be selected by Government, and we have therefore struck out section 8 of the Bill as introduced into Council, and increased the number of Trustees to be nominated by Government from five to seven (section 5). At the same time we have provided that not less than three of the total number of Trustees must always be Natives, thus leaving it optional with the Chamber of Commerce to elect, or with the Government to nominate more than this minimum number of Native Members of the Board, if they shall think fit.

6. It will be observed that we have increased the minimum number of Native Trustees from two to three. This point has been very fully considered by us, and we are of opinion that it is not necessary or advisable that the number should be higher than three. The proportion of three Native representatives to five elected by the European mercantile community is, we think, sufficient with reference to the relative experience and knowledge of the two classes as to the requirements of general trade, and the best means of administering so large a concern as the Port Trust of probably the finest and most important port in the East. But if, as time advances, Native Merchants acquire a claim to be more strongly represented on the Board, the power, which we propose to leave in the hands of Government, of nominating seven out of the twelve Ordinary Trustees will, we think, supply a ready means of recognizing such claim. Hitherto, we find, there has been considerable difficulty in obtaining as many as two or three Native gentlemen, both competent and willing to act as Trustees, and for the present, we are satisfied, a minimum of three Native Trustees on the Board will suffice.

7. The only other alteration of any importance made by us in Part II of the Bill is that contained in section 9 of the Amended Bill, the effect of which will be to cause one-half of the Ordinary Trustees (*i.e.*, of all the Trustees except the Chairman) to retire year by year. The object of this arrangement is to avoid the inconvenience of having an entirely new Board every two years.

8. In Part III of the Bill we have had sections 21 to 24 re-cast with a view of determining more satisfactorily the respective duties and powers of the Chairman and the Board. We consider it expedient that the Chairman should, in executive matters, have full authority over all subordinate officers and servants of the Board, and we have therefore vested him with the power, subject, of course, to the general regulations of the Board, of appointing, promoting, suspending, dismissing, fining, reducing, or granting leave to all officers and servants not drawing more than Rs. 300 per month (section 23). But in the case of the officers and servants of the Board whose salary exceeds that amount we have conferred this power on the Board; and we propose that the Board alone shall have authority to dispense with the services of any officer or servant, or to permit any officer or servant to retire on a pension, &c.

9. With regard to the Secretary and other chief officers of the Board we have, after much consideration, come to the conclusion that they should be appointed, and that every thing connected with their service should be determined by the Board, subject only to the previous sanction of Government (section 24 of the Amended Bill). To the last para. of section 22 of the Amended Bill (=section 23 of the Original Bill) we have added a few lines to enable Government, in case of dispute, to determine what pensions, &c., any officer or servant of the Board, who, previous to the passing of the Port Trust Act of 1873, held his appointment from Government, is entitled to.

10. In Part IV of the Bill we have had sections 29 and 30 re-drafted. As these sections stand in the Original Bill it would be impossible for the Council to pass the Bill until the Government have finally settled the terms of purchase with each of the holders of the new properties which are to be vested in the Board. But we have been given to understand that the Secretary of State in Council is desirous that the Bill should be passed, and that all the proceedings of the Council in respect of it should be before him before he ultimately sanctions the project contemplated by the Bill. Under these circumstances we have had these two sections re-drawn in such a form as will distinctly express the approval of the Council to the purchase of the new properties in preference to any other mode of amalgamating the various properties on the foreshore of the Port (our reasons for which have been already given above in para. 3), and at the same time authorize Government to purchase those properties on behalf of the Board. We recommend that the Bill be passed by the Council in this shape, because of our conviction that every thing possible should be done to accelerate the measures necessary for the establishment of the new Board and for vesting in them the new properties.

11. The price at which the Government of Bombay hoped to be able to secure all the new properties required was 77 lakhs. The Chamber of Commerce has since had under its consideration the reasonableness or otherwise of the prices offered by the Government, and the result is that it considers that all the properties ought to be acquired for 75 lakhs, with, perhaps, a lakh or so besides. In proposing therefore to authorize the Government to expend as much as 30 lakhs, we do not mean to give expression to any view of our own as to the proper value of the respective properties, but we think it is necessary to allow sufficient latitude to the Government when finally closing the purchasetransactions, and we have no doubt that the Executive Government will obtain the properties for as small an amount as is consistent with equitable claims of the holders. 12. We have retained the provision in section 30 that the new properties shall be paid for in securities to be issued by the Board, this being the only practicable shape in which payment can be made, and we propose that these securities shall bear interest at the rate of four per cent. per annum. This is the rate which has been contemplated by all parties in the overtures which have hitherto been made, and if this rate were not to be adhered to, the estimated limit of the capital price (80 lakhs) would need modification.

13. The transposing of sections 31 and 32 of the Original Bill, and the re-drafting of section 31 (=32 in the Amended Bill) have been done for technical reasons, and are of no material importance.

14. In Section 33 (a) we have added words to render it clear that the Board's liability is to include the monies advanced by Government to the present Trustees for the Prince's Dock and other purposes since the Port Trust Act of 1873 became law.

15. Section 34 we have amended so as to make the rate of interest payable by the Board on any loan which may hereafter be made to them by Government dependent upon such terms as shall be agreed upon between Government and them at the time, instead of fixing the rate unalterably at $4\frac{1}{2}$ per cent., as the Original Bill proposed to do. It does not seem reasonable that either the Government or the Board should be tied to any one particular rate. For this same reason the proviso to the 2nd para. of section 39 of the Original Bill (=section 40 of the Amended Bill) has been omitted.

16. In section 36 of the Bill, as introduced, the amount of the lump payment to be made annually by the Board to the Municipality, in lieu of the consolidated rate to which their property would under the Municipal Act be otherwise liable, was left blank. After some discussion, the Municipal Commissioner and the Chairman of the Port Trust have concurred in recommending us to adopt the section in the form in which it appears in the Amended Bill. The present Port Trust Act (Bombay Act I, 1873, section 9) fixes the amount to be paid at Rs. 50,000 for ten years, from the date on which that Act took effect (26th June 1873), and makes no provision for the settlement of the amount to be paid after that period. There appears to be no reason for disturbing the arrangement come to when the Act of 1873 was passed, except to provide for an additional payment being made by the Board in respect of the new properties from such date as they shall vest in them. This is the purpose which the new section is intended to serve. Rs. 10,000 is calculated to be about the proper rate to be charged for the new properties, and the section therefore prescribes that, until the new properties vest in the Board, they shall pay the Municipality Rs. 50,000 annually, and after that, until the 25th June 1883, Rs. 60,000 annually, and that, after the last-mentioned date, the Governor in Council shall determine what sum shall be so paid.

17. Part V of the Bill (sections 39—42) has been re-arranged, but without any material alteration, except (1) the omission of the proviso to section 39 already referred to above (para. 15); and (2) the modification of the language of the 1st para. of that section (=para. 2 of section 39 of the Amended Bill) so as to enable the Board to spend money which they raise with the consent of Government on any of the general purposes of the Act; and (3) the addition of a proviso to section 39 of the Amended Bill, prohibiting the Board from charging any expenditure to capital except with the sanction of Government.

18. The alterations made by us in Part VI. of the Bill consist principally in an amplification of section 44 (=section 45 of the Original Bill), and in a re-arrangement and partial re-draft of the sections 43 (=section 47 of the Amended Bill) and 48 to 51.

19. The new section 51 is in substitution of the last para. of section 49, section 50 and the last para. of section 51 of the Original Bill. Its object is to provide a more simple arrangement for the disposal of balances than was proposed by the Original Bill, and to enable the Board to hold, and, when not immediately wanted, to invest such balances as Government may from time to time sanction.

20. In Part VII we have thought it expedient to add to the provise to section 68 words similar to those contained in the last part of section 36 of the present Trust Act (Bombay Act I, 1873), prohibiting the commencement of any work of magnitude until the plan and estimate shall have been submitted to and approved by Government. But we have made this provision applicable only to works of which the estimated cost will exceed 2 lakhs instead of twentŷ-five thousand rupees, as in the present Act.

21. In a few other respects also we have reverted to the same extent to the policy of the present Act, as regards the necessity of obtaining the previous sanction of Government for the validity of the Board's acts (vide sections 74 and 26).

22. In section 72 we have taken the power of imposing penalties on pilots from the Chairman and given it to the Board. This is in accordance with the same consideration which have led us to amend sections 21-24 of the Bill (*vide supra* para. 8), as we understand that all pilots receive a larger salary than Rs. 300 per month.

23. Our attention has been drawn to the fact that the present Bill does not re-enact sections 74, 76, 77, 78, 79, and 83 of Bombay Act I., 1873, but we understand that these sections relate to matters which have been dealt with by the Governor General in Council in the Indian Ports Act, 1875, and which therefore it would not be competent for this Council to legislate upon. This difficulty prevents the present Bill being made as complete in itself as we would desire it should be, but this is a matter beyond our control.

24. The foregoing paragraphs comprise all the important points on which we deem it necessary specially to remark. Several minor alterations and additions have been made by us to the Bill which do not seem to require explanation.

Bill No. 12 of 1878,

A Bill to consolidate the immoveable and other property vesting in the Trustees of the Port of Bombay and certain other property on, or connected with, the foreshore of the Island of Bombay into one estate, and to vest the control and management of the same in one Public Trust; and for other purposes.

WHEREAS it is expedient that the immoveable and other property vesting in the Trustees of the Port of Bombay should be consolidated with certain other property on, or connected with, the foreshore of the Island of Bombay into one estate, and that such consolidated estate should, together with the rights and powers now exerciseable by the said Trustees, be vested, subject to the provisions hereinafter appearing, in a new Trust; It is enacted as follow s:--

··· I.-PRELIMINABY,

1. This Act may be called "The Short title. Bombay Port Trust Act, 1879." 2. From the date which shall be noti-Repeal of Bombay Act I. of 1873. I. of 1873 (The Bombay Port Trust Act, 1873,) shall be repealed:

Provided that all debts and obligations incurred, all contracts entered into, and all matters and things engaged to be done by, with or for the Trustees appointed under the said Act, shall be deemed to have been incurred, entered into, or engaged to be done by, with or for the Board constituted by this Act;

and all rates and sums of money due to the said Trustees shall be deemed to be due to the said Board; and all suits or other legal proceedings, civil or criminal, instituted, or which might, but for the passing of this Act, have been instituted by or against the said Trustees, may be continued or instituted by or against the said Board.

3. In this Act, unless there be something repugnant in the subject or context,

- (1) the word "rates" includes any "Rates." toll, due, rent, rate, or charge, leviable under section 43;
- (2) "Port" means the Port of Bombay within such limits as may from time to

time be defined by Government for the purposes of this Act by notification in the Bombay Government Gazette, and until a notification is so issued, within such limits as may have been defined by Government under section 73 of the Bombay Port Trust Act, 1873, for the purposes of that Act;

(3) "Vessel" denotes any thing made "Vessel." for the conveyance by water of human beings or of property;

(4) "Master," when used in relation "Master." to any vessel, means

the time being the charge or control of such vessel;

(5) "Owner," when used in relation "Owner." to goods, includes any consignor, consignee, shipper or agent for the sale or custody of such goods; and when used in relation to any vessel, includes any part owner, charterer, consignee, or mortgagee in possession thereof;

(6) "Land" includes the bed of the "Land." sea below high-water mark;

(7) "Wharf" includes a bandar and "Wharf." any part of the foreshore used for loading or unloading goods, and any wall enclosing or adjoining the same;

(8) "Dock" includes basins, locks, "Dock." cuts, entrances, graving docks, graving blocks, inclined planes, patent slips, gridirons, quays, warehouses, and other works and things appertaining to any dock;

(9) "Pier" includes any stage, stairs, "Pier." landing-place, hard,

floating barge, or pontoon, and any bridges or other works connected therewith;

(10) the word "Goods."

rd "Goods" includes wares and merchandise of every description;

(11) "Immoveable Property" in-"Immoveable Property." cludes wharfagerights and all other rights exerciseable on, over, or in respect of any land, wharf, dock or pier;

(12) the words "Public Securities" "Public Securities." mean securities of the Government of India, Bombay Municipal Debentures and securities and debentures issued under sections 30 and 41, respectively, of this Act.

II .- OF THE BOARD OF TRUSTEES.

Constitution of Board.

4. The duty of carrying out the provisions of this Act shall, sub-

as are hereinafter contained, be vested in a Board, to be called "the Trustees of the Port of Bombay;" and such Board, hereinafter referred to as "the Board," shall be a body corporate and have perpetual succession and a common seal, and shall sue and be sued by the name first aforesaid.

5. The Board shall consist of thirteen Constitution of Board. members, that is to say, of

five Elective Trustees, seven Nominee Trustees, and a Chairman;

and not less than three of the Trustees shall be natives of India residing in the City of Bombay.

6. The elective Trustees shall be elect-

Elective Trustees to be elected by the Bombay Chamber of Commerce; Crustees shall be elected by the members for the time being of the Bombay Chamber of Commerce in such manner as shall from

time to time be determined at a meeting of the members of the said Chamber convened in accordance with the rules at the time in force in this behalf. The Secretary to the said Chamber shall make a return to the Government of the name of every person so elected by the Chamber, and his return shall be published in the Bombay Government Gazette.

In the event of default being made by

or in default of such election shall be nominated by Government. the Chamber in electing any Trustee under the foregoing provisions within the period hereinafter

prescribed in this behalf, it shall be lawful for Government by notification in the Bombay Government Gazette to nominate a person, and the person so nominated shall be deemed to be a Trustee as if he had been duly elected by the Chamber.

7. The nominee Trustees and the Chair-

8. The term of office of the first nominee

The remaining four of the first nominee Trustees and the remaining two of the first elective Trustees shall hold office until and inclusive of the 31st day of March next following the 31st day of March aforesaid.

In every other case the nominee and elective Trustees shall, unless they become in the meantime disqualified, hold office for a term of two years.

than the Chairman occasioned by the death, resignation, or disqualification of such Trustee shall be filled up within one month by Government, if the office vacated was that of a nominee Trustee, or by the Chamber of Commerce, if it was that of an elective Trustee, in the same manner and subject, so far as may be, to the same provisions as are applicable in the case of original appointments and elections of Trustees : Provided that the Trustee so chosen shall retain his office so long only as the vacating Trustee would have retained the same, if such vacancy had not occurred.

If a Trustee departs from Bombay with Acting Trustees. an intention of being absent for a longer period than three months, or if a Trustee shall have been absent for such period, a person shall be elected or appointed as aforesaid to act for such Trustee during

The lien for such rates shall have priority over all other liens and claims, except for general average, for the ship-owner's lien for freight upon the said goods, (where such lien exists and has been preserved in the manner hereinafter provided), for primage and for money payable to Her Majesty or to the Secretary of State for India in Council.

said has been given, is not discharged, the Board may, and in the latter event, if required by or on behalf of the person claiming such lien for freight, shall, at the expiration of two months from the time when the goods were placed in their custody, or if the goods are of a perishable nature, at such earlier period (being not less than twenty-four hours after the landing of the goods), as they shall think fit, sell by public auction the said goods, or so much as may be necessary to satisfy the amounts hereinafter directed to be paid out of the produce of such sale.

Before making such sale, ten days' notice of the same shall be given by publication thereof in the Bombay Government Gazette, unless the goods are of so perishable a nature as, in the opinion of the officer aforesaid, to render their immediate sale necessary or advisable, in which event such notice shall be given as the urgency of the case admits of.

If the address of the owner of the goods has been stated on the manifest of the cargo or in any of the documents which have come into the hands of the Board, or is otherwise known, notice shall also be given to the owner of the goods by letter delivered at such address, or sent by post; but the title of a bona fide purchaser of such goods shall not be invalidated by reason of the omission to send the notice hereinbefore mentioned, nor shall any such purchaser be bound to inquire whether such notice has been sent.

65. In every case of any such sale as aforesaid, the monies Application of proreceived from the sale ceeds of sale. shall be applied as follows :-

1stly .- In payment, according to their respective priorities, of the liens and claims excepted in section 61 from the priority of the lien of the Board for rates;

2ndly.-In payment of the expenses of the sale;

The surplus, if any, shall be paid to the owner of the goods or his agent on his applying for the same, provided such application be made within one year from the sale of the goods, or good reason be shown why such application was not so made to the satisfaction of the Board; and in case such application shall not be so made, nor reason shown, such surplus shall be applied by the Board to the purposes of this Act.

66. Power to distrain vessels for the non-payment of rates, &c.

If the master of any vessel in respect of which any rates, charges, or penalties shall be payable under this Act, or

any bye-laws made in pursuance hereof, shall refuse or neglect to pay the same, or any part thereof, on demand, it shall be lawful for the Board to distrain or arrest, of their own authority, such vessel, and the tackle, apparel, or furniture belonging thereto, or any part thereof, and detain the same until the amount so due shall be paid; and, in case any part of the said rates or penalties or of the costs of the distress or arrest, or of the keeping of the same, shall remain unpaid for the space of fifteen days next after any such distress or arrest shall have been so made, the Board may cause the vessel, or other thing so distrained or arrested, to be sold, and with the proceeds of such sale may satisfy such tolls, dues, rates, penalties, or charges and costs of sale remaining unpaid, rendering the surplus (if any) to the master of such vessel on demand.

67. If the Board shall give to the officer of Government, Port Clearance not to whose duty it is to be granted till rates, &c., grant the port clearare paid. ance of any vessel, a notice stating that an amount therein specified is due in respect of rates, charges, or penalties chargeable under this Act, or any bye-laws, or orders made in pursuance hereof, against such vessel, or the owner or master of such vessel, in respect thereof, such officer shall not grant such port clearance until the amount so chargeable shall have been paid.

Works.

General nature of works to be executed under this Act.

68. The works to by undertaken be the Board under this Act may include-

(1) wharves, docks, and piers within the Port or on the foreshore of the Port with all necessary and convenient arches, drains, fences, roads, railways, and approaches;

tramways, warehouses, sheds, (2)engines, and other appliances for conveying, receiving, and storing goods landed, or to be shipped, or otherwise;

(3) light-houses, light-ships, beacons, pilot-boats, and other appliances necessary for the safe navigation of the Port and of the approaches thereto within a distance of three miles from the limits of the Port;

(4) laying down moorings, and the erection of cranes, scales, and all means and appliances necessary for berthing, loading and unloading vessels;

(5) reclaiming, excavating, enclosing, and raising any part of the fore-shore of the Port vested in the Board, when such reclamation, excavation, enclosure, or raising may be necessary for any of the purposes of this Act;

the construction and application of dredges and other machines for cleaning, deepening, and improving any portion of the Port or foreshore aforesaid;

the construction of such works, without the limits of the Port, as shall be necessary for the protection of works executed by the Board within the Port, and all such other works and appliances as may, in the opinion of the Board, be necessary for carrying out the purposes of this Act:

Provided always that no new work, the

69. Nothing in this Act shall be deemed to affect :

(a) Reservation of the rights of Government to use the wharves, &c., for collecting customs duties ;

the right of Government to collect customs duties, or of the Municipal Corporation of the City of Bombay to collect town duties,

at any wharf, pier, or dock in the possession of the Board, or

any power or authority vested (b)and of powers of Customs Officers.

in the Customs Authorities of the Presidency under any law

for the time being in force for the administration of Sea Customs.

Whenever any wharf, pier, or dock, 70. in the possession of Places to be set apart the Board shall be for use of Customs Officers on wharves, &c. appointed, under the provisions of any Act for the time being in force, for the administration of Sea Customs, a wharf or place for the landing and shipping of goods within the meaning of such Act,

and whenever any warehouse, or portion of a warehouse, in the possession of the Board shall be appointed or licensed under the provisions of any such Act as a warehouse for the deposit of dutiable goods on the first importation thereof without payment of duty,

the Board shall set apart, and maintain, such place on or adjoining such wharf, dock, or pier, or in such warehouse, or portion of a warehouse, for the use of the Officers of Customs as Government shall in that behalf approve or appoint;

but all rates payable in respect of any wharf, pier, or warebut the right of the house, Board to levy rates not or portion to be thereby affected; thereof so set apart, or for the storage of goods thereupon or therein, shall be paid to the Board or to such person or persons as they may appoint to receive the same, notwithstanding that the same has been so set apart ;

Port, and all fees for pilotage shall be paid to the Board : Provided that no person shall be appointed to be a pilot by the Board who is not for the time being authorized by Government, under the provisions of the Indian Ports Act, 1875, to pilot vessels.

The Board may also, from time to time, make such bye-laws and regulations as they shall think fit:

(a) for fixing and regulating the wages and allowances for pilotage to be received by pilots, and

(b) for regulating the behaviour and conduct of pilots;

and shall enforce the observance of such bye-laws and regulations, by the imposition of pecuniary penalties not exceeding two hundred rupees for each offence, or by suspension, or deprivation of appointment, or otherwise as to them may appear ex-pedient: Provided that such bye-laws shall first have been approved by Government, and published in the manner directed by section 74.

Bye-Laws.

73. The Board may, from time to time, make bye-laws :

(a) for the guidance of persons employed by them under this Act;

(b) for the safe and convenient use of the wharves, docks, piers, war houses, tramways, and other works constructed or acquired by them under this Act;

(d) for the reception and removal of goods brought within the premises of the Board;

for keeping clean the harbour *(e)* and basins and the works of the Board, and for preventing filth or rubbish being thrown therein or thereon;

(f) for settling the mode of the payment of the rates and charges leviable under this Act;

(g) for regulating, declaring, and defining the wharves, docks, and piers vested in the Board on which goods shall be landed from, and shipped on board vessels; and

(h) generally for carrying out the purposes of this Act.

The Board may also, from time to time, vary, alter, or revoke any such bye-laws so made by them.

74. No bye-law, or alteration or revocation of a bye-law, shall Approval and publihave effect until the cation of bye-laws.

(a) having a share in any Joint Stock Company which shall contract with, or be employed by, or on behalf of the Board, or

(b) having a share or interest in any newspaper in which any advertisement relating to the affairs of the Board may be inserted, or,

(c) interested in any loan of money to the Board.

79. Any person employed under this For obtaining illegal gratification.

Act, not being a public servant within the meaning of section 21

of the Indian Penal Code, who shall accept or obtain, or agree to accept or attempt to obtain from any person, for himself or for any other person, any gratification whatever, other than legal remuneration, as a reward for doing, or forbearing to do, any official act, or for showing, or forbearing to show, in the exercise of his official functions, favour or disfavour to any person; or for rendering, or attempting to render, any service or disservice to any person with the Board or with any public servant as such, or with the Government, shall be liable to the same punishment as is provided

by the Indian Penal Code in the case of the like offence committed by a public servant.

80. For refusing or neglecting to appear before an Auditor of Accounts, &c.

Any person who shall refuse or neglect to appear before any auditor of accounts, or to produce any books, deeds, con-

tracts, accounts, vouchers, documents, or papers, or to make or sign any declaration when duly required so to do by any auditor of accounts under section 58, shall be punished for every such neglect or refusal with fine which may extend to one hundred rupees.

81. Any person, other than the Board

Any such wharf, quay, pier, mooring, or other erection, may be removed by the Board, and the person who made, set up, or fixed the same, shall also be liable to pay all expenses which may be incurred by the Board in the removal thereof.

For understating quantity or weight of from, any wharf, dock goods, &c. or pier in the possession of the Board, that the weight or quantity of such goods, or the tonnage of any vessel carrying such goods, has been understated in any document presented to any officer of the Board for the purpose of enabling him to determine the rates or charges payable in respect of the said goods or vessel, the consignee, in the case of goods imported, and the consignor, in the case of goods exported, shall be liable to pay to the Board such sum not exceeding twice the proper rates or charges on the weight or quantity of goods or amount of tonnage so understated as may be determined by the Board, and the said sum shall on the application of the Board be recoverable under a Presidency Magistrate's warrant as if it were a fine inflicted by such Magistrate.

83. Any person who removes, or attempts to remove, For evading rates, &c. or abets within the meaning of the Indian Penal Code the removal of any goods, vessel, animal, or vehicle with the intention of evading payment of the rates or charges lawfully due in respect thereof to the Board shall be punished with fine which may extend to fifty rupees.

84. If, through the negligence of any

Recovery of value of damage to any property of the Board.

person having the. guidance or command of any vessel, or of any of the mariners

or persons employed on such vessel, damage shall be caused to any wharf, dock, pier, or other work in the possession of the Board, the amount of such damage shall, on the application of the Board, be recoverable, together with the cost of such recovery, by distress and sale, under a Presidency Magistrate's warrant, of a sufficient portion of the boats, masts, spars, ropes, cables, anchors, or stores belonging to such vessel : Provided that no such warrant shall issue until the. master of such vessel has been duly summoned to appear, or, if he appears, until he has been heard, and provided also that no such warrant shall issue if the vessel was at the time under the orders of a duly authorized officer in the pilot service of the Port or of the Master Attendant's Department.

Except as is otherwise provided in 85. section 82, all offen-Cognizance of ofces against this Act fences against this Act. or against any bye-law made under section 73 shall be cognizable by a Presidency Magistrate.

All fines and damages recovered from any offender, or by any distress under section 84, shall be paid to the Board.

IX.-MISCELLANEOUS.

Provision when day appointed by this Act for any purpose falls on a Sunday or public holiday.

86. Whenever any day by this Act Provision when day appointed for any purpose shall happen to be a Sunday or a public holiday, the business appointed to

be done on such day shall be done on the day next after such Sunday or public holiday.

No suit or other proceeding shall 87. be commenced against Limitation of suits, &c. thing done, or purporting to have been done, in pursuance of this Act without giving to such person one month's previous notice in writing of the intended suit or other proceeding, and of the cause thereof, nor after six months from the accrual of the cause of such suit or other proceeding.

The Board shall not be responsible for any mis-feasance, mal-feasance, or nonfeasance of any officer or servant appointed under this Act;

nor, if they should be appointed by Government, under the Indian Ports Act, 1875, Conservators of the Port, for any mis-feasance, mal-feasance or non-feasance of any Deputy Conservator, Master Attendant or Harbour-Master, or of any assistant or deputy of any such officer, or of any person acting under the authority or direction of or in subordination to any such officer, assistant or deputy;

nor for any damage sustained by any vessel in consequence of any defect in any of the moorings, hawsers, or other things belonging to the Board, which may be used by such vessel;

nor shall the Board, or any of the said officers or servants, be liable in damages for any act bona fide done, or ordered to . be done by them in pursuance of this Act.
