

Transactions other than the above will be conducted with the Bank through the Treasury Department, or such Officer as may be appointed by the Resident.

CXI. With reference to G. O. C. of the 23rd ultimo, appointing Lieutenant Holt to the Transport Train, Major Sheppard, 2nd Grenadiers, is appointed Acting Provost Marshal at Zoulla, vice Holt, who will join the Transport Train.

CXII. Lieutenant Lambard, 45th Foot, is appointed Superintending Officer of the water supply at Zoulla, vice Ensign Carruthers, 4th Foot, with effect from the 3rd instant.

CXIII. The services of Lieutenant Warburton, R.A., at present attached to the 21st Punjaub Infantry, and Lieutenant Mackinnon, 25th Regt. N. L. I., are placed, the former at the disposal of the Director of the Transport Train, and the latter at the disposal of the Deputy Commissary General, with effect from 8th instant.

CXIV. Captain Callwell and Ensign Humfrey, 45th, and Ensign Scott, 4th Foot, are appointed Sub-Assistants Commissary General, 1st Class, with effect from the 6th instant.

CXV. Lieutenant Tulloch, of the Bengal Army, at present attached to the Kahars, is attached to the Transport Train. This order to have effect from 4th instant.

CXVI. It is notified for general information that, in future, mails for England and India will be despatched by Steamers weekly, direct to Suez and Aden, on the following dates:—

Mails for England.

Will leave Zoulla at 5 a. m. on the 20th and 26th of February, the 6th of March, and every subsequent Friday.

Mails for India.

Will leave Zoulla at 5 A.M. on the 15th and 23rd of February, the 2nd and 9th of March, and every subsequent Tuesday.

CXVII. The middle compartments of the Hospital Ship "Mauritius," accommodating forty-four Sick, having been allotted for the reception of Sick Seamen of the Merchant Ships, when not required for Sick Soldiers, the charge for dieting such Sick has been fixed at two shillings a head per diem. This sum is to recovered by the Purveyor on board, from the Masters of Transports, immediately on their men being discharged from Hospital. In the event of a ship leaving Annesley Bay before such discharge from Hospital, the accounts are to be forwarded to Captain Tryon, R.N., Principal Transport Officer, who will take the necessary steps to recover the amount from the owners, in accordance with the provisions of the "Merchant Shipping Act."

CXVIII. Lieutenant J. G. McRae, Wing Subaltern, 2nd N.I. (Grenadiers), is attached to the Intelligence Department from this date, and will proceed at once to Addigerat, where instructions will await him.

CXIX. Bi-weekly returns of provisions in hand at Zoulla, or on board ships anchored in Annesley Bay, and daily similar returns from all other stations, will be sent in future, by Officers in charge of Commissariat Depôts, direct to the Deputy Adjutant General, Abyssinian Expeditionary Force, for the information of His Excellency the Commander-in Chief.

CXX. The daily ration of spirits issued to fighting men will be reduced in future to one dram.

In publishing this order the Commander-in-Chief wishes it to be made known to the troops under his command, that it is with the greatest reluctance he feels himself compelled to deprive them of any part of their rations.

The difficulties, however, of providing for the numerous wants of an army in a country almost destitute of supplies, renders it imperative that the essential articles of food, such as biscuit, flour, and rice, should be sent to the front in preference to all others, which must be looked on in the light of luxuries, when troops are in the field.

The Commander-in-Chief has remarked with pride the fine spirit shown by all ranks of the army since its arrival in this country; and he feels assured that, whatever further privations may have to be endured in order to ensure the success of the expedition, one and all will cheerfully submit to them.

CXXI. The Commander-in-Chief is pleased to permit the Public Followers of the Land Transport Train to draw the full ration of flour and rice, in lieu of the pertion of meat ration lately ordered.

This order to have effect from 30th ultimo.

Artificers, Troop Moochees, Regimental Saddlers, according to actual requirement, to be specially sanctioned.

- 25 Muleteers for each Mountain Train Battery of Artillery.
- 1 Tent Lascar to each General Officer or Assistant Quartermaster General of Division.
- 1 Muleteer for every three Land Transport Train Mules or Cavalry baggage animals.

No Syces are to be allowed to any Regiment of Cavalry or Battery of Artillery.

Grass-cutters are allowed in the proportion of one to every five Regimental or Battery Horses.

No Officers are to be allowed any private carriage whatever-

Every Staff, Regimental, or Battery Officer is to be allowed a Soldier servant-

No Civilian Clerks are to be permitted to accompany the Force.

Commissariat Officers are prohibited from issuing rations to any followers, excepting those above named unless indents for the same are in the first instance specially countersigned by the Assistant Quartermaster General at Army Head Quarters.

Indents for rations for followers and cattle in the Commissariat, Land Transport, and other departments, should be forwarded for sanction as soon as possible.

All public and private followers discharged under the operation of this order will be allowed free rations to Zoulla, and a passage to india or Egypt as required.

Major General Malcolm, C.B., Brigadier General Collings, Colonel Field, and Colonel Graves are requested to be so good as to order all followers attached to Officers and Troops under their command over the scale above noted to be sent to Zoulla at once, and the Brigadier Generals Commanding at Koomayle and Zoulla, and Officers Commanding at Sooroo, Undul Wells, and Rayrayguddy, are held responsible that no Officers or Troops leave the stations under their respective commands for the highlands with more followers or carriage than now sanctioned.

The Commissariat Department at Zoulla are authorised to detain any public followers discharged under this order for any department requiring their services.

Williaume, Assistant Superintendent Revenue Survey and Assessment, Hydrabad Assigned Districts, may be allowed to count towards furlough his previous Service in the Indian Navy, and in reply to state that, in accordance with the ruling of the Secretary of State, contained in his Marine Despatch to the Government of Bombay, dated 15th December 1866, No. 76, Mr. Williaume cannot count towards benefits under the Uncovenanted Service Leave Rules any service rendered in the Indian Navy till its abolition on 28th November 1862.

FINANCIAL DEPARTMENT.

The attention of Treasury Officers is drawn to the following amended instructions regarding the preparation of their Registers of Deposits received and repaid:—

2. The Registers are to be prepared in the forms prescribed in this Office Notification No. 10, dated 15th June 1868.

- 3. The object for which these monthly returns are required is, that an independent and collateral check may be kept up in this office—first, to prevent the undue accumulation of Deposit Receipts; and, secondly, to prevent excess or erroneous payments under that head of account.
- 4. Each deposit should be entered in the Register of Receipts as a separate item as soon as it is made, and have a distinct serial number assigned to it. There should also be a separate Register and an unbroken series of numbers for each class of Deposit, viz. Revenue and Judicial, for the official year.
- 5. The amount and particulars of each entry in the Register of Receipts should be carefully checked by the Treasury Officer, who should affix his initials to each item in the column set apart for the purpose. Provision has been made in the Register for the entry of repayments as they occur against each Deposit, and care should be taken that each of these repayments is carefully checked and initialled by the Treasury Officer, and that no repayment is made until the sufficiency of the outstanding balance to meet it is fully ascertained.
- 6. In charging a Deposit in the Register of Repayments the entry should invariably possess the same number as that allotted to the credit on the same account in the Register of Receipts. This course must be pursued whether the payment be in whole or in part of the original Deposit, in order that the several payments on account of any Deposit may be easily referred to the sum at credit. The repayments should not, therefore, be noted in numerical sequence, but daily in the order of their occurrence.
- 7. The entries in the daily Deposit accounts should be brief, but distinct, and all unnecessary repetitions avoided. When explanations are necessary they should be specific, and a reference given in the office copy to any special orders bearing on the case.
- 8. The Registers sent to this office should be attested at foot by the Treasury Officer, and show in detail all the transactions of the month in both the Hoozoor and Talooka Treasuries, with the exception of the detailed entries of personal accounts, of which only the totals entered at the end of the month will be exhibited against a single number.
- 9. Each item of repayment should be separately numbered in red ink, and have its appropriate Voucher, which should also bear a corresponding red ink number. Ordinarily the proper Voucher is the receipt of the party which should be taken on the biglot form that is already in use. The original number and amount as entered in the Register of Receipts rendered to this office should be carefully entered therein. A single receipt is sufficient for several repayments to the same person, and in such cases the biglot form must show the different items from which the payments are made in full detail.

- 10. All the Deposit Vouchers of each month must be furnished with the Register of Repayments, and both the Register and the Vouchers should accompany the 2nd list of Payments.
- 11. The Vouchers must be numbered in the regular series in which those belonging to other heads o account are numbered; for example, if the number assigned to the Voucher supporting the last item of charges under the head immediately preceding that of Deposit be 56, the Voucher supporting the first item of repayments under Deposits must bear 57, and so on until each Deposit Voucher has received is appropriate number in the consecutive series which terminates with the last item of charge in the 2nd list of Payments.
- 12. The Details of the Receipts and Repayments of Deposits will not be given in the lists of Receipts and Payments, in which the aggregate amounts only should be exhibited.
 - 13. All Deposits should be available for the public service and form a part of the Cash Balance.
- 14. Deposits should never be received by Mamlutdars or other subordinate Officers from private individuals without previous authority obtained.
- 15. No Deposits should be received at a Hoozoor Treasury without an order from the Collector or the Treasury Officer, nor any repayment made without a written order from the Collector or the Treasury Officer.
- 16. The Deposits of the Talooka Treasuries are to be entered in full detail and brought upon the Hoozoor Register.
- 17. When the executive duties of the Treasury Department are conducted by a Subordinate Officer, the Collector of the District is required personally to examine these Deposit Registers at least once a quarter, and to satisfy himself that they have been kept with the utmost care and regularity.
- 18. A certificate to the effect that this examination has been made is to be entered at the time on the Extract Register of Receipts under preparation for the Accountant General's office.
 - 19. The following rules must be strictly observed in order to reduce the number of Deposits:—
 - a. No sums are to be entered in the Deposit Books which can properly be credited to any other head of Account.
 - b. Collections made from the Estates of Minors under the Court of Wards, and generally numerous Deposits on one account or payable to one person, are to be recorded in a personal ledger.
 - c. A transfer to the account of Revenue or Miscellaneous Receipts is to be made annually of the amount of all Deposits remaining unclaimed without sufficient cause for three years. Deposits that have been credited to Government under this rule cannot be repaid without the sanction of the Accountant General. Sums not exceeding one Rupee, lying unclaimed for more than one year, and the balances of Deposits which have been partially repaid during the year if not more than one Rupee in amount, may be included in the transfer.
 - d. Every public Officer having an account in the Personal Deposit Register will annually furnish the Officer in charge of the Treasury with an account of the particulars of Outstanding Deposits, in order that such as may be more than three years standing may be dealt with in the manner above directed.
- 20. Excess payments must be carefully guarded against. When such payments are discovered in the Accountant General's office they will be disallowed in the Register of Repayments.
- 21. The Outstanding Balances on the 31st March of each year must not, as was before directed, be brought forward as fresh Deposits on the 1st April following.

Overland Postage Rates on Army Officers' letters.—Instructions having this day been received from the London General Post Office altering from full ounces to half-ounces the scale of progression of weight for Letters between India and the United Kingdom sent to or by Officers of the Army in India, this Postal Notice will supersede that issued by this Office on the 29th ultimo, No. 5.

2. It will be observed that the only change now made is the imposition of four annas per half oz. in

lieu of 8 annas per oz. on Letters weighing more than one ounce.

3. Under the authority of the Treasury Warrant, published in page 490, Part I. of the Bombay Government Gazette, dated 26th December 1867, the correspondence of Officers of the Army in India is excluded from the operation of the increased rates of Postage on letters passing between India and the United Kingdom, intimated in this Office Postal Notice No. 4, dated 26th instant, and will be charged, the uniform rates below mentioned, in which Inland Postage has been included.

4. Letters entitled to the privileged rates laid down in the Warrant, may be classed as follows, and must be subject to the conditions enumerated. Should any of these conditions not have been regarded, the cover will

be considered an ordinary Overland letter, and treated accordingly:-

I.—LETTERS POSTED IN INDIA.

(a.) The Sender must be a Commissioned Officer of the Army, actually employed (otherwise than in Civil employ) in Her Majesty's Service in India.

The letter must be one addressed to the United Kingdom.

The letter must bear by way of superscription-

1. The signature of the Commissioned Officer who sends the letter.

2. The signature of the Commanding Officer of the Regiment, Corps, or Detachment in which the sender is serving, or of the Local Head of the Department to which he belongs.

A specification by the Commanding Officer or Local Head of the name of the Regiment, Corps,

or Detachment in which the Officer is serving or of the Department to which he belongs.

II .- LETTERS DELIVERED IN INDIA.

The letter must be one which has been posted in the United Kingdom.

(b). It must be addressed to a Commissioned Officer of the Army actually employed (otherwise than in-Civil employ) in Her Majesty's Service in India.

(c). It must bear by way of superscription,-

 The rank of the addressee; and
 The Regiment, Corps, or Detachment in which he is serving, or the Department to which he belongs.

5. As regards the term "Čivil employ," it will be proper to regard all Military Officers serving under the orders of the Civil Administrations (i. c. not under the orders of the Commander-in-Chief) as being in Civil employ. For instance, Military Officers belonging to the Survey, Public Works, Education, Telegraph, Post Office, Police, Jail, and other similar Departments, as well as Secretaries to Government, Cantonment Magistrates, Commissioners, Deputy Commissioners, Civil Surgeons, &c., will be regarded as being in Civil employ.

The condition that the Officer must be "actually employed" in Her Majesty's Service in India,

excludes Officers who may be on leave from a title to claim the privilege.

7. The term "Local Head of a Department" may be regarded as meaning the Chief Officer of the Department in the station where the letter is posted.

Increased Rates of Postage on Overland Letters.—Under instructions this day received from Her Majesty's Post Master General, it is hereby notified for the information of the public, that the single rate of postage on Letters sent between the United Kingdom and India, viá Southampton, has been raised from 4 Annas to 6 Annas, the rate on those forwarded viá Marseilles by British Packet, or by French Packet, being in like manner raised from 6 Annas 8 Pie to 8 Annas 8 Pie.

Unpaid Letters, whether forwarded viá Southampton, viá Marseilles, or by French Packet, will be liable, in addition to the foregoing rates, to a fine of 6 Annas, and insufficiently paid Letters will be liable to the deficient postage, and a like fine of 6 Annas.

All Letters forwarded from India through the United Kingdom to Foreign Countries or British Colonies will in like manner be subject to an additional charge of 2 Annas per ½ oz. over and above the rates which have heretofore been chargeable in India.

It has also been decided to alter the scale of progression for charging Letters above the weight of ½ oz., and to adopt a scale of charge rising by half ounces.

The above changes have been ordered with effect from the 1st April next; Letters posted in India on or after that date being subject to the new rates.

Note.—The change in rates does not, as will be observed, affect Newspapers, Books, or Patterns, and it applies only to Letters sent to or through the United Kingdom. The charges for instance on Letters sent to Foreign Europe viā France or via Trieste, or through the British, French, or Austrian Post Offices at Alexandria, or to Malta or Gibraltar, or British Colonies in Asia, are not affected by the present alteration.

Postage to the United States.—The public are hereby informed, that, under a new Postal Convention concluded by Her Majesty's Postmaster General with the United States of America, the postage chargeable on letters sent from England to the United States has been reduced, provision being also made for the transmission of Book and Pattern Packets.

2. Under the new arrangement, the consolidated rates of postage (including the increased rates recently ordered between India and the United Kingdom) chargeable on Letters, Newspapers, and Book and Pattern Packets, addressed to the United States of America, will be as follows, viz.:—

Postage to Turkey.—Under instructions from Her Majesty's Post Master General the following rates of postage will be chargeable in India, on correspondence addressed to Europe "via Trieste," or sent through the Austrian Post Office at Alexandria, to places* in Turkey where there are Austrian Post Offices.

The full prepayment of these rates is in all cases compulsory, and they do not carry the covers to destination, being in fact only the Indian and British Packet rates. The Austrian rates cannot be prepaid in India.
