BILLS OF THE COVERNMENT OF INDIA.

The following Bill was introduced into the Council of the Governor General of India for the purpose of making Laws and Regulations, on the 20th March 1868, and was referred to a Select Committee with instructions to make their report thereon in a week-

Bill No. 8 of 1868.

A Bill to empower the Governor General of India in Council to suspend the operation of section 17 of Act No. XI. of 1841.

Power to suspend Act No. XI of 1841, section 17.

any military cantonment beyond the limits of British India the operation of section seventeen of Act No. XI. of 1841 (for consolidating and amending the Regulations concerning Military Courts of Requests for Native officers and soldiers in the service of the East India Company) from such day as shall be specified in the said notification until further notice, or to such other day as shall be specified in such notification.

STATEMENT OF OBJECTS AND REASONS.

The object of this Bill is to improve the administration of civil justice in military cantonments GOVT. OF INDIA BILLS—86

beyond the frontier of British India. In such cantonments, demands exceeding the jurisdiction of Courts of Small Causes are, under Act No. XI. of 1841, section 17, cognizable only by Military Courts of Requests. These Courts are not well fitted to try cases involving very large amounts, such as are often litigated in cantonments like Secundrabad; and though the section last-mentioned gives an appeal to the nearest High Court, there are obvious difficulties in the prosecution of an appeal to such Court from a Court not in British India, and not exclusively resorted to by British subjects. Under these circumstances, the Resident or Representative of the Government of India in more than one Native State has, with the consent of the Native Chief, established a system of justice analogous to that prevailing in British India. The legality of this procedure has, however, been doubted, as it conflicts with the provisions of Act No. XI. of 1841, which a servant of Government is bound to observe. The present Bill, therefore, proposes to enable the Governor General in Council to suspend that section.

Bill No. 9 of 1868.

A Bill for taxing Professions, Occupations, and Trades.

WHEREAS it is expedient to impose a tax on all persons exercising professions, occupations, and trades in British India; It is hereby enacted as follows:—

I .- PRELIMINARY.

1. In this Act "Ma-Interpretation-clause. gistrate" means any person exercising the powers of a Magistrate, or of a Subordinate Magistrate of "Magistrate." the first class, and includes a Magistrate of Police and a Justice of the Peace. 2. Acts No. XXI. of 1867 (for the licensing of professions and trades) and Repeal of Acts. No. XXIX. of 1867 (to explain and amend Act No. XXI. of 1867) are Saving of other laws hereby repealed; but save relating to licenses or taxes. as aforesaid nothing in this Act shall be construed to affect the provisions of any other law relating to taxes or licenses.

Exemptions from Act.

3. Nothing in this Act shall apply to—

- (1) Officers of Her Majesty's Forces or of Her Majesty's Indian Forces, whose pay and allowances do not exceed Rs. 6,000 per annum, and who are not in Civil employment other than employment in the Police:
- (2) Non-Commissioned Officers and Privates of either of the said Forces, and who are not in Civil employment other than employment in the Police:
- (3) Officers of any Police Force whose pay and allowances are less than the pay and allowances of a Captain of Infantry in Her Majesty's Forces in India:
- (4) Servants and Clerks (whether of Government, Companies, bodies corporate, municipal committees, partnerships, or individuals) whose receipts from all sources amount in the year to less than Rs. 1,000:
- (5) Any cultivator of land, as such in respect of the sale of the produce of his land, when he does not keep a shop for the sale of such produce:
- (6) Any part of British India, tribe or class of persons exempted by order under section 4 of the said Act No. XXI. of 1867.
- A. The Governor General of India in Council

 Power to exempt from may from time to time, by order, wholly exempt from the operation of this Act any part of British India, or any tribe or class of persons dwelling or personally working for gain or carrying on business in British India or in any such part.

The Governor General of India in Council may revoke any such order,

All orders and revocations made under this section shall be published in the Gazette of India and also in the local Gazette.

11.—CERTIFICATES.

Rs. 500 or upwards shall exercise any profession, occupation, or trade, without a certificate as hereinafter provided; and every such person exercising any such profession, occupation, or trade, shall annually pay in advance for his said certificate the sum specified in schedule A hereto annexed:

Provided that no person exercising two or more professions, occupations, or trades, shall be required to take out under this Act more than one certificate in any one year for the purpose of exercising such professions, occupations, or trades.

6. Every such certificate shall have effect and continue in force from the day of the date thereof until the thirtieth day of April next following, on which day in each year all such certificates shall expire.

7. Every person who has taken out any such Renewal of certificate. certificate and who intends to continue any profession, occupation, or trade for which such certificate was granted, shall take out a fresh certificate for the year following, to expire on the day last hereinbefore mentioned, and shall so renew the same from year to year so long as he continues such profession, occupation, or trade, and shall pay in each such case the duty thereupon imposed.

8. In cases where the certificate is so renewed,

In all other cases the certificate shall bear date from the day of the application made therefor, although it may be delivered at any day subsequent to the application.

9. If any person commences any profession, certificate to persons commencing business.

quired, such person not having before taken out any such certificate, the Collector may grant such certificate for the remainder of the current year in which it is taken out, ending on the thirtieth day of April next following the date of the certificate taken out by such person, upon payment of such proportional part of the duty thereupon imposed as hereinafter mentioned (that is to say):—

If the certificate be taken out at any time in the quarter expiring on the thirty-first day of July of the current year in which it is taken out, the person taking out the certificate shall pay the whole duty imposed thereon, in such manner as hereinbefore mentioned at the time of granting such certificate;

If the certificate be taken out at any time in the quarter expiring on the thirty-first day of October of such current year, he shall pay three-fourth

parts of the said duty;

If the certificate be taken out at any time in the quarter expiring on the thirty-first day of January of such current year, he shall pay one-half of said duty; and

If the certificate be taken out at any time in the quarter expiring on the thirtieth day of April of of such current year, he shall pay a fourth part only of such duty.

Officer to grant certificate under this Act shall be granted by, and the sum payable therefor shall be paid to, the Collector of place or district at or in which the person requiring the certificate exer-

cises his profession, occupation, or trade.

Provided that, if such person exercises his profession, occupation, or trade at or in more than one place or district, the certificate shall be granted and payment made by and to the Collector for the place or district at or in which the certificate-holder's principal place of business in British India is situate.

Every such certificate shall be signed by the Collector granting it, or by such other officer as he shall from time to time empower in this behalf, and such signature shall be judicially noticed.

Contents of certificate. 11. Every such certificate shall specify—

(1) The year or portion of the year for which it is granted;

(2) The name and profession, occupation, or trade of the holder;

(3) The sum paid for the certificate, and

- (4) The place or places, district or districts, where the holder intends to exercise his profession, occupation, or trade until the thirtieth day of April next following, and shall be received in evidence as primá facie proof of all matters contained therein.
- 12. The Collector shall from time to time determine what persons are liable to take out certificates under this Act, and under which of the classes mentioned in the said schedule every person to whom a certificate may be granted under this Act shall be assessed.
- 13. As soon as may be after the first day of
 May in every year, the Collector shall prepare a list of
 the persons certified or to be
 certified, under this Act, for the current year, and
 may from time to time alter and add to the said
 list.

Such list shall state-

- (1) The profession, occupation, or trade of each person therein named;
- (2) The class under which he is assessed;
- (3) The sum paid or payable for his certificate.

The list shall be filed in the Collector's Office and the list or such part or parts thereof as he thinks fit shall be filed in such other places as he directs, and shall be open to public inspection at all reasonable times without the payment of any fee.

Objection to list. Objection to list which he is assessed; or denying his liability to be assessed under this Act, shall be at liberty, if he has paid the sum in which he was assessed under this Act, within thirty days from such payment, to apply by petition to the Collector in order to establish his tight to have his name transferred to another class, or altogether to be removed from the list.

The petition shall bear a stamp of eight annas, and the statements therein contained shall be verified by the petitioner or some other competent person in manner required by law for the verification of plaints.

Whoever makes a statement in any such petition which is talse, and which he either knows or believes to be false, or does not believe to be true, shall be deemed to have intentionally given false evidence in a stage of a judicial proceeding.

15. The Collector shall fix a day for the hearing of the petition, and on the day so fixed, shall hear such petition and pass such order thereupon as to him seems fit.

Any person dissatisfied with such order may, within fifteen days from the date thereof, present an appeal in writing to the Commissioner of Revenue of the Division, whose decision upon such appeal shall be final.

Every appeal preferred under this section shall bear a stamp of one rupee, and shall be accompanied by a copy of the petition, the Collector's order thereon, and all other documents (if any) connected with the case.

Power to summom persons to give necessary information.

The Collector or Commissioner may summon any person whom he thinks able to give evidence for the purpose of enabling him to deter-

mine under which of the said classes the petitioner should be assessed, and may examine on oath the person so summoned, and the petitioner, and may require each of them to produce any documents in his possession or power relating to the petitioner, or to the amount of the annual profits accruing from his profession, occupation, or trade.

III .- PENALTIES.

Penalty for carrying on business without a certificate.

Penalty for carrying on the class under which he has been assessed, and requiring him within se-

ven days from the date of the service to take out a certificate and to pay for the same the sum (mentioning it) payable therefor under the provisions of this Act; and if the person so served does not within the period specified in the said notice take out a certificate and pay for the same as required by the said notice, he shall on conviction before a Magistrate be subject to a penalty not exceeding three times the sum mentioned in such notice.

Every such notice shall be deemed to be sufficiently served if left at the residence or usual place of business of the person to whom it is addressed.

On the recovery of the penalty from the person so convicted the Collector shall grant him a certificate without any further payment. Every such certificate shall bear date from the recovery of the penalty, and save as aforesaid, the provisions of this Act relating to certificates shall apply to certificates granted under this sanction.

Out a certificate, who without reasonable excuse, neglects or refuses to produce and show his certificate when required so to

do by the Collector or by an officer generally or specially empowered in writing by the Collector to make such requisition, shall on conviction before a Magistrate, be liable to a penalty not exceeding one hundred rupees.

19. All penalties imposed under this Act may be recovered, if for offences Mode of recovering pocommitted outside local limits of the towns of Calcutta, Madras, or Bombay, in the manner prescribed by the Code of Criminal Procedure, and if for offences committed within those limits, in the manner prescribed by any Act regulating the Police of such towns in force for the time being.

IV .- MISCELLANEOUS. (a) Companies.

From the first day of May 1868, every Company carrying on bu-siness in British India, Provision as to Compa-India, nies. whose stock or funds is or are divided into shares and transferable, whether such Company be incorporated or not, and whether its principal place of busines be situate in British India or not, shall take out a certificate and annually pay in advance for the same the sum mentioned in Schedule B hereto annexed:

The Treasurer, Secretary, or principal agent or manager in India of any such Company whose principal place of business is in British India, shall be legally bound to prepare, and, on or before the thirtieth day of April in each year, to deliver to the Collector for the place or district at or in which its principal place of business is situate, a return in writing signed by him and stating the dividend (if any) declared by the Company during the year ending on the thirty-first day of March in the year of assessment.

When any Company has taken out and paid for a certificate as aforesaid, no person shall be deemed to exercisea trade within the meaning of this Act solely by reason of any share or interest in such Company.

All the other provisions of this Act applicable to individuals shall apply, matatis mutandis, to Companies: Provided that the maximum penalty to which a Company shall be subject on conviction under Section 17 shall be Rupees five thousand.

(b) Government Officials.

23. Every person holding any paid office, employment, or commission under Her Majesty or un-Provision as to Government officials. der the Government of India, or under any local Government, other than the persons exempted under Section 3 or by order under Section 4, shall be deemed to exercise an occupation within the meaning of this Act; Provided that he shall not be required to take out a certificate under this Act in respect of such office, employment, or commission.

The sum which, but for this proviso, he would have paid for a certificate shall, notwithstanding anything hereinbefore contained, be one per cent. on the amount of the pay of his substantive ap-pointment, and shall be deducted therefrom at the time of payment by the Examiner of Claims or other proper officer, and shall be deemed to be a tax paid under this Act.

In determining under which of the classes men-tioned in the said Schedule A any person holding any such office, employment, or commission, and permitted, nevertheless, to exercise a profession, occupation, or trade, shall be assessed, the Collector shall neglect the amount of the pay which such person receives in respect of his office, employment, or commission.

All taxes under this Act, except when 24. they are deducted under Tax when pavable. Section 23, shall be payable on the first day of May in each year.

Provided that in every case where the amount so payable equals or exceeds Rupees forty, it may be paid in each year by instalments, on the first day of May for the first instalments, and on the first day of November for the second instalment, and if, in any such case, the whole amount be paid on or before the said first day of May, the person paying the same shall be entitled to a discount of two and a half per cent on the amount of the second instalment.

25. All taxes paid and penalties recovered under this Act shall by paid to the credit of the Payment of taxes raised Government of India, or

as such Government shall from time to time direct. 26. All or any of the powers and duties conferred and imposed by this Act on a Collector and on a Commissioner

ercised and performed by such other officers or persons as the Local Government shall from time to time appoint in this behalf.

Every person shall be legally bound to furnish information respecting his profession, occupation, or trade, and the annual profits arising therefrom, to any officer or person so appointed when required by him to do so.

27. The Local Government may, with the previous sanction of Salaries and establish-Governor General of Inments. dia in Council, assign such salaries as such Government may from time to time deem proper to the officers appointed un-der this Act, and allow such establishments for their respective offices as may be necessary for the purposes of this Act.

28. The Local Government may, from time to time, with the previous sanction of the Governor sanction of the Governor Local Government empowered to make rules. General of India in Council, make rules for the guidance of officers in matters connected with the enforcement of this Act, provided that such rules are not inconsistent with any of the provisions herein contained.

29. This Act shall come into operation on the first Commencement of Act. day of May 1868.

STATEMENT OF OBJECTS AND REASONS.

The present Bill proposes to repeal and re-enact with some modifications, the License Act and the amending Act XXIX. of 1867 under the title of a Bill for taxing professions, occupations, and trades.

The principal changes which the Bill will introduce are these:—

The License Act taxes traders whose profits are Rupees 200. The Bill only applies to cases where the profits equal or exceed Rupees 500.

The Act comprises within one class all profits amounting to Rupees 25,000, and upwards. The Bill here makes three classes, the highest class commencing at Rupees 1,00,000, the second, at Rupees 50,000. The Act comprises in its Class IV. profits from Rupees 1,000 to Rupees 5,000. The Bill here has two classes, the higher class commencing at Rupees 2,500.

The rate of the tax imposed under the Act was two per cent. on the lowest income in each of the six classes. The Bill lowers this rate to 1.6 per cent., except in the case of official incomes, where it adopts an uniform rate of one per cent.

SIR,—I transmit to your Excellency in Council a copy of a letter which has been addressed to this Department, by direction of the Lords Commissioners of Trade, enclosing a copy of a Despatch from Her. Majesty's Chargé d'Affaires at Washington, which forwarded a Circular put forth by the Government of the United States of America in which vessels bound for that country are warned that they must be furnished withfull manifests of cargo.

From Thomas Gray, Esq., to the Under Secretary of State for India,—dated Whitehall, Board of Trade, the 25th January 1868.

SIR,—I am directed by the Board of Trade to transmit to you, to be laid before Secretary Sir Stafford H. Northcote, a copy of a Despatch received from Her Majesty's Chargé d'Affaires at Washington, enclosing a copy of a Circular issued by the United States Government respecting the necessity of vessels bound for the United States being provided with full manifests of cargo.

The Board of Trade have reprinted the Circular, a copy of which is annexed, and caused it to be distributed at the Ports in the United Kingdom, and I am to suggest, for the consideration of Sir Stafford H. Northcote, whether it may not be desirable for steps to be taken to bring it to the notice of persons interested in shipping at Ports in Her Majesty's possessions in India.

From Francis Clare Ford, Esq., to Lord Stanley, M.P., &c., &c., &c., -No. 36, dated Washington, the 12th November 1867.

My Lord,—I have the honour to inform your Lordship that two cases have been brought to my notice by Her Majesty's Consul at Baltimore, in which the Masters of British Vessels, the Jenny Lind and the Magic, having recently arrived at that Port, the former from Puerto Rico, and the latter from Greenock, were fined the sum of \$500 each in consequence of their being unprovided with manifests of their ships' cargo.

On application from the consignees of the respective vessels the entire fine was remitted in the case of the Jenny Lind, but a portion only in that of the Magic.

I have ascertained, however, from the Department of State, that should the consignce of the Magic apply for my official intervention in the matter, it will meet with the favourable consideration of the Government of the United States.

I beg to enclose herewith to your Lordship a copy of the Circular that was issued by the Department of State to the Consular Officers of the United States, calling their attention to the 25th Section of an Act approved on the 18th of July 1866, and which was to come into force on the 1st of March of the present year, by which an Act passed on the 2nd March 1799 relating to the manifests was made applicable to vessels owned in whole or in part by Foreigners, as well as to vessels of the United States. The 26th Section of that Act fixes a penalty of a sum not exceeding \$500 for a violation of it. Owing, however, to this provision of law not having passed at the recommendation of the Department of State for the United States, some delay inadvertently occurred in issuing the Circular to their Consuls, and for that reason I anticipate no difficulty in obtaining a remission of such penalties as may hereafter be inflicted on Masters or Consignees of British Vessels, provided always that it can be established by them that no notice was given to them of the New Act by the Consular Officers of the United States at the Ports from which their vessels may have sailed.

INSTRUCTIONS TO SUPERINTENDENTS.

Vessels bound for the United States to be provided with Manifests of Cargo.

The Board of Trade have received a copy of a Circular, issued by the United States Government, respecting the necessity of vessels bound for the United States being provided with full manifests of cargo. As the subject is important, the accompanying copy of the Circular in question is forwarded for the Superintendent's information and for the information of Shipowners and Masters in his Port.

DEPARTMENT OF STATE, WASHINGTON D. C., August 13th, 1867.

To the CONSULAR OFFICERS of the UNITED STATES.

Your attention is called to the 25th Section of the Act entitled "An Act further to prevent Smuggling, and for other purposes," approved July 18th, 1866, which is as follows:—

"Scc. 25. And be it further enacted, that, on and after the first day of July next, the several provisions of the Act entitled 'An Act to regulate the collection of duties on imports and tonnage,' approved March two, it seventeen hundred and ninety-nine, relating to manifests, shall apply as well to vessels owned in whole or in part by foreigners as to the United States; and that the Secretary of State send copies of this section to all conular officers of the United States in foreign countries."

S Your attention is also called to the fact that, by section 3 of chapter 42 of the laws of the second session of e 39th Congress, the section above quoted was amended by inserting the word "March" in place of the Librd "July" therein.

It will be seen that the law has already gone into effect, which places vessels owned in whole or in part by foreigners upon the same footing as vessels owned by citizens of the United States, so far as the production of of manifests is concerned.

You are therefore instructed to inform the Masters of all vessels leaving your port for the United States that they are required to produce manifests in accordance with the provisions of section twenty-three (23) of the Act, to regulate the collection of duties on imports and tomage, approved March 2, 1799, a copy of which is hereto annexed. (Statutes at Large, vol. I., p. 644.)

NOTIFICATION BY THE HIGH COURT OF JUDICATURE, BOMBAY.

The following Rules for the examination of candidates for the Office of Moonsiff are published in supersession of all former rules on the subject:—

- 1. An examination of candidates for the office of Moonsiff will be held annually in Bombay, in the month of March or April. Due notice will be given in the Government Gazette of the days and place of examination.
- 2. The examination will be conducted by a Committee appointed by the Chief Justice and Judges of Her Majesty's High Court of Judicature at Bombay. All applications to the Committee are to be addressed to the Registrar of the High Court, Appellate Side.
- 3. Any natural born subject of Her Majesty who shall be desirous of qualifying himself for the appointment of Moonsiff will be entitled, on application to the Committee, to be examined at any such examination, provided he shall, on or before the first day of January preceding the examination, have transmitted to the Committee, with his application:—
 - (a).—A certificate showing the place of his birth, and that his age at the date of the examination will be more than twenty-five years.
 - (b).—A certificate that he can speak, read, and write with case and correctness one or more of the vernacular languages which are used in the District Courts of the Bombay Presidency, viz. Mahratta, Guzerathec, and Canarese, and also that he has a similar knowledge of the English language.
 - (c).-Satisfactory proof of good moral character.
 - (d).—A fee of Rs. 25, for which a receipt will be furnished by the Registrar, and which will be returned if the candidate's certificates are not considered by the Committee to be satisfactory.
- 4. If the candidate resides in Bombay, his certificates must be signed by the Head of the Department in which he has served, if the candidate is a Government Servant, or by the First Judge of the Court of Small Causes at Bombay, or by the Principal of some College or other Institution recognized by the University of Bombay, or by a Professor of the Government Law School.
- 5. If the candidate does not reside in Bombay, his certificates must be signed by the Judge of the District in which he has resided during the twelve mouths immediately preceding the date of application; or if, during such preceding twelve months, he has resided in more than one District, then his certificates must be signed by the Judge of each District in which he has so resided. If the candidate has not resided for twelve months in any District of the Bombay Presidency, then his certificates must be signed by the Chief Officer or Officers having civil authority in the place or places where he has been so residing.
- 6. In any case in which a doubt may arise as to the eligibility of a candidate in respect of age or character, such enquiries as may be necessary will be made by the Committee.
- 7. The Registrar will publish in the Government Gazette, under the orders of the Chief Justice and Judges of the High Court, within a reasonable time before the date fixed for the examination, a list of the candidates whose applications are admitted.

The examination will be conducted in the English language in the following subjects, and the merit of each candidate will be estimated by marks, the number set opposite to each subject in the following list denoting the greatest number of marks that can be obtained in respect of such subject :-

- 10. No candidate will be allowed any marks in respect of any subject of examination unless he shall be considered to possess a competent knowledge of that subject.
- 11. The examination will be conducted by means of printed questions and written answers, and by vivá roce examination, as may be deemed necessary.
- 12. The marks obtained by each candidate in respect of the several subjects of examination will be added together, and each caudidate who has obtained at least one-third of the total number of marks which can be obtained in respect of each subject of examination, and at least two-thirds of the total number of marks which can be obtained in respect of all the subjects, will be held to be duly qualified for appointment as a Moonsiff; and a list of qualified candidates will be published, under the orders of the Chief Justice and Judges of the High Court, in the Government Gazette, after the close of the examination. In the published list, the candidates will be ranked in their order of merit as determined by the macks obtained by them.
- 13. Each candidate who has passed the examination will receive a certificate of qualification signed by the Registrar.
- 14. The first examination under these Rules will be held in 1869, and, after the 1st January 1871, the the Chief Justice and Judges of the High Court will not appoint to the office of Moonsiff any person who has not obtained a certificate of qualification under these Rules.
- 15. No person who has obtained a certificate of qualification will be appointed a Moonsiff in any District unless the Chief Justice and Judges of the High Court shall be satisfied that he is sufficiently acquainted with the language of the District.
- Any person who shall have obtained a certificate of qualification under these Rules will be entitled, without further examination, to apply for a sunnud authorising him to practise as a pleader in the Civil Courts of any District of the Bombay Presidency with the vernacular language of which he has been certified, under Rule 3, to be acquainted.

CCXI. Several instances having occurred of letter bags having been opened during transit, the Commanderin-Chief prohibits any one from stopping the Postal Sowars when en route from station to station, and from opening the Mail bags they carry, under any pretence whatever.

Separate packets of letters for each station should be carefully made up, enclosed in linen or paper, and distinctly addressed to the Officer in charge of the Post Office at the station for which they are destined, by whom alone they are to be opened.

As continual delays occur in the transit of letters, owing to the Postal Sowars not being ready to take them on, the Commander-in-Chief desires that at each station, two Sowars may constantly be kept in readiness, by day and night, and that strict orders be given that they carry on the Mails directly they arrive.

CCXII. In future, all Regiments and Detachments leaving Senafe or other Highland Stations, for the front will be provided with rations for 15 days, to be received into Regimental charge and issued agreeably to scale und Regimental arrangements, the Commissariat limiting its operations to the supply of Medical Comforts, the purchas and supply of slaughter cattle, grass, grain, wood, and any other article such as ghee, flour, bread, &c. which make procurable locally. The last mentioned articles must be received and issued whenever tendered by the Commissariat, the similar ration articles in Regimental charge being kept intact so far as such local issues will admit. All empty bags, &c. must be carefully preserved and returned to the Commissariat.

The Transport Train Mules, attached to Regiments, &c., that become unloaded as rations are consumed, must be delivered over day by day to the Officer in charge of the Transport Train, who will place them at the disposal of the Commissariat Officer for the carriage of local purchases made over and above that which is required for daily use.

Overland Postage Rates on Army Officers' letters.—Instructions having this day been received from the London General Post Office altering from full ounces to half-ounces the scale of progression of weight for Letters between India and the United Kingdom sent to or by Officers of the Army in India, this Postal Notice will supersede that issued by this Office on the 29th ultimo, No. 5.

2. It will be observed that the only change now made is the imposition of four annas per half oz. in

lieu of 8 annas per oz. on Letters weighing more than one ounce.

3. Under the authority of the Treasury Warrant, published in page 490, Part I. of the Bombay Government Gazette, dated 26th December 1867, the correspondence of Officers of the Army in India is excluded from the operation of the increased rates of Postage on letters passing between India and the United Kingdom, intimated in this Office Postal Notice No. 4, dated 26th instant, and will be charged, the uniform rates below mentioned, in which Inland Postage has been included.

4. Letters entitled to the privileged rates laid down in the Warrant, may be classed as follows, and must be subject to the conditions enumerated. Should any of these conditions not have been regarded, the cover will

be considered an ordinary Overland letter, and treated accordingly:

I.—LETTERS POSTED IN INDIA.

(a.) The Sender must be a Commissioned Officer of the Army, actually employed (otherwise than in Civil employ) in Her Majesty's Service in India.

The letter must be one addressed to the United Kingdom, ... (6.)

(c.)

The letter must bear by way of superscription—

1. The signature of the Commissioned Officer who sends the letter.

2. The signature of the Commanding Officer of the Regiment, Corps, or Detachment in which the sender is serving, or of the Local Head of the Department to which he belongs.

3. A specification by the Commanding Officer or Local Head of the name of the Regiment, Corps,

or Detachment in which the Officer is serving or of the Department to which he belongs.

... II.—LETTERS DELIVERED IN INDIA.

The letter must be one which has been posted in the United Kingdom.

(b). It must be addressed to a Commissioned Officer of the Army actually employed (otherwise than in Civil employ) in Her Majesty's Service in India.

(c). It must bear by way of superscription,-

1. The rank of the addressee; and

The Regiment, Corps, or Detachment in which he is serving, or the Department to which

he belongs.

5. As regards the term "Civil employ," it will be proper to regard all Military Officers serving under the orders of the Civil Administrations (i. e. not under the orders of the Commander-in-Chief) as being in Civil employ. For instance, Military Officers belonging to the Survey, Public Works, Education, Telegraph, Post Office, Police, Jail, and other similar Departments, as well as Scoretaries to Government, Cantonment Magistrates, Commissioners, Deputy Commissioners, Civil Surgeons, &c., will be regarded as being in Civil employ.

The condition that the Officer must be "actually employed" in Her Majesty's Service in India,

excludes Officers who may be on leave from a title to claim the privilege.

7. The term "Local Head of a Department" may be regarded as meaning the Chief Officer of the Department in the station where the letter is posted.

Increased Rates of Postage on Overland Letters.—Under instructions this day received from Her Majesty's Post Master General, it is hereby notified for the information of the public, that the single rate of postage on Letters sent between the United Kingdom and India, viá Southampton, has been raised from 4 Annas to 6 Annas, the rate on those forwarded viá Marseilles by British Packet, or by French Packet, being in like manner raised from 6 Annas 8 Pie to 8 Annas 8 Pie.

Unpaid Letters, whether forwarded viá Southampton, viá Marseilles, or by French Packet, will be liable, in addition to the foregoing rates, to a fine of 6 Annas, and insufficiently paid Letters will be liable to the deficient postage, and a like fine of 6 Annas.

All Letters forwarded from India through the United Kingdom to Foreign Countries or British Colonies will in like manner be subject to an additional charge of 2 Annas per ½ oz. over and above the rates which have heretofore been chargeable in India.

It has also been decided to alter the scale of progression for charging Letters above the weight of ½ oz., and to adopt a scale of charge rising by half ounces.

The above changes have been ordered with effect from the 1st April next; Letters posted in India on or after that date being subject to the new rates.

The following Table shows the rates chargeable in India, under the abovementioned provisions, on Letters addressed to the United Kingdom:—

Note.—The change in rates does not, as will be observed, affect Newspapers, Books, or Patterns, and it applies only to Letters sent to or through the United Kingdom. The charges for instance on Letters sent to Foreign Europe via France or via Trieste, or through the British, French, or Austrian Post Offices at Alexandria, or to Malta or Gibraltar, or British Colonies in Asia, are not affected by the present alteration.

Postage to the United States.—The public are hereby informed, that, under a new Postal Convention concluded by Her Majesty's Postmaster General with the United States of America, the postage chargeable on letters sent from England to the United States has been reduced, provision being also made for the transmission of Book and Pattern Packets.

2. Under the new arrangement, the consolidated rates of postage (including the increased rates recently ordered between India and the United Kingdom) chargeable on Letters, Newspapers, and Book and Pattern Packets, addressed to the United States of America, will be as follows, viz.:—

The conditions in respect to the mode of packing, maximum weight, &c., of Book and Pattern Packets addressed to the United States of America, will be the same as those relating to Packets addressed to Great Britain.

Postage to places in Turkey.—Under instructions from Her Majesty's Post Master General the following rates of postage will be chargeable in India, on correspondence addressed to Europe "via Trieste," or sent through the Austrian Post Office at Alexandria, to places* in Turkey where there are Austrian Post Offices.

The full prepayment of these rates is in all cases compulsory, and they do not carry the covers to destination, being in fact only the Indian and British Packet rates. The Austrian rates cannot be prepaid in India.
