I beg to forward herewith copy of the Chemical Examiner's report on the sample of black writing ink submitted by Amrita Lal Roy, and to state, as requested in your letter No. 2143, dated 23rd December last, that the ink is, no doubt, manufactured in India, and is of good quality, having fairly withstood the tests of the Chemical Examiner. The price is Rs. 2 per dozen quarts, and is cheaper than Dr. Waldie's ink (the cheapest of the samples formerly reported on) by 4 annas per dozen. In deciding upon the contract to be entered into for the ensuing year, full consideration will be given to the merits of Amrita Lal Roy's ink as compared with other samples tendered, from every point of view, mere cheapness not being the only desideratum.

2. This report has been kept back by me in the hope of being able also to report on Mr. George Law's sample of ink, which was not received till last month, after I had applied to him. The Chemical Examiner has not yet furnished his report, but I may mention that Mr. Law proposes to charge Rs. 12 per dozen quarts delivered at any station in the upper Provinces. Supposing the ink to be not superior to either Dr. Waldie's or Amrita Lal Roy's samples, the relative prices of the several inks delivered at the principal stations in the North-Western Provinces and the Punjab would be as shown in the annexed statement. I am not yet in a position to state

whether the ink is equal to Stephen's ink, and could be issued in the place of it to the officers who use the latter. The comparison, so far as it goes, including Stephen's ink, shows that Mr. Law's ink is much dearer as respects the other country-made inks, but cheaper as respects Stephen's ink.

I have the honour to acknowledge receipt of your letter No. 5048, dated 30th January 1882, forwarding one bottle of ink with the following printed label:—-

"Youngman's steel jet black, writing ink, &c."

The bottle contained 15 ounces of black ink of acid re-action, and with a tar-like odour. The ink was of a good colour and flowed well.

On analysis it yielded 12.76 per cent. of solid residue by weight dried at 100° C.

The ash was equal to 1.7 per cent. by weight calculated on the ink and consisted of oxide of iron.

The action of re-agents on the ink is shown in the accompanying table.

The ink appears to be essentially a gall-ink of good quality.
