## BY HER MAJESTY'S HIGH COURT OF JUDICATURE.

The following Rules are respectively substituted for Rules 1, 2, 6 and 10 of the present Rules for the Admission of Attorneys, and shall come into force on and from this 20th day of April 1882:—

- 1. No person (other than those in the next Rule mentioned) not being a Graduate of one of the Universities following, viz., the Universities of Oxford, Cambridge, London, Durham, Dublin, Queen's University of Ireland, the Universities of Scotland and the University of Bombay, shall become an Articled Clerk to any Attorney of the High Court with a view to being admitted as an Attorney of that Court, and it shall not be promissible for any Attorney of the High Court to accept, as an Articled Clerk, any person who shall not produce to him a memorandum in writing signed by the Prothonotary to the effect that the certificate of the B.A. degree has been lodged with the said Prothonotary. Articles of Clerkship entered into under this Rule shall be for a period of service as Articled Clerk of not less than three years.
- 2. Persons who have been educated in Europe, and are not such Graduates as mentioned in the preceding Rule, but who shall appear to the Chief Justice and Judges to have been educated up to the same standard, may, by special order, be permitted to enter into Articles of Clerkship to serve for a period of not less than four years.

- 6. A person who has taken the degree of Bachelor of Laws in the University of Bombay, or in any of the other Universities, mentioned in the first of these Rules shall be admissible as an Articled Clerk on production of a memorandum in writing signed by the Prothonotary, to the effect that the certificate of the LLB. degree has been lodged with the said Prothonotary. Articles of Clerkship, entered into under this Rule shall be for a period of service as Articled Clerk of not less than two years.
- 10. An Attorney, who has been in practice in Bombay for any period less than three years, shall not be at liberty to accept any person as an Articled Clerk. Provided always that where a member of a firm of Attorneys in Bombay is about to retire from the same and from practice in Bombay, he may assign to any other member of the same firm, (although the latter Attorney may have been in practice in Bombay for a period less than three years), the Articles whereby any Clerk has been articled to the Attorney so retiring, as aforesaid.
