by inserting therein the name of any person whose name ought to be so inserted, or any property liable to the rates previously omitted, or by striking out the name of any person or any property not liable to the rates ; or by increasing, or by reducing the amount of the rates; but in all cases in which the name of a person is newly inserted, or in which any property is newly insorted as liable to the rates, or in which the rates are increased, notice of the amendment shall be given by the Cantonment Magistrate to the person interested, and a day shall be fixed in such notice for hearing complaints against such amendments, which shall be made and heard in the manner prescribed in section 8 for complaints concerning original entries in the Assessment Book.

11. When any house or building shall have been newly

built, or shall be rebuilt, or shall be enlarged so as to increase the yearly value, or when any house

or building which has been vacant is re-occupied, the owner shall give notice thereof in writing to the Cantonment Magistrate within fifteen days from the date of completion of the building, rebuilding or enlargement, or from the date of occupation of each newly built or rebuilt or enlarged property, whichever date happens first, or in the case of any house or building which has been vacant from the date of the re-occupation thereof. In default of such notice, the owner will be liable to a fine not exceeding fifty rupees on conviction before a Magistrate.

12. It shall not be necessary to prepare a new Assessment

Book every year, but the Canton-New Assessment Book need ment Magistrate may from year not be prepared yearly. to year adopt the valuations contained in the book for the last preceding year, with such alterations as may, in particular cases, be deemed necessary, as the valuations and rates for the current year : Provided always that public notice of such valuations and rates shall be given in the manner prescribed in section seven, and the provisions of the said section and of sections eight, nine and ten shall be applicable to the valuations and rates and to the book in which they are contained.

#### Appeals.

## GENERAL DEPARTMENT.

#### Bombay Castle, 16th June 1882.

No. 2240.—In exercise of the power conferred by Act I. of 1870, the following Rules for Quarantine against Cholera have been made by the Government of Bombay with the previous sanction of the Governor General in Council; they will take effect from the 16th June 1882 in the Ports of Bombay, Aden and Karáchi as a temporary measure :—

- I.—The Commander of every vessel, including buggalows or other native craft, arriving from Batavia shall, before entering the harbour, indicate by signal the port from which such vessel has come.
- II.—Such Commander shall not, except as hereinafter provided, allow any communication, either with the pilot boat, except orally, or with the shore, or with any other vessel or boat in the harbour.
- 111.—Immediately on any such arrival being signalled, the Health Officer of the port shall go alongside the vessel and, if communication with the shore is desired, shall direct the Commander to take the vessel to the quarantine anchorage, duly appointed and notified in that behalf, there to remain for a period of seven days from the date of arrival in the harbour, and undergo disinfection, which should apply as well to crew, passengers, effects and susceptible goods. The Health Officer shall also direct the Commander to prohibit, during the period for which the vessel remains at the quarantine anchorage as aforesaid, all communication, except such as is hereinafter provided for, between such vessel and the shore, or other vessels and boats in the harbour. If communication with the shore is not required the vessel shall not enter the inner harbour, and no communication in any way shall be allowed with the pilot boat, except orally, or with the shore, or with any vessel or boat in the harbour.

- IV.—If during the period a vessel is at the quarantine anchorage aforesaid, any case or cases of cholera should occur on board, the said vessel shall remain in quarantine for a period of seven days from the date of the last case occurring, and be subject to all the prohibitions provided for in Rule III.
  - V.—When any vessel has been placed in quarantine as aforesaid, the Health Officer may direct the removal of so many of the passengers and crew as may not be suffering from illness, and whose services may not be required on board the vessel, to such particular spots as may from time to time be selected by the local officers as places of quarantine, there to remain for a period of seven days. If a case of cholera occurs among such passengers and crew during any such period, they shall remain in a place of quarantine for a period of fifteen days from the date of the occurrence of the last case of such illness.
- VI.—Any mails or cargo which may be brought by any vessel so arriving shall be landed under such precautions as the Health Officer may deem necessary to prevent the spread of the disease.
- VII.—It will be the duty of the Port Officer to facilitate the conveyance to all vessels in quarantine of such supplies of provisions, stores and other articles as may be required by those on board. Such supplies will be placed on the boats of the vessels in quarantine to be subsequently removed by members of their crews.
- VIII.—All vessels arriving at Bombay, Aden and Karáchi which may have communicated with vessels coming from Batavia shall be subjected to the same quarantine as vessels arriving at Bombay, Aden and Karáchi from Batavia.
- IX.—All vessels which have undergone quarantine in the manner above prescribed should have the fact clearly stated on their Bills of Health.
