NOTIFICATIONS.

FINANCIAL DEPARTMENT.

Bombay Castle, 7th March 1882.

No. 835.—In supersession of the rules of the Government Savings' Bank, Bombay, published at pages 521—523 of the Bombay Government Gazette, Part I., dated 22nd June 1876, the following amended Rules are published for general information :-

> "REVISED RULES FOR THE BOMBAY GOVERNMENT SAVINGS' BANK.

Principles.

1.-Subjoined are the revised rules relative to Government Savings' Banks published under Government of India Financial Resolution No. 461, dated the 9th May 1881 :-

I.—In these Rules—

'Depositor', 'Deposit', and 'Secretary' bear the meaning which they bear in The Government Savings' Bank Act, 1873.

'Account' means the account of a Depositor in a Government Savings' Bank.

'Balance' means the balance at credit of an account.

II.—Any person may become a Depositor on his own behalf, or on behalf of any other named person dependent upon him. Deposits may also be made by the Managers of Benevolent or other Public Associations or by Public Officers, of money deposited with them ex-officio as security for the discharge of any public duty or for the fidelity of any Public Officer, or for the accomplishment of any public object.

III.—Subject to the provisions of these Rules, the Government of India guarantees the repayment of every deposit, with interest.

IV .- Without the sanction of the Comptroller General, no Account will be opened for less than One Rupee, and no person may deposit more than Five Hundred Rupees, in all, between the 1st of April in any year and the 31st March of the following year.

V.—Interest will not be allowed upon a smaller balance than Rs. 13, or upon the excess in any balance over the highest multiple of Rs. 13.

VI.—Interest will be allowed for each Calendar Month upon the minimum Balance of the Account between the close of the Fourth Day and the end of the Month.

VII.—Till further notice, interest will be allowed upon deposits at the rate of one pie a Month for every Rs. 1-10-8, which is equal to one anna for every Rs. 20, being at the rate of Rs. 3\(^3\) per centum per annum. Without the sanction of the Comptroller General, no higher Monthly Interest will be allowed upon any Balance than Rs. 9-6; being the interest upon Rs. 3,000.

In calculating interest, one anna will be taken as the interest for one month on every twenty rupees of the amount entitled to bear interest; and for broken sums below twenty rupees the following table will be used:—

VIII.—Every Account will be made up on the 31st March, and the interest then due, calculated under these Rules, added to the Balance upon which future interest will accrue. If an Account is closed on any other date, interest due to the end of the preceding Calendar Month will be paid to the Depositor: but a Depositor who closes an Account should not, ordinarily, be permitted immediately to re-open it, except on payment of a fine varying at the discretion of the Secretary from One to Ten Rupees.

IX.—Whenever a Depositor changes his residence, an Account may be transferred, free of charge, to the Government Savings' Bank in the District to which the Depositor is removing. Without the special permission of the Comptroller General, an Account may not be otherwise transferred from one Bank to another.

X.—A Deposit Book will be supplied to each Depositor, in which the Secretary, or, if the Savings Bank is at a Public Treasury, the Treasury Officer, will acknowledge every Deposit. The personal attendance of a Depositor is not required; but no Deposit will be received, or payment made, without the Depositor's Deposit Book, and the Government will not be responsible for any Deposit the receipt of which is not acknowledged in a Deposit Book. The interest, due to date, will be entered in each Deposit Book the first time that it is produced after the 31st March. The first Deposit Book will be supplied free of charge; but, if a Deposit Book is lost or injured, or if a Closed Account is re-opened, One Rupee will be charged for a new book.

XI.—Without special permission, a Depositor may not draw upon his Account more than once in thirty days, or open more than one Account in his own name or in the name of any member of his family or for his own benefit or the benefit of any member of his family, The Comptroller General must take precautions to prevent any transgression of this Rule, and, in particular, any employment of an Account as an ordinary drawing Account. This Rule is not meant to prevent any one from opening more than one ex-officio or public Account.

XII.—The Secretary may refuse to open any Account or may close any Account, for any sufficient reason, as, for example, because he thinks that the Account is likely to be used, or is being used, contrary to the object with which Government Savings' Banks are established, namely, the encouragement of saving.

XIII.—When the Secretary thinks it proper to close any Account, he shall give notice in writing to the Depositor, of such closure. After the date of such notice, no Deposit shall be accepted on the Account so closed and no interest shall be allowed upon the Balance of the Closed Account after the end of the Calender Month then current.

XIV.—These Rules apply as well to Accounts opened before as after their publication. Save that upon Accounts opened before the date of this Resolution, interest will be calculated, up to 31st May 1881, at the rate of 4½ per centum per annum, according to the rules prescribed in Nos. V, VI and VII of the Resolution No. 3528, of 27th October 1880.

XV.—(1) Any person, whether a Depositor or not, who desires to purchase Government Securities, may make written application for the purpose at a Savings' Bank. He will be required to tender in cash the amount necessary to complete the purchase, unless he has a sufficient deposit at his credit in the local Savings' Bank. The purchase will be made through the Comptroller General.

(2) The paper purchased will be of the 4 per cent. Loans, unless $4\frac{1}{2}$ per cent. paper is specially applied for.

(3) The investor may also specially apply that the paper remain in the custody of the Comptroller General and that the interest be remitted as drawn to the local Savings' Bank, for delivery to him. In this case the Comptroller General will, if necessary, transfer the paper to the 4 per cent. Loan of 1865, and will remit the interest as applied for. The investor may at any time apply through the local Savings' Bank for the delivery to him of paper thus held by the Comptroller General. If application is not made under this clause the paper purchased by the Comptroller General will be enfaced for payment of interest at the local Treasury, and forwarded to the Savings' Bank for delivery to the investor.

(4) An investor under these Rules may at any time apply in the same way for the sale of paper purchased through the Savings' Bank, whether held by himself or held for him by the Comptroller General.

(5) These arrangements are intended only for persons of moderate income, who belong to a class who do not ordinarily have transactions with Bankers; and the advantage of them must be refused, both by the Savings' Bank and if necessary by the Comptroller General, if the applicant is not within this definition, except in the case of a Government servant purchasing Government paper in consequence of an order requiring him to give security.

(6) In the case of applications made at Savings' Banks at Treasuries in the interior of the Madras and Bombay Presidencies, the duties here laid upon the Comptroller General will be performed by the Accountants General of Madras and Bombay respectively. And in the case of applications made at the Presidency Banks in the Towns of Calcutta, Madras and Bombay, they will be performed by the Secretaries of those Banks, in the capacity of Secretaries of the Presidency Savings' Banks.

(7) The following fees will be charged:

On purchases: 4 annas per cent.

On realisation and remittance of interest: 4 annas per cent.

On delivery out of custody: 4 annas per cent., unless the application for delivery is made within a year of the purchase.

On sales: 4 annas per cent., and any actual outlay upon brokerage.

These fees may be appropriated by the Presidency Banks, in the case of applications made in the Towns of Calcutta, Madras, and Bombay, and complied with by the Secretaries of the Banks.

XVI.—The Governor General in Council reserves the right to alter or add to these Rules at any time.

XVII.—A copy of the Government Savings' Banks Act, 1873, and of these Rules, shall be printed in each Deposit Book delivered after this date, and the signature, or, if he cannot write, mark, of the Depositor obtained to the annexed declaration before any deposit is accepted from him.

XVIII.—These Rules shall come into force from the 1st June 1881.

Declaration to be recorded in accordance with Rule XVII.

Management.

2.—A Committee nominated by Government will exercise general supervision and control over the proceedings of the Bank. The Accountant General will be ex-officio a member of the Committee.

3.—The Secretary and Treasurer of the Bank of Bombay will be ex-officio Secretary to the Bank, and will have immediate charge of the Establishment and be held responsible for the duties of the Bank being conducted in accordance with these rules, the further orders which Government may from time to time issue, and the instructions of the Committee.

4.—The Collector of a district will, for all administrative purposes, exercise, in his district, the powers of the Secretary of the Savings' Bank; but, in cases which may appear to be inconsistent with these rules, he will refer questions to the Accountant General through the Head Office.

Business arrangements.

5.—The Government Savings' Bank will be open for business every day, Sundays and holidays excepted.

Nature of Accounts.

6.—No person should be permitted to resort to the Savings' Bank as a place for the deposit of a floating balance, on which he will operate constantly by depositing and withdrawing money. The Secretary has full discretion to close such accounts.

More than one withdrawal in the same month under the same account should not be allowed without the special permission of the Secretary given for assigned reasons. 7.—No non-official accounts should be opened in the name of two or more persons jointly, nor should any trust accounts be allowed.

This is a prohibition of accounts of trust, not of deposits on behalf of minors, &c.

Corporations.

8.—There is no objection to an account being opened with the Savings' Bank in the name of a Corporation or Committee, provided that it be notified at the time what officer of the Corporation or Committee may draw upon the account, and by whom such officer is appointed, and that the name of the incumbent of the office and any subsequent change of incumbent be regularly notified to the Bank, which in its turn should report the change to the Head Office-provided further that the restrictions applicable to single depositors are observed, viz., that not more than Rs. 500 are deposited in one official year, i.e., from 1st April to 31st March, and that the Bank is not made a convenience for keeping a current account. If, however, it is desired to have a larger account the orders of the Head Office should be applied for with full particulars as to the character of the' account.

Note.—This rule does not apply to Municipalities whose revenue is the produce of taxation, as they are not permitted to become depositors in the Savings' Bank, and are not within the objects of Savings' Banks, as defined in No. II of the rules reprinted under Rule I.

9.—Special Accounts may be allowed to benevolent institutions or to quasi-public associations, provided that the funds are of a cumulative character, and that it is not intended to employ the Bank for the custody of mere floating deposits. The provise in the last rule regarding the officer who may operate on the account applies here also.

No plural accounts.

10.—Speaking generally, no person, who already has an account in a Savings' Bank, should be permitted to open another in the same or in another Bank. This rule, however, is not intended to debar persons from opening one or more accounts in their official, as distinct from their private capacities, provided the accounts opened in the official capacity are entirely for official and not private funds.

An account may be opened in the name of the wife of a man who already has an account, if the money is the earning or property of the wife.

Security Deposits.

11.—Security deposits lodged with Government officers will be received on the following terms. The money will be received directly from the person depositing it, and the account will be opened in his name: he will be required to sign a letter (Form I.) addressed to the Secretary to the Savings' Bank, undertaking not to make any claim on the Bank, for the principal of the sun deposited, except with the express written sanction of the Government officer; not to object to the payment by the Bank to the Government officer upon his claiming it, and not to make any claim for the interest after such officer. shall, have revoked the authority to him to receive it.

Money Limit.

12.—The limit of Rupees 500 for a single Depositor within one year may be exceeded only in the following cases:—

- (1) A security deposit of any person serving under Government, but not that of a contractor (Rule 11).
- (2) A benevolent or quasi-public institution (Rule 9).
- (3) A transfer from another Bank, so far as the money transferred is not on account of deposits made in the current year. (Fifth correction.)

In each case the reason for allowing it must be explained on the monthly statement of deposits.

The limit of Rs. 500 is to be construed strictly; withdrawals must not be deducted in applying it.

Opening an account.

13 .- To a Depositor opening an account, a passbook (see Rule 17-) is given which bears the number of the Depositor's account. The Depositor's name, occupation (see annexure A) and residence must be entered in the pass-book in a clear hand; when a Depositor can write, his signature should also be taken. If the account is a security deposit, the fact should be stated. personal attendance of a Depositor need not be insisted on, either when he opens an account, or on any other occasion; but before any deposit is accepted, the signature (or, if he cannot write, the mark, duly witnessed) of the Depositor must be obtained to the declaration prescribed in the rules published under Financial Resolution dated 9th May 1881 (reprinted under Rule I). Accordingly when a Depositor does not appear personally to open an account, a copy of the rules prescribed in the above Resolution should be sent to him together with the form of declaration. The latter must be duly signed and returned with the rules; and the money tendered for deposit must not be accepted pending its receipt.

The numbers given to the Depositors' accounts should be consecutive, and a Depositor's number should never be altered, nor should the numbers of closed accounts be given to new Depositors.

If a Mahomedan Depositor, on opening his account, makes the express request that interest be not added to his deposit, a note to this effect should be made in the pass-book, and the words 'no interest' written on the top of his account in the ledger.

On first opening an account, the pass-book is given without charge; but a fee of one Rupee is charged for a new pass-book, when the old pass-book has been lost or so soiled or injured in the Depositor's possession as to require renewal. It is to be understood that if a pass-book is lost, the Depositor will not be allowed to transact business until he obtains a new one; and when an account is closed, the Depositor should not be allowed to open a new one within twelve months, except on payment of a fine varying, at the discretion of the Secretary, from one to ten Rupees.

Minors' Accounts.

14.—A person depositing money on behalf of a minor should be warned that such money cannot be withdrawn during the owner's minority, except by a legal guardian; a term which the Government of India have decided includes the father or, if the father be not living, the mother, of the minor. If it is desired that the minor shall be able to withdraw the money, the minor must deposit it himself—see Act V of 1873, Section 10.

15.—When money is deposited by another person on behalf of a minor, the following words should be added to the notice printed at the end of the pass-book:—

'Deposits are repayable only to the properly constituted guardian of the minor during his minority'—

The nazir of Civil Court appointed by the Court guardian of a minor's estate cannot, in that capacity, become a depositor in the Savings' Bank. The proper place for his account is 'Civil Court Deposits'.

16.—Native women not accustomed to appear in public may be allowed to open accounts and deposit money in the Savings' Bank through their husbands or other agents, provided business is transacted by the persons through whom the accounts were opened, and any change of agents is notified to the Bank, which should report the change to the Head Office. The agent on opening the account should sign a declaration that the Depositor has read the rules published in Rule 1, or that they have been read to her.

Receipt of Deposits.

17.—The amount tendered for deposit should be paid with a chalan, which will be signed by the Treasurer and made over to the Savings' Bank clerk, in order that the amount may be entered in the Journal of Deposits received, and in the Depositor's pass-book. An acknowledgment will be given in the pass-book signed by the Savings' Bank clerk and countersigned by the Treasury Officer for every sum deposited—the book being initialled by the Treasury Officer after comparison with the journal, and delivered to the Depositor.

Fractions of a rupee should not be received in deposit.

Repayment of Deposits.

18.—When a Depositor wishes to withdraw money personally he should fill in a slip containing these particulars only:—

This slip he will hand in, together with his deposit book, and the necessary entries will be made in the Bank's books before payment is made. A stamp must be affixed to the slip if the amount exceeds Rupees 20, and the payment should be entered in the pass-book.

Repayment in absence.

19.—When a Depositor withdraws money without attending personally, he will send his passbook to the Bank with a letter of authority naming the person to whom payment is to be made. A receipt stamp should be affixed, when necessary, to the payee's slip (or receipt) mentioned in the preceding rule.

The Secretary or Treasury Officer should then make reasonable examination and enquiry as to the genuineness of the authority produced by the payee from the Depositor, and the identity of the payee.

The payment must in all cases be made at the Bank; Treasury Officers are forbidden to remit

the amounts to Depositors.

- Notes 1.—Deposits and withdrawals should be neatly written in the pass-books, and particulars confined to the space given. They should also be certified by the initials, and not by the full signature of the Treasury Officer.
- When a Depositor requests his accounts to be finally closed, his pass-book must be sent to the Bank for that purpose.

Investment of Savings' Bank Balances in Government Loans.

- 20.—(a). If a Depositor wishes to have the balance at his credit or any portion of it invested in stock of any loan, he should apply in writing to the Treasury Officer, who will forward to the Head Office a copy of the application with a statement of the balance at credit of the account, making a note in the account in order to guard against any intermediate withdrawal of the amount to be invested.
- (b). On receipt of the application the Head Office will make the purchase, and instruct the Treasury Officer to debit the purchase money as well as four annas per cent. commission on it to the Depositor's account.
- (c). The Treasury Officer should treat the purchase money of Government Securities and the commission as withdrawals. Interest on the purchase money of Government Securities being allowed to the end of the month preceding that of investment.

Disposal of Securities.

- 21.—(a). If a Depositor wishes to take delivery of Government Securities, or to sell them, he should apply in writing to the Treasury Officer, who will forward a copy of the application to the Head Office.
- (b). On receipt of the application the Head Office will surrender the Notes, or forward the sale proceeds through the Treasury Officer. But a commission of four annas per cent. will be charged on the nominal value of the papers, when delivered, and on their proceeds when sold. Any brokerage to be paid should be defrayed from the proceeds.
- (c). So long as the Government Securities remain in the custody of the Head Office, interest, when due on them, will be drawn and advised to the local Bank for credit to the Depositor's account less commission of four annas per cent. For this purpose the notes should be endorsed to the Secretary, Government Savings' Bank.
- 21 A.—If any person, not a Depositor, wishes to purchase or sell a Government Security, he should apply in writing in form No. 2 or 3 to the Treasury Officer, who will open a temporary account to receive the price of the Security, and will in other respects follow the procedure laid down in the preceding rules—

- 1. In the case of purchase, a pass-book need not be delivered, if the note is to be returned at once to the applicant, since the balance will be repaid to him when he takes his note; his receipt will be taken upon the ledger. Otherwise a pass-book should be given, as the account will remain open to receive the interest remitted from time to time. The procedure will be the same when a note is sold.
- 2. As regards the cities of Calcutta, Madras, and Bombay, and the Presidencies of Madras and Bombay, see Rule XV-6, printed in Rule 1.
- 22—(a). The Head Office will also receive for safe custody from Savings' Bank Depositors Government Promissory notes to a moderate amount. The notes duly endorsed to the Secretary and Treasurer, Bank of Bombay, should be forwarded to the Treasury Officer with a written application accompanied by the Depositor's passbook.
- (b). The Treasury Officer will, after entering them in the pass-book (which he will return) send them with a copy of the application to the Head Office, which will deal with them as described above; and when a note is returned or sold, the fact should also be recorded in the pass-book. The commission of four annas per cent. mentioned above will be charged when notes are sold or surrendered to the Depositor.
- 23. A Register will be kept for the record of Promissory notes purchased or received, and sold or returned.

Addition of Interest.

- 24.—At the end of every month the 'Principal or lowest Balance' and 'Interest' columns of every current account will be filled up. In the column headed 'Principal or lowest Balance' should be entered against each month the minimum balance of the account between the close of the fourth day and the end of the month.
- 25.—Interest which is 31 per cent. per annum, though added annually to principal, will be calculated monthly and entered in the interest column.

The rule for calculation is given in No. VII of the rules quoted under Rule 1. But it should be remembered that no higher monthly interest will be allowed upon any balance than Rs. 9-6-0, which is the interest upon Rs. 3,000.

Annual Closing of Ledger.

26.—At the end of the year, each current account will be closed by making a total of the deposits without the opening balance, entering thereunder the opening balance and interest for the year. Then the deposits, opening balance and interest should be added together, and from the total the repayments should be deducted. The remainder will be the closing balance and will agree with the last figure in the ledger column 'Balance after each transaction' plus the total of the interest for the year.

For this purpose officers in charge of Civil Treasuries will collect and forward to the Head Office the pass-books belonging to Depositors resident in their districts soon after the close of the official year.

Note.—'Treasury Officers will be careful to leave a vacant space in the pass-book after the last entry of transactions for the month of March enough for the Bank's closing entries of the account.'

The list of account-holders whose pass-books are submitted for annual adjustment should have

the names arranged alphabetically.

3. When the pass-books of Depositors in the Mofussil are sent to the Head Office to be balanced after the close of the official year, deposits may be received in the interim on separate receipts to be granted by Treasury Officers—such deposits being entered in the pass-books on return from the Head Office. But no withdrawals should be allowed in the absence of the pass-books.

Intermediate Closing of Accounts.

27.—When a Depositor wishes to close his account in the course of the year, interest to the end of the preceding month is to be credited to the account and paid to the Depositor with the principal: otherwise no payment on account of interest for the current year should be made within it.

Transfer of Accounts to another Presidency or Province.

28.—A Depositor leaving the Presidency may transfer his account, free of charge, to the Government Savings' Bank in the district to which he is proceeding. Such transfers are permitted in the following manner, except during the latter part of March, when no transfers should be allowed.

What the Depositor is to do.

- (a). Submit his pass-book either personally or by letter, naming the Bank to which the transfer is to be made.
- (b). Present his pass-book, as soon as possible, at the Bank to which the transfer is made.

What the remitting Bank is to do.

- (c). Make the following endorsement on the pass-book immediately after the last entry:—
- 'Transferred to the Savings Bank at and sign the endorsement.
- (d). Make the necessary entries in the withdrawal sheet and Depositor's account just as if an actual payment had been made.
- (e). Take the Depositor's signature on a separate piece of paper when the application, for transfer is made personally.
- (f). Return the pass-book to the Depositor.
- (g). Obtain a remittance transfer receipt, for the principal only, from the Treasury.
- (h). Send to the Bank, to which the transfer is made, the transfer receipt, with an advice of transfer, together with a copy of the Depositor's account for the current year, as well as the signature taken on a separate piece of paper or the original application of the Depositor.
- (i). Show the principal and interest separately in the advice.
- (j). Note on the withdrawal sheet, sent to the Head Office, the fact of the transfer, naming the Bank, to which transferred.

What the remitting Bank is not to do.

(k). Enter current year's interest in the passbook, or in the copy of the account sent to the receiving Bank, or in any of its books and accounts.

What the receiving Bank is to do.

(l) On receipt of the advice, remittance transfer receipt, copy of the account and the signature or letter of the Depositor, the Bank should open an account in its book free of any charge for a pass-book.

(m) When posting interest in the Depositor's ledger the amount due for the period prior to the transfer and for the time in transit should be entered separately, in lump, against the principal in the column 'Interest on lowest Balance,' care being taken that compound interest is not allowed.

(n). Make over the transfer receipt to the Treasury for credit to the Bank in the Treasury cash account.

(o). Send copy of the advice to the Head Office with the monthly deposit statement.

(p). Open the account immediately on receipt of the advice, &c., without waiting for the personal attendance of the Depositor.

What the receiving Bank is not to do.

- (q). Not to charge any fee for a fresh pass-book if it be necessary to issue one.
- (r). The transfer endorsement adverted to in Rule 29 will be dispensed with in regard to public establishments liable to be ordered on duty from one district to another.
- (s). The deposits and withdrawals in such cases will be made on the application and responsibility of the Heads of Offices—the pass-book being presented at the same time, and the disbursing officers will specially note in their list the entries of such extraneous transactions and

Transfer of Accounts within the Presidency.

29.—A Depositor desiring to transfer his account from the Head Office to a subordinate Treasury, or vice versa, should obtain the requisite authority for the refund of his deposits elsewhere, which should be effected by a transfer endorsement written in the pass-book by the Bank or Treasury Officer immediately below the lowest entry of receipts or withdrawals as follows:

Decease, Marriage, Minority and Lunacy of Depositors.

30.—The cases of decease, marriage (of women), minority and lunacy of Depositors are provided for by Act V. of 1873. The rule for minors is also stated under Rules 14 and 15.

In the case of a Commissioned Officer or European soldier of the army dying on service, the Committee of Ajdustment appointed under the Regimental Debts Act (of Parliament) 1863 have

power 'to give receipts (which shall be effectual discharges) for all or any of the credits forming part of the estate of the deceased.'

31.—The amount at credit of a deceased Depositor in excess of Rupees 1,000 shall be paid only on production of Probate of Will, Certificate granted under Act XXVII. of 1860, or Regulation 8 of 1827, or Letters of Administration.

32.—When a female Depositor changes her name on marriage, the name must be altered in the Bank's accounts or books under the initials of the Secretary or Treasury Officer, and the Head Office informed of the change.

33.—Should a Depositor become insane or otherwise incapable of managing his or her affairs, and if such insanity or incapacity is satisfactorily proved to the Secretary, he may from time to time make payments from the deposit to any proper person on the Depositor's behalf. Where a committee or manager of the Depositor's estate has been appointed, payment shall be made only to such committee or manager.

Miscellaneous.

34.—Persons residing in the Mofussil may effect the deposit and withdrawal of their savings either through the Civil (that is, the Huzúr or the Mámlátdár's) Treasury or through the Divisional Paymaster's Treasury.

35.—The Officers in charge of the above Treasuries are authorised to supply pass-books and to receive and refund deposits on behalf of the Government Savings' Bank under the foregoing rules; but every new book must be sent to the Bank that it may be registered and indexed before being made over to the Depositor.

Deposits are permitted to be received from Civil Depositors in the Military Treasure Chests at Mhow, Deesa, Neemuch, Asirgarh and Dápuli.

36.—Officers in charge of Huzúr Treasuries will communicate to the Bank monthly, according to prescribed forms, the amount deposited in and withdrawn from their Treasuries on each individual account. The receipts and payments will be credited and debited to 'Presidency Savings' Bank Deposits' under 'Debt Accounts', and the list of receipts and withdrawals sent to the Head Office.

37.—Officers in charge of Mámlatdárs' Treasuries should credit the deposits received by them in their accounts with the Huzúr Treasuries of their districts, giving full particulars regarding the deposits. The pass-book should then be forwarded to the Huzúr Treasury Officer in view to the deposits being noted therein.

38.—Refund of deposits from Táluka Treasuries will be made by means of 'Red orders' issued by the Huzúr Treasury Officer, who will note the payment in the pass-book at the Huzúr Treasury.

39.—Divisional Paymasters will forward lists of the deposits and withdrawals at their Treasuries for incorporation in and transmission with the Collector's lists as supplements to them, and that the amounts of the lists may be adjusted with the Divisional Paymaster's monthly receipts for advances from the Civil Department.

40.—Should an account be overdrawn in consequence of a withdrawal not having been duly debited or of an erroneous entry in a pass-book the amount thereof must be at once recovered from the Depositor, or made good by the officer at whose Treasury the oversight or mistake occurred.

41.—If the Secretary finds that a Depositor has opened more than one account in different names but for his own benefit, such accounts may be closed on the Secretary being satisfied of the fact.

42.—In addition to the general audit which all public accounts undergo in the office of the Accountant General, and to that which the Committee may deem it necessary personally to undertake, a particular audit of the accounts of the Bank after the close of each year will be effected by two persons to be appointed by Government.

43.—An annual General Statement of the transactions of the Bank, showing the balance at the close of the year, will be submitted for the information of Government and for publication in the Bombay Government Gazette."

Financial Resolution No. 2777, dated 1st September 1881.

Read also — Letter No. 2551 P., dated 18th February 1882, from Messrs. Burn & Co., Managing Agents of the Indian Portland Cement Company, Limited.

RESOLUTION-In the Resolution read above, the Governor General in Council directed that whenever Portland cement was required for the public service in India, it should be obtained of Indian manufacture. The Managing Agents of the Indian Portland Cement Company, Limited, now say that the Company has determined to erect, at a cost of Rs. 4,50,000, new works to enable them to meet the increasing Government demand. They represent that they 'would like to have their hands strengthened by contracts from Local Governments as authorised by the Supreme Government,' and they request that the attention of the various Departments and local authorities interested may be called to the establishment of the additional works at Raniganj, 'with the view of entering into contracts for a supply of the ce-ment for a period of five years.' His Excellency the Governor General in Council has no objection to making known the information communicated by Messrs. Burn & Co., in order that Local Governments and Administrations or Public Departments may contract for a term of years not exceeding five if they find that they can rely on obtaining cement of good quality and at prices not higher than the market prices ruling at the time of delivery for imported cement of equal quality.

ORDERED, that the foregoing Resolution be communicated to all Local Governments and Administrations and to the Public Works Department for consideration, and to Messrs. Burn & Co. for information.







Machinery in pieces will be charged by measurement or weight at option of Dock Officers; if by measurement, forty cubic feet will be considered a ton. Articles not landed on the wharf, but lowered into lighters, will not be charged wharfage but only Dock and cranage rates, unless the weight is kept suspended for more than quarter of an hour.

For lifting from the hold of a vessel and placing on deck half dock and cranage rates, but no wharfage fee, will be charged.

POLITICAL DEPARTMENT.

RESOLUTION OF GOVERNMENT.

Bombay Castle, 13th March 1882.

The mental disorder of His Highness the Rájáh Seváji of Kolhápur has been certified by a Committee of Medical Officers to afford no hope of his restoration to sanity. It has, therefore, become incumbent on Government to appoint a form of administration for the Kolhápur State, to be continued for such time as the Rájáh de jure shall be incapable of ruling in person.

- 2. Government do not desire to maintain during this interregnum the direct control of Kolhápur affairs which has subsisted, with only a brief interval, since the disturbances of 1844. The temporary administration now to be constituted will conduct public business in accordance with the traditions of the Kolhápur State, and its relations with the British Government will be regulated by the Treaties in force.
- 3. The administration of Kolhápur will be carried on in the name of His Highness the Rájáh and his style and title will be prefixed to public documents.
- 4. The affairs of the Kolhápur State will be administered by a Regent, assisted by a Council of three. The members of the Council will be the Diván, the Chief Judge and the Chief Revenue Officer. The Regent in Council will 1.—51

form the Executive Government and will deliberate and pass resolutions by vote on questions of public business submitted for orders by Heads of Departments. All engagements binding on the Rajahs of Kolhapur under the Treaty of 1862 will be binding on the Regent in Council. The appointment and removal of the Regent and the members of his Council will remain vested in Government.

4. A Journal of proceedings in Council will be kept in charge of the Diván. The names of the members present at each meeting of Council shall be noted in the Journal, and it shall be stated what members voted for and dissented from each Resolution. The Journal shall be signed after each meeting of Council by the Regent and the Diván.

5. The Regent will have a casting vote in the Council when the votes are equally divided. If the Regent decides a question under discussion by his casting vote, a member of the Council dissenting from the decision may require that the question shall be referred to the Political Agent under Article 1 of the Treaty of 1862. The Regent will possess the same right of reference, if he is over-ruled by a majority of votes in Council.

6. Effect will be given to the Resolutions of the Regent in Council by the Regent and Diván through means of orders issued to the Heads of Departments

under the hand of the Diván.

7. The State business will be distributed under the heads of General, Judicial and Revenue, and the Diván, Chief Judge and Chief Revenue Officer will respectively conduct the business of these three Departments under the control of the Regent in Council to whom they will be directly responsible.

- 8. Public finance will be in the Department of the Diván, who will place annually before the Regent in Council a financial statement and budget estimates. The accounts and budget, after consideration in Council, will be submitted for the approval of Government. Loans shall not be raised on the credit of the Kolhápur State without the previous consent of Government. The Regent in Council will adopt in the first instance the budget estimates approved under the present administration, which shall not be departed from without the sanction of Government.
- 9. The Judicial system of the Kolhápur State, as now existing, will be maintained by the Regent in Council, who will however be at liberty to propose, for approval by Government, modifications in the regulations as to the jurisdictional powers of the Judical Officers, and as to the right of appeal. The Regent in Council will be the highest Court of appeal and revision. This Court will consist of the Regent and the Diván with at least one other member of the Council when practicable. Sentences of death and of imprisonment for life are, according to the Treaty of 1862, to be submitted for confirmation by Government, who will also receive appeals from such sentences, and will exercise a general power of reviewing the Judicial administration, but will not otherwise entertain regular appeals from the Kolhápur Courts. The law in the Kolhápur State will be the law as now administered, with such modifications as may be made by the Regent in Council with the approval of Government.
- 10. The principles of Revenue administration, now in force in the Kolhápur State, will be maintained by the Regent in Council. The Survey operations in progress will be carried on to completion. New taxation will not be imposed without the sanction of Government. Alienated revenue will be dealt with strictly according to the rules respecting alienations now established in Kolhápur.
- 11. Appeals from the Executive Departments will be made to the Regent in Council, and orders will be passed on them by the Regent sitting with at least one member of the Council other than the Head of the Department against whose order the appeal is preferred.
- 12. The supervision of the Political Agent over the affairs of the higher Jaghirdars will be maintained according to the terms of Article 8 of the Treaty of 1862.
- 13. The existing assignment for the expenses of the Darbar will continue subject to future modifications to be approved by Government. The expenditure will be controlled as laid down in Article 2 of the Treaty of 1862, by a

Khásgi Kárbhári, who will conduct his duties under the immediate orders of the Political Agent.

- 14. The Administration of the Kolhápur State as above constituted will continue in power during the pleasure of Government and subject to such modifications as may from time to time be deemed necessary by the Governor in Council.
- 15. The Right Honourable the Governor in Council is pleased to nominate Jysing Ráo Ghatgé, Chief of Kágal, to be Regent of Kolhápur.

Ráo Bahádur Mahádev Wásudev Barvé, C.I.E., will continue to hold the office of Diván and will be a member of the Council.

Khán Sáheb Meherjibhái Kuvarji Tárápurwála will be Chief Judge and member of the Council.

Ráo Bahádur Yeshwant Moreshwar Kelkar will be Chief Revenue Officer and member of the Council.

The other officials of the present administration will retain their offices pending further orders."
