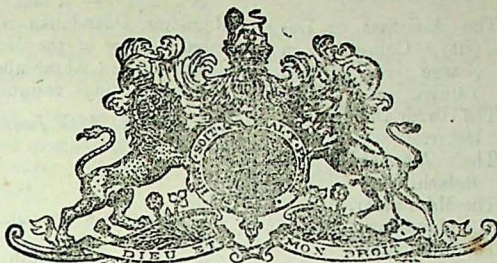

### Notifications under the Bombay Local Boards and District Municipal Acts.

#### GENERAL DEPARTMENT.

*Bombay Castle, 10th June 1901.*

No. 3276.—Under Section 144 of the Bombay District Municipal Act, 1901, the Governor in Council is pleased to confer on the City Municipality of Poona all the powers specified in sub-section (2) of the said section.
