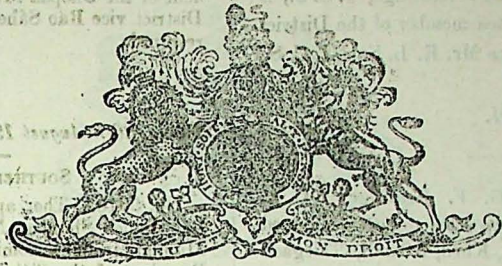

No. 4884.—In exercise of the power conferred by Section 27 of the Bombay Local Boards Act of 1884, His Excellency the Governor in Council is pleased to appoint Khán Bahádúr Ratanji Edulji Kanga to be President of the Táluka Local Boards of Broach and Jambusar in the Broach District vice Mr. C. V. Vernon, I. C. S., resigned.
