No. 5999A .- Under Section 144 of the Bombay District Municipal Act, 1901, the Governor in Council is pleased to confer on the Ahmednagar Municipality all the powers specified in clauses (b), (c), (e), (f), (g), (h), (i), (j) & (k) of sub-section (2) of the said section.
