"LEAVE AND ALLOWANCES.

Simla, the 6th October 1869.

No. 3848 .- Read the undermentioned papers :-

Resolution No. 57 passed in this Department on the 2nd January 1868, deciding 'that when an officer is placed in charge of the current duties of a Judicial office, and the charge, in the opinion of the Local Government, entails a substantial increase of responsibility as well as some additional work, he shall be permitted to draw one-half of the deputation allowance which he would have received had he been appointed to officiate in the office concerned.'

Resolution No. 2905, passed in this Department on the 27th August 1869, deciding that in calculating half acting allowance under the rule of 2nd January 1868, the proviso in the Notification of this Department, No. 534, dated the 16th June 1868, that the minimum of acting allowance must be two-thirds of the difference between the salaries of the substantive and acting appointments of the officer concerned shall be disregarded.

Endorsement from the Home Department, No. 612, dated the 30th August 1869, transferring for disposal a letter from the Government of the Punjab, soliciting that the operation of the rule of the 2nd January 1868, may be extended to the cases of officers carrying on the current duties of offices in the Police Department.

RESOLUTION.—The Governor General in Council is pleased to sauction the extension of the operation of the rules of the 2nd January 1868 and 27th August 1869, to the cases of officers placed in charge of the current duties of offices in the Police Department.

The following letter, from the Officiating Secretary to the Government of India in the Foreign Department, to the address of the Secretary to the Government of the North-Western Provinces, is published for general information:—

FOREIGN DEPARTMENT,

GENERAL.

Simla, the 2nd October 1869.

SIR,—I am now directed to communicate to you, for the information of His Honor the Lieutenant Governor, the decision of His Excellency the Viceroy and Governor General in Council on the subject of the Durbar which His Excellency had intended to have held at Agra in January next, on the occasion of the visit of His Royal Highness the Duke of Edinburgh to India.

- 2. From the communication lately made by the Lieutenant Governor to the Government of India, it appears that, although from the recent copious rain-fall and the prospect of a good harvest in Rajpootana and the Districts round Agra, the prices of grain have sensibly fallen; nevertheless, from the exhaustion of the stocks, and the demand for seed grain which will probably arise in October, His Honor and the Agent to the Governor General in Rajpootana do not seem to anticipate any very considerable decrease in the price of the food of the people until after the spring harvest has been gathered.
- 3. Carriage also is already dearer than in ordinary years, and His Excellency in Council is informed that for the next few mouths, transport of grain to Rajpootana will occupy a large number of the few cattle which remain in the country.
- 4. Several of the Chiefs whom His Excellency in Council would have desired to invite to Agra have suffered severely in revenue, and could not, without possible inconvenience, incur the heavy expenses inseparable from a long journey and presence at Agra, with such attendance and followers as befits their dignity and rank.
- 5. Considering, therefore, that, under present circumstances, any large gathering of Native Princes and British Troops at Agra must inevitably retard that recovery from the late severe distress, which is so ardently looked for; that the large requirements of carriage by the Commissariat would check the transport of food to the still suffering districts in Rajpootana; considering also the distance from Agra at which many of the Chiefs reside, and the risk attending the assembling of a large concourse of Native followers, predisposed to disease by insufficient and bad food, His Excellency in Council has, with much regret, come to the decision that it would be impossible to carry out his intention of inviting the Chiefs and Princes of India to meet His Royal Highness in Durbar at Agra, without prolonging the suffering which the late scarcity has occasioned, and which His Excellency in Council has so deeply deplored.

EXTRACT from the Proceedings of the Government of Bombay in the Revenue Department, dated 18th October 1869.

READ the following papers:-

Joint letter from A. F. Bellasis, Esq., Officiating Revenue Commissioner, N. D.; W. H. Havelock, Esq., Acting Revenue Commissioner, S. D.; F. S. Chapman, Esq., Chief Secretary to Government; C. Gonne, Esq., Judicial Secretary to Government; and R. White, Esq., Judge of Poona; to the Chief Secretary to Government, Bombay, No. 4772, dated 30th September 1869.

With reference to the Government Resolution No. 778, dated 26th February 1868, we have the honour to report that we met in Committee on the 21st August last, and subsequent occasions, and enclosed we beg leave to submit, for the approval of His Excellency the Governor in Council, the Rules drawn up by us for the special examination of probationers in the subordinate branches of Government service in the Revenue, Magisterial, and Police Departments, as contemplated in paragraph 5 of the Government Resolution No. 3259 A, dated 12th September 1866.

2. It appeared to the Committee that the examination could not be so regulated as to include the subordinate Establishments in the Judicial branch of the service, but that it might be practicable for a Judge, or his Assistant, in co-operation with one or two other of the Judicial Officers, to frame such questions in the elements of Criminal and Civil Law, and in respect to departmental duties, as would meet the wishes of Government and Her Majesty's High Court on the subject; and we propose that a set of separate Rules be drawn up as regards the Judicial branch by the Judicial Secretary to Government and the Judge of Poona.

Draft Rules for examination of Subordinate Native Establishments of Government in the Revenue,

Magisterial, and Police Departments.

An examination will be held annually at the Sudder Station of each Collectorate by a Committee, composed of the Collector and Magistrate, his First Assistant or other Assistant, who has passed the second or higher departmental examination, and the Hoozoor Deputy. The date fixed for this examination is that of the third Wednesday in July.

All appointments are to be probationary till this examination has been passed. A probationer shall be bound to appear at the examination to be held next after the expiration of his first year of probationary service. In case of failure he shall be removed from office, but may be permitted to appear at the examination next ollowing, and, if found qualified, may be re-appointed on the occurrence of a suitable vacancy, at the discretion of the Officer with whom the nomination rests.

The first day's examination will be conducted by papers of questions to which written answers will be given by the examinees. The questions will be framed on the following subjects, which are classed under separate heads, with a scale of marks to be awarded according to the degree of proficiency under each head:—

I. Revenue Matters.

II. Magisterial and Police.

III. Miscellaneous.

IV. Oral examination.

The question under the first head will be prepared by the Revenue Secretary to Government, and those under the second head by the Judicial Secretary to Government; and they will be transmitted under seal to the Collector and Magistrate as President of the Committee of Examination, but the adjudication on the answers will rest entirely with the Local Committee.

Under the head of Revenue, questions to test knowledge of the following Regulations:-

Regulation XVI. of 1827. X VII. of 1827.

Act III. of 1857.

Act V. of 1864, Bombay. Act I. of 1865, Bombay. Act IV. of 1868, Bombay.

Under the head of Magisterial and Police, questions to test knowledge in the following:-

Chapters IV., V., VI., VII., VIII., and IX. of Act XXV. of 1861; and Act VIII. of 1869, as far as it modifies Chapters IV., V., VIII., and IX. of the above. Chapter IX. of Act XL. of 1860.

III. Under the head Miscellaneous, questions to be prepared by the President of the Committee regarding Talooka and Village Accounts. The examinees will also be required to write in the language of the district an account or précis of procedure in a Revenue case.

For the English Department the same to be written in English, instead of the Vernacular. The number of questions in each of the papers to be limited to eight. The time for disposing of each

paper to be limited to two hours.

IV. The oral examination will succeed the written papers, and will embrace the system of Revenue • Survey and Settlement, including the revised rules, and such general questions connected with the current rules and practice as the Committee may consider suitable. For the English Department the oral examination will include the method of conducting official correspondence and keeping the records-

The names of the successful candidates will be placed in order of merit, according to the total number of the marks obtained by them. The maximum number of marks assignable for each of the papers will be

200, and the same for the oral examination, making a maximum of 800 marks in all.

An examinee must, in order to pass, obtain not less than one-lifth of the highest number incach of the four heads of examination, and an aggregate of not less than 400 Marks, or one-half of the highest number attain-

These rules do not interfere with the standing orders for examination to test fitness for the office of a Sub-Magistrate to which an Officer will still be liable before he can be invested with Magisterial powers.

Financial Resolution No. 10 G., dated 15th September 1862, regarding gratuities of Uncovenanted Servants.

RESOLUTION.—Under the Rules of the Uncovenanted Service, an officer discharged on reduction of establishment with a gratuity, if subsequently re-employed under Government, should refund his gratuity in the event of his being desirous of regaining the service for which the gratuity was allowed; and under the terms of Financial Resolution of the 15th September 1862, and of paragraph 15 of the Uncovenanted Service Pension Rules of 13th April 1864, it is imperative that the refund should be made at the time of re-employment. But there are cases of officers who, in consequence of their having been re-employed under Government before the issue of the order of the 15th September 1862, had no opportunity of securing the benefits of that order by refunding their gratuity at the time of re-employment, and in regard to these the Governor General in Council is pleased to rule that if the officers in to claim pension hereafter in respect of the previous service for which they obtained a gratuity, they must refund the gratuity at once, and not wait till they wish to claim pension.

The question having been raised what classes of Uncovenanted Servants are entitled to gratuitous medical attendance at their own houses, the Governor General in Council has had under his consideration the necessity of laying down some authoritative ruling on the subject for general observance in the Bengal Presidency, and in consultation with the Inspector General of Hospitals, Indian Medical Department, His Excellency in Council has been pleased to determine that Civil Surgeons should attend personally all Uncovenanted Officers living at the head quarter station of the district, whose appointments are notified in the Official Gazette by the Government of India, or by any Local Government or Administration.

- 2. In any station where there is an Apothecary, Sub-Assistant Surgeon, or Hospital Assistant, the duty of cuch Officers should be to attend at their own residences the upper subordinate grades of Government servants, including Clerks, whose appointments are not gazetted.
- 3. As regards Government servants of inferior grades, Dispensaries and General or Civil Hospitals are provided for them at most stations. The servants of Government employés should also be treated at those Dispensaries or Hospitals.
- 4. His Excellency in Council is, however, of opinion that in all cases of emergency, or of great danger or difficulty, the attendance of the Civil Surgeon should be given when applied for by the subordinate medical attendant.

"No. 1020 of 1869.—His Excellency the Right Honourable the Governor General of India in Council is pleased to notify that the padlocks with keys used for the barrack boxes of Soldiers, shall, in future, be considered a part of their regimental necessaries and form part of the Indian kit of the soldier.

The first issue after arrival in India, or on enlistment in India, will be made free of cost, and the padlock must thereafter be kept in serviceable order by the soldier at his own expense while serving in India, both for repairs and replacement.

The padlocks will, in future, be supplied by the Ordnance Department, and a reserve will be allotted to each European regiment, to be accounted for in the same way as regimental stores.

The introduction of Sorting the Overland Mails on board Steamers between Suez and Bombay has necessitated the abandonment of this system, as time does not allow of the necessary intimation to Sea Sorters, who are also otherwise fully employed, and letters reach Bombay ready packeted for the interior.

3. Requests to intercept or redirect Overland Letters are therefore not attended to by the Bombay Post Office. Those expecting a change of residence, are recommended to have their letters consigned to some Agent in Bombay.

Complaints from Residents of Bombay requiring redress as to surcharge of postage, mis-sending, or delay in the delivery of letters, &c., should be made to the Post Master, accompanied by the envelopes of the letters referred to.

Similar complaints in the Mofussil should be made to the Inspecting Post Master of the Division, also accompanied by the envelope.

An appeal against the decision of the Post Master of Bombay, or of the Inspecting Post Master, can always be made to the Post Master General.

Complaints against the Post Office.—From the 1st proximo, complaints against the Post Office, certified as such under the full signature and address of the sender, and addressed to any officer of the Postal Department, will not be chargeable with any postage.

Overland Mails.—The Overland Mails per P. and O. Company's Steam Packets will leave Bombay every Saturday at 5 p.m. during the remaining months of the present year.

The Mails close at the General Post Office at 2 P.M.

The After Packet at 3 P.M.

After-Packet Letters are not forwarded unless an 8-anna stamp is affixed to the letter in addition to the postage.

Registered Letters are received until 1 P.M.

The latest hour for posting Overland Covers at the several Branch Post Offices is 1 P.M.

Late Letters for the Overland Mails.—Independently of the After-Packet which is kept open at the General Post Office till 3 P.M., late letters for the English Mail will be taken at the Pier Post Office from 2 P.M., and as late as 4-30 P.M. The full postage, including the usual fee of 8 annas, must be prepaid on each cover.

Rules for the treatment of Official Correspondence.—The introduction of the new Rules for the treatment of Official Correspondence has been postponed till the 1st April 1870.

Weight and Rates of Letter Postage on Indian Letters.—Under the provisions of Section 20 of the 'Indian Post Office Act, 1866," the Governor General in Council is pleased to declare that the limits of weight, prescribed by Section 8 of the said Act for the several rates of letter postage, shall be doubled in respect of letters posted on or after the 1st April 1869.

Mail between Calcutta, the Straits, and Hongkong.—It is hereby notified for general information that under arrangements made with the owners of the Opium Steamers, which will ply monthly between Calcutta, the Straits, and Hongkong, these Steamers will in future be closed as Indian Mail Packets, and that for the Straits and Hongkong under the same conditions, and at the same rates, as similar articles forwarded by British Mail Packets [Peninsular and Oriental Company]. This arrangement will commence with the first Opium Steamer which leaves Calcutta in April.

2. These Steamers leave Calcutta about 12 days more or less after each Government Opium Sale; the advertised dates of the Opium Sales for the current year (1869) being as follows:-

- 3. Mails for the United States of America, via Hongkong, can be forwarded by these Steamers at the same rates and under the same conditions as by British Packets.
- 4. The Opium Steamers proceed from Calcutta direct to the Straits and thence to Hongkong, and the time of transit from Calcutta to Hongkong is only about 15 days, that is about 7 days less than the time taken by the British Packets [Peninsular and Oriental Company], which proceed by the more circuitous route of Madras and Galle.

Postage Stamps cut from Envelopes or Notepaper not to be recognized in payment of Postage.—The Governor General in Council is pleased, under Section 36 of Act XIV. of 1866, to order that Postage Stamps, impressed on Envelopes or Notepaper, shall not be recognized in payment of postage when cut or otherwise detached from the envelopes or paper on which they were impressed.

Mails for Mauritius, Reunion, &c.—In consequence of the alteration of the dates of departure of the French Mail Packets from Aden to Mauritius, the Mails for Mauritius, Reunion, &c., will be forwarded on the following dates from Bombay to Aden, to be thence conveyed by the above-named Packets to destination:-
