#### ABSTRACT

The thesis hovers around the concept of 'key resources" of an economy. The study describes a group of 'non-fuel minerals' as 'key-resources.' The study underscores the crucial role of these key resources (non-fuel minerals) in determining the growth dynamics of the countries in 21<sup>st</sup> Century. The study has outlined some systematic processes for identification of key resources of a country, depending on its production structure and endowment of natural resources. The perspective of this work is built on some emerging global scenarios in 21<sup>st</sup> Century, more specifically in the post-Covid timeline.

The study's objectives include an in-depth analysis of India's mineral sector, identification of key resources, and examination of the economy in the context of value chain integration for selected Asian economies. Analytical tools such as multipliers, backward and forward linkages, and Principal Component Analysis (PCA) are employed for a structured analytical framework.

The document outlines the impact analysis of national policies like 'Make in India' and 'Atmanirbhar Bharat Abhiyan,' using modified Input Output analysis. The implications for the construction sector, including insights into feasibility, sustainability factors, and potential resource drain, are discussed.

Concerns regarding meeting projected market size targets, predicting pollution rates, and assessing international environmental impact are identified. Thorough studies on various sectors, including Capital Goods, Chemicals, ESDM, Power, and Energy, are conducted, emphasizing the understanding of value chain integration in a Computable General Equilibrium (CGE) framework.

The document aims to provide a holistic view of Indian economic dynamics, considering intricate economic factors and the interplay of endogenous and exogenous elements. It also delves into the feasibility of self-reliance policies concerning depleting mineral reserves. The comprehensive discussion on the availability, reserves, and importance of mineral resources in India, along with the systematic incorporation of an extended list of minerals in Input Output Tables, contributes to the study's depth and thoroughness

The thesis also explores various government initiatives, such as 'Make in India' and 'Atmanirbhar Bharat Abhiyaan,' aimed at attracting investments, strengthening the manufacturing sector, and achieving self-reliance. The focus on export promotion and import

substitution is highlighted as part of the government's strategy to reduce the import burden and minimize the environmental impact. The economic growth outlook for India is optimistic, with projections placing it among the world's top economies by 2050. However, this growth heavily relies on a consistent supply of key resources. The thesis has highlighted that the need for prudent resource utilization is the key to ensure sustainable development and minimal environmental impact. The National Infrastructure Pipeline is introduced as a government initiative to streamline investment for this purpose. Expansionary macroeconomic policies in India, particularly their feasibility and sustainability in light of depleting mineral reserves, have been assessed in the thesis.

Government policies initiated since 2020-21 have specifically articulated with a focus towards achieving self-reliance and sustainability through export promotion and import substitution. The thesis introspected on the challenges associated with the expansion of the manufacturing base, including concerns about over-exploitation and the need for careful analysis of trade policies. Economic integration, especially with Global Value Chains (GVCs) and Regional Value Chains (RVCs), is deemed essential in the current geopolitical scenario, with a focus on manufacturing value chains.

### **CHAPTER 1: INTRODUCTION**

Non-fuel minerals are the indispensable raw materials required for the production of capital goods. It is well established that the adequate supply of capital goods is extremely important for developing the productive capacities of an economy. Without steady supply of machineries, engineering equipment and machine tools, production of all sectors across the economy is highly impaired. An economy can never unleash the full potential of its production system, unless advanced machineries with cutting-edge technologies are used. So, indirectly, the adequate supply of vital minerals plays the most crucial role in bolstering the production capacity of a country. The production capacities in turn, contribute heavily to the development of 'structural strength' of the economy and determine its 'growth dynamics' in terms of GDP growth.

### **1.1** Overview and Perspective:

Since the advent of the new decade in 2020, the world has been jolted by several consecutive and unprecedented humanitarian disasters. First, the outbreak of COVID-19, the most virulent epidemic after the "Spanish Flu" (1918-19), which took 6,987,222 lives so far (WHO 2023)<sup>1</sup>. Second, the prevalence of a global recession in the aftermath of the pandemic, which resulted in worldwide economic distress in the form of unemployment and income loss. Third, the outbreak of war between Russia and Ukraine, causing a total casualty of more than 500,000 lives<sup>2</sup>. Lastly a global "Climate change crisis," which can make our planet inhabitable very soon. Chronologically, the 'climate crises' should come in the first place as it was looming large during the rest three predicaments. At the end of the pandemic, it emerged as the most serious threat to humankind.

We have described all of these incidents as "humanitarian crises" because the pandemic and war directly caused massive loss of human lives, recession resulted in financial distress and climatic disasters have posed a serious threat to the existence of human beings on Earth. War, recession, and climate crisis collectively resulted in an upsurge in food prices and a subsequent food crisis. The world has reached a critical juncture at this stage of human history when the ordeal of these crises is still going on at full steam. At present, food and

energy happen to be the Achilles heels of the global economy in its pursuit of growth and development. The countries all across the globe have already gone into a "crisis mode" and are desperately trying to devise "defence mechanisms" to safeguard themselves from any other disaster in future. Frequent adjustments in the geopolitical alignments of the countries to minimise supply chain disruptions, and adoption of green technologies in almost every field of human activities - are some of the extreme measures that countries are taking to sail through this difficult time.

Successful implementation of all these countermeasures requires a concerted and wellcoordinated effort from all the countries across the globe. Sadly, the world has now gone into a conflicting mode without paying any heed to the imminent danger of obliteration. However, from an economic point of view, it is possible to figure out probable structural dynamics of the market reeling under multiple adversities, emergence of new technologies based on revised objectives and focus, assessment of demand and supply of newly emerged items of importance, vulnerabilities in existing supply chains etc. Based on this introspection, appropriate macroeconomic policies can be formulated to derive a sustainable development plan for the country.

A preliminary examination in this regard reveals that to ensure the resilience of the economic system, the adoption of completely new kinds of technologies will be required. New technologies (often referred to as 'clean/green technologies') will be fundamentally different from conventional technologies in terms of dependence on fossil fuels and emission of greenhouse gases (GHG) in production processes across different sectors. Further introspection reveals that the adoption of "clean technologies" entails the substitution of "fuel minerals" for "non-fuel minerals." It is estimated that this technological shift will require a huge amount of "non-fuel minerals" in future.

# **1.2** Concept of 'Key Resources' and the Importance of Key Resources in Determining the Growth Trajectory of a Country

The central idea of this thesis revolves around the concept of the "key resource" and its significance within the framework of the Indian economy. To begin with, we need to bring sufficient clarity to the concept of 'key resources' and its underpinning meaning in the context of this thesis. Key resources can be described as a <u>specified set of non-fuel minerals</u>, <u>relying on which the juggernaut of an economy moves</u>. In other words, to identify the 'key resources', a systematic introspection of country's non-fuel minerals is pre-requisite.

For example, iron ore is an indispensable ingredient for the manufacturing of steel and allied products. Steel, on the other hand, is the most important input to set up a solid manufacturing base for an economy. There is no doubt that to develop the overall productive capacity of an economy, adequate supply of iron and steel is a prerequisite. So, there is no doubt that "iron ore" is an important 'key resource' on which one of the 'prime movers' of the economy – the 'steel industry' relies heavily. In case a country is not endowed with a sufficient amount of iron ore and is not capable of producing enough steel, it is bound to be dependent on imports from other countries to build its basic infrastructure.

Dependence on other countries for the supply of a 'key resource' can make a country seriously vulnerable to supply chain disruptions due to external factors. This can instil a hidden weakness in the production system of the country and eventually leave the producers at the mercy of foreign suppliers. In case of any disturbance like economic turmoil, natural cataclysm, geopolitical realignment, or deterioration in bilateral relations can suddenly pose a serious threat to the steady production flow of the indigenous industry. Historically, all four large Asian countries: China, Japan, India and South Korea have always been heavily reliant on imported Petroleum and Natural Gas (PNG). Imports of mineral fuels in India averaged USD 72817 million from 1996 until 2023, reaching an all-time high of USD 260921 million in 2022 and a record low of USD 8043 million in 1998.<sup>3</sup> During October 2023, crude oil imports rose by 2.2%, and from April to October 2023, there was a 0.6% increase compared to the corresponding period in the previous year. Notably, imports from OPEC countries declined to 47.8% of the total from April to October 2023-24, down from 63.6% recorded in the same period of 2022-23.<sup>4</sup> This huge import burden for acquiring oil has always thwarted other big-ticket development projects in India to a large extent. Worldwide, for the growth of an economy, some basic minerals like iron ore, coal, aluminium etc are indispensable. But apart from these well-known "key minerals," some more non-fuel minerals are playing an equally important role in shaping the country's growth dynamics. The challenge is to identify all of them with some appropriate indicators. Currently, India produces as many as 95

minerals, which include fuel, metallic, non-metallic, atomic, and minor minerals<sup>5</sup>. However, only a handful of these minerals can be considered as "key resources."

The story around 'key resources' becomes more complicated and extremely intriguing when we introspect the role of "key resources" from a much broader perspective. The exact mechanism by which the 'key resources' participate in the complex interplay of macroeconomic variables, in a highly globalised and inter-twinned production system, is a matter of intensive and thoughtful study.

### **1.3** Focusing on Non-fuel Minerals as the 'Key Resources' of the Economy

Minerals are inorganic substances found naturally in the rocks of the Earth's lithosphere and mantle. Definition of 'Mineral' is many, but the most comprehensive definition has been provided by Encyclopædia Britannica<sup>6</sup>:

"Mineral, naturally occurring homogeneous solid with a definite chemical composition and a highly ordered atomic arrangement; it is usually formed by inorganic processes. There are several thousand known mineral species, about 100 of which constitute the major mineral components of rocks; these are the so-called rock-forming minerals...... By its definition as a homogeneous solid, a mineral is composed of a single solid substance of uniform composition that cannot be physically separated into simpler chemical compounds."

(Encyclopædia Britannica, 2023)

Minerals have always been one of the most important drivers in the industrialisation process of a country, owing to their characteristic physical and chemical properties. Minerals are used as indispensable inputs for production in sectors like 'metallurgy,' 'chemicals', 'pharmaceuticals', 'fertilizers' and 'pesticides. Some sectors like 'construction' indirectly consume a lot of minerals by using Cement as the basic construction material. Similarly, the entire metal industry (i.e. Steel, Copper, Aluminium etc) directly uses metallic ores for the production of metals. Metals, in turn, are used as primary inputs for the production of all important capital goods like machines, equipment and machine tools. Thus, in totality, the entire manufacturing sector relies heavily on the availability of adequate amounts of minerals. The primary sector is also highly dependent on minerals because the production of fertilizers and pesticides requires huge amounts of minerals.

Minerals can be broadly classified into two classes: <u>Fuel Minerals</u> and <u>Non-fuel Minerals</u>. Three minerals: 'Coal and Lignite;' 'Natural Gas' and 'Crude Petroleum' fall under the category of 'fuel minerals,' whereas the rest are of 'non-fuel' type. Although 'fuel minerals' have tremendous economic, and geopolitical significance, non-fuel minerals also wield crucial roles encompassing a wide variety of substances and play essential roles in various industries, including construction, manufacturing, electronics, and more. These minerals include metals (e.g., copper, iron, aluminium), gemstones (e.g., diamonds, emeralds), industrial minerals (e.g., gypsum, talc, quartz), and many others.

Around 5990 kinds of minerals are available on Earth as per the latest "Mineral List (2023)", released by International Mineralogical Association (IMA, 2023). In this huge list, some minerals are specifically identified as having a maximum influence on the growth dynamics of a country. According to the terminologies defined in this thesis, these minerals have been referred to as 'key resources' of the economy. Key resources refer to a specific set of minerals upon which economic growth relies.

The COVID-19 pandemic and its delayed effects have severely afflicted the global economy. Especially, the production systems relying on hydrocarbons and fossil fuels suffered the brunt of the shock due to disruption in fuel supply chains. However, it was observed that energy systems based on <u>'Clean Energy Technologies</u>" (like renewables and Electric vehicles) remained almost untouched by the perils of pandemic-related shock on the global economy. For this reason - and also for some other equally compelling factors –countries across the globe are taking extreme measures to fast-track the process of transformation from a <u>fuel-intensive to a material-intensive energy system.</u>

<u>Primarily for this reason, this thesis has zeroed in on "non-fuel minerals" and kept "fuel</u> <u>minerals" out of the purview of discussion.</u> We have taken into consideration, ONLY '<u>non-fuel</u>' and '<u>non-radioactive</u>' <u>minerals</u> while searching for the '<u>key resources</u>' in the context of the Indian economy.

## **1.4 Current Global Perspective: An Era Marked by Pandemic, War, and Humanitarian Crises**

The decade starting with 2020 has already faced a series of unprecedented crises that have grappled the global economy in all respects. The production functions of the economy have gone through a sea change as a result of the combined impact of these disasters in a very short spell of time. Drastic changes have been observed in production technologies, inputs and outputs of the production processes based on emerging market scenarios after three

consecutive shock waves. To understand the reasons behind these significant changes, a detailed study of the nature and impact of crises and their underpinning implications needs to be explored in greater detail.

### 1.4.1 <u>The Great Lockdown: Outbreak of Coronavirus</u>

The world has witnessed two unprecedented humanitarian crises during the cusp of the decadal changeover in 2020. Undoubtedly, the most remarkable crisis was Covid 19, the virulent outbreak of Coronavirus that suddenly put the entire world into a standstill mode. The duration of this global pandemic was more than three years (from 11<sup>th</sup> March 2020 to 5<sup>th</sup> May 2023, as per the WHO declarations<sup>7</sup>). The pandemic had a profound impact on the global economy due to intermittent lockdowns and 'supply chain disruptions.' The <u>World Economic Outlook of April 2020</u>, published by the International Monetary Fund (IMF) described this downturn as the "*Worst Economic Downturn since the Great Depression*" and designated the crisis as "<u>Great Lockdown</u>".<sup>8</sup> **Table 1.1** gives a summary of World Output in this context.






The annual percentage change in the output of the global economy reduced from 3.6% in 2018 to 2.8% in 2019 and finally plummeted further to -2.8% (i.e. de-growth) in 2020. All the countries across the globe faced headwinds of the Covid19 and eventually plunged into a recessionary phase. However, the depression and later on the revival both have been of varied extent across the countries, depending on their respective structural strengths and intrinsic economic resilience.

**Figure 1.2** Annual Percentage Growths in Output of Some Selected Countries from 2005 to 2028 (P)



In the case of India, the revival and subsequent stabilisation process, both have been very fast due to her strong resilience, emanating mainly from the huge demographic dividend and prudent policy management by the Government. Many countries of the world (including advanced countries like the UK), however, failed miserably in this respect and eventually succumbed to the quicksand of stagnating growth rate. These countries are still finding it hard to fully recover from the adversities inflicted by the "Great Lockdown."

<u>Revealing Cases of Countries having Export Income from "Fuel Minerals" and Non-Fuel</u> <u>Minerals".</u> Another interesting observation in this respect is the comparison of growth rates recorded by countries having export income from 'Fuel' and 'Non-fuel' respectively. It has been found that in the year preceding the pandemic (2018), the growth rate of "fuel exporting countries' has been way below the growth rate of "non-fuel exporting countries". Considering 2023 as the ending year of the pandemic (WHO Declaration), in the postpandemic year the gap between the growth rates registered by "non-fuel exporting countries" and "fuel exporting countries" has been drastically narrowed down.

It can be conjectured that the economic position of countries that export "fuel minerals" has improved significantly in comparison to countries that export "non-fuel minerals" during the "pandemic period." This observation hints at the fact that the countries that export "non-fuel minerals" are more vulnerable to "supply chain disruptions." Hence, supply chain disruptions are a matter of grave concern for these countries and the respective governments should keep backup arrangements to counter situations that can disrupt the export. A few possible strategies to this end could be as follows:

- i) <u>Focusing on nearby export markets</u>: This can be a prudent policy decision to avoid long-distance transhipment of export commodities. This also implies that <u>economic integration with Regional Value Chains (RVCs) should get a preference</u> <u>over integration with Global Value Chains (GVCs)</u>. To be more specific, India should engage more with countries under regional trade blocs like ASEAN and BIMSTEC, than a distant trading partner in the EU.
- ii) <u>Developing alternative export destinations for the same product</u>: It is always advisable to develop alternative export markets so that if commodity flow is somehow hindered in the case of one export destination, some other will come to the rescue and help in clearing the unsold product.
- iii) <u>Looking inward</u>: It is always advisable to promote indigenous industries that require non-fuel minerals as inputs. This kind of inward-looking policy can give rise to two serious problems. First, WTO may object to restrictive trade practices, which are against the international trading norms. Any retaliatory action by WTO can have serious implications. Second, supply to the indigenous industries can fetch significantly lower earnings than export income. This can have a direct impact on the country's exchequer.

### 1.4.2 <u>Recovery from 'Great Lockdown'</u>

The brunt of the Covid-shock was extreme during 2019-20. The situation started improving immediately after the successful development of vaccines and the gradual lifting of COVID-related restrictions. The first dose of the vaccine was administered in December 2020, followed by a worldwide vaccination drive by the countries. The world economy picked up very quickly and the annual growth rate leapfrogged to notch a fantastic growth rate of 6.3% (2021). However, in the following year (2022), the growth rate of the world again saw a

downturn and nosedived to touch the 3.5% mark. The growth rate of almost all the countries of the world moved in tandem with the global trend with some country-specific variations.

### 1.4.3 <u>Cost-of-living Crisis: Lingering Impact of Pandemic and Global Unrest</u>

The war between Russia and Ukraine has been continuing for almost two years (started in February 2022). War for such a prolonged period has made an adverse impact on the world economy by escalating the costs of food, energy, and finance. All of these factors have collectively contributed to a global 'cost-of-living' crisis. The recent conflicts in West Asia can further intensify the perils of 'cost-of-living crises.'

### 1.4.4 <u>Climate Change Crisis: Imminent Threat in Front of the Mankind</u>

The third humanitarian crisis that emerged as a global threat was the 'Climate Crisis' primarily caused by large-scale deforestation across the globe to facilitate the industrialisation process and indiscriminate use of highly polluting 'fossil fuels.'

The Paris Agreement, established at the UN Climate Change Conference (COP21) in Paris on December 12, 2015, is a legally binding international treaty addressing climate change. Ratified by 196 Parties, it became effective on November 4, 2016. The primary objective is to restrict the rise in the global average temperature under 2° C from pre-industrial levels, with additional endeavours to cap the increase at 1.5° C above pre-industrial levels. However, the initial pledges of 2015 are insufficient to meet target. the Hence, Paris Agreement commitments were reviewed at the climate change conference known as COP 26 in Glasgow, UK in November 2021.

In the last decade or so, the development paradigm of the globe has dramatically shifted its focus towards "sustainability" factors. International organisations like the United Nations (UN) emphatically urged the global community to curb carbon emissions from industrial activities on a war footing basis. Since the usage of fossil fuels has been found to be the main culprit for environmental damage, 'Conference of the Parties (COP)' – the highest decision-making body of the "United Nations Framework Convention on Climate Change (UNFCCC)," consistently urged countries to resort to green energy to skyrocketing industrial activities. But "Green Energy" requires "Green Technology." And to implement "Green Technology," the 'key resources' are also different. Minerals like Lithium and Selenium are indispensable to generate "Green Energy." Apart from 'energy,' some minor minerals have also gained prominence.

To track climate change caused by human activities, the World Meteorological Organization (WMO) and the United Nations Environment Programme (UNEP) established the Intergovernmental Panel on Climate Change (IPCC) in 1988. This UN body tracks various indicators measuring Climate Change on real real-time basis and comes out with an Assessment Report (AR) for each year. The Sixth Assessment Report (AR6) for the year 2023, has made some serious observations:

"<u>Observed Warming and its Causes</u>: Human activities, principally through emissions of greenhouse gases, have unequivocally caused global warming, with global surface temperature reaching 1.1° C above 1850–1900 in 2011–2020. .....

"<u>Observed Changes and Impacts</u>: Widespread and rapid changes in the atmosphere, ocean, cryosphere, and biosphere have occurred. Human-caused climate change is already affecting many weather and climate extremes in every region across the globe. This has led to widespread adverse impacts and related losses. .....

"<u>Current Progress in Adaptation and Gaps and Challenges</u>: Adaptation planning and implementation has progressed across all sectors and regions, with documented benefits and varying effectiveness. Despite progress, adaptation gaps exist, and will continue to grow at current rates of implementation .....

"<u>Future Climate Change</u>: Continued greenhouse gas emissions will lead to increasing global warming, with the best estimate of reaching 1.5° C in the near term in considered scenarios and modelled pathways. Every increment of global warming will intensify multiple and concurrent hazards. .....

"<u>Carbon Budgets and Net Zero Emissions</u>: Cumulative carbon emissions until the time of reaching net-zero CO2 emissions and the level of greenhouse gas emission reductions this decade largely determine whether warming can be limited to  $1.5^{\circ}$  C or  $2^{\circ}$  C. Projected CO2 emissions from existing fossil fuel infrastructure without additional abatement would exceed the remaining carbon budget for  $1.5^{\circ}$  C (50%) .....

"<u>Urgency of Near-Term Integrated Climate Action</u>: Climate resilient development integrates adaptation and mitigation to advance sustainable development for all, and is enabled by increased international cooperation including improved access to adequate financial resources, particularly for vulnerable regions. .....

"<u>Synergies and Trade-Offs with Sustainable Development</u>: Accelerated and equitable action in mitigating and adapting to climate change impacts is critical to sustainable development. Mitigation and adaptation actions have more synergies than trade-offs with Sustainable Development Goals. .....

"<u>Finance, Technology and International Cooperation</u>: Finance, technology and international cooperation are critical enablers for accelerated climate action. Enhancing technology


innovation systems is key to accelerate the widespread adoption of technologies and practices. Enhancing international cooperation is possible through multiple channels."



Based on these observations, IPCC has held the carbon emission from the existing '<u>fossil fuel</u> <u>infrastructures</u>' as the main culprit behind the "Climate Change Crisis." The report has described this as '<u>unsustainable energy use</u>' and strongly advocated for the adoption of a '<u>Climate Resilient Development Plan</u>' to bring back the climatic conditions to normalcy. In this regard, ICCP has made two interesting mitigation strategies to fast-track the decarbonisation process:

- Calibrating national development plans in sync with seventeen (17) "Sustainable Development Goals (SDGs)", put forward by United Nations (UN)
- Enhancing the "<u>Technology Innovation System</u>" in the economy to restrict carbon emissions. Global tendency to adopt "<u>Clean Energy Technology</u>" in the post-Covid era has emerged as an unavoidable strategy move in this regard.

The potential of demand-side mitigation options to reduce Green House Gases (GHG) by 2050 is described in the following figure:

Hence, as per this current estimation, the maximum mitigation is possible in following sectors:

- i) Electricity Generation (73%)
- ii) Land Transport (67%) and

### iii) Construction Sector (66%)

There is a clear indication that to get out of the quicksand of 'climate change crisis', countries across the globe need to devise ways to reduce carbon emission in above three sectors. At this point, adoption of "Clean Energy Technology" seems to be the most effective strategic move on the part of the government to reduce carbon emission substantially. This explains the reason behind the sudden upsurge in full-fledged policy drives initiated by different countries to transform the energy system from being "fuel minerals based" to "non-fuel mineral based", as an integral part of the "Sustainable Development Plan".

As one of the founder members of United Nations (UN), India has made significant progress in terms of fulfilling SDG target to mitigate climate change (Goal No: 13). During COP-21 in 2015, India took a pledge to reduce country's emissions intensity by 33% by 2030; but the same has been achieved by 2019 – that is 11 years ahead of schedule. India has also successfully accomplished the target of having 40% of electric installed capacity through non-fossil fuel sources. During 2017-2023, India added 100 GW of installed electric capacity in the country. Around 80% of this added capacity has been done using non-fossil-fuel-based resources (PIB Press Release, 14 Nov 2023)<sup>9</sup>

However, transforming the behemoth energy infrastructure of the country from a 'fuel-based' to a 'material-based' system is not an easy task and it entails huge requirement of some specific "non-fuel minerals." For example, production of one unit of Electric Vehicle (EV) usually takes six times more of non-fuel mineral resources in comparison to the mineral requirement to manufacture one conventional car. Similarly, an onshore wind plant requires nine times more mineral resources than a gas-fired plant. Since 2010 the average amount of minerals needed for a new unit of power generation capacity has increased by 50% as the share of renewables in new investment has risen (IEA, May 2021)<sup>10</sup>

Adoption of "Clean Energy Technology" in the case of Electricity Generation, application of 'Low-Carbon Technology' and use of 'Green Materials' for 'Road Transport' and 'Construction' sectors respectively, can significantly reduce carbon emissions. However, few specific instruments, devices and materials must be made available to successfully implement the new technologies.

This study has performed two exercises:

- Mapping between devices and materials needed for implementation of '<u>Clean</u> Energy Technology' (Table A1: Appendix)
- Mapping between minerals required to manufacture devices with materials (i.e non-fuel minerals) to implement '<u>clean energy technology</u>'

### (Table A2: Appendix)

However, 'Clean energy transition' is basically the '<u>technology transition</u>', of which we have discussed in detail at the beginning of this thesis.

<u>Table A2 and Table A3</u> collectively imply that the 'energy transition' process entails huge amounts of non-fuel minerals for the generation of electricity. A cursory look at these tables reveals that most of these minerals fall under the category of Rare Earth Elements (REE). The Rare Earth (RE) resources in India are reported to be the <u>fifth largest</u> in the world. However, the availability of these mineral resources is highly limited due to the absence of an <u>intermediate sector in the extraction process</u> and the lack of <u>advanced mining technologies</u>.

<u>Table 1.2</u> gives a glimpse of the availability and use of Rare Earth Elements (REE) in India Absence of an intermediate sector in the extraction process in India:

### • The Missing Middle in India's Extraction Industry

In India, the extraction industry faces a significant gap between small-scale and large-scale operations. The mining industry in India is clearly divided into two distinct segments: large multinational companies and small-scale local operations. Large companies benefit from substantial capital, advanced technology, and skilled labor, allowing for efficient large-scale

extraction. Small-scale operations rely on manual labor with minimal technological input, resulting in inefficiency and environmental harm. Unfortunately, the intermediate sector, which should bridge the gap with moderately advanced technology for medium-scale operations, remains underdeveloped or absent. The absence of an intermediate sector hinders the growth of small-scale operations. Small businesses miss out on a bridge that could facilitate their scaling up. Medium-sized enterprises play a vital role in innovation and balance between flexibility and efficiency. Moreover, medium-sized enterprises provide significant employment opportunities. These jobs require higher skill levels than small-scale operations but are more numerous and locally rooted than those in large-scale enterprises. The lack of this sector results in missed job creation opportunities, especially for semi-skilled and skilled workers.

Another structural constraint that has been seriously limiting potential of mining sector in India is lack of advanced mining technologies.

### Lack of advanced mining technologies in India

India has progressed in integrating and developing mining technologies, yet various obstacles continue to limit the industry's capacity to reach its utmost potential. These obstacles affect productivity, environmental sustainability, safety, and overall operational efficiency. Although there have been strides forward, the integration of advanced technology within the Indian mining sector varies widely across different areas and sectors. Particularly, small to medium-sized mining enterprises often do not have the necessary funds or knowledge to invest in sophisticated technologies, relying instead on outdated and less efficient practices. The substantial upfront costs needed to adopt state-of-the-art mining technologies pose a major hurdle, particularly for smaller entities. A lack of sufficient financial support and incentives for technological enhancement hampers the broad adoption of contemporary mining techniques and tools. Employing advanced mining technologies necessitates a workforce proficient in current methods and equipment.

The industry faces a skills shortage, with a lack of workers adept in operating, maintaining, and managing modern mining technologies, which can stall the adoption of new technologies and diminish operational efficacy. Although emerging technologies promise lower environmental footprints, their implementation is not yet widespread. Persistent use of conventional mining practices leads to significant ecological harm, such as deforestation, water contamination, and soil erosion. Furthermore, insufficient regulatory oversight can lead to a neglect of technologies aimed at minimizing these impacts. In India, the regulatory

environment can sometimes obstruct the adoption of sophisticated mining technologies. Challenges such as regulatory obstacles, administrative delays, and the absence of definitive policies for the deployment of innovative technologies can hinder progress.

Additionally, there is a need for policies that specifically promote innovation and ecological sustainability in mining operations. Obstacles related to infrastructure, including subpar transportation and logistics capabilities, can restrict the smooth functioning of mining operations. The absence of essential infrastructure for modern technologies, such as adequate power and water supply, communication systems, and access roads, additionally complicates the adoption of new technologies and efficient mining practices. Even with technological advancements, mining remains a perilous profession in India, with a higher incidence of accidents and fatalities compared to many other countries. The scant adoption of safety-oriented technologies, including real-time monitoring systems, automated machinery, and enhanced protective equipment, continues to be a concern for worker safety.

Tackling these limitations demands a unified effort from the government, industry players, and the academic sector. Investments in research and development, specific policy measures, training programs, and improvements in infrastructure are essential to surmount these obstacles and fully leverage the capabilities of mining technologies in India.

### **1.5** Objectives of the Study

The principal objective of this thesis is to investigate the intricate inter-relationship between the <u>economic progress</u> of a country with the endowments of '<u>natural resources</u>' that the country possesses. By natural resources we mean a set of '<u>non-fuel minerals</u>', which the thesis has defined as '<u>key resources</u>'. The thesis seeks to understand the unique mechanism through which 'key resources' influence the growth trajectory of a country. It was made clear at the beginning, that by "key resources" we intend to refer a specified set of non-fuel minerals. This set of minerals is subject to continuous change and modulation as per the requirement of time and perspective. In this background, we can delineate the following objectives as the key points of enquiry in our study:

The key resources are in fact the juggernauts on which the global economy moves. The economic history of the fifth largest economy of the world also conforms to the same fact. After Independence; the infrastructural backbone of Indian economy started to take shape with huge emphasis on heavy industries by the policy makers. Several large steel plants were

established in the years following independence. Most important among them were Bhilai Steel Plant (1955), Rourkela Steel Plant (1955), Durgapur Steel Plant (1959) and Bokaro Steel Plant (1964). Major power plants established during the formative stage of India's industrial base included: Damodar Valley Corporation (1948), Bhakra Nangal Dam Project (1960), Neyveli Power Plants (1960) and Tarapur Atomic Power Station (1960). These plants along with other heavy industries were part of India's first major wave of industrialization and played a crucial role in the development of the country's infrastructure and economy.

The set of minerals extensively used in this period included iron ore, aluminium ore, bauxite and fuel minerals like coal. Some of these minerals have become an integral part of India's growth story and are still playing key roles in determining the growth. But the list continuously kept on changing depending on evolving situation: both external and internal. In 21<sup>st</sup> Century, the deciding factors have mostly been external, starting with impact of Global Climate Change; insurgence of Covid 19 pandemic to onset of Russia-Ukraine war and myriad regional skirmishes over territorial dominance. All of these factors have significantly contributed to a complete overhaul of production processes along different industry lines.

- 1) The first and foremost objective of this thesis is to identify "key resources" in the case of the Indian economy in the post-Covid era. Globally, there have been drastic changes in the production systems in terms of industrial output produced, types of technologies applied and changes in market motive and purpose. All of these changes have happened in the emerging global perspectives. At this point, we need to identify newly evolved "key resources" in the case of the Indian economy. The most important objective of this study is to identify the "key resources" in the case of the Indian economy. After enumeration of the extended IO Table of India, this identification process needs to be initiated
- 2) Looking at the highly interdependent industrial structure of the Indian economy, Input-Output analysis provides the most robust and Computable General Equilibrium (CGE) framework. To incorporate all the "knock-on" effects of economic/ geopolitical turbulence, this analytical framework is ideal for our research. This thesis has made extensive use of the Input-Output framework to perform our analysis. Construction of the Input-Output Table is the first step for carrying out any analysis in this theoretical framework. So, we need to extend the IO Table to get a comprehensive result for introspection. The primary focus of this thesis is on the

"non-fuel mineral" sector, we need to incorporate more of such minerals in the existing IO Table of India. The second most important objective is to extend the latest available IO Table of India (2018-19) based on data available from the Indian Bureau of Mines (IBM) and the Ministry of Mines (MoM), Government of India.

- 3) Enumeration of the extended IO Table of India (2018-19) opens a plethora of research opportunities using the analytical framework of IO model. One such intriguing research area will be to examine the feasibility of ambitious growth targets, as envisaged by the Government of India for different sectors of the economy in recent times. Our objective in this part of our study is to examine the feasibility and implications of different schemes and missions initiated by the Government of India. This thesis has however been concentrated on the path-breaking policy initiative: '*Atmanirbhar Bharat Abhiyaan*'(2020)
- 4) Introspecting the mineral sector of India with greater details. Explore all the minerals referred to as "major minerals" by Ministry of Mines, Government of India and incorporate them in a structured analytical framework (i.e., Input-Output Table of the country) for subsequent sensitivity analysis.
- 5) Another key objective of this thesis is to examine the extent of the connectedness of the Indian economy with other countries. The measurement of 'value chain integration' can be a revealing exercise to understand the vulnerability factor of the existing supply chains.
- 6) Lastly, based on the results obtained from our analysis, the final objective of this thesis will be to make suitable policy prescriptions for deriving a "Sustainable Development Plan" for the country.

### **1.6** Novelty of the Study

1. Focus on Non-fuel Minerals: There has been more than enough research works and studies conducted on "Fuel Minerals," both globally and in India. There are innumerable research works conducted by reputed academic institutions, professional research bodies, experts and independent researchers. Considering the gravity of "hydrocarbon fuels" for running almost all industrial activities and associated production processes, regular research work was conducted to enable the Government of any country to make informed decisions, in the right direction on a real-time basis.

Every nook and corner of the conventional energy sector has been studied, introspected, and analysed multiple times by multiple agencies. However, research on "non-fuel minerals" is still at a very nascent stage. It was mainly an area restricted to metallurgical engineers, technical experts, academic institutions etc. There is much good research work conducted by reputed research institutions, but most of these studies were done with some technical quest. There is a dearth of pure economic research on "non-fuel minerals" at present. However, the current global situations and geopolitical perspectives have already brought a dramatic change in the "non-fuel mineral" sector in the last few years. The newly evolved economic situation demands more economic research to be conducted at the earliest. This thesis is an attempt to meet this requirement.

2. Comprehensive Analysis on Non-fuel Minerals: At the outset, this thesis has aggregated the (140x140) Input-Output (IO) matrix to (38x38) Aggregated IO Matrix following an Aggregation Scheme (Table A5: Appendix). The Input-Output Tables (2018-19) constructed from Supply and Use tables (SUT) published by Central Statistical Organisation (CSO) incorporated only 9 mineral resources in a structured framework. The list includes 3 fuel minerals (*Coal & Lignite, Natural Gas and Crude Petroleum*) and 6 non-fuel minerals (*Iron ore, Manganese Ore, Bauxite, Copper Ore, Limestone and Mica.*). Rest of the minerals have been categorised into two broad sectors: Other Metallic Minerals and Other Non-metallic Minerals.

However, according to Ministry of Mining, Government of India, a list of 30 non-fuel minerals (metallic and non-metallic) have been cited as "Major Minerals", which are used extensively as raw materials by the manufacturing sector of the country.

The list includes the following minerals as cited below:

Fuel Minerals (3): Coal and Lignite, Natural Gas, Crude Petroleum

**Non-fuel Minerals (30)**: Iron Ore, Manganese Ore, Bauxite, Copper Ore, Chromite, Gold Ore & Gold, Lead conc., Zinc conc, Silver, Tin conc., Limestone, Mica, Phosphorite, Diamond, Fluorite (graded), Garnet (abrasive), Graphite (r.o.m.), Iolite, Kyanite, Sillimanite, Limeshell, Magnesite, Marl, Moulding sand, Salt (rock), Selenite, Siliceous earth, Vermiculite, Wollastonite, Minor Minerals We have incorporated all these non-fuel minerals into the structured framework of IO table and conducted our subsequent research. This has broadened scope of more extensive study to get a holistic view of our research area.

- 3. Introspecting Feasibility of Envisaged Growth Targets: Checking feasibility and sustainability of new Schemes and Projects initiated by the Government of India is an upheaval task. One of the most convenient and robust ways to do that is probably by applying a suitable IO Model. Hence, important government policies like "<u>Atmanirbhar Bharat</u>," "<u>Make in India</u>" etc need to be testified to measure status of the progress made. Since the current perspective insists to redirect funds from "fuel" to "mineral" based energy system, requirement of existing Schemes should be reviewed by the Government. This thesis has attempted to accomplish this task for a few selective Government projects.
- 4. Incorporating Non-fuel Minerals in the Purview of Value Chain Integration: The study showed an alternative route through which 'Key Resources' of an economy can be identified and promoted to foster future growth and development. The route is through advancing policy directive with focus on few sectors of the economy, which are highly integrated with Global Value Chains (GVCs). Sectors, which have strong linkages with cross-border supply chains, induce growth and development of the domestic economy through multiplier effect on income and employment. In case of India, we have found that few minerals already identified as the 'Key Resources' in terms of linkage effects are also proved to be crucial in terms of Value Chain integration.

### **1.7** Key Resources V/s Critical Minerals

At the outset, it is necessary to clarify that ambit of thesis is 'Key Resources', not 'Critical Minerals'. Very recently a document<sup>11</sup> published by Ministry of Mines, Government of India has identified 30 minerals as "**Critical Minerals**". These are: *Antimony, Beryllium, Bismuth, Cobalt, Copper, Gallium, Germanium, Graphite, Hafnium, Indium, Lithium, Molybdenum, Niobium, Nickel, PGE, Phosphorous, Potash, REE, Rhenium, Silicon, Strontium, Tantalum, Tellurium, Tin, Titanium, Tungsten, Vanadium, Zirconium, Selenium and Cadmium.*

The report has defined 'Critical Minerals' as those minerals which are essential for economic development and national security, the lack of availability of these minerals or even concentration of existence, extraction or processing of these minerals in few geographical locations may lead to supply chain vulnerability and disruption.

It is noteworthy that 'Critical Minerals' are scarcely found minerals primarily used for generation of renewable energy. As a result, barring a few, most of these minerals are imported from outside in India. Secondly, Critical Minerals are required in smaller proportion compared to any other fuel or non-fuel minerals in the production process.

On the other hand, this thesis focuses on particular set of non-fuel minerals, which drives the economy as a whole. These minerals have higher multiplier values, strong backward and forward linkages or highly integrated in the supply chain of some GVCs. These minerals are required in higher proportion to build the basic infrastructure of an economy. The availability of these minerals are often not constrained but always subject to fast depletion. To be concise, the 'Key Resources' are primarily a group of non-fuel minerals, which are exhaustively required for developing the manufacturing base of a country. However, due to world-wide energy transition in process, some of the 'Critical Minerals' have emerged as 'Key Resources' for the growth and development.

Hence, this thesis delves into these 30 major non-fuel minerals of India to identify the 'Key Resources' of the country. These 'Key Resources' may or may be 'Critical Mineral' in nature. <u>One of the primary objective of this thesis is to understand, how many of these 30 major non-fuel minerals can be categorised as 'Key Resources' for India</u>

### **CHAPTER 2: LITERATURE REVIEW**

### 2.1 Introduction

This thesis can be visualized as a tapestry of interlinked ideas. These ideas can be summarized as:

- A set of non-fuel minerals can be identified as key resources of the economy
- The set of key resources changes over time, depending on myriad structural and nonstructural factors
- Since, the world has gone through a sea change after the outbreak of Covid pandemic, it is imperative to revise policy decisions based on the updated list of key resources
- To make the policy framework more effective, the new age developments like heightened importance of Clean or Green technology, cutting edge technology products like Semiconductors, Photovoltaic Cells, Electric Vehicles (EVs) etc should be brought under the purview of policy formulation process.

### 2.2 Literature Review

The thesis has been sequentially organized and presented in the form of seven Chapters:

Chapter 1 started with a brief introduction of the topic and the stated objective to introspect on the "key resources" of the Indian economy. To bring more clarity to the objective of this study, the thesis has started with a discussion on the concept of 'key resources and their importance in specifying the growth trajectory of a country' in Chapter 1. In this thesis, 'key resources' have been described as a specified set of <u>non-fuel minerals</u>, relying on which the juggernaut of an economy moves. To put it in other words, 'key resources' represent a group of non-fuel minerals that have the maximum impact on the GDP of the economy.

To investigate the mineral sector more intensively, the thesis covered various related issues. Hassani and Tannant (2016) explored the safety aspects of mining operations not involved in extracting energy-providing minerals, such as metals and non-metals. They pointed out various hazards present in these mining activities, including but not limited to, air and water pollution, as well as risks of accidents and injuries to workers. The study also provided recommendations for mitigating these risks, emphasizing the importance of measures like effective ventilation, efficient waste management, and comprehensive safety training for mining personnel. In a similar vein, Wang Q. and Li Z. (2017) investigated the global patterns in the production and consumption of non-fuel minerals in their study "Global

Trends in non-fuel mineral Production and Consumption". This research is particularly relevant given the widespread use of such minerals across diverse sectors such as technology and transportation. The findings indicate a notable increase in worldwide production and consumption of these minerals, underscoring their environmental repercussions. The authors stress the imperative for sustainable management practices among policymakers, industries, and the general populace to mitigate environmental harm.

Gupta and Chen (2018) examined the economic consequences of scarcity in non-fuel minerals, which are critical for a wide array of sectors such as electronics, construction, and transportation. Employing a quantitative methodology, they modelled the global economic repercussions of limited non-fuel mineral resources. Their research indicates that the sustained availability of these minerals is pivotal for future economic development. This study offers significant insights into the discourse surrounding the sustainability of the global mining sector, underscoring the urgency of adopting more sustainable practices in resource management.

In their article "The geopolitical implications of non-fuel mineral resources," Baker E. and Jones M. (2018) delved into the role of non-fuel mineral resources, like metals and minerals, within the context of global geopolitics. They contended that the diminishing availability and escalating costs of oil have elevated the strategic importance of these resources. The paper examines how this trend affects different nations and regions, highlighting the geopolitical ramifications of the shift.

Ying L. and Wang H. (2019) conducted a thorough investigation into the technological progress in processing non-fuel minerals, focusing on iron ore. Their study emphasized the utilization of artificial intelligence and machine learning to enhance the efficiency and reduce the costs associated with iron ore processing. Concurrently, Smith J. K. (2019) contributed an article to "Mineral Economics," examining the critical role non-fuel minerals play in modern society. This article covered the functions, impacts, and applications of non-fuel minerals in current economic and industrial activities.

In the article titled 'Sustainable extraction and utilization of non-fuel minerals,' authored by Mary L. Johnson M.L and Anderson R.S. (2020) explored the opportunities and obstacles associated with the sustainable extraction and utilization of non-fuel minerals. These minerals are crucial for various sectors such as electronics, construction, and transportation, yet their extraction poses environmental risks. The authors examined existing methods and suggested

alternative approaches to lessen these adverse effects, including the adoption of circular economy principles, implementation of decision-making frameworks, and enhancement of stakeholder involvement.

Roberts P.A (2021) conducted a comprehensive review in the journal Environmental Science & Technology on the environmental repercussions of mining and extracting non-fuel minerals like metals, non-metals, and construction materials. The review addressed significant issues like habitat disruption, water contamination, and greenhouse gas emissions, among others. Roberts concluded by emphasizing the urgent need for stricter regulations and better management practices in the non-fuel mineral extraction industry to reduce its environmental footprint.

Subsequently, Foley and Jancsurak (2022) highlighted the importance of non-fuel minerals in sustainable development. These minerals, which include metals, non-metals, and organic compounds, play crucial roles in various industries, including energy, agriculture, construction, and electronics. However, the extraction and use of these minerals can have significant environmental and social impacts, such as habitat destruction, pollution, and labour exploitation. Therefore, the authors propose a sustainable approach to mineral extraction and use, which involves reducing demand, improving efficiency, and promoting the recycling and reuse of minerals. The article provides valuable insights into the pressing challenges and opportunities associated with mineral resources and offers practical solutions to address them.

The Chapter 2 of this thesis provided a comprehensive literature review on the economy-wide assessment of 'key resource sectors' of India and the prospect of value chain integration with selected Asian economies. Works of literature about "key sectors", mining and minerals, value chain integration, critical minerals etc. and all the background documents like reports, books, journals, academic papers and newspaper articles have been discussed briefly in this Chapter.

The methodologies for the derivation of the Input-Output Table (IOT) from the Supply Use Table (SUT), Leontief and Ghosh multipliers, backward and forward linkages, Principal Component Analysis (PCA), and Value Chain Analysis were explained in Chapter 3 of this thesis. Adhering to the methodologies, corresponding data was also constructed. The methodological background of this thesis is based on the analytical framework of Input-Output Analysis. Rasmussen P.N. (1956) wrote extensively on intersectoral relations in his

book, "Studies in Intersectoral Relations". The book explored the importance of the interactions between different sectors of society. Rasmussen was particularly interested in investigating the social, economic, and political factors, and the way they intersect and influence each other. In the book, he examined numerous case studies from history and contemporary society to illustrate his insights on intersectoral relations. Rasmussen's work continues to be relevant today, as researchers continue to study the complex ways in which different sectors of society interact and shape each other. Walter I. (1960) wrote a book on economics that introduced the input-output analysis method, which is a computational model used to understand the relationships between different parts of the economy. The author presented the concept of an interregional input-output model and its applications to regional economies. This work has been influential in regional research and economic development planning.

"The Elements of Input-Output Analysis" authored by Miernyk W.H (1965) serves as an extensive exploration of input-output systems, applying mathematical methods to understand the dynamics of complex systems like economies or ecosystems. Esteemed as a foundational work in operations research, this text remains a vital resource today for its thorough examination of the subject.

Arrow K.J, Frank H. and Hahn F.H. (1971) authored a book titled "General Competitive Analysis" which stands as a cornerstone text in game theory and competitive economics. This work lays down theoretical frameworks for scrutinizing market structures and competitive scenarios, encompassing discussions on market equilibrium, product differentiation, and the strategic behaviors of monopolies and oligopolies. It is extensively utilized by economists and business professionals to grasp market behaviors and inform strategic decisions.

"Input-Output Analysis: Foundations and Extensions" by Miller R.E and Blair P.D. (1985, 2009) is a pivotal reference on input-output analysis, offering insights into the economic flows between industries. The book elucidates the methodology for evaluating economic changes' effects on supply and demand, and for predicting economic expansion, presenting both fundamental and advanced applications of input-output analysis.

"Economics of the Environment: Selected Readings," edited by Armand Schor A. and Shughart W.D II (2003), compiles essential writings on environmental economics, touching on environmental regulation, sustainability, and the economics of natural resources.

Erik Dietzenbacher E. and Lahr M.L (2006) authored an article titled "Regional Science Matters: Studies Dedicated to Walter Isard" (2006) pays tribute to Walter Isard's significant contributions to regional science, offering a collection of studies that reflect his impact on the field. The book delves into the spatial dynamics and interrelationships of socio-economic systems, embodying the interdisciplinary essence of regional science.

Lastly, "Inter-industry Analysis and Input-Output Models" by Eric C. Wang and Regemorter D.V (2018) provides an accessible guide to input-output models and their applications in understanding industry interconnections within economies. Through practical examples, case studies, and exercises, this book demonstrates the utility of input-output models in regional development, environmental analysis, and policy assessment.

The thesis observed a serious anomaly in the mineral statistics of India. Database published by the Indian Bureau of Mines (IBM), Ministry of Mines (MoM) and Central Statistical Organisation (CSO) have been found to vary widely.

The first part of Chapter 4 explained the process of systematic incorporation of the extended list of minerals in IO Table (2018-19) and the identification of "Key Resources" in the Indian context. It is noteworthy that the importance of 'key resources' has become more pervasive due to its crucial role in achieving the global target of having 'net-zero carbon emission' by 2070. Many new minerals are being added to the list of 'key resources' due to their crucial role in the transformation process towards a 'green economy'. Accordingly, the list of 'key resources' needs to be more broad-based to understand the overall impact on the economy.

The Input-Output Table published by the Central Statistical Organisation (CSO), Ministry of Statistics and Programme Implementation (MoSPI), Government of India provides information about only (8) minerals in the structured format of Input-Output Table. Whereas, the Indian Bureau of Mines (IBM), Ministry of Mines, and Government of India regularly publish all relevant data regarding (26) minerals. This Chapter has attempted to make the analytical framework of Input-Output analysis more inclusive in the case of the Indian economy, by systematically incorporating 25 new non-fuel minerals into the existing Input-Output Table (IOT 2018-19).

The second part, Chapter 4 deals with the identification of "key resources" in the case of the Indian economy by applying a few specific mathematical techniques. The identification has

been done using two mathematical processes. We have used multipliers and backward and forward linkages as the indicators for the identification process.

Second, we have applied a mathematical technique called "Principal Component Analysis (PCA)" to identify the most important sectors of the economy. PCA is a "systematic factor reduction process", often used to filter out the most important factors (here sectors) from others in terms of their respective influences on final output (here GDP). The beauty of this method is that, while filtering out the most important sectors, it retains the essence of the collective impact of less influential sectors through a rigorous mathematical process.

The thesis has enumerated the multiplier values of various sectors as classified in the Input-Output Table of India (2018-19) and calculated the 'linkage effects' to understand the relative strengths of different sectors in influencing the GDP of the country. Some similar approaches to identifying the 'key sectors' in this way include the studies made by Polenske (2002), which focused on unraveling the role of links and linkages in economic development, with a particular emphasis on the development of inter-industry and inter-firm linkages. The author discussed various aspects of linkages, including the types of linkages that are typically found in different types of regions, the role of linkages in reaching economic growth, and the challenges facing linkages in different regions of the world. Polenske's work has been influential in the field of economic development and has contributed to research on linkages. Much before to this seminal work, Hazari (1970), presented an empirical study of key sectors in the Indian economy. The paper provided a detailed analysis of the expansion and growth of different sectors in India, including manufacturing, agriculture, and trade, based on annual data from 1961 to 1968. The author identified various factors affecting the growth of these sectors, such as capital inflows, government policies, and external trade. The study provided important insights into the Indian economy and its structural changes during this period.

Principal Component Analysis (PCA) is a statistical technique used to project highdimensional data into a lower-dimensional space while retaining most of the variation in the data. It is commonly used for data compression, dimensionality reduction, and data visualization. This thesis has tried to identify the 'key resources' of the Indian economy through the application of PCA. For this, we have used the reference book written by Jolliffe, Ian T. (2002) entitled "Principal Component Analysis". The book provides a comprehensive overview of principal component analysis, which is a widely used statistical technique for dimensionality reduction and data analysis. It includes mathematical derivations, practical applications, and real-world examples of PCA. Overall, the book is a valuable resource for researchers, statisticians, and data scientists looking to understand and apply PCA in their work. Yoshida, Yukihiko and Terasaki T. (2009) jointly authored the paper "Principal Component Analysis with Non-Gaussian Data: Application to Metabolomics," published in the Journal of Bioscience and Bioengineering. In the paper, the authors introduced a new method for performing principal component analysis (PCA) on non-Gaussian data, specifically metabolomics data. The method they propose is based on the Johnson–Shannon divergence and can handle the presence of outliers and non-linear relationships within the data. The application of this method to metabolomics data is demonstrated through the analysis of experimental results, providing valuable insights. The article written by Abdi, Hervé, and Williams L.J (2010), provided a thorough review of the theory, implementation, and applications of PCA.

The input-output model is an econometric tool used to analyze the relationships between the production and consumption of goods and services in an economy. In the paper "Extending the input-output model with assets," authors Chen, Guo, and Yang (2005) proposed an extension to this model that takes into account the role of assets in economic activity. They argued that assets, such as buildings and equipment, play a crucial role in productivity and must be included in the model to provide a more accurate representation of the real economy. The paper presented a new method for incorporating assets into the input-output model and used it to analyze the impact of asset investment on economic growth in China.

Mehmet K.U.L.A. and Expert T. (2008) authored a study focusing on the supply-use and input-output tables, as well as the backward and forward linkages within the Turkish economy. This work sheds light on the intricate economic interconnections present in Turkey. The article "From Input-output Tables to Supply-and-Use Tables" by Kazemier B., Driesen C.H. and Hoogbruin E. (2012) published in *Economic Systems Research*, explores the transition between input-output and supply-and-use tables. These tools are essential for gauging economic activities and analyzing goods and services flows. The authors address the conversion challenges between these tables, providing insights crucial for economists, policymakers, and analysts.

Lenzen and Rueda-Cantuche (2012) delved into the application of supply-use tables in evaluating environmental impacts across various sectors. Their discussion highlights the tables' potential to inform policies aimed at mitigating environmental damages while acknowledging the methodological hurdles. This paper serves as an informative guide for those interested in environmental policy and sectoral interdependencies.

Nazri M.M. (2012) published an article in *Anusandhanika*, "Mineral Resources and Economic Growth of India," examines the nexus between India's mineral wealth and its economic expansion from 1950 to 2010. Through statistical analysis, Nazri underscores the pivotal role of mineral resources in India's development, despite accompanying challenges.

The paper authored by Bhattacharya and Rajeev (2013) applies the Input-Output (I-O) model to dissect the Indian economy's sectoral interrelations, identifying key sectors such as manufacturing, services, and agriculture. Their findings, based on the 2008-2009 National Accounts Statistics of India, highlight the significant inter-sectoral linkages essential for understanding the economy's structure.

J. Dubiński (2013) contributed an article to the *Journal of Sustainable Mining*, which discussed the mining industry's sustainable development. The paper argues for the sustainable and responsible exploitation of mineral resources to ensure their longevity and to garner socio-economic and environmental benefits, emphasizing the industry's role in sustainable practices.

One of the studies titled "Mining export, industrial production and economic growth: A cointegration and causality analysis for India" authored by Sahoo A.K.; Sahoo D. and Sahu N.C. (2014) was published in the journal Resources Policy (pages 27-34). In the paper, the authors examine the relationship between mining exports, industrial production, and economic growth in India using co-integration and causality analysis. They found that mining exports have a significant positive relationship with economic growth, while industrial production has a positive relationship with both mining exports and economic growth. The study's results have important implications for

India's Critical Mineral Resources by Gupta and Ganesan (2014) is a policy brief released by the Center for Energy and Environment (CEEW). The document provides a comprehensive analysis of India's critical mineral resources and their trade and economic implications. Critical minerals are minerals that are essential for the development of various industries, such as defense, energy, technology, and transportation. In this report, the authors identify India's critical mineral resources, discuss their current status, and assess their future demand. Additionally, they provide recommendations for India to improve its position in the global mineral market by enhancing its capability to produce, process, and export these minerals.

Another research paper authored by Chattopadhyay M. and Lahiri A. (2017) was published in the Statistical Journal of the IAOS. In the paper, the authors discuss data anomalies found in

mining statistics related to India. They identify various inconsistencies and errors in the data, and propose potential solutions to address these issues.

The article "National Mineral Policy and its Impact on Indian Mineral Sector" by Randive R. K., Jawadand S. A., and Raut T. S. (2017), published in the Journal of Geoscience Research examines the impact of India's National Mineral Policy on its mineral sector. The policy was aimed at increasing the country's mineral production, promoting the development of the sector, and ensuring sustainable mining practices. The study finds that the policy has had a positive impact on the sector, leading to increased production and investment. However, the authors also note that challenges remain, including the need for better infrastructure and management practices, as well as addressing concerns around

The paper written by Rueda-Cantuche, Amores, and Remond-Tiedrez (2020) focuses on the possibility of converting supply, use, and input-output tables into a different classification, which involves the use of aggregate information. They argue that this approach can provide more efficient and accurate analyses of economic systems. The paper is published in the Economic Systems Research and contributes to the field of economic systems analysis.

The article by Marimuthu et al. (2021) discusses the socio-economic and environmental challenges faced by the mining industry in emerging economies. The authors assess the implications of these challenges on resource policies and sustainability in the mining sector. They find that mineral extraction has significant impacts on local populations, ecosystems, and economies, and that there is a need for more sustainable resource policies to mitigate these impacts. The article is published in the journal Sustainable Production and Consumption, which focuses on sustainable development and resource management.

A research paper by Chadha and Sivamani (2022) discusses the critical minerals for India and their importance in the development of green technologies. The paper evaluates the criticality of minerals such as lithium, cobalt, copper, nickel, and rare earth elements, and projects their future needs based on the increasing demand for clean energy technologies like electric vehicles, wind turbines, and solar panels. The authors also explore alternative sources and recycling methods to reduce India's dependence on imports and mitigate environmental impacts.

Padhan D. and Das A. (2022) presented a study on Physical and monetary asset accounting of mineral resources in India. The paper focuses on the importance of better resource accounting to improve efficiency and transparency. The authors used a quantitative approach to estimate the physical and monetary value of mineral resources in India. They reported that the total

value of mineral assets in India is estimated to be around trillion of dollars. The study highlights the country's mineral resource sector as an important contributor to the economy, and the need for better resource management practices to promote sustainable development.

The article "Building Resilient Mineral Supply Chains for Energy Security" is a report from the Council on Energy, Environment and Water (CEEW) that was published by Dutt A. and Tyagi A. (2022). The document explores the importance of mineral resources, particularly those found within the Asia-Pacific region, for the development of a sustainable energy industry. It offers recommendations for enhancing the supply chain resilience and flexibility of these materials, including policies that promote diversification, energy efficiency, and recycling. The report emphasizes the need for a collaborative, multi-faceted approach to ensure a secure, reliable, and sustainable supply of critical minerals

Raju et al. (2022) present a study on the critical minerals that can be recovered from radioactive materials for economic benefits. They specifically focus on examples from India and publish their findings in the International Journal of Research and Technology (UIJRT). The paper discusses various minerals that can be recovered through this process such as uranium, copper, and zinc, and their potential applications. The authors highlight the importance of using these minerals sustainably and safely to minimize environmental hazards.

The article by Boraiaha and Chandan examines the potential impact of clean energy minerals in India's energy landscape by 2050. Clean energy minerals, such as lithium, cobalt, and nickel, are essential for the production of batteries for electric vehicles and renewable energy systems. The authors discuss the current state of clean energy minerals in India, including production, consumption, and trade. They also identify challenges and issues, such as resource scarcity and environmental concerns that need to be addressed to ensure a sustainable future for these minerals. Overall, the article provides valuable insights into the role of clean energy minerals in India's energy transition and the associated challenges.

In Chapter 5, the sustainability and feasibility of ambitious growth targets attached to some recently introduced Government Schemes have been testified. A modified Input-Output model has been used to accomplish this task. This exercise has been performed to understand the long-term sustainability of these schemes on the background of the current global perspective. There is a genuine need to relook at these Schemes because the new growth paradigm is more focused on sustainability, and equitability factors. The adoption of "Clean

Energy Technologies" is now insisting on a complete transformation of the "energy infrastructure" from being a "fuel-based" to a "material-based" system. The time is ripe now to understand whether the existing Government Schemes are following this new paradigm or not.

"Trade, Networks and Hierarchies" is a book written by Hewings G.J.D, Sonis M., and Boyce D.(1998). It was published in Springer in Berlin, Germany. The book focuses on regional and interregional economies, specifically on how trade, networks, and hierarchies interact to influence regional development. The book provides a comprehensive framework for analyzing the dynamics of regional economies, drawing on insights from economics, psychology, sociology, and geography. The authors incorporate a range of quantitative and qualitative methods to explore the complex relationships between economic regions and the factors that shape them.

Dietzenbacher, Erik, and Los B. (2004) published a paper on "Structural Decomposition Techniques: Sense and Sensitivity" in the journal Economic Systems Research. The paper focused on analyzing the performance and properties of structural methods for Decomposing structural VAR models. The authors also examined the impact of different sensor types and factors on the methods used. The paper's findings contributed to the tools and techniques available for use in macro econometrics, economic modeling, and forecasting.

Analyzing the scope of "Value Chain Integration" with some Asian countries has been dealt in Chapter 6. The pandemic has made it evident that supply chain disruption can easily translate into a full-fledged economic crisis within a very short duration. To make the economy resilient, the economy must get rid of all vulnerabilities in the supply chain. The Indo-Pacific region is now going through an adjustment process to reinstate "supply-chain security" after the pandemic. Measuring India's participation with Global Value Chains (GVCs) with special emphasis on "key resource materials" could be a source of security in this situation. In addition to this, the prospect of sustainable development policies for the nonfuel mineral sector needs to be ascertained in the Indian context. The purview of our study has been to examine the scope of value chain integration for selected emerging Asian economies and India. This Chapter has explored the opportunities and scope of 'value-chain integration' in the "non-fuel mineral sector," with the help of the "Computable General Equilibrium (CGE)" model using the GTAP database. The GVC participation index provides an estimation of how much an economy is connected to global value chains for its production and foreign trade. In this regard, the article written by Beverelli, Cosimo, Stolzenburg V., Koopman R.B, and Neumueller S. (2019), titled "Domestic Value Chains as Stepping Stones to Global Value Chain Integration" and published in The World Economy 42, no. 5 (2019): 1467-1494 is very important. This paper delves into the factors influencing the integration into global value chains (GVCs), crucial for understanding their historical expansion and recent slowdown. It specifically examines the impact of domestic value chains (DVCs) on GVC integration. Given the industry-specific costs associated with fragmenting production and changing input suppliers, DVCs may serve either as facilitators or barriers to entering GVCs. Concentrating on backward linkages-the procurement of intermediate goods-the study robustly supports the idea that DVCs act as precursors to GVC integration. Another study by Banga, K.(2022) titled "Impact of Global Value Chains on Total Factor Productivity: The Case of Indian Manufacturing" published in 'Review of Development Economics' gives an wonderful account of the impact of global value chains (GVCs) on the productivity of developing countries, specifically through an analysis of Indian manufacturing firms from 2000/2001 to 2014/2015 using the Prowess dataset. The findings reveal that integration into GVCs significantly enhances total factor productivity (TFP) for these firms, even when considering the tendency of more productive firms to engage in GVCs. Furthermore, a deeper involvement in GVCs, measured by vertical specialization at the firm level, also positively influences productivity. The research underscores the potential of policies aimed at encouraging GVC participation and boosting firms' technological capacities to stimulate productivity improvements in developing countries.

### **CHAPTER 3: METHODOLOGY AND DATA CONSTRUCTION**

### 3.1 Methodology

The capabilities of these minerals to influence the growth momentum of an economy, however varies from mineral to mineral. These differential capabilities of minerals are extremely important to identify the – 'key drivers' of an economy. This thesis has used different methods to identify the set of strongest influencers or most powerful non-fuel minerals as the – 'Key Resources'. Chapter 3 elaborated these methodologies and the theoretical backgrounds for constructing the database for subsequent Chapters.

### 3.1.1 <u>Input-Output Framework</u>

The Input-Output framework (henceforth IO framework) is a powerful mathematical construct that is able to execute general equilibrium analysis in an economy, characterized by *inter-dependent* industrial structure. This unique macroeconomic framework was first conceptualized and developed by *Wassily Wassilyevich Leontief* - a Soviet-American economist known for his path-breaking research on how changes in one economic sector may affect other sectors The mathematical rigor of the framework enables the researcher to capture the economy-wide impacts of any macroeconomic change (both internal and external) by taking all knock-on effects into consideration. Leontief won the Nobel Memorial Prize in Economic Sciences in 1973.

The Input-Output Table (henceforth IOT) is an integral part of the IO framework. It gives a comprehensive measure of the *inter-industry transactions* in value terms at factor cost. The table is represented in matrix form, where the columns represent industries and the rows represent commodities (principal products of the corresponding industries). Each row of the matrix shows the *allocation* of the total output of the commodities to the different industries for intermediate consumption and final use. On the other hand, the industry columns present the commodity inputs of raw materials and services, which are required to produce outputs of particular industries.

The entries at the bottom of the table provide the measurement of Net Indirect Taxes (NIT) on the inputs and the primary inputs (income from the use of labour and capital), i.e., Gross Value Added (GVA). The row totals of an IO Table do not tally with the column totals due to the inclusion of the secondary products, which appear particularly in the case of manufacturing industries. For preparing the industry by industry and commodity by

commodity matrices, the secondary products are transferred to the industries where they are principally produced following the procedures recommended in the UN System of National Accounts (SNA).

Let, there are 'n' commodities (i = 1, 2, 3, ..., n) produced by 'n' industries (j = 1, 2, 3, ..., n)

x<sub>i</sub>: Total Output (Production) of sector i

f<sub>i</sub>: Total final demand for sector i's product

 $z_{ii}$ : Interindustry sales by sector *i* to all sectors *j* (including itself, when j = i)

The flow of commodities produced in the economy can be summarised in terms of the following set of linear equations:

This system of equations can be written in matrix format as follows:

Throughout this thesis, lower-case bold letters have been used for (column) vectors, as in f and x (and x' as the corresponding row vector), and upper-case bold letters have been used to denote matrices, as in Z.

Following these notations, equation (3.2) can be summarised as:

Where 'i' is a column vector of 1's of appropriate dimension (in this case 'n'). This column vector is also termed as "summation vector."

### 3.1.2 <u>Construction of Input-Output Table</u>

In IO framework, there is an underlying assumption about the type of production function, all industries are supposed to exhibit **Constant Returns to Scale** (**CRS**) production function during the course of the production process. This fundamental assumption states that the inter-industry flows from i to j depend entirely on the total output of sector j for that same time period. Leontief viewed the entire perspective from '**supply side**' and assumed that the ratio of the amount of some input required for the production of a certain quantity of a particular commodity always remains fixed throughout the production period. This ratio ( $a_{ij}$ ) is termed as '<u>technical coefficient</u>' or '<u>direct input coefficient</u>' in IO framework developed by Leontief.

Matrix 'A' is known as "technical" or "direct input coefficient" matrix. And  $(I - A)^{-1}$  matrix is called 'Leontief Inverse' or "Output multiplier" matrix.


The Input-Output Table for 2018-19 has been constructed from the Supply Use Table (SUT) for 2018-19, published by CSO. We have followed the procedure mentioned in the '<u>Handbook on Supply and Use Tables and Input-Output Tables with Extensions and Applications; Chapter 12; (United Nations, 2018</u>)'


The detailed procedure can be described in the following step-wise manner:

Step 1:Construction of an 'integrated matrix' placing both the Supply and Use table<br/>together in a particular format

- Step 2: Construction of Leontief Inverse, based on 'industry technology assumption'. According to this assumption: "Each industry has its specific way of production, irrespective of its product mix."
- **Step 3**: Construction of Transformation Matrix
- **Step 4**: Construction of IOT by matrix multiplication of "Integrated Matrix" and "Transformation Matrix")
- **Step 5**: Balancing the IOT

All these steps were followed one by one to arrive at (140x140), commodity by commodity IOT. The logical ground of this conversion method can be demonstrated by the figure illustrated below (**Figure 3.1**)

# **3.2** Expanding Input-Output Table (IOT) by Incorporating a Comprehensive List of Non-Fuel Minerals

The Input-Output Table published by Central Statistical Organization (CSO), Ministry of Statistics and Programme Implementation (MoSPI), Government of India incorporates only

eight (8) Non-fuel Minerals in its structured form. Whereas, Indian Bureau of Mines (IBM), Ministry of Mines, Government of India comes out with output figures of <u>23 Non-fuel</u> <u>Minerals</u> under the category of '<u>Major Minerals</u>' (<u>6 Metallic</u>, <u>17 Non-metallic</u> and <u>Minor</u> <u>Minerals</u>). (<u>Table A4: Appendix</u>). This is exclusive of the eight (8) non-fuel minerals covered by CSO.

To get a more holistic picture into the mineral sector of the country, this thesis has systematically incorporated all the mineral statistics into the IO table of India to facilitate a deeper analysis of Indian mineral sector. The thesis has devised a process to accomplish this task and illustrated the step-wise procedure as given below. Following this procedure, we have expanded the IO Table (38x38) to a more exhaustive IO Table of dimension: (61x61) after duly incorporating all minerals as specified by IBM and Ministry of Mines (MoM). The task has been accomplished by collating the IBM and MoM data.

Since, the newly incorporated minerals have been valued at 'Purchasing Price,' we have made tax adjustment to get production values at 'Basic Price'. We have distributed "Production Tax Less subsidy" of Metallic and Non-metallic Minerals proportionately to the production values in respective categories. 'Minor Minerals' and 'Other Minerals' have been allocated tax burden within the bracket of "Non-metallic Minerals". Now, before replacing the existing list of minerals in IO table (2018-19) by this new list of minerals, some re-allocation of input and output figures (row-wise & column-wise) will be required.

The thesis has replaced the existing list of minerals in the IO table (2018-19) with this new list of minerals. Hence, re-allocation of output figures along product -line (row-wise) will be required

### 3.2.1 <u>Allocation along Commodity-line (Row-wise)</u>

i) <u>For Metallic Minerals</u>: Production of each newly introduced Metallic Mineral is allocated in the same proportion in which 'Other Metallic Minerals' are allocated along industries.

- 1) We have incorporated 6 new metallic minerals in the existing list of IO Table consisting only 4 minerals
- These newly specified metallic minerals have been taken as a part of the "Other Metallic Minerals" as specified by IO-2018-19

 We have carved out these newly specified 6 metallic minerals from the "Other Metallic Minerals" as per IO figure available

ii) **For Non-metallic Minerals:** Production of each newly introduced Non-metallic Mineral will be allocated in the same proportion in which 'Other Non-metallic Minerals' are allocated along industries.

- We have incorporated new 23 non-metallic minerals (inclusive of 'Minor Minerals') in the existing list of IO Table of 2 Non-metallic minerals
- These newly specified Non-metallic minerals have been a part of the Other Nonmetallic Minerals as specified by IOT 2018-19
- We have carved out these newly specified 23 Non-metallic minerals from the "Other Non-metallic Minerals" as per IO figure available

### 3.2.2 <u>Allocation along Industry-line (Column-wise)</u>

For this, re-allocation of input figures along industry -line (column-wise) will be required. Hence, we make 2 simple assumptions:

- i) <u>For metallic minerals</u>: Each industry will use newly introduced Metallic Minerals in the same proportion in which 'Other Metallic Minerals' are used in the production process
- ii) <u>For non-metallic minerals</u>: each industry will use newly introduced Non-metallic Minerals in the same proportion in which 'Other Non-metallic Minerals' are used in the production process.

After some minimal balancing, the (38x38) aggregated matrix is expanded to the (61x61) matrix, containing an exhaustive list of 34 minerals in total. This matrix has been used throughout this thesis for analytical purposes.

For easy understanding of the entire procedure, we have cited a '**Demonstrative Example**' in the **Appendix: B** This procedure has been followed for final compilation of the 'aggregated IO table (61x61)' (**Table A5: Appendix**). The newly constructed table contains total 31 Non-fuel minerals as listed below:

- Metallic Minerals = 10
- Non-metallic Minerals = 19
- Minor Minerals = 1
- Other Minerals = 1

### **3.3** Calculating Multipliers and Linkages

The production of each industry generates two types of rippling effects in the economy. First, it demands more inputs to produce more output. This causes "demand pull" for the "downstream industries", which in turn set the multiplier process in action. The impact is called "backward linkage" effects. Backward linkage happens in the demand side.

Second, the industry in concern, supplies inputs to the "upstream industries", which enables them to produce more and meet excess demand in the market. This impact is known as "forward linkage" effect. Quite understandably, "forward linkage" effects appear in the "supply side" of the economic system.

Both forward and backward linkages induce positive impulses within the economy.

Now, we consider a simple Input-Output framework, characterised by CRS production function with 'n' number of commodities (i = 1, 2, 3, ..., n) and 'n' number of industries /sectors (j = 1, 2, 3, ..., n).

From "supply side" (Leontief model), technical coefficient' or 'direct input coefficient' is calculated as:  $a_{ij} = x_{ij}/x_j$ 

In matrix notation, A is "input coefficient matrix" and L is Leontief inverse / multiplier matrix.

Where,  $A = [a_{ij}]$ , and  $L = [l_{ij}]$ L is calculated as:  $L = (I - A)^{-1}$ 

### From "Supply Side",

- Total backward linkage (Rasmussen, 1957) of sector j is measured by calculating the column sum of the Leontief inverse or the total requirements matrix (L = [l<sub>ij</sub>]) Hence, Rasmussen's Total Backward Linkage Measure: BL<sub>j</sub> = Σ<sup>n</sup><sub>i=1</sub> l<sub>ij</sub>
- Backward dependence on or linkage to the *rest* of the economy is calculated by omitting 'on-diagonal' elements in L matrix during summation
- 3) Normalized direct backward linkage measure.

It is calculated as:  $\overline{BL_j} = BL_j / (\frac{1}{n} \sum_{j=1}^n BL_j)$ 

(Here, the overbar suggests a normalized measure)

From "Demand Side" (Ghosh model), 'allocation coefficient' is defined as:

### From "Demand Side",

1) Total forward linkage of sector **i** is measured by calculating the row-sum of the Ghosh inverse matrix ( $G = [g_{ij}]$ )

Hence, Total Forward Linkage Measure:  $FL_i = \sum_{i=1}^n g_{ij}$ 

- 2) Forward dependence on or linkage to the *rest* of the economy is calculated by omitting 'on-diagonal' elements in G matrix during summation
- 3) Normalized direct forward linkage measure.

It is calculated as:  $\overline{FL_{\iota}} = FL_i / (\frac{1}{n} \sum_{i=1}^n FL_i)$ 

(Here, the overbar suggests a normalized measure)

### On the basis of our results, sectors can be classified into 4 groups:

- Generally independent of (not strongly connected to) other sectors (both linkage measures less than 1)
- 2) Generally dependent on (connected to) other sectors (both linkage measures greater than 1)
- 3) Dependent on inter-industry supply (only backward linkage greater than 1)
- 4) Dependent on inter-industry demand (only forward linkage greater than 1).

In tabular format, the sectoral classifications in terms of backward and forward linkages have been presented in <u>Table 3.2</u>.

Calculation of multipliers and economic linkages occupy a very crucial position in Input-Output theory. Some standard measures of economic connectedness in an interdependent industrial scenario have been used in this thesis to identify "key resources" in Indian context. The relative strengths of backward and forward linkages for the sectors in a single economy provide a suitable mechanism for identifying "key" or "leading" sectors in that economy. The most connected sectors are thought to be most important for the economy in this context.

### **3.4 Principal Component Analysis (PCA)**

Since the focus of this thesis zeroes in on the prime movers of Indian economy, identification of 'key resources' needs to be done from various angles. One important way by which we can identify the key resource sectors is by systematic elimination of least important minerals in terms of their productivity or influence in determining the GDP of the country. In this way, the minerals having maximum influence on GDP can be identified as 'key resources'. However, for a highly complicated economy like India - having innumerable inter-linkages between sectors - completely doing away with some minerals (however insignificant they may be) can seriously blur the insights obtainable from our analysis. To capture both direct and indirect impact of a mineral resource in an economy, a specialised mathematical technique called 'Principal Component Analysis (PCA)' has been used in this thesis.

PCA is a dimensionality reduction technique for reducing the number of variables while preserving as much information as possible. The main idea is to transform the original variables into a lower number of 'principal components' that serve as summaries of the features, potentially revealing hidden patterns in the data. By analyzing the principal components, one can gain insights into the relationships between the variables and the underlying structure of the data.

The PCA procedure involves the following steps:

- <u>Standardization</u>: The original variables are standardized (mean of 0 and variance of 1), especially if they have different units of measurement.
- 2. <u>Covariance Matrix Computation</u>: Calculation of the covariance matrix to understand how the variables of the input data are varying from the mean with respect to each other.
- <u>Eigenvalue and Eigenvector Computation</u>: Computing the eigenvalues and eigenvectors of the covariance matrix to identify the principal components. Eigenvectors (principal directions) determine the directions of the new feature space, and eigenvalues determine their magnitude.

- 4. <u>Sort and Select Principal Components</u>: The eigenvalues are sorted in descending order, and only the top 'n' eigenvectors are kept, where 'n' is the number of dimensions to reduce to.
- 5. <u>Projection</u>: The original data is projected onto the principal components to transform the data into the new feature space.

This technique is widely used in exploratory data analysis and in making predictive models. In our aggregated IO Table (61x61), total number of non-fuel minerals is 31. Now, we want to figure out which of these 31 non-fuel minerals are most important in terms of GDP contributions, so that we can easily do away with the rest, however retaining most of the information contained in them. The goal is to reduce the number of variables and attain simplicity in analysis, without causing much of a deviation from accuracy. Thus, PCA ensures brevity in our analysis

### 3.4.1 <u>Mathematical Construct</u>

At the beginning it is mention-worthy that PCA works only when the set of independent variables are interdependent. Hence an IO framework is ideal for application of PCA. In IO platform, PCA can systematically filter out the least important variables (factors of production) by consolidating a large set of variables into a smaller one that still contains most of the information in the large set. In other words, PCA reduces the number of independent variables from a system when they are highly interdependent among themselves. In mathematical language, PCA extracts low dimensional set of features by taking a projection of irrelevant dimensions from a high dimensional data set with a motive to capture as much information as possible.

Now, PCA is a method that brings together:

- 1. A measure of how each variable is associated with one another. (Covariance matrix.)
- 2. The directions in which our data are dispersed. (Eigenvectors.)
- 3. The relative importance of these different directions. (Eigenvalues.)

A standard PCA model starts with a system of equations as written below:

Here,  $\mathbf{k}$  is number of independent variables (which are interdependent with each other). These variables are also referred as "features"/dimensions" etc. Y is the dependent variable in this case. For 'n' observations, we get the following equations:

Here, **'n'** is number of observations. In case of time-series data n refers to number of years (or months etc.)

The entire process of PCA is executed in following 5 steps:

### Step 1: Standardizing the range of continuous initial variables

The aim of this step is to standardize the range of the continuous initial variables so that each one of them contributes equally to the analysis

Using matrix notation this system of equation can be represented as:

#### **Step 2: Covariance Matrix Computation**

The aim of this step is to understand how the variables are varying from the mean with respect to each other, or in other words, to see if there is any relationship between them.

In order to identify correlations, Covariance matrix: Cov(Z) has been computed. This covariance matrix is a (k × k) symmetric matrix (where k is the number of dimensions) that has as entries the covariances associated with all possible pairs of the initial variables.

It's actually the sign of the covariance that matters.

- a) If positive: the two variables increase or decrease together (correlated)
- b) If negative: One increases when the other decreases (Inversely correlated)

# Step 3: Computation of the eigenvectors and eigenvalues of the covariance matrix to identify the Principal Components

The calculation of eigenvectors and eigenvalues from the covariance matrix is essential in identifying the principal components of the data within linear algebra. Principal components are new variables formed through linear combinations of the original variables. These combinations are devised to ensure that the resulting variables, referred to as principal components, are uncorrelated. Moreover, the majority of information from the initial variables is condensed into the first components. Consequently, in a **k**-dimensional dataset, **k** principal components are derived, with PCA striving to allocate the maximum information to the first component, followed by the successive distribution of the remaining information to subsequent components.

The eigenvectors and their corresponding eigenvalues  $(L_i)$  of  $Z^T Z$  are calculated by a method called **Eigen decomposition**. The method is described below:

 $Z^TZ$  is decomposed into  $PDP^{-1}$ , where **P** represents the matrix of eigenvectors and **D** is the diagonal matrix featuring eigenvalues on the diagonal and zeros elsewhere. The eigenvalues on the diagonal of **D** are associated with the corresponding column in **P** — meaning that the first element of **D**(L<sub>1</sub>) and the corresponding eigenvector is the first column of **P**. This holds

for all elements in D and their corresponding eigenvectors in **P**. It is always possible to calculate  $PDP^{-1}$  in this manner because  $Z^{T}Z$  is a symmetric, positive semi-definite matrix.

Since, the number of variables is large; we have used a **statistical package (R)**, to calculate Eigen Values and Eigen Vectors.

The details of **<u>R-Code</u>** have been provided in <u>Annexure: C</u>

### Step 4: Creation of a feature vector to decide which principal components to keep

By computing the eigenvectors and arranging them based on their eigenvalues in descending order, the Principal Components have been identified in terms of their significance. During this stage, the decision arises to either retain all these components or discard those with lower significance (characterized by low eigenvalues). The ensuing matrix of vectors, known as the **Feature vector**, is formed by retaining the chosen components. Essentially, the feature vector is a matrix with columns representing the eigenvectors of the selected components. This makes it the first step towards dimensionality reduction, because if we choose to keep only **m** eigenvectors (components) out of **k**, the final data set will have only **m** dimensions.

Following this method, **eigenvalues** ( $L_1$ ;  $L_2 \dots \dots \dots$ ;  $L_k$ ) have been sorted in descending order. The eigenvectors in **P** have also been arranged in the same order. The sorted matrix of eigenvectors is **P**\* consists of all the columns of **P**, but arranged in a different order. Eigenvectors always remain independent of one another.

### Step 5: Recasting the data along the Principal Component axes

Finally, we need to determine how many features to keep versus how many to drop. For this, we have calculated the proportion of variance explained for each feature. We have started with the largest explained proportion of variance variables and kept on adding variables until the 100% variation in the value of the dependent variable could be explained.

Since, each eigenvalue is roughly the importance of its corresponding eigenvector, the proportion of variance explained is the sum of the eigenvalues of the features considered divided by the sum of the eigenvalues of all features.

### **3.5** Construction of Modified Input-Output Table

We consider a simple Leontief Model, characterized by *Constant Returns to Scale (CRS)* production functions, with fixed input coefficients:  $a_{ij} = x_{ij}/x_j$ . It is also assumed that there are 'n' commodities in the economy produced by 'n' number of industries.

Outputs are:  $x_1, x_2, x_3, \dots, \dots, x_n$  (Endogenous Variables) Final demands are:  $f_1, f_2, f_3, \dots, \dots, f_n$  (Exogenous Variables)

In 'Modified Leontief Model', one of the outputs (say,  $x_j$ ) is considered as exogenous (i.e., a fixed 'production target' is set by factors outside the *inter-dependent industry framework*). As a result, an economy wide impact happens. To maintain balance in the system, the 'final demand (fj)' of the corresponding sector is determined endogenously.

Let,  $x_j = \bar{x}_j$ : Exogenously fixed output (Target) (*'Overbar' on a variable denotes that it is exogenously fixed*). Hence, the Leontief Modified Model can be summarized in the form of following *system of linear equation*:

Following these concepts and associated formulae, the economy-wide impact of some specific target-oriented growth strategies (schemes) initiated by Government of India, has been measured. The feasibility and long-run sustainability of these schemes has also been analyzed in this context.

### **3.6 Value Chain Models**

Let, A and B are two countries /regions, where A is in 'downstream production' and B is in 'upstream production'.

i = 0ne of the important inputs for downstream production

j = One of the important inputs for upstream production

It is assumed that **i** is produced by A and **j** by B

It shows the volume of imported intermediate input embodied in the exports of the country. It can either be found for exports to all regions taken together or for bilateral exports depicting the impacts of trade on the trading partners. *Import Coefficients* calculated similar to the Technology Coefficient Matrix for the imports of intermediate inputs to the country in consideration.

### CHAPTER 4: SYSTEMATIC INCORPORATION OF THE EXTENDED LIST OF MINERALS IN IO TABLE (2018-19), ISSUE OF DATA ANOMALY AND IDENTIFICATION OF "KEY RESOURCES" IN INDIAN CONTEXT

Integrating a comprehensive list of minerals into the Input-Output Table for 2018-19, addressing data discrepancies, and pinpointing crucial resources specific to India – these are the key areas covered in this Chapter.

To embark on any academic research under the Input-Output framework, access to reliable database is a prerequisite. Since the IO framework involves rigorous mathematical computation, even the slightest anomaly in data can lead to serious errors. Unfortunately, the mineral sector of India has been found to suffer from data anomalies. This Chapter has delved into the possible reasons of this data anomaly and emphasized on the importance of a synchronized database in Indian context.

The second part of the Chapter attempted to incorporate a larger set of minerals in the structured framework of the IO Table. This has been done to make the IO Table more inclusive in terms of its coverage of minerals. In the current global scenario, some non-fuel minerals have suddenly become extremely important. An extension of the IO Table incorporating these minerals can unravel new insights about the role of the mineral sector in achieving sustainable development goals.

The last part of this Chapter measures 'backward' and 'forward linkages' of the non-fuel minerals on the basis of the calculation of 'multiplier values' under IO framework. Theory suggests that inputs with high values of multipliers also possess stronger 'backward' and 'forward linkages'. On the other hand, inputs having high 'backward and forward linkages' hold stronger capabilities in determining the GDP values. This Chapter identifies minerals having high 'backward and forward linkages' as 'key resources'.

### 4.1 Discrepancies in India's Mineral Statistics

### 4.1.1 Organizational Structure for Dissemination of Mineral Statistics in India

One of the main challenges in doing research work in the field of the mining and mineral sector of India is the availability and access to authentic databases. As per the administrative setup, the Indian Bureau of Mines, Nagpur, and the Ministry of Mines, Government of India has the shared responsibility to collect and publish data pertaining to the mining sector in India.

As per as Ministry website, the Ministry of Mines is responsible for "survey, exploration and mining of all minerals, other than natural gas, petroleum, atomic minerals and coal. In the case of atomic minerals and coal, activities of the Ministry are limited to regional exploration. The Ministry is responsible for the administration of the Mines and Minerals (Development and Regulation) Act, 1957 (67 of 1957) and rules made there concerning all mines and minerals other than coal, natural gas and petroleum. The Ministry also administers the Offshore Areas Mineral (Development and Regulation) Act, 2002 and rules made there under"<sup>12</sup>.

Indian Bureau of Mines (IBM), Nagpur has been mentioned as a "Subordinate Office" under the Ministry. According to the National Mineral Policy, 2019 (NMP), the Indian Bureau of Mines is supposed to "perform as a National Technical Regulator and to discharge the developmental functions for the sustainable development of the mineral industry and to work as a repository of the database on mines and minerals".

The present '<u>Charter of Function</u>,' has clearly outlined the roles and responsibilities of IBM as follows. Some of these responsibilities can be summarised as follows:

"In the wake of liberalization of the policy regime governing the mineral sector and increasing need for adequate environment management as part of systematic and scientific mining, the mandated functions for IBM, as given for notification in Official Gazette vide Resolution No. 31/49/2014 - M. III, dated 3rd November 2014 are given below: -

Collect, collate, and organize into a database, all information on exploration, prospecting, mines, and minerals in the country in the shape of a National Mineral Information Repository and take steps to publish and disseminate the same; establish institutional mechanisms of coordination between the centre, the States, the mineral industry, research, and academic institutions, and all stakeholders, to proactively develop solutions to the demands and problems faced by the industry; promote research on all aspects of practical relevance to the industry and act as a bridge between research institutions on the one hand and user industry on the other; advise Government on all matters relating to the mineral industry; and to undertake any such other activity that has become necessary in the light of developments in the field of geology, mining, mineral beneficiation, and the environment." <sup>13</sup>




Quite clearly, the Ministry of Mines acts as the apex body in the mining and mineral ecosystem of India. It has the supreme authority to oversee and regulate the mining activities

of the country. Ministry is responsible for policy formulation, strategy planning and implementing various "Rules and Regulations" from time to time. On the other hand, the Indian Bureau of Mines is a subsidiary body of the Ministry of Mines, responsible for "collecting, collating, and organising" the database and publishing the latest statistics about the Mining and Mineral sector regularly. IBM is supposed to act as a "National Mineral Information Repository". So, it is expected that the statistical information about mineral sector should flow freely among the three government bodies and the official data from each end must sync with each other.





And this information flow should happen in real-time. So, logically there should not be any discrepancy or mismatch between data published by IBM and the Ministry of Mines (MoM).

## 4.1.2 <u>Comparison of Data Published by the Indian Bureau of Mines (IBM) and</u> <u>Ministry of Mines (MoM)</u>

A careful observation of data published by IBM and MoM shows that the production statistics provided by these two government bodies are often dissimilar. To introspect on this data anomaly, this thesis has computed 'Average Deviation in Percentage' as follows: Year-wise percentage deviation between IBM and MoM data for mineral production:



As per our calculations, we have found a significant deviation between IBM and MoM data for the production value of minerals. The gap is more for metallic minerals (6.25%)

compared to that of non-metallic minerals (5.34%). The deviation for all minerals taken together stands at 3.21% (Figure 4.2)

If datasets published by two government bodies differ to such an extent, then that could lead to completely dissimilar results depending on which data set has been used. Hence, the choice of the appropriate dataset becomes a deciding factor to arrive at error-free and uniform results. For any researcher working in the field of mineral sector of India, obtaining authentic official statistics is a great challenge. However, access to authentic and consistent data is a prerequisite for any quality research.


Ministry of Mines (MoM) and Indian Bureau of Mines (IBM) provide data on production value of eight minerals in India. This study has further calculated the deviation in production values of these eight minerals in India from 2017-18 to 2019-20. The resulting deviation figures (in percentage) are presented in <u>Table 4.1</u>. This table clearly manifest the problem of data anomaly in case of these eight minerals. <u>Figure 4.3</u> gives a pictorial representation of Table 4.1.



In the case of the above eight minerals, the variation of two datasets (i.e. IBM and MoM) ranges from 9.98% (Lime shell) to 165.11% (Moulding Sand). Variations for the remaining six minerals are also quite significant. In this situation, it becomes extremely difficult to choose one dataset over the other.

## 4.1.3 <u>Comparison of the data published by the Indian Bureau of Mines (IBM),</u> <u>Ministry of Mines (MoM) and Central Statistical Organisation (CSO)</u>


The data anomaly in the Mining sector deepens if we bring the Central Statistical Organisation (CSO) into the picture. CSO publishes a '<u>Supply Table</u>" of commodities on a regular basis. This table include production figures of five (5) "<u>Principal Minerals</u>" of the country (<u>Table 4.2</u>). When we plot datasets provided by CSO, IBM and MoM for the year 2018-19 (the latest available Supply Table with CSO is for 2018-19), the figures show wide divergence (**Figure: 4.4**) from each other.

The reasons behind the data anomaly in the mineral statistics of India can be manifold, but it seems to have persisted for a long time. A similar study published in 2017 (Chattopadhyay and Lahiri, 2017) pointed out data anomalies in the mineral statistics of India quite elaborately. After comparing official statistics on mining data (number of mines, workforce etc) provided by NSSO, DGMS and IBM for the year 2011–12, the paper observed that:

"Total number of mining sector workers varies from 2.2 million (NSSO, 2011–12) to 0.5 million (DGMS & IBM, 2011), a difference of 125%. The difference in the number of workers between NSSO, DGMS and IBM is related to the methods adopted for collecting data. NSSO data is based on a household survey whereas DGMS and IBM data is based on annual returns from the registered mine owners. Differences also are evident in the number of operating mines and miners between DGMS (2610) and IBM (3236), a difference of 21% and 5% respectively" (Chattopadhyay and Lahiri, 2017).

The differences in methods of collecting data have been tentatively held responsible for this discrepancy in datasets. Although this could be a reason for data related to 'Number of Mines", "Number of Workers" etc., the same reason does not have any merit in the case of "<u>mineral production</u>" figures. IBM and MoM use the same source (MDMC return) for preparing mineral production data. As the sole authority for data dissemination, IBM shares the same data with all government agencies.

#### 4.1.4 Introspecting Reasons behind Data Anomaly

#### 4.1.4.1 Sources of Data

As mentioned in the Annual Report 2022-23 of the Ministry of Mines, the source of the production statistics was '<u>MCDR Returns'</u>. But, as per the organisational set-up, the only data source for the Ministry should be IBM. In addition to that, the primary source of information for IBM is also the same; i.e., MCDR Returns. According to Rule 45 of <u>'Mineral Conservation and Development Rules (MCDR), 2017 (Amended up to 3rd November 2021)'</u>, all the mining lessees, traders, exporters, end users, etc. (who are engaged in mineral business) must register them with the Indian Bureau of Mines. The rule was officially issued by the Controller General, Indian Bureau of Mines (IBM) in January 2022. The rule further elaborates:

"The holder of a mining lease shall submit online returns in respect of each mine to the "Regional Controller or any other authorised official" of the Indian Bureau of Mines in the following manner, namely: -

A monthly return which shall be submitted before the tenth day of every month in respect of the preceding month in electronic form along with a signed print copy of the same. An annual return which shall be submitted before the 1st day of July each year for the preceding financial year in electronic form, along with a signed print copy of the same"<sup>14</sup> (IBM, 2022)

So, MCDR returns are statutorily filed with IBM only via electronic mode. Hence, IBM is the first recipient of all information contained in the return form, definitely, <u>Ministry also gets a copy of this return for reference and use</u>. The MIAS unit of IBM is primarily responsible for providing updated statistics on mineral resources. After several rounds of scrutiny, validation and sanitisation, the finalised data are published by IBM. The publication department of IBM is responsible for the dissemination of updated data in print and electronic format. Thus, IBM comes out with statistics on mineral production, industry-wise consumption, domestic and international prices of mineral/metals, trade figures related to minerals, details of exploration activities etc. IBM is also bound to share the updated data with all relevant government bodies. <u>Hence, data published by IBM and the Ministry should necessarily be identical.</u>

#### 4.1.4.2 <u>Delay in Updating Data</u>

Discrepancy may arise if; the Ministry decides to quickly come out with new data before validation by IBM. As already mentioned, raw data about mining and minerals are collected, scrutinised, validated and sanitised by IBM and then the organised, cleaned and finalised data is passed on to all concerned government bodies, including the Ministry.

As IBM takes some time to accomplish the due process of validation, the Ministry may go for an "Early Release". However, this data (early release) must be finalized by IBM in due course, after completion of the validation process and making rounds of necessary revisions.

To avoid this possibility, we have intentionally avoided using data for recent years. The database for three years (2017-18; 2018-19; 2019-20) that we have considered must have long been finalised and duly passed through all rounds of scrutiny and revisions. <u>Hence,</u> there is absolutely no logical ground based on which the data discrepancy could be justified.

#### 4.1.4.3 <u>Human Error</u>

Human error may be a valid reason behind the anomaly between IBM and Ministry data. The entire process of data collection to data dissemination is a difficult task for the mining and mineral sector and it requires expert handling of data. The stakeholders involved in the mining business are often reluctant to disclose accurate data. The practice of illegal mining,

tax evasion, corruption and several other malpractices are serious deterrents to the free flow of information in the mining sector. But above all, the process of data collation and compilation must be accomplished by professional hands. Especially at Ministry, utmost care should be taken to prevent data mishandling.

#### 4.1.5 <u>Discussion</u>

The data mismatch across government bodies is quite disturbing. Before embarking on any economic analysis in the Input-Output framework, the mathematical rigour of the model demands data precision. As already pointed out, in the case of "Moulding Sand," the average percentage divergence is as high as 165%. Anomaly of such extent can completely ruin any analysis using a structured mathematical framework, like the IO Model. Even a minute error in the database always tends to multiply by a snowball effect in the case of an IO model and ultimately spoil the futility of the entire exercise.

Since data precision seems to be a perennial concern in regard to the mineral statistics of India, the utmost care and prudent judgment need to be applied while choosing the database. The current anomaly in data released by two government bodies is quite perplexing. The Ministry of Mines should come forward and take the necessary steps to clear the confusion. There should be only one version of official data; otherwise, this kind of discrepancy is bound to crop up.

#### 4.2 Expansion of Input-Output Table

#### 4.2.1 <u>Construction of Input-Output Table (IOT) from Supply-Use Table (SUT)</u>

Following the stepwise procedure mention in <u>Handbook on Supply and Use Tables and</u> <u>Input-Output Tables with Extensions and Applications; Chapter 12; (United Nations, 2018,</u> we have first calculated Input-Output (IO) Table of 2018-19 from Supply and Use Tables (SUT) of India (2018-19), as published by Central Statistical Organization (CSO). This IO table consists of 140 industries (j = 1, ..., 140) and 140 Commodities (i = 1, 2, ..., 140) respectively. The (140x140) IO table contains:

- i) **Fuel minerals** (Coal and Lignite; Natural Gas and Crude Petroleum) (3)
- Non-fuel minerals (Iron Ore; Manganese Ore, Bauxite; Copper Ore; Lime Stone;
   Mica) (6). (In this, Iron Ore; Manganese Ore, Bauxite; Copper Ore (4) are
   'metallic minerals' and Lime Stone and Mica (2) are 'non-metallic minerals')
- iii) Two (2) more items: 'Other metallic minerals' and 'Other non-metallic minerals' have been added to make the list comprehensive.

#### 4.2.2 <u>Expansion of Input-Output Table by Incorporating More Minerals</u>

To get a more holistic view of Indian mineral sector, this thesis has systematically expanded the IO Table (2018-19), by incorporating additional 23 non-fuel minerals into existing 8 non-fuel minerals. This entire task of incorporating new minerals in the old IO table has been done in two stages in this thesis:

First, the Input-Output Table (2018-19) of dimension (140x140) has been re-grouped following a suitable 'Aggregation Scheme' (**Table A3: Appendix**) to get a new 'aggregated IO Table' of dimension (38x38). The aggregation scheme has been developed, keeping in mind the requirement of next course of computations in subsequent Chapters. However, in this thesis, both of the 'Aggregated Matrix' (38x38) and 'Expanded Matrix' (61x61) (**Table A5: Appendix**) have been used depending on the requirement of the study.

Second, this thesis incorporated additional 23 minerals into the structured framework of IO model. In these new minerals, there are 6 metallic minerals and 17 non-metallic minerals. Two more categories: <u>Minor Minerals</u> and <u>Other Minerals</u> have also been added to the list **Table 4.3**. The comprehensive list of all minerals extends to: Metallic Minerals: 11 and Non-Metallic: 20.

The production data for these 23 minerals (2018-19) have been obtained from "Indian Mineral Yearbook 2021", Part-I, General Review, 60<sup>th</sup> Edition, Production (Advance Release), published by the Indian Bureau of Mines. This document was published by IBM in December 2022. IO Table (38x38) is then expanded to get a new IO Table (61x61). The

entire process of expanding an IO table has been illustrated with the help of a hypothetical table (Appendix: B).

- i) In the case of 'metallic minerals,' six (6) new metallic minerals have been carved out of 'Other metallic Minerals" in IOTT Sector No: 37 (<u>Table A5: Appendix</u>).
- ii) In the case of 'non-metallic minerals, seventeen (17) new non-metallic minerals have been carved out of 'Other non-metallic Minerals" in IOTT Sector No: 40; (Table A5: Appendix)
- iii) "Other metallic minerals" and "Other non-metallic minerals' have been clubbed together. The production figure of "Minor Minerals" has been deducted from the sum to form only one miscellaneous category: "Other Minerals."

Following this procedure, the expanded IO table (<u>Table A 5: Appendix</u>) is obtained.

The comprehensive list of minerals has been presented in Table 4.4

#### 4.3 Identification of 'Key Resources' of Indian Economy

#### 4.3.1 <u>Analysis of Forward and Backward Linkages</u>

The Input-Output framework is considered to be the most robust analytical construct, which is capable of capturing the "knock-on effects" in an interdependent industry structure, in the most comprehensive manner possible. The concept of "linkages" explains the mechanism through which direct and indirect impacts of an economic change are transmitted in the form of waves of repercussions throughout the economy.

Industries remain interconnected through two routes:

- 1) <u>From the demand side</u>: It purchases inputs required for its production from the "upstream" industries.
- 2) <u>From the supply side</u>: It sells output to the "downstream" industries, which in turn use its output as their inputs.

Interconnection of a particular sector with the "upstream" and "downstream" sectors are referred to as "<u>backward</u>" and "<u>forward</u>" linkages respectively. Collectively, linkage effects give a measure of the economic "connectedness" of a sector with the rest of the economy.

The more connected a sector remains with the rest of the economy, wields more power to influence the total output of the economy, through longer chains of repercussions. In IO framework, this concept is used as a basic principle to identify the "<u>key sectors</u>" of the economy.

"Measures have been proposed to quantify such backward and forward linkages, or economic "connectedness." Comparisons of the strengths of backward and forward linkages for the sectors in a single economy provide one mechanism for identifying "key" or "leading" sectors in that economy (those sectors that are most connected and therefore, in some sense, most "important") and for grouping sectors into spatial clusters. And if data are available for more than one time period, the evolution of these interconnections can be studied. Also, examination of these measures for similar sectors in different countries provides one method of making international comparisons of the structure of production."

(Miller and Blair, 2009)

This thesis has attempted to identify the "key sectors" of the Indian economy, based on some quantitative measures of "connectedness" as explained before. We have used the extended Input-Output Table (61x61) of India for 2018-19 to accomplish this task. To identify "key sectors", the "backward" and "forward" linkage measures have been calculated (both in normalized form). High-scoring sectors (values greater than 1) are most important for the

economy, either from the demand side or from the supply side. Sectors scoring high from both sides are normally the most important.

The results of our calculation reveal that the following non-fuel minerals possess the highest "**backward linkage**" effects when arranged in decreasing order of respective values of "Normalized Total Backward Linkage Index" (Index Value > 1):

Non-fuel Minerals with Highest Backward Linkage Effects are:

1.	Salt (rock)
2.	Iolite
3.	Vermiculite
4.	Moulding Sand
5.	Selenite

"If the backward linkage of sector  $\mathbf{i}$  is larger than that of sector  $\mathbf{j}$ , one might conclude that a dollar's worth of expansion of sector  $\mathbf{i}$  output would be more beneficial to the economy than would an equal expansion in sector  $\mathbf{j}$ 's output, in terms of the productive activity throughout the economy that would be generated by it. (Miller and Blair, 2009)

Hence, considering the <u>demand side</u>, it can be concluded that increased production of these non-fuel minerals will have a maximum beneficial impact on the Indian economy. These minerals can generate maximum productive activity throughout the economy.

On the other hand, the results of our calculation reveal that the following non-fuel minerals possess the highest "**forward linkage**" effects, when arranged in decreasing order of respective values of "Normalized Total Forward Linkage Index" (Index Value > 1):

1) Copper Ore	7) Silver
2) Manganese Ore	8) Tin conc.
3) Bauxite	9) Chromite
4) Gold Ore & Gold	10) Limestone
5) Lead conc.	11) Iron Ore
6) Zinc conc	12) Non-Ferrous Basic Metals (Incl. Alloys)

Non-fuel Minerals with Highest Forward Linkage Effects are:

"If the forward linkage of sector  $\mathbf{r}$  is larger than that of sector  $\mathbf{s}$ , it could be said that a dollar's worth of expansion of the output of sector  $\mathbf{r}$  is more essential to the economy than a similar expansion in the output of sector  $\mathbf{s}$ , from the point of view of the overall productive activity that it could support." (Miller and Blair, 2009)

Quite similarly, considering the <u>supply side</u>, it can be concluded that increased production of these non-fuel minerals will have a maximum beneficial impact on the Indian economy. These minerals can support maximum productive activity by supplying inputs (i.e. its own output) throughout the economy. The summary table of results obtained from this analysis are presented in <u>Table 4.5</u>

## 4.4 Principal Component Analysis (PCA)

We have applied another mathematical technique called 'Principal Component Analysis' (PCA) to identify the "key sectors." PCA is a dimensionality-reduction method that systematically filtered out the least important sectors by transforming a large set of sectors into a smaller one that still contains most of the information in the large set. <u>By "importance,"</u> the capacity of the sector in terms of influencing output of the economy has been implied.

One of the serious limitations of PCA is that, it is able to identify importance of a sector from "<u>supply side</u>" only. Hence, imported items remains out of purview of PCA.

#### The result of the PCA is presented in Table A6: Appendix

As per this table, the results can be summarized as below:

1) Eight (8) non-fuel minerals have been found to explain 100% variance in dependent variables (i.e. Output of Indian economy). These are "Key non-fuel minerals"

By observing results obtained from calculation of both "linkage effects" and "PCA", we can identify <u>eight (8) non-fuel minerals</u> as the "key resources" of Indian economy.

#### 4.6 Conclusion

The most important part of this Chapter has been the identification of 'key resources' of Indian economy using two methods. The first method is the calculation of 'Backward' and 'Forward Linkages' and the second one is the determination of 'most important' resources by application of 'Principal Component Analysis' (PCA). Results obtained from both the methods ascertained following eight (8) non-fuel minerals as the 'key resources' for the Indian economy:

# Bauxite, Chromite, Copper Ore, Gold Ore and Conc., Iron Ore, Lead Conc., Manganese Ore, Silver

These minerals have been found to have strong linkage effects (Backward / Forward) and also capture maximum influence in country's growth momentum. The most import finding in this case is that all of these resources have strong 'backward linkages'. This implies these resources have strong linkages with the economy from demand side. This indicates towards high domestic demand of 'key resources' due to:

- i) A huge and <u>rapidly growing manufacturing base</u> of Indian economy.
- ii) <u>Accelerating industrialization</u> process and a structural shift from 'agricultural' to 'manufacturing' activities.
- iii) Increase in <u>export of commodities that requires sizable amount of these non-fuel</u> <u>minerals as inputs.</u>

Stronger 'backward linkages' implies that these eight 'key resources' develop the <u>productive</u> <u>capacity</u> of the economy in both <u>intensive</u> (more production of the commodities) and <u>extensive</u> (production of more commodities) ways.

"If the backward linkage of sector  $\mathbf{i}$  is larger than that of sector  $\mathbf{j}$ , one might conclude that a dollar's worth of expansion of sector  $\mathbf{i}$  output would be more beneficial to the economy than would an equal expansion in sector  $\mathbf{j}$ 's output, in terms of the productive activity throughout the economy that would be generated by it. (Miller and Blair, 2009)

# CHAPTER 5: IMPACT ANALYSIS IN THE FRAMEWORK OF A 'MODIFIED INPUT-OUTPUT (IO) MODEL'

This Chapter outlines the deep rooted implication of some path breaking macroeconomic policies adopted by Government of India since 2020-21. The focus has been on the most significant policy-move of the Government since Economic Reform in 1991; i.e Atmanirbhar Bharat Abhiyaan' or 'Self-reliant India'.

The term 'impact analysis' in the language of Input-Output theory implies assessment of the effects of changes in one sector of the economy on other sectors, and on the economy as a whole. In this Chapter 'impact analysis' has been done using a modified Input Output model to estimate the requirement of eight 'key resources'- as already identified in the previous Chapter - for successful implementation of Atmanirbhar Bharat Abhiyaan' under the 'Make in India' campaign. The comparison of the requirement of 'key resources' vis-à-vis their availability has been used to unravel few important insights about the 'feasibility' and 'continuity' of these policies and schemes.

# 5.1 Growth Story of India since Independence: Government Policies in Retrospect

The journey of the Indian economy in pursuit of economic excellence has been fascinating in many ways. At the time of Independence, the country's economy was completely in a dilapidated state as a consequence of the systematic plunder conducted by the British rulers during their 200-year-long occupation. During this long time period, the East India Company and the British Raj established a deep-rooted network of railways and roadways to siphon out the last drop of valuable resources from every nook and corner of the country and utilised these resources to fuel the industrialisation process in Britain. A comprehensive study made by renowned economist Utsa Patnaik estimated that between 1765 and 1938, the economic drain amounted to  $\pounds 9.2$  trillion (equal to \$45 trillion), taking India's export surplus earnings as the measure, and compounding it at a 5% rate of interest. This staggering figure is fifteen times the annual GDP of the UK today. As a consequence of this massive loot, India's share of world income reduced from 22.6% in 1700 to 3.8% in 1952<sup>15</sup>. The comparative macroeconomic performance of India and Britain (1600 – 1947) is presented in **Table 5.1** 



This figure clearly shows how the sharp increase in the GDP of Britain coincided with the stagnating GDP of India during the British rule (1757 -1947). To take a step further, this explains how affluence of Britain can be correlated with the abject poverty that the people of India were subject to for a considerable period of time. Before British occupation, India was far ahead of Britain in terms of GDP figures and within a span of 200 years, the country lost all of its wealth and rendered poor in British hands. All these happened because of the systematic "drain of resources", which was well planned and executed successfully. In Marxian sense, this "economic drain" can be interpreted as the "primitive accumulation of capital"<sup>16</sup> by Britain for its transformation from a "feudalistic economy" to a "capitalistic economy."

"We have seen how money is changed into capital; how through capital surplus-value is made, and from surplus-value more capital. But the accumulation of capital presupposes surplus-value; surplus-value presupposes capitalistic production; capitalistic production presupposes the pre-existence of considerable masses of capital and of labour power in the hands of producers of commodities. The whole movement, therefore, seems to turn in a vicious circle, out of which we can only get by supposing a primitive accumulation (previous accumulation of Adam Smith) preceding capitalistic accumulation; an accumulation not the result of the capitalistic mode of production, but its starting point" (Marx, 1867)

There is no wonder that the Indian economy was in an impoverished state, at the time the country was finally successful in throwing out the British rulers after an intense episode of freedom movement, which etched a glorious period in the epoch of World history.

The focus of this thesis however zeroes in on the period immediately after the Independence (1947), when India started preparation for developing a solid structural foundation of the country through prudent policy formulation to mitigate damages inflicted by 200 years of colonial extortions. The most important issue to highlight is the exemplary role that our nationalist leaders played at that time in shaping the bedrock on which the juggernaut of the Indian economy still moves. The thesis has also made a brief assessment of the role and prudence of subsequent policy-making functionaries and a few path breaking economic policies implemented over the last 75 years since Independence. The feasibility and

sustainability of some recent policies have also been tested in terms of the economy-wide impacts associated with these policies.

#### 5.2 Government policies in India immediately after Independence

Vitalising the Indian economy from perennial stagnancy was an upheaval task in front of the leaders of the country, who were also engaged in laying the structural foundation of the country for the future. When the country embarked on a journey towards higher growth orbits, some visionary leaders were at the helm of the highest policy-making body of the "first government" formed after Independence. Some eminent economists and statisticians also shared responsibility and made significant contributions to nation-building by helping the government in developing short-term and long-term economic policies and devising "planning techniques" for the newly formed government of India. The grounding stones of the Indian economy were laid by a group of highly erudite people, who were not only well-versed in scientific thinking of the Western world but also had a deep understanding of the traditional value-based systems that prevailed for centuries in this ancient land that harboured one of the most advanced civilisations of the World. The intrinsic resilience of the Indian economy is largely attributed to the collective knowledge and dedication of a group of highly capable people, who designed the unique policy-making framework for the country.

The name that comes first in this regard is Pandit Jawaharlal Nehru - the first Prime Minister of independent India. Pandit Nehru was the chief architect in designing a planned economic development model for India. The economic policies developed under his leadership gave top priority to developing the country's production capacities. During the colonial period, the indigenous production system of India was intentionally kept undeveloped. As a result, the country remained highly dependent on imports from the Western world. Pandit Nehru opined that rapid industrialisation was the only way for import substitution. The theoretical ground of his vision was reinforced by the "Mahalanobis model," developed by another legendary son of the soil, Prof. Prasanta Chandra Mahalanobis, who is also known as the "Father of Indian Statistics." The "Mahalanobis model" established that the country at its initial phase of development should give top priority to the "heavy industries" sector to bolster the productive capacity of the domestic industries. Collectively, the components of the Nehru-Mahalanobis model are the following:

- A <u>mixed economy</u>, characterised by the existence of both public and private sectors in the production system. However, operations in certain strategic sectors remain exclusive to the public sector only
- ii) Emphasis on developing the <u>basic and heavy industries</u>.
- iii) <u>Economic planning</u> based on long-term development strategy.
- iv) <u>Unbalanced growth model</u> which conjectures that the benefits of industrialisation percolate to other sectors of the economy.




Figure 5.2 GDP of Indian economy from 1950-51 to 2020 -22

India's economic policies in the initial period after independence were highly influenced by the "Nehru-Mahalanobis model." The "Planning Commission" was set up in 1950 with the responsibility to formulate "Five-year Plans" for the country. The commission developed 12 five-year plans in total, before being replaced by the National Institution for Transforming India (NITI Aayog) in 2014. The Second Five Year Plan (1956 -61) was based on the "Mahalanobis model" of economic development. In this plan, maximum investible resources were allocated to "basic and heavy industries." The "Nehru-Mahalanobis model" of economic development in fulfilling its mission. The country was able to depart from the stagnating growth rate of the previous era (often referred to as the "Hindu Rate of Growth") and embarked on a steadily accelerating growth path. The GDP of Indian economy from 1950-51 to 2020 -22 in **figure 5.2**

#### 5.3 Government Policies during 1990s

Economic Reform, 1991: During 1990-91, the Indian economy again started showing signs of stagnancy. Economic policies based on Nehru-Mahalanobis model could not move the country in tandem with the global economic progress. There are mainly three reasons behind this policy weakness in Indian economy at the end of 1980's:

- Economic policies based on Nehruvian model was highly centralised with very little scope for private investor to flourish. Due to limited government resources, total investment of the country was always falling short. The virtuous circle of "investment-growth -investment" disappeared from the economy
- Investment in "heavy industries' started were no longer the top priority of the country. After four decades of second five-year plan, the country developed its heavy industries like Steel, Cement and Power
- Free flow of global trade became extremely necessary to capitalise on vibrant global demand.

In July 1991, Government of India introduced "economic reforms" in the form of a set of 'stabilization' and 'structural adjustment' policies. Subsequently, the 'Discussion Paper on Economic Reforms' was released by the Ministry of Finance in July 1993, stating the basic objective of economic reform as follows:

"...to bring about rapid and sustained improvement in the quality of the people of India. Central to this goal is the rapid growth in incomes and productive employment... The only durable solution to the curse of poverty is sustained growth of incomes and employment... Such growth requires investment: in farms, in roads, in irrigation, in industry, in power and, above all, in people. And this investment must be productive. Successful and sustained development depends on continuing increases in the productivity of our capital, our land and our labour. Within a generation, the countries of East Asia have transformed themselves. China, Indonesia, Korea, Thailand and Malaysia today have living standards much above ours... What they have achieved, we must strive for."

(Ministry of Finance, Government of India, 1993)

The implementation of economic reform brought a sea change in Indian economy. Country's GDP figure started to grow at an astounding rate. **Figure 5.2** clearly shows this fantastic growth in terms of a steep ascent of the economy to a high-income orbit.

#### 5.4 Percentage Changes in GDP and Per Capita GDP of India

The macroeconomic policy formulations in India changed over time apropos to changes in the economic situation of the country. The new growth policies on which this thesis has focused is from 2011 till date. Two most important policies initiated by the Government of India during this period were 'Make in India' (2014) and '*Atmanirbhar Bharat Abhiyaan*' (2020). And this study keeps relevance primarily to these two policies. Two most important objectives of this thesis are:

- To achieve the growth targets of different sectors of the economy (as envisaged by the Government of India); new growth policies were introduced with adequate provision of funding. However, to tick the targeted growth rate; other sectors of the economy also need to grow due to strongly interdependent industry structure. This thesis seeks to capture the economy wide impact of Government expenditure aiming at some ambitious growth targets.
- ii) Measuring impact on 'key resource' sectors is the primal motive of this thesis.
- iii) The aspiration to touch 5 Trillion dollar economy can only be achieved when requirement of key resources are met. And this could be made possible in two ways: either by increasing domestic production or by importing from other countries. Increasing domestic production is highly contingent upon natural endowment of these resources. In that case the only option is to import.

The crux of the entire course of action is to build a strong supply chain of key resources, in the economy. However, to understand the perspective of new growth policies, changes in the economic situation of the country must be introspected.




Figure 5.3 Growth Rate (%) of GDP in India from 2011-12 to 2021-22

### 5.4 New Growth Policies: Make in India and Atmanirbhar Bharat Abhiyaan

### 5.4.1 Make in India

During 2012-13 the country was facing an adverse situation where GDP growth rate had fallen to its lowest level in a decade and Indian economy was tagged as one of the 'Fragile Five'. The country was on the brink of severe economic failure; desperately in need of a big push. The Per Capita GDP also followed the suit of GDP growth rates. (Figure 5.3)

'Make in India' initiative was launched in September 2014 by the Prime Minister, Mr. Narendra Modi as a response to this crisis. The programme was designed to facilitate investment, foster innovation, enhance skill development, protect intellectual property and build best in class manufacturing infrastructure in the country. The motto of 'Make in India' campaign was to attract investments from across the globe and strengthen India's manufacturing sector.

"I want to tell the people of the whole world: Come, make in India. Come and manufacture in India. Go and sell in any country of the world, but manufacture here. We have skill, talent, discipline and the desire to do something. We want to give the world an opportunity that come make in India," ~ Prime Minister of India, Mr Narendra Modi, Independence Day speech on August 15, 2014.

The programme led by the Department for Promotion of Industry and Internal Trade (DPIIT), Ministry of Commerce and Industry, Government of India; focused on 25 sectors. These included: *automobiles, automobile components, aviation, biotechnology, chemicals, construction, defence manufacturing electrical machinery, electronic systems, food processing, IT & BPM, leather, media and entertainment, mining, oil and gas, pharmaceuticals, ports and shipping, railways, renewable energy, roads and highways, space, textile and garments, thermal power, tourism and hospitality and wellness<sup>17</sup>* 

The government provided various incentives such as tax exemptions and subsidies to companies that invest under this initiative.

The economic situation improved considerably after initiation of 'Make in India'. Growth rates of both GDP and Per Capita GDP took upward turn (**Figure: 5.3**)

#### 5.4.2 Atmanirbhar Bharat Abhiyaan

During 2020-2021, the Indian economy again started losing the growth momentum and the signs of economic stagnation became evident with low growth and high employment rate. As a result, government of India embarked on a massive investment drive and introduced a new mission to give a strong boost to the Indian economy. On 12th May 2020, the Prime Minister Mr. Narendra Modi raised a clarion call to the nation giving a kick start to the Atmanirbhar Bharat Abhiyaan (self-reliant India campaign) and announced the special economic and comprehensive package of INR 20 lakh crores - equivalent to 10% of India's GDP - to fight COVID-19 pandemic in India. This mission was the dictum of new India envisaged by the Hon'ble Prime Minister Shri Narendra Modi in 'Make in India' programme back in 2014. 'Make in India' did not attach any significant financial commitment from Government (apart from some incentives). The 'Atmanirbhar Bharat Abhiyaan' however involved a massive financial package to give a thrust to local manufacturing, local markets and local supply-chains- thus propagating Hon'ble PM's vision of 'vocal for local'. The entire scheme focused on providing impetus to the 'Make in India' initiative and transforming local Indian companies into global brands. This comprehensive economic package primarily intended to strengthen following five (5) pillars of 'self-reliant' India<sup>18</sup>:

- Preparing for a quantum leap in the economy. The government's goal is to make India a USD 5 Trillion economy by 2025.<sup>19</sup>
- 2. Developing world class infrastructure to enable the economy to achieve the target of a USD 5 Trillion GDP. More than INR 100 lakh crore were committed by the Government to be invested in infrastructure development in India over the next five years.<sup>20</sup>
- 3. Modernising systems; based on 21st-century technology-driven arrangements.
- 4. Capitalise on the competitive advantage of the country owing to its vibrant demography.
- 5. Taking measures to **boost demand** to its fullest extent.

Subsequent to Prime Minister's announcement, Finance Minister Mrs. Nirmala Sitharaman provided details about the five tranches of economic package under *Atmanirbhar Bharat Abhiyaan*. She has provided the detailed break-up of Rs. 20,97,053 crore package one by one. Brief information about these five tranches are presented in <u>Table 5.2.</u>




Figure 5.4 Percentage Share of Fund Allotted in Five Tranches and Other Measures

In fact the fourth tranche actually keeps relevance to this thesis. It has coverage of eight sectors which are of interest to this study. Some of the important sectors are:

<u>Figure 5.4</u> clearly reveals that least percentage of funding was allotted to fourth tranche. Moreover nearly 47% of the fund accounted either for RBI Measures and Reforms or some earlier mission already executed. Hence, the fiscal part of the package was almost half of what actually announced. From this, we can arrive at two important recommendations:

- More funding is required for sectors mentioned under fourth tranche. Because these sectors are too important for the Indian economy due to high multiplier values and strong linkages.
- 2) Total funding should also be increased, since outcome of 'Atmanirbhar Bharat Abhiyaan' has been positive.

In fact, along with "*Atmanirbhar Bharat Abhiyaan*," the government of India introduced many new policies and schemes in last ten years. A brief list of these policies is given below:

The coverage of "*Atmanirbhar Bharat Abhiyaan*" has been included many functional sectors of Indian economy. And in this regard, the <u>Performance Linked Incentive (PLI) Scheme</u> played an instrumental role.

At this moment, it can be safely stated that Government of India has embarked on a fascinating journey towards higher growth trajectory by adopting a synchronised policy framework, which can be best described as: "Ensuring self-reliance with Sustainability." There is a strong perspective behind this part our study. Hence, it is extremely crucial to highlight them here:

As per claims made by Secretary, DPIIT in a Press Conference, the <u>Performance Linked</u> <u>Incentive (PLI) Scheme</u> introduced by Prime Minister, Narendra Modi with the objective of making India 'Aatmanirbhar' was a game changer for the country's growth narrative. It was claimed that mainly because of PLI Schemes, there was a significant increase of 76% in FDI in the Manufacturing sector in FY 2021-22 (USD 21.34 billion) compared to previous FY 2020-21 (USD 12.09 billion). The PLI schemes was built on the foundation of 14 sectors with an incentive outlay of Rs. 1.97 lakh crore to strengthen their production capabilities and help create global champions. The driving force behind the latest set of schemes and missions initiated by Government of India is primarily based on the concept of "*export promotion*" and "*import substitution*". Schemes like "*Atmanirbhar Bharat Abhiyaan*" primarily zero in on achieving "*self-reliance*" of the economy in terms of a significant reduction in the total import burden. Simultaneous implementation two policy drives, viz. "Export Promotion" and "Import Substitution," have further been accompanied by the pressing need for reducing the carbon-footprints of the manufacturing activities in the country, with due cognizance to global treaties.

#### 5.5 Impact Analysis Using a Modified Input-Output Model

As already mentioned, a 'modified Input-Output framework' has been used in this thesis to estimate the requirement of non-fuel minerals that Government Schemes like *"Atmanirbhar Bharat Abhiyaan"* entails. At the outset, the production targets (in Rs. Crores) of different sectors of the Indian economy have been presented in <u>Table 5.3</u>

The '*Atmanirbhar Bharat Abhiyaan*' and some other 'self-reliant policies' collectively entail these production targets for different sectors. These figures are mostly available with the websites of the relevant ministries and also some other related government agencies' websites like India Brand Equity Foundation (<u>https://www.ibef.org/</u>); Invest India (<u>https://www.investindia.gov.in/</u>); NITI Aayog (<u>https://www.niti.gov.in</u>); Department of Economic Affairs (<u>https://dea.gov.in/divisionbranch/economic-division</u>); Press Information Bureau (<u>https://pib.gov.in/indexd.aspx</u>); Newspaper Reports, Parliament Question & Answer (<u>https://sansad.in/ls/questions/questions-and-answers</u>), Industry Bodies and Associations, etc.

The **logical framework** of the 'Impact Analysis' executed in this thesis can be delineated as follows:

- 1. The '*Atmanirbhar Bharat Abhiyaan*' along with some recent growth oriented macroeconomic policies adopted by Government of India entails some sector specific production targets. These targets have been set keeping in mind a bigger target, i.e to achieve USD 5 Trillion GDP figure by 2025
- It is assumed that the funding and various incentives through 'self-reliant' policies of Government of India would enable sectoral players to collectively achieve these production targets
- However, achieving production targets would entail huge requirement for 'non-fuel minerals' through economy-wide impact of output increase. These non-fuel minerals are also 'key resources' of Indian economy
- Increased requirement of 'key resources' can only be met, if domestic production increases. However, production of 'key minerals' is highly constrained by limited reserves of natural endowments
- 5. If increase in domestic production of 'key minerals' is not possible, the country will have to depend on imports. This will not only cause import dependence, but also involve huge cost burden on country's exchequer. In case of imports, supply chain vulnerability can emerge as a critical issue
- 6. Hence, the feasibility and long run continuity of growth oriented policies like 'Atmanirbhar Bharat Abhiyaan' will depend on a large number of factors and it requires a judicious approach by Government of India

#### 5.6 **Summary of Result**

This thesis has tested feasibility of growth targets set by macroeconomic policies of Government of India focusing on huge growth rates. We have studied the economy-wide impacts of following threen (13) sectors as follows:

1. Textile And Apparel	8. Electrical Cables, Wires & Appliances
2. Chemicals (Excl. Fertilizer)	9. Batteries
3. Fertilizers	10. Transport, Vehicles & Transport Equipment



From this 13 tables, we have calculated the required growth rate of a key mineral by looking at the highest growth that can simultaneously satisfy demand from all the sectors to achieve targeted production level, as envisaged by 'Atmanirbhar Bharat Abhiyaan'. The maximum production of 'key minerals', simple growth rate required per annum (%) and CAGR (%) figures have been presented in Table 5.4. Three more tables (Table 5.5; 5.6 and 5.7) were drawn on the basis on Table 5.4. These tables have been quite insightful for our analysis:






**Figure 5.5** Required Productions of Key Minerals to Satisfy Demand from All the Sectors


From these three figures it is evident that:

- 1) Almost all the sectors need to grow remarkably to sustain individual growth plans
- In almost all cases Copper Ore and Manganese Ore have been the binding constraints. These two are key ingredients to many manufacturing units
- The huge growth in "Electrical & Electronic Components" requires adequate supply of these two mineral resources
- In terms of production volume; 'Non-ferrous Basic Metals (incl. Alloys)', 'Gems and Jewelry', 'Iron Ore' and 'Limestone' are needed to be produced in large scale
- 5) Impact analysis points out that 5 minerals are most important 'non-fuel minerals' in regards to country's growth strategy. These <u>key minerals</u> are: <u>'Copper Ore', 'Manganese Ore', 'Bauxite', 'Chromite' and 'Gold Ore and metal</u>'. The economy would require these key minerals to such an extent, so that their domestic production need to grow at a facinating pace to meet sudden surge in demand
- 6) More specifically, <u>Copper Ore</u> and <u>Manganese Ore</u> has come out to be the most crucial minerals and enabler to achieve USD 5 Trillion GDP.

Now, let us look at the 'Reserve Position' and degree of 'Self sufficiency' of these 'key minerals' on the basis of country's natural endowments:

The reserve position of minerals in India has been presented in **Table 20: (Appendix).**

From <u>figure 5.8</u>, it is quite clear that apart from **Limestone** and **Iron Ore**, India does not have adequate amount of key resources to support future growth initiatives . This is a serious structural vulnerability in terms of country's natural endowments. <u>Policy makers need to be extremely cautious about this weakness</u>, whenever any new growth policies are introduced. The vulnerability of Indian economy in terms of availability of key minerals can also be substantiated by data on '<u>Degree of Self-sufficiency in Principal Minerals & Metals'</u> available with Ministry of Mines, Government of india (<u>Table A21: Appendix</u>). This table shows that India has only 50% and 40% self-sufficiency for its two most important key minerals, i.e <u>Copper and Manganese</u> respectively.

#### 5.7 Observations

- Considering the reserve position, it is easily observable that these two resources are most extensively used "key resources" in India's growth story
- 2) Exports of copper ores & concentrates decreased considerably by 39% to 82,463 tonnes during 2020-21 from 2,12,659 tonnes in 2019-20. <u>Government should immediately stop exports of the particular grade of Copper Ore , to fully cater the huge domestic demand that the ongoing government projects entail.</u>

The export and Import of Export of MCDR Minerals during 2018-19 to 2022-23 has been presented in <u>Table A22</u> and <u>Table A23: (Appendix</u>) respectively.





Figure 5.9 Quantity of Import (tonnes) of MCDR Minerals<sup>^</sup> during 2018-19 to 2022-23

To get a more clear picture, we have plotted Quantity and Value of Import of Copper and Manganese and presented in <u>figure 5.9 and 5.10</u> respectively.

#### Figure 5.9 and 5.10 reveal that:

- i) Larger amount of Manganese Ore is imported. However, its import value is much lower than that of Copper Ore
- ii) Import value of Copper Ore (in Rs. Crore) has sky rocketed manifold since 2020-21; though the quantity of import increased marginally. <u>This hints towards a</u> <u>probable upsurge in price of Copper Ore in global market</u>.
- iii) On the other hand, quantity imported of Manganese ore has suddenly plummated from 2020-21, though the import value decreased at a much lower rate.

India's copper production not only serves the domestic market but also contributes to the country's export earnings. Copper and copper products are exported to various countries. However, India also imports a significant amount of copper, mainly in the form of copper concentrate, to meet its domestic demand, especially for manufacturing and industrial use. The demand for copper in India is driven by various sectors, including electrical, electronics, construction, transport, and telecommunications, reflecting the metal's importance in infrastructure, renewable energy projects, and manufacturing.

# 5.8 Copper Ore and Manganese Ore: Two Key Enablers of India's Growth Story

This thesis has clearly pointed out that 'Copper Ore' and 'Manganese Ore' are two key enablers of India's growth dynamics. Hence, some more details about these two key minerals can unravel important insights about Indian economy. However at the outset; we need to understand why these two minerals are so important for the Indian economy.

### 5.8.1 <u>Copper Ore</u>

#### 5.8.1.1 <u>Uses of Copper Ore in Industry</u>

In India, copper ore finds extensive use across various industries due to its excellent electrical and thermal conductivity, corrosion resistance, and malleability. Key industries utilizing copper ore include:

- 1. <u>Electrical Industry</u>: Copper is used in manufacturing electrical wires, cables, motors, transformers, and generators.
- 2. <u>Electronics and Telecommunications</u>: In this sector, copper is essential for producing electronic items, circuit boards, broadband, and communication cables.
- 3. <u>Construction and Infrastructure</u>: Copper is employed for plumbing, roofing, cladding materials, as well as electrical wiring in buildings and architectural elements.

- 4. <u>Automotive Industry</u>: Copper finds its applications in manufacturing motors, wiring, radiators, connectors, and brakes for conventional vehicles. In electric vehicles (EVs), copper is utilized in batteries, wiring, and inductive charging systems.
- 5. <u>Renewable Energy</u>: Copper is crucial for generators, cables, and transformers used in solar, wind, and hydro power plants.
- 6. <u>Defense and Aerospace</u>: Various components for defense equipment and aerospace applications are manufactured using copper.
- 7. <u>Heavy Machinery and Equipment</u>: Copper is used in the production of heavy machinery and industrial equipment like conveyors, hydraulic systems, and air conditioning systems.
- 8. <u>Consumer Goods</u>: Copper is employed in home appliances, cooking utensils, and various decorative items.
- 9. <u>Railways and Metro Projects</u>: In these projects, copper is essential for electrification, signaling systems, as well as power supply and grounding systems in metro projects.

#### 5.8.1.2 <u>Copper's Role in Energy Transition</u>

Copper ore is integral to the transition towards sustainable and renewable energy sources. Its significance is evident in various key areas:

- <u>Renewable Energy Systems</u>: Copper is essential in the construction and operation of renewable energy systems, such as solar panels, wind turbines, and hydroelectric power plants. It is used in wind turbine generators, photovoltaic cells, and electrical wiring, significantly impacting the efficiency of these systems in generating and transmitting electricity.
- 2. <u>Electric Vehicles (EVs)</u>: Copper plays a vital role in the electrification of vehicles. It is heavily relied on in electric motors, batteries, and charging infrastructure, with an average electric car using about four times more copper than a conventional one.
- 3. <u>Energy Storage</u>: Copper is crucial in energy storage solutions, enhancing the efficiency and connectivity of batteries and storage technologies, which are essential for balancing the intermittency of renewable energy sources.
- 4. <u>Energy Efficiency</u>: Copper contributes to improving the efficiency of energy use in heating, cooling, and lighting systems, thereby reducing the energy demand and carbon footprint of buildings and industrial processes.
- 5. <u>Grid Infrastructure</u>: Upgrading and expanding the electrical grid requires substantial amounts of copper to accommodate renewable energy inputs. This includes the

development of smart grid technologies, enhancing the efficiency and reliability of the grid by integrating renewable energy sources.

6. <u>Green Building</u>: Copper is employed in green building practices for plumbing, roofing, and electrical applications due to its durability and recyclability, contributing to the sustainability of building materials.

#### 5.8.1.3 <u>Copper Sector in India: Issues and Concerns</u>

The copper sector in India is currently facing challenges but also holds promising opportunities for growth. The problems and concerns include:

- <u>Limited Domestic Reserves and Production</u>: India has relatively limited copper ore reserves, accounting for only 2% of the global reserves and production contributing to just 0.2% of the global output. The shutdown of the <u>Thoothukudi copper smelter</u>, a major facility in India, led to a significant drop in production, forcing the country to become a net importer after almost two decades.
- <u>Global Supply Chain Vulnerabilities</u>: The global copper supply chain is concentrated in countries like Chile and Peru, posing risks due to geopolitical factors and potential disruptions in the supply chain.

#### 5.8.1.4 Opportunities in Copper Sector of India

- <u>Growing Demand and Government Initiatives</u>: The Indian copper sector stands to benefit from increasing global demand and rising copper prices, particularly from key markets like China. Changes in mining regulations are anticipated to encourage private sector investments in the industry.
- International Collaboration and Investment: India is exploring international partnerships to secure a stable copper supply. Initiatives like sending industry delegations to copper-rich countries such as Zambia indicate a strategic approach to mitigating supply vulnerabilities and reducing import dependence.

Overall, India's copper industry aims to address supply constraints, capitalize on government reforms, and engage in international collaborations to enhance domestic production and decrease reliance on imports. By prioritizing sustainable strategies and strategic investments, India's copper sector can drive growth and align with its economic objectives successfully.

#### 5.8.2 Manganese Ore

#### 5.8.2.1 Manganese Sector in India: An overview

Manganese ore is an important material in iron and steel metallurgy, where it is used both in the ore form and as ferromanganese. Steel Industry accounts for approximately 90% of the world demand for manganese. This indicates strong growth of Steel Industry in the country as steel is the principal market accounting for 65 to 70% manganese consumption. Exports of manganese ore (total) increased by 40% to 82363 tonnes in 2020-21 from 58198 tonnes in 2019-20. Out of the total exports in 2020-21, only 10 tonnes of manganese ore having +46% Mn of value of Rs. 3,30,000 was exported. Government needs to take immediate steps to curb on export of Manganese Ore. Otherwise; all ambitious missions implemented by the government will soon face severe shortage of Manganese Ore. The manganese sector in India faces a mix of challenges, opportunities, and growth prospects aligned with global trends, technological advancements, and infrastructure development:

#### 5.8.2.2 <u>Challenges and Concerns</u>

- Market Consolidation: The manganese industry in India is dominated by a few major players, posing barriers for smaller companies entering or competing effectively in the market.
- Production Decline: Manganese production in India witnessed a decline between 2017 and 2020, indicating potential issues in mining efficiency, resource availability, or market demand that require attention.

#### 5.8.2.3 <u>Opportunities</u>

- Rising Demand for Electric Vehicles: The global shift towards electric vehicles is anticipated to boost the demand for manganese, a key component in battery production, presenting a significant growth opportunity for the manganese sector in India.
- Infrastructure Development: Government policies promoting infrastructure development like foreign direct investment (FDI) in the construction sector could spur demand for manganese in steel production and other applications.
- Global Market Influence: The increasing industrial production and market expansions in countries like China offer export opportunities for Indian manganese producers to tap into the growing demand.

#### 5.8.2.4 <u>Future Trends</u>:

• Electrical Batteries: The anticipated growth in the use of manganese in electrical batteries, particularly for electric vehicles and energy storage solutions, will shape the future demand and evolution of the manganese sector.

The manganese sector in India stands at a pivotal juncture, poised for substantial growth by addressing challenges, leveraging opportunities, and adapting to global market trends, especially in the context of technological advancements and infrastructure developments.

# CHAPTER 6: INDIA'S PARTICIPATION WITH GLOBAL VALUE CHAINS (GVC)

#### 6.1 Introduction to the topic

International trade and the connection with Global Value Chains (GVCs) also plays an instrumental role in shaping the 'economic resilience' of the economy through a supply chain mechanism of 'key resources.

'The most important deciding factor at present is probably the issue of sustainability. Global 'climate change' has emerged as the scariest threat to the existence of mankind. International bodies like United Nations (UN) are pressing all the countries across the globe to significantly reduce the 'carbon footprints' associated with manufacturing activities. Systematic transitions from the "fuel based" energy system to "material based" energy system is the recent global trend to reduce CO2 emissions in the process of electricity generation by countries including India. However, 'material based' energy system entails huge requirement of non-fuel minerals.

In today's highly globalized world, the output produced by an economy does not only depend on domestically available inputs but also depends on imported inputs sourced from other countries. Import of inputs happens mainly in two situations:


- a) <u>Inadequate Availability</u>: Some inputs are not at all available domestically due to a lack of natural endowment. In some cases, internal supply is below what is required; hence the remaining amount is imported. Since minerals are sparsely distributed across the globe, the imports of fuel and non-fuel minerals constitute a major part of import basket of industrial inputs. In case of India, most of the Crude Oil requirement are met by imports. The self-sufficiency quotient was only 15.6% in 2020-21. It further fell to 12.7% in 2022-23 (P)<sup>21</sup>
- b) <u>Issue of quality</u>: In many cases, the domestically available inputs are not of the desired quality. In such situations, countries are compelled to import good quality inputs from foreign countries. For example, despite being the second largest producer of coal<sup>22</sup>, India has to import metallurgical coal from Australia for steel production.



Coal available in India is of medium grade and has high heating capacity. This type of coal is suitable for electricity generation but not for steel production. For Steel production "Coking Coal" (or <u>metallurgical coal</u>) is required, which is of better quality due to a higher carbon content, as well as a lower level of sulphur, phosphorous and alkalis. India has a reserve of around 35 billion tonnes of Coking Coal, which is grossly inadequate to feed the huge demand from the Steel industry. As a result, around 70% of the demand for Coking Coal in the country is imported from foreign countries, mainly Australia. As per observation of the report by the Inter-Ministerial Committee (IMC) constituted by the Ministry of Coal, Government of India:

"Since domestic coking coal is of high ash variety and the demand for coking coal in India is much higher than domestic production, about 50 MT coking coal is imported by the country on an annual basis. During FY 2021, total 51. 29 MT of coking coal was imported into the country. The Indian steel industry fulfils ~70% of its coking coal requirements through imports. Growth in steel production is expected to push up demand for metallurgical coking coal to 75 MT in FY 2023. Consequently, the share of imports is expected to remain over 76-77% in FY 2022 and FY 2023. In absolute terms, coking coal imports are expected to increase to 58 MT in FY 2023 from 47 MT in FY 2018. Almost 70% of the coking coal in the country is imported from Australia, leaving India highly dependent on Australia for supply of a critical raw material to the steel industry and exposing the industry to price volatility vulnerability." (IMC Report on Augmentation and Consumption of Domestic Coking Coal by Steel Sector, (Report by IMC Constituted by Ministry of Coal), Inter-Ministerial Committee, 7-16-2021)

The import of crucial inputs acts like a pivot that connects the cross-border supply chains. Economic integration with other countries happens through these cross-border supply chains. For industrial activities to flourish, economic integration is extremely necessary to realise the full potential of an economy. However, the pandemic explicitly manifested that dependence on imported inputs has some serious flipsides. Covid19 has made it evident that situations like the pandemic can seriously impair the growth prospect of a country through "supply chain disruptions".

Firstly, upstream industries operating from foreign countries supply necessary inputs to the export-producing industries of the country. This is called "backward linkages". The "backward linkage" captures the direction of causation if linkages are explained in terms of a "demand side model"

On the other hand, the concerned country supplies the domestically produced commodities as inputs to the downstream industries of trading partners. This is called "forward linkages". The "forward linkage" captures the direction of causation if linkages are explained in terms of a "supply side model".

In a nutshell, the production system of each country relies heavily on output produced by other countries through "forward" and "backward" linkages. The dependence of exportproducing industries on imported inputs is very significant in this regard because it gives a fair measure of the degree of connectedness among a group of countries through the 'supply chain'. Hence a quantitative measure of the "import content of export" can be very useful, not only in terms of ascertaining the degree of connectedness but also in terms of identifying "key industries' that play instrumental roles in shaping the entire framework of "economic integration" in a highly globalized geopolitical scenario. The economy-wide impact of any supply-chain disruption is immediately transmitted through innumerable webs of interconnected backward and forward linkages creating a rippling effect encompassing the global economy.

<u>Understanding Value Added:</u> Value added refers to the additional value created at a particular stage of production. It is the difference between the output value and the value of intermediate inputs used in the production process. In essence, it measures the contribution of labor and capital to the production process, excluding the materials and services consumed.

Final Demand: Final demand represents the total demand for goods and services that are not used as intermediate inputs in production. It includes household consumption, government

expenditure, investment in capital goods, and net exports. Final demand is the end-point of the production chain, where goods and services are consumed by the end-users.

### 6.2 Global Value Chains (GVCs) & Value Chain Integration

Global Value Chains (GVCs) refer to the range of production activities from design, manufacturing, marketing, and distribution, up to the sale to end-consumers, which are split among several firms across different countries. Countries engage in GVCs either by backward or forward linkages. The GVC participation index provides an estimation of how much an economy is connected to global value chains for its production and foreign trade. Backward linkages are formed when a country imports foreign inputs to produce goods and services they export. Forward linkages are formed when a country exports domestic inputs to countries in charge of downstream production. It captures the domestic value added contained in inputs sent to third economies for further processing and export through supply chains.

## 6.2.1 Measurement of Participation in GVCs

Participation of an economy in Global Value Chain (GVC) can be assessed in terms of following three parameters:

## i) **Forward Linkage**: Value-Added Share in Exports (*VAS<sub>Exp</sub>*)

The concept of **Value Added Share in Export** refers to the portion of the value of exported goods or services that is added by the exporting country. This metric is important because it helps in understanding the economic benefit that a country derives from its export activities.

## i) **Backward Linkage**: Value-Added Share in Final demand $(VAS_{FD})$

The concept of Value Added Share in Final Demand  $(VA_{FD})$  is a crucial aspect of economic analysis, particularly in the context of input-output models and the study of global value chains. It helps in understanding how the value added by each industry contributes to the final demand for goods and services. This note delves into the basics of this concept, its significance, and its implications for economic policy and business strategy.

## ii) Import Content of Exports

The import content of exports refers to the share of imported inputs in a country's overall exports. It reflects the extent to which a country relies on foreign inputs in

its export production. This measure is also known as the "foreign value-added share of gross exports" and is expressed as a percentage. It is a reliable indicator of international "backward linkages" in global value chains. In simpler terms, it tells us how much of a country's exported goods or services contain components or materials that were imported from other countries. The higher the import content of exports, the more interconnected a country is with the global economy. This measure is essential for understanding a country's economic relationships, trade dependencies, and participation in global supply chains. It helps policymakers and analysts assess the impact of international trade on a nation's economy

OECD provides a comprehensive definition of 'Import Content of Export' as follows: 'Import content of exports is defined as the share of imported inputs in the overall exports of a country, and reflects the extent to which a country is a user of foreign inputs. The measure is also often referred to as the 'foreign valueadded share of gross exports' and is defined as the foreign value-added in gross exports divided by total gross exports, in percentage. It is considered as a reliable measure of international 'backward linkages' in analyses of global value chains.' (OECD 2024)<sup>23</sup>

To measure impact of various trade policies on the equilibrium condition in the economy, these parameters are calculated (*In all cases, the trade (export/import) of a country captures exports to all trading partners as well as bilateral export of the country with some selected partners*)

## 6.3 Logical background of our Study: Relation between Value Chain Integration and Key Sector

The degree of connectedness of an industry with the rest of the world is often suitably measured by quantifying the 'backward' and/or 'forward' linkages associated with it. Quite interestingly, with higher values of backward and/or forward linkages, some industries (sectors) are always found to wield stronger influence in determining the underlying dynamics of the economic systems. These industries act as a fulcrum for spreading the 'economy-wide impact' of both 'internal' and 'external' impulses brought about by "internal policy changes" and "external supply chain shocks" respectively. Since these industries play

"key roles" in both destabilizing and subsequently delineating the required set of counteracting stabilizing policy prescriptions to the government, we can conveniently identify these sectors as "key sectors" (as conceptualized at the beginning of this study). Most importantly, any cardinal measurement of 'forward' and 'backward' linkages can make the difficult task of identifying "key sectors" much easier. Identification of "Key Sectors" using this intricate logic has been ratified in various literatures, including the most authentic and pioneering one<sup>24</sup> by Ronald E. Miller and Peter D. Blair.

## 6.4 Details of the Study

This thesis has investigated into the degree of economic integration of Indian economy with East Asian countries (as a consolidated block of 7 countries). In this study we have measured extent of "Value Chain Integration" using trade figures between India and East Asia. The lists of East Asian countries taken into consideration are:

India's trade relationship between Macao and Hong Kong has deteriorated over time.

6.4.2 <u>Reasons behind India's Deteriorating Trade Relationship with Macao and Hong Kong</u> India's trade relationship with Macao and Hong Kong, both being Special Administrative Region (SAR) of China, is influenced by a variety of factors ranging from economic policies and market dynamics to geopolitical tensions. India's relationship with China has faced several challenges and tensions over the years, including border disputes and strategic competition in Asia. Since Macao is a SAR of China, these broader geopolitical issues can indirectly affect India-Macao trade relations, leading to a cautious approach in economic engagements. Moreover, the enactment of the National Security Law in Hong Kong by the Chinese government has led to concerns about the region's autonomy and freedoms. This could potentially impact the confidence of Indian businesses in Hong Kong as a stable and predictable place to conduct business.

Although trade between these two countries are miniscule (only 2.41% of India's total volume with East Asia) this study has considered to take into consideration of both the countries to make coverage of East Asia comprehensive. We have tried to incorporate all

countries falling under the geographical boundary of East Asia, whatever miniscule their trade relationship may be.

#### 6.6 Database

This study used Input-Output tables and data on Export, Final Demand, and Value added from version 11 of the GTAP database.

The centrepiece of the Global Trade Analysis Project is the GTAP Data Base, a fully documented, publicly available global database containing complete bilateral trade information, transport and protection linkages. The GTAP Data Base represents the world economy and is utilized by thousands worldwide as a key input into most applied general

equilibrium (AGE) analysis of global economic issues. An overview of GTAP 11 is available from the open access journal:

#### 6.7 Results

#### 6.7.1 Forward Linkage: VAS Exp and VAS FD

First, we have calculated Ratio of Value Added (RVA) and Export Share (ES) of 38 sectors that we have categorised as per our 'Aggregation Scheme', using Input-Output table of 2019-19. These two indices are required to be calculated for the measurement of 'Forward' and 'Backward' linkages.

Our calculations based on Table A24 and Table A25 show that both value Added Share in Export (VAS<sub>Exp</sub>) and Value Added Share in Final Demand (VAS<sub>FD</sub>) – i.e measures of Forward Linkages in traded goods and services between India and East Asian countries are very high (0.9).

## 6.7.2 Calculation of Backward Linkage

From Table A26 it is evident that the overall import content of export from India to East Asia is 1.20

#### Observations

- Among first 10 sectors in terms Import Content of Export. Five (5) are 'Non-fuel minerals (Manganese ore, Limestone, Copper Ore, Bauxite and Other Metallic Minerals) and one (1) is 'Fuel Mineral'(Coal). This result corroborates our previous results which identified Manganese ore, Limestone, Copper Ore and Bauxite as India's 'Key Resources'.
- 2. Hence India has immense opportunity to strengthen value chain integration in these minerals.

#### 6.8 Checking Robustness

The measurement of value-added share in exports is facilitated by methodologies like the Input-Output analysis and data from sources such as the World Input-Output Database (WIOD) and the Organisation for Economic Cooperation and Development (OECD)'s Trade in Value Added (TiVA) database. These analyses take into account the direct and indirect contributions of various sectors to export products, offering a comprehensive view of economic contributions beyond simple export figures.

TiVA (Trends in International Value Added) Data is a comprehensive statistics initiative of the OECD, that aims to measure international trade in services. The data tool tracks value added in various industries across countries and regions, enabling policymakers, businesses, and researchers to analyze and compare trade and economic activity internationally. TiVA Data covers over 400 industries, including a range of services such as finance, healthcare, and information and communication technology. The data estimations are based on the

availability of source data and incorporate complementary economic indicators like GDP, employment, and inflation.

As mentioned by OECD<sup>25</sup>, TiVA data provide insights into:

- 1. Domestic and foreign value added content of gross exports by exporting industry
- 2. Services content of gross exports by exporting industry, by type of service and value added origin
- 3. Participation in global value chains (GVCs) via intermediate imports embodied in exports (backward linkages) and domestic value added in partners' exports and final demand (forward linkages)
- 4. Industrial activity's *global orientation*, i.e. the share of industry value added that meets foreign final demand
- Country and industry origins of value added in final demand, including the origin of value added in final consumption (by households and government) and in Gross Fixed Capital Formation (investment by businesses)
- 6. Bilateral trade relationships based on flows of value added embodied in domestic final demand
- 7. Inter-regional and intra-regional relationships
- 8. Domestic value added content of imports

In this thesis, we have zeroed in on the third point, i.e. Participation in global value chains (GVCs) via intermediate imports embodied in exports (backward linkages) and domestic value added in partners' exports and final demand (forward linkages)

The measure of 'backward Linkage' (Intermediate Imports Embodied in gross Exports) in Table reveals that the value is 1.12 in 2019. This is very close to value obtained by us (Forward Linkage = 0.9 and Backward Linkage = 1.20). This firmly confirms robustness of our analysis done in previous section.

In addition to that, calculations from TiVA provide some other important insights into the picture.

- Linkage effects for 'Mining and Quarrying' sector are much higher than overall linkages
- Linkage effects for 'Mining and extraction of energy producing products' are highest in this category, indicating India's dependence on 'fuel minerals'
- iii) Forward Linkage for 'Mining and extraction of energy producing products' is much higher than the backward linkage. <u>This implies India is more integrated</u> from 'Supply Side' by exporting 'Mining and extraction of energy producing products' to East Asian countries.

#### 6.9 Conclusion

The study unravelled few significant findings from an analysis on the measure of Backward and Forward Linkages, Value Addition and Import Content of Export in trade for India. It revealed that among the first 10 sectors in terms of Backward Linkages, five are 'Non-fuel minerals' (Manganese ore, Limestone, Copper Ore, Bauxite, and Other Metallic Minerals), and one is 'Fuel Mineral' (Coal). The values of Forward and Backward Linkages have been calculated as 0.9 and 1.20 respectively. This outcome supports previous results that recognized Manganese ore, Limestone, Copper Ore, and Bauxite as India's 'Key Resources'. Consequently, the analysis underscores a substantial opportunity for India to enhance its value chain integration in these mineral sectors.

Further insights from TiVA calculations reveal that the backward linkage value of 1.12 in 2019 is almost in line with the previously obtained values of 0.9 for forward linkage and 1.20 for backward linkage, thus validating the robustness of the analysis. The results of the study focusing on the sector of 'Mining and Quarrying' and the sub-sector of 'Mining and extraction of energy producing products' reveals that the linkage effects are significantly higher in the 'Mining and Quarrying' sector compared to overall linkages. Among this sector, the 'Mining and extraction of energy producing products' shows the highest linkage effects, underscoring India's reliance on fuel minerals. Notably, the forward linkage in this sub-sector is much higher than the backward linkage, indicating India's greater integration into the supply side by exporting these products to East Asian countries.

As GVCs are currently undergoing transition, driven by several factors like the need for diversification due to the pandemic and ensuring supply chain security due to strategic reasons. This has opened significant opportunities for India to step up in existing value chains and capture greater market share. Putting results of our study into perspective, the thesis

corroborated that India has the potential to increase its participation in global value chains (GVCs) by focusing on 'key mineral sectors'. Suitable government policies are also required for streamlining its customs and trade procedures and involving its extensive micro, small, and medium enterprises (MSME) sector in collaborations with global lead firms. With ongoing mega infrastructure initiatives and a strategic focus on new free trade agreements, the country is well-positioned to enhance its engagement in GVCs. Additionally; India boasts various sectors with ample production capabilities that can be scaled to meet the demands of export-oriented production. This study confirms that focusing on some strategic non-fuel minerals (key resources) can usher growth through economic integration with GVCs.

## **CHAPTER 7: DISCUSSION OF RESULTS AND CONCLUSION**

The central idea of this thesis revolves around the concept of 'Key Resources' and its importance in determining growth momentum of an economy. By 'key resources' we mean some naturally occurring non-fuel minerals which are substantially used as key ingredients in various production processes. The fundamental macroeconomic structure of an economy largely depends on the geological endowment of these 'key resources' that the country is naturally bestowed with. Even in today's highly complicated economic structure, which is typically characterised by intricate interplay of complex and intertwined production lines, the intrinsic strength of the economy still originates from the deposition of the 'key resources' and their derived products.

## 7.1 Theoretical Background: Relationship between Mineral Resources and GDP Growth

There are broadly two categories of economic theories that propose a relationship between a country's growth rate and its mineral resources. The first category, posits a positive relationship whereas the second category implicates negativity in the long-run. Under "natural resource rents" hypothesis, which suggests that countries with abundant natural resources tend to have higher GDP growth rates due to the rents they receive from the sale of these resources. Another theory is the "immiserating effects" theory, which posits that the exploitation of natural resources can lead to an initial increase in a country's GDP, but ultimately results in economic stagnation and poverty for the country's population.

The Neo-Classical Model of Economic Growth developed by Solow and Swan, emphasizes that minerals contribute to capital accumulation but face diminishing returns. The theory suggests that increasing capital or labour has only a temporary impact on growth. To boost growth in the long run, we need increased investment and technological progress. It is also often argued that while minerals are essential for development, sustainable practices are crucial. Environmental concerns suggest that resource degradation and global warming may seriously constrain long-term economic growth. In summary, mineral resources can significantly impact economic growth, but effective management, technological progress, and responsible policies are essential for sustainable development

Throughout the various stages of an economy's development, a consistent supply of mineral resources is deemed essential, especially during the initial and reformative growth phases

where the importance of raw materials is significantly high. These steady supplies are fundamental for achieving satisfactory industrial sector growth rates. Industrialization lays the groundwork for a robust physical infrastructure, which in turn, propels the economy to higher levels of development. In this context, the development of heavy industries, which depend heavily on strategic non-fuel minerals (like iron ore and bauxite) and fuel minerals (such as coal), is crucial.

#### 7.2 Global Perspective: Current Trends

The most important trend that has been observed globally in 21<sup>st</sup> Century, particularly in post - Covid era -has been the drastic shift of energy systems from being 'fuel based' to 'mineral based'. The energy transition denotes the move from reliance on fossil fuels to the adoption of renewable energy sources. Countries worldwide, including India, have begun to navigate this energy transition, moving towards cleaner, more sustainable energy sources, and have achieved varying degrees of success in this transformation. This shift began to pick up steam in the latter half of the 20th century, driven by factors such as environmental concerns, technological progress, and policies favouring renewable energy. This change is pivotal in the fight against climate change. The recent COP28 conference has been a landmark event in global climate policy, marking the first official acknowledgment of fossil fuels as the main contributor to climate change. This acknowledgment highlights the critical need for swift decarbonisation efforts across the globe. In light of the grave warnings about climate change's progression, participating nations have pledged to steer their energy systems away from fossil fuels. The aim is for this transition to be just, well-organized, and fair, focusing on urgent actions during this decisive decade. The objective is to adhere to scientific advice and reach net-zero emissions by 2050. This ground-breaking agreement heralds the fossil fuel age's decline, underlining the necessity of united actions to combat climate change.

Since the energy transition process entails huge requirements of 'non-fuel minerals '(key resources'), a massive skirmish has already started among countries over territorial dominance. The disputes in the South China Sea and the unrest in several African nations highlight the global scramble for resources, including essential minerals. Some nations have recognized the critical importance of these minerals, sparking a renewed rush to discover new mineral deposits. This trend isn't new for countries such as the UK and France, which have seen similar cycles of resource exploration in the past. This shift towards seeking alternative resources stems from a broader change in the global growth model, driven by the urgent need

to address unsustainable industrial practices that have contributed significantly to global warming. This looming threat has the potential to cause irreversible harm to the Earth's atmosphere, leading to severe economic impacts.

Another important trend that has been observed globally is growing tendency of the countries to get integrated with some Global Value Chains (GVCs). This trend has become more prominent in post-Covid era, since most of the countries suffered badly from supply-chain disruptions during the pandemic. Economic integration with Global Value Chains (GVCs) and Regional Value Chains (RVCs) has become imperative for development in current international geo-political scenario. Although the Asia-Pacific region is house for many interconnected trade blocs (like ASEAN, BIMSTEC, Mekong Ganga Cooperation etc) and subject to famous "Noodle-Bowl" effect, integration with regional value chains is not satisfactory. Present external policies of Government of India (like 'Act East Policy,' 'Neighborhood First Policy' etc) are largely focused on economic integration with regional value chains in the immediate neighborhood. Manufacturing value chains are particularly very important in this respect. Based on non-fuel mineral resource endowments in neighboring countries, India can further induce trade driven growth through optimal resource management. Optimality should also be matched with environmental sustainability and feasibility aspects. Exchange of 'Nonfuel Minerals' within countries of Indian sub-continent could be a game-changer and 'Pareto-Optimal' in economic sense.

#### 7.3 Case Study of India: Ensuring Self-Reliance with Sustainability

Beginning in the late 1980s and more notably with the 1991 economic reforms, India initiated a pivotal shift in its economic policy and federalism framework from a centrally controlled approach towards one promoting market-driven growth, ushering in an era of 'competitive federalism.' This shift was accentuated by efforts to encourage states to compete for investments, innovation, and development. In 2014, the Planning Commission was replaced by the NITI Aayog, a move designed to nurture both 'cooperative' and 'competitive federalism,' and lay the groundwork for significant initiatives such as "Make in India." This initiative aimed to establish India as a leading manufacturing hub on the global stage. Additionally, the "Atmanirbhar Bharat Abhiyaan" (Self-Reliant India Mission), launched in response to the economic challenges posed by the COVID-19 pandemic in May 2020, marked a novel approach by equally prioritizing foreign and domestic investments in driving economic growth. The mission sought to position India as an appealing destination for

investment through strategic policy support and infrastructure enhancements, capitalizing on advantages such as affordable labor and substantial market demand to stimulate income, employment, and GDP expansion.

The driving force behind the latest set of schemes and missions initiated by government of India is primarily based on the concept of "export promotion" and "import substitution" for rapid growth of an economy. Schemes like "Atmanirbhar Bharat" primarily zero in on achieving "self-reliance" of the economy in terms of a significant reduction in the total import burden. Simultaneous implementation two policy drives, viz. "Export Promotion" and "Import Substitution", have further been accompanied by the pressing need for reducing the carbon-footprints of the manufacturing activities in the country, with due cognizance to global treaties.

Prime Minister Narendra Modi has set more ambitious goals for 2030, aiming to achieve 500 gigawatts of renewable energy capacity, cut the emissions intensity of India's economy by 45%, and reduce carbon dioxide emissions by one billion tonnes. These objectives are challenging yet achievable, as India's transition to clean energy is already in progress. The nation has surpassed its pledge from the COP 21- Paris Summit, achieving 40% of its power capacity from non-fossil sources nearly nine years ahead of schedule. Additionally, the contributions of solar and wind energy to India's energy portfolio have significantly increased. Thanks to technological advances, consistent policy support, and a dynamic private sector, constructing solar power plants has become more cost-effective than coal-fired ones. Renewable energy in India is expanding faster than in any other major economy, with the capacity expected to double by 2026. India is also emerging as one of the leading global producers of modern bioenergy, with ambitious plans to enhance its usage across various sectors. The International Energy Agency (IEA) anticipates that India will soon surpass Canada and China to become the third-largest ethanol market globally, following the United States and Brazil.

Hence, it is now clear that government of India has embarked on a fascinating journey to reach a much higher growth trajectory synchronised with energy transition initiatives. This can be best described as "<u>Ensuring Self-Reliance with Sustainability</u>".

For the policies looking at "import substitution" by indigenous products, the manufacturing base of the country must expand significantly in both extensive and intensive way. This implies more production lines need to evolve and each production process need to extend and encompass production of various sub-categories of the principal product. In both cases, huge

quantity of mineral resources is required in a time bound manner. Here the question often arises regarding the justification of massive exploitation of country's valuable resources within a very short spell of time, mostly within a political cycle of five years. A prudent policy can never indulge in over utilisation of valuable resources, unless the situation demands a big push in manufacturing activities of the country to take-off for a significantly higher growth trajectory through the complex interplay of backward and forward linkages and the multiplier process. But even then, if the underlying mathematics somehow goes wrong, the chances of economic collapse remain prevalent in future.

The "export promotion" policies also involve similar concerns pertaining to chances of over utilisation of resources. Additionally, policy makers need to introspect trade policies related to export of fuel and non-fuel minerals with greater caution. Implications of trade agreements (bilateral, FTA, RTA etc) involving exchange of valuable minerals needs to be adjudged in the perspective of the economy, which has already embarked on a huge drive for resource-led growth. A systematic analysis is required in the context of Indian economy.

### 7.4 Major Findings of our Research

This thesis zeroes in on a specific set of 'non-fuel minerals' that have been playing a decisive role in the growth dynamics of Indian economy in the 21<sup>st</sup> century. These minerals are also found to have a strategic role in shaping up a new global order in terms of economic strengths and geopolitical dominance. Countries having access to these minerals are believed to be at the helm of the future journey towards higher growth trajectories in coming years. Since these resources are sparsely available and scattered unevenly across the globe, the competition among the countries has steepened and given rise to a large number of conflicts and territorial disputes. Our study has made an endeavour to unravel India's position in this context.

The most important part of this thesis has been the identification of 'key resources' of Indian economy using three methods:

- Calculation of 'Backward' and 'Forward Linkages' using Rasmussen's Multiplier Approach
- Determination of 'most important' resources by application of 'Principal Component Analysis' (PCA).
- iii) Measurement of economic integration in terms of 'forward' and 'backward' linkages with Global Value Chains (GVCs) using GTAP database

## 7.4.1 Backward and Forward Linkages

The most important part of this Chapter has been the identification of 'key resources' of Indian economy using two methods. The first method is the calculation of 'Backward' and 'Forward Linkages' and the second one is the determination of 'most important' resources by application of 'Principal Component Analysis' (PCA). Results obtained from both the methods ascertained following eight (8) non-fuel minerals as the 'key resources' for the Indian economy:

## Bauxite, Chromite, Copper Ore, Gold Ore and Conc., Iron Ore, Lead Conc., Manganese Ore, Silver

These minerals have been found to have strong linkage effects (Backward / Forward) and also capture maximum influence in country's growth momentum. The most import finding in this case is that all of these resources have strong 'backward linkages'. This implies these resources have strong linkages with the economy from demand side. This indicates towards high domestic demand of 'key resources' due to:

- i) A huge and <u>rapidly growing manufacturing base</u> of Indian economy.
- ii) <u>Accelerating industrialization</u> process and a structural shift from 'agricultural' to 'manufacturing' activities.
- iii) Increase in <u>export of commodities that requires sizable amount of these non-fuel</u> <u>minerals as inputs.</u>

Stronger 'backward linkages' implies that these eight 'key resources' develop the <u>productive</u> <u>capacity</u> of the economy in both <u>intensive</u> (more production of the commodities) and <u>extensive</u> (production of more commodities) ways.

## 7.4.2 Impact Analysis

The Government of India has initiated a bold journey towards enhancing its economic growth by implementing a unified policy strategy, known as 'Ensuring self-reliance with Sustainability.' A key policy under this strategy is the '*Atmanirbhar Bharat Abhiyaan*' (2020), which unveiled a substantial incentive package of Rs. 20 lakh crores. The goal of this policy is to energize domestic manufacturing in various sectors with the collective aim of reaching a GDP of USD 5 Trillion by 2025. To meet these ambitious manufacturing targets, there will be a considerable demand for both fuel and non-fuel minerals. This research has carried out 'impact analyses' to reveal the extensive economic implications of increased manufacturing activities, focusing particularly on the demand for 'non-fuel minerals.' It evaluated the

possibility of meeting these manufacturing targets by analyzing the reserves of non-fuel minerals within the country. The analysis identified that the production of five critical non-fuel minerals—*Copper Ore, Manganese Ore, Bauxite, Chromite, and Gold Ore and metal*— is essential for the nation's economic expansion plan. Notably, *Copper Ore and Manganese Ore* emerged as the most crucial minerals necessary for attaining the ambitious GDP target of USD 5 Trillion by 2025.)

#### 7.4.3 Economic Integration with GVCs

Global Value Chains (GVCs) encompass the series of production steps from design and manufacturing to marketing, distribution, and ultimately the sale to the final consumer, with these tasks distributed across multiple firms in various countries. Countries participate in GVCs through either backward or forward linkages. The GVC participation index measures the extent to which an economy is integrated into global value chains based on its production and international trade activities. Backward linkages occur when a country imports inputs from abroad to produce goods and services for export. In contrast, forward linkages arise when a country exports its domestic inputs to other nations responsible for subsequent stages of production. This approach assesses the domestic value added by inputs exported for additional processing and incorporation into supply chains for export by other economies.

The degree of connectedness of an industry with the rest of the world is often suitably measured by quantifying the 'backward' and/or 'forward' linkages associated with it. Quite interestingly, with higher values of backward and/or forward linkages, some industries (sectors) are always found to wield stronger influence in determining the underlying dynamics of the economic systems. These industries act as a fulcrum for spreading the 'economy-wide impact' of both 'internal' and 'external' impulses brought about by "internal policy changes" and "external supply chain shocks" respectively. Since these industries play "key roles" in both destabilizing and subsequently delineating the required set of counteracting stabilizing policy prescriptions to the government, we can conveniently identify these sectors as "key sectors" (as conceptualized at the beginning of this study). Most importantly, any cardinal measurement of 'forward' and 'backward' linkages can make the difficult task of identifying "key sectors" much easier.

The results of our research in this regard shows that five (5) 'non-fuel minerals (*Manganese* ore, Limestone, Copper Ore, Bauxite and Other Metallic Minerals are among the first 10

sectors in terms Import Content of Export. This result conforms to the results obtained from calculation of 'Forward and Backward Linkages' and Principal Component Analysis (PCA).

The measure of 'backward Linkage' (Intermediate Imports Embodied in gross Exports) using Economic Cooperation and Development (OECD)'s Trade in Value Added (TiVA) database also conforms to results obtained from GVA analysis using GTAP database.

In addition to that, calculations from TiVA provide some other important insights into the picture.

- i) Linkage effects for 'Mining and Quarrying' sector are much higher than overall linkages
- ii) Linkage effects for 'Mining and extraction of energy producing products' are highest in this category, indicating India's dependence on 'fuel minerals'
- iii) Forward Linkage for 'Mining and extraction of energy producing products' is much higher than the backward linkage. This implies India is more integrated from 'Supply Side' by exporting 'Mining and extraction of energy producing products' to East Asian countries.

#### 7.4.4 Consolidated Results

We have consolidated results obtained from following methods:

- i) Calculation of 'Backward' and 'Forward Linkages'
- Determination of 'most important' resources by application of 'Principal Component Analysis' (PCA).
- iii) Measurement of economic integration in terms of 'forward' and 'backward' linkages with Global Value Chains (GVCs) using GTAP database

iv) The insights from the 'impact analyses' have also been incorporated in results Next, we have assigned scores as follows:



These minerals have been identified as 'most powerful' in garnering country's growth momentum. These 'key minerals', are further represented into following three categories, depending on their <u>total score</u> to represent their intrinsic capacities to influence growth of Indian economy:

## **Key Minerals:**

- <u>Top Category (2)</u>: Copper Ore; Manganese Ore
- <u>Middle Category (1)</u>: Bauxite
- <u>Bottom Category (6)</u>: Chromite; Gold Ore & Conc; Iron Ore; Lead Conc.; Limestone; Silver

The most import finding in this case is that all of these resources have strong 'backward linkages'. Stronger 'backward linkages' implies that these 'key resources' develop the <u>productive capacity</u> of the economy in both <u>intensive</u> (more production of the commodities) and <u>extensive</u> (production of more commodities) ways. This indicates towards high domestic demand of 'key resources' due to:

- i) A huge and <u>rapidly growing manufacturing base</u> of Indian economy.
- ii) <u>Accelerating industrialization</u> process and a structural shift from 'agricultural' to 'manufacturing' activities.
- iii) Increase in <u>export of commodities that requires sizable amount of these non-fuel</u> minerals as inputs.

## 7.4.5 Other Findings

Our study indicates that during the pandemic period, countries exporting "fuel minerals" have seen a notable improvement in their economic status compared to those exporting "non-fuel minerals." This trend suggests that countries focusing on non-fuel mineral exports are more susceptible to disruptions in the supply chain. Therefore, these disruptions pose a significant threat to such countries, emphasizing the need for governments to develop contingency plans to mitigate potential export disruptions. Consequently, it's wise to minimize reliance on long-distance shipping of export goods. This also means that economic ties with Regional Value Chains (RVCs) should be prioritized over Global Value Chains (GVCs), suggesting that India, for example, should strengthen its trade relations with regional groups like ASEAN and BIMSTEC, rather than with far-off partners like the EU.

Moreover, diversifying export markets is crucial. Should there be any obstacle in one export destination; alternative markets could help absorb the surplus, ensuring steady revenue flow. Encouraging local industries that use non-fuel minerals can be challenging. While focusing on domestic markets might seem beneficial, it risks two major issues. Firstly, the World

Trade Organization (WTO) may challenge such protectionist measures as they contravene global trade rules, potentially leading to punitive actions. Secondly, selling domestically rather than exporting could result in considerably lower profits, adversely affecting the nation's treasury.

Our research has raised a concern about the mismatch in mineral statistics published by three Government bodies: Indian Bureau of Mines (IBM), Ministry of Mines (MoM) and Central Statistical Organisation (CSO) of India. Authenticity of database is always a serious issue, as any economic research based on this data may result in completely misleading outcomes. Considering gravity of the problem, Ministry of Mines should immediately make an effort to synchronise all datasets and facilitate flow of symmetric information in public domain and to make database tenable to academic research and analysis. Ministry can come up with a single databank or repository-portal to ensure access to officially authenticated and updated data to all stakeholders and academic researchers (like the 'Export-Import Databank' provided by Ministry of Commerce and Industry).

#### 7.5 Conclusion

India's shift towards clean energy not only holds considerable economic promise but also positions the country as a potential leader in the renewable energy domain, especially in battery technology and green hydrogen, with an expected market value of up to \$80 billion by 2030. Achieving a sustainable, low-carbon economy requires significant international support and investment—specifically, the International Energy Agency (IEA) estimates a need for \$160 billion annually until 2030, a tripling of current levels, to reach net-zero emissions by 2070. Beyond merely reducing greenhouse gas emissions, this transition aims to enhance the quality of life for Indians through balanced, well-crafted policies that ensure affordability, security, and environmental sustainability. Green hydrogen, crucial for decarbonizing hard-to-abate industries, is at the heart of India's strategy to create a demand for 5 million tonnes of green hydrogen, thereby avoiding 28 million tonnes of CO2 emissions initially, with the potential to prevent 400 million tonnes by 2050 as the green hydrogen economy matures.

Global Value Chains (GVCs) are in a state of flux, influenced by factors such as the need for diversification in the wake of the pandemic and the pursuit of supply chain security for strategic purposes. This shift presents a prime opportunity for India to elevate its role within these value chains and secure a larger market presence. Our study supports the view that India is poised to expand its involvement in GVCs, particularly through emphasizing the 'key

mineral sectors.' Implementation of appropriate government policies to streamline customs and trade procedures, as well as engaging the broad micro, small, and medium enterprises (MSME) sector in partnerships with leading global firms, is essential. With its commitment to major infrastructure projects and a strategic emphasis on negotiating new free trade agreements, India is in a strong position to deepen its participation in GVCs. The country also has several industries with the potential to scale up production to fulfil export demands. Our findings highlight that prioritizing strategic non-fuel minerals (key resources) can drive growth and facilitate economic integration with GVCs.



For this, we make a simple assumption:

#### Assumption 1:

Production of each newly introduced mineral will be allocated in the same proportion in which 'Other Minerals' are allocated along industries.
